# Private offices, dine-in facilities in restaurants closed in Delhi

AGENCY NEW DELHI, JAN 11

Amid a surge in COVID-19 cases in the national capital, the Delhi Disaster Management Authority (DDMA) has directed that all private offices shall be closed except those that come under the exempted category.

Private banks, insurance companies, courier services, non-banking financial corporations and companies providing essential services will reEarlier, the private offices were working with 50 per cent of work-

The DDMA has also ordered that the dine-in service in restaurants and bars will be discontinued in the national capital. Earlier, the eateries and bars in the capital were allowed to run with 50 per cent capacity to curb the spread of coronavirus. 'DDMA directs that in the terri-

tory of NCT of Delhi (outside Containment Zones), the following additional activities shall also be prohib-



ited/restricted with immediate effect till further orders: (i) All Private Ofwhich are falling under the "Exempted Category"

The practice of work from home shall be followed. (ii) All Restaurants and Bars shall be closed. However, restaurants will allowed only for home delivery/takeaway of food items," the DDMA notification read.

Delhi reported 19,166 new COVID-19 cases during the past 24 hours, informed the state in a health bulletin on Monday.


### Manual sewerage cleaning work completely banned in the state: Manohar Lal

Manohar Lal said that in case of death of a sewerman during sewerage cleaning, his family is being given an assistance of Rs.10 lakh. So far, this assistance amount has been given to the families of 57 sewermen across the state. If private companies engaged in cleaning work are reluctant in giving this assistance, then strict action will be taken against them. The Chief Minister was presiding over a meeting of the State Monitoring Committee constituted on the Manual Scavenging Act on Tuesday. Cooperation Minister, Sh. Banwari Lal was also present during the

During the meeting, the Chief Minister directed the Public Health Engineering Department that sewerage cleaning machines should be available in rotation in all municipal corporations and municipalities. He said that old sewers should be cleaned



with machines based on similar technology. Apart from sewers should be cleaned with state-of-the-art robotic machines at the places where there is a new sewerage system. The Chief Minister directed the officers of the Urban Local Bodies Department to form a committee of employees engaged in cleaning work and make arrangements for awarding contracts related to cleanliness. Along with companies and contractors, sewermen should also be given priority so that this class can also benefit. The Chief Minister said that manual cleaning of sewerage is prohibited throughout the state.





Most of the farmers are being forced to leave farming due to destitute and wild animals. Apart from this, he said that farmers are not

getting the price of the crop according to the cost of the produce. He has demanded from the Chief Minister that arrangements should be made to give price to the farmers on the basis of cost of produce and to save the crops from destitute animals and wild animals, cow shelters and cow protection should be constructed at the earliest.

# Farmers seek cost base price for crops

This information was given by Additional Superintendent of Police (Cyber Crime) Narveer Singh Rathore in the weekly webinar of Umang Foundation on Human Rights Awareness on Monday. He said that investigation found that more men are victim of Cyber fraud compared to women. In the year 2021, more than 8500 complaints of cyber crimes were registered with Himachal Police out of these, 77 per cent complaints were from men. Internet and cyber security is now a fundamental right of all citizens. Narveer Singh Rathore said that more than 72 crore people use the internet in the country. Out off these, 67 per cent are males and 33 per cent are females. 62 per cent of internet users are connected to social media. He said that the Supreme Court and other courts have made it clear that Internet access and cyber security is a fundamental right of any individual or institution. He also listed several measures that could be adopted to protect against hacking and other cyber crimes He said that awareness is the biggest measure to counter the cyber crime as highly educated persons such as doctors, engineers, professors and senior officers are also among the victims of cyber fraud due to ignorance towards cyber security issues.

# Corona infected people roaming fearlessly increasing problems of health department

The havoc of Corona is increasing in Kangra, largest district of state. District Health Department has accelerated the pace of corona test after 365 cases of corona were reported in a single day. The health department's troubles increased when the department found that the district corona infected people were roaming freely, raising the possibility of more cases of corona in the coming days. The Health Department believes that 10 percent of the corona in the district is running fearlessly. Giving information to the journalists in Dharamsala on Tuesday, CMO Dr. Gurudarshan Gupta said that when the team of Health and Police Department conducted corona tests of many people roaming without masks in bus stands, temples and other crowded places, in which most of the cases were found infected which is a matter of concern. He said that due to such careless people, many other people would also have been hit by Corona. Gurudarshan Gupta said that Kangra district has been divided into three

sectors Nurpur, Tanda and Palampur after registering a sudden jump in corona cases. There are 53767 total cases in the district, out of which 1265 have become active. In this third wave of corona, the number of patients admitted to the hospital is less, which is also a matter of relief. He said that one covid care system is working in these three sectors. With this, ten other hospitals have been selected by the Health Department. In these hospitals too full arrangements have been made to deal with corona disease and the hospitals can be used in case of any emergency. He said that the Covid care system is working in all the three sectors. In these sectors, arrangements for beds including oxygen have been made by the Health Department. He said that about 150 corona cases have also been reported from Tibetans living in McLeodganj in Dharamsala. He said that the Health Department, along with the administration of District Kangra, has also launched a campaign to make people aware of corona disease, in which people should be told about wearing face masks properly, washing hands frequently and social distancing.

The Punjab Pollution Control Board (PPCB) and the PPWMS, on 2nd October 2018 launched the programme for effectively managing post-consumer multi-layered packaging (MLP) in the state of Punjab. IPCA is actively collecting plastic waste (MLP waste) since then on behalf of PP-WMS and in current year, col-



lected 5201 MT of plastic waste from seven cities of Pun-jab which is 87,34,020 kg CO2 equivalent. Thus, this initiative is not only removing plastic waste from our environment, it is also reducing CO2 emissions and providing income source to waste workers. "According to CPCB Annual Report 2019-20, Punjab is generating approximately 92890.17 TPA, which is roughly translated to generation of 250 Tonnes of plastic waste per day. Plastic waste generation share of Punjab is 3% of India's total plastic waste generation and Punjab is following a unique model for

executing Extended Producer Responsibility through PP-WMS consortium. The target for FY2021-22 is to collect more than 7000 MT of MLP waste and till December 2021. IPCA has collected 5201.6 MT of MLP waste in Punjab, i.e. 74 % of the fixed target. With this collection efficiency, we will be able to achieve our target on time. IPCA and PPWMS are not just collecting plastic waste under this mission, they are also making people aware about the efficient plastic waste management through IEC activities" said Ajay Garg Secretary IPCA.


#### C-Vigil app empowers citizens to report any violation of Model Code Of Conduct: DC

# Manipur government extends AFSPA for another year

AGENCY IMPHAL, JAN 11

The Manipur government has extended the "Disturbed area" status in the state for one more year on Tuesday. The extension is done every year by the state Home department. The extension of Disturbed Area status implies an extension of the Armed Forces of Special powers Act 1958 till the end of this year. Special Secretary (Home) H Gyan Prakash said in an order that "the Governor of Manipur is of the opinion that due to violent activities of various extremist/insurgent groups, the entire state of Manipur is in such a disturbed condition that the use of armed forces in aid of civil power is necessary and is of the opinion that the areas within the state be declared as a "Disturbed Area" under the provisions of the Armed Forces (Special Powers) Act, 1958." In exercise of the powers conferred by Section 3 of the Armed Forces (Special Powers) Act, 1958 (Act No.28 of 1958) as amended from time to time, the Governor of Manipur accords ex-post facto approval to declare the entire state of



Manipur excluding the Imphal Municipal Area as "Disturbed Area" for a period of one year with retrospective effect from December 1, 2021, it was added. The Imphal Municipal area was however excluded. Most political parties, including Congress, Left, MPP, civil societies and victims' families have demanded the repeal of the Armed Forces Special Powers Act. Chief Minister N Biren Singh also stated that the government is reviewing the matter. The Extrajudicial Execution Victim Families Association, Manipur (EEVFAM) formed by 1958 families of extrajudicial execution has also filed a case in the Supreme Court. The

EEVFAM and Human Rights Alert have also demanded that government immediately issue pending prosecution sanctions against all the police personnel indicted by the CBI/SIT in pursuance EEVFAM v/s Union of India, SC WP (Cril) 129 of 2012. Even though prosecution sanctions against the lower-ranking police personnel were issued, those against the higher-ranking police personnel were not issued to date it was stated. It further demanded that the state government should pursue with the Union of India to prosecution sanction against all the armed forces of the union found to be involved in the extrajudicially killing of the

whose prima facie evidence have been already submitted to the Chief Judicial Magistrates of various districts of Manipur following the investigation of the CBI/SIT in pursuance EEVFAM v/s Union of India, SC WP (Cril) 129 of 2012. Irom Sharmila of Manipur launched unprecedented fast for 16 years demanding repeal of AFSPA from 5 Aug 2004 to 9 Aug 2016 after the Malom massacre during which 8 Assam Rifles personnel shot dead ten persons who were waiting for a bus in a bus shed at Malom, Imphal. Manipur government withdrew AFSPA from the Greater Imphal area covering seven Assembly constituencies after the public uprising over the alleged rape and murder of Thangjam Manorama by personnel of 17 Assam Rifles in 2004. The AFSPA is a British colonial law promulgated to suppress Quit India Movement in 1942. Only Army Officers were empowered to kill anybody on mere suspicion during British colonial time but it was amended in 1958 to empower all army personnel to kill anybody on mere suspicion.

Advertisement pre certification is required for electronic media that includes all online e papers, radio, TV, cinema hall and social media, bulk messages on mobile and social media platforms like Facebook. Before uploading advertisements on any of these platforms, a pre certification from the district level MCMC is mandatory. He added that the registered national/ regional party will have to apply for approval at least three days before uploading the content. In case of individual or unregistered party, this has to be done 7 days before. Application should have copy of the recording and transcript. A candidate will be able to spend a maximum of Rs 40 lakh on his campaign, earlier the spending limit was Rs 30.80 lakh, which has now been increased. In this regard, a meeting was held under the chairmanship of Additional District Electoral Officer Mr. Varjit Walia in which representatives of various political parties participated and assured cooperation to the district administration. Disclosing this here today, Mr. Walia said that the Election Commission of India (ECI) has been taking various measures to



reduce the exorbitant expenditure incurred by the candidates in the elections. He said that candidates would be able to spend only on rallies, campaign materials, advertisements, vehicles, and other miscellaneous activities required for elections. Therefore, they have to open a joint bank or postal account in their name or with their election agent one day before filling up the nomination papers. Candidates will be able to cover all election expenses from this account. Payment of up to Rs.10,000 can be

made in cash, whereas more amount has to be paid by check. He appealed to the delegates not to use illegal means such as distribution of liquor and drugs, distribution of cash, distribution of gifts, etc. during the elections. Special Expenditure Monitors will be sent by the Election Commission to monitor the expenditure incurred by the candidates and teams have also been formed at the local level. Details of expenses incurred by the candidates will have to be recorded in the daily expenditure register.

### **EDITORIAL** Global wish list

ystopia-dependent depression is too easy a mode in which to start a new year. Perhaps we should attempt to do the far more difficult, counter-intuitive thing by reaching instead for mad optimism — given the sheer, mind-shuttering direness of the multiple lunacies currently engulfing us, we might as well deploy the counter-craziness of vividly projecting scenarios that go well beyond the logical, 'best-case' models.

So, 2022 will be the year in which we will finally see the petering out of Sars-Covid-19. Given that Calcutta and West Bengal have been nationally behind the curve on most variants but are well ahead on Omicron, the post-Corona sun will rise first on our Sonar Bengal and Rupashi Kolkata. Even as the rest of the country is still reeling from the last tail-lashes of the monster, we will be the first state in the country to regain whatever counts for normalcy. This will provide a much-needed boost to our economy and to the general happiness-quotient of all of us residing in the lap of Mama Bangla.

Our state government and ruling party, chastened by their electoral misadventures in far corners of the country where they have no business, will return their attention to the betterment of our state with renewed vigour. Made consultative, collegiate and sagacious in the triple forge of the pandemic, the cyclones and the horrendous state election battles, our leaders will have learnt many lessons. In close collaboration with scientists, researchers and thinkers, the state government will shift from yo-yoing top-down populist whimsy to putting into practice much-needed reforms. The clean air periods of the last two years will be remembered and curbs on vehicles and industrial pollution will aim for and attain 'Lockdown Level' air-quality. # In 1st, US surgeons transplant pig heart into human patient

In a medical first, doctors transplanted a pig heart into a patient in a last-ditch effort to save his life and a Maryland hospital said Monday that he's doing well three days after the highly experimental

While it's too soon to know if the operation really will work, it marks a step in the decades-long quest to one day use animal organs for life-saving transplants. Doctors at the University of Maryland Medical Center say the transplant showed that a heart from a genetically modified animal can function in the human body without immediate rejection.

The patient, David Bennett, a 57year-old Maryland handyman, knew there was no guarantee the experiment would work but he was dying, ineligible for a human heart transplant and had no other option, his son told The Associated Press.

It was either die or do this transplant. I want to live. I know it's a shot in the dark, but it's my last choice, Bennett said a day before the surgery, according to a statement provided by the University of Maryland School of Medicine.

On Monday, Bennett was breathing on his own while still connected to a heart-lung machine to help his new heart. The next few weeks will be critical as Bennett recovers from the surgery and doctors carefully monitor how his heart is faring. There's a huge shortage of human organs donated for transplant, driving scientists to try to figure out how to use animal organs instead.

Last year, there were just over 3,800 heart transplants in the U.S., a record number, according to the United Network for Organ Sharing, which oversees the nation's transplant system. "If this works, there will be an endless supply of these organs for patients who are suffering, said Dr. Muhammad Mohiuddin, scientific director of the Maryland university's animal-to-human transplant program. But prior attempts at such transplants or xeno-



transplantation have failed, largely because patients' bodies rapidly rejected the animal organ. Notably, in 1984, Baby Fae, a dying infant, lived 21 days with a baboon heart.

The difference this time: The Maryland surgeons used a heart from a pig that had undergone gene-editing to remove a sugar in its cells that's responsible for that hyper-fast organ rejection. Several biotech companies are developing pig organs for human transplant; the one used for Friday's operation came from Revivicor, a subsidiary of United Therapeutics.

I think you can characterize it as a watershed event, Dr. David Klassen, UNOS' chief medical officer, said of the Maryland transplant. Still, Klassen cautioned that it's only a first tentative step into exploring whether this time around, xenotransplantation might finally work.

The Food and Drug Administration, which oversees such experiments, allowed the surgery under what's called a compassionate use emergency authorization, available when a patient with a lifethreatening condition has no other op-

It will be crucial to share the data gathered from this transplant before extending it to more patients, said Karen Maschke, a research scholar at the Hastings Center, who is helping develop ethics and policy recommendations for the first clinical trials under a grant from the National Institutes of Health. Rushing into animal-to-human transplants without this information would not be advisable,

Over the years, scientists have turned from primates to pigs, tinkering with their genes. Just last September, researchers in New York performed an experiment suggesting these kinds of pigs might offer promise for animal-to-human transplants. Doctors temporarily attached a pig's kidney to a deceased human body and watched it begin to work.

The Maryland transplant takes their experiment to the next level, said Dr. Robert Montgomery, who led that work at NYU Langone Health. This is a truly remarkable breakthrough," he said in a statement. "As a heart transplant recipient, myself with a genetic heart disorder, I am thrilled by this news and the hope it gives to my family and other patients who will eventually be saved by this break-

The surgery last Friday took seven hours at the Baltimore hospital. Dr. Bartley Griffith, who performed the surgery, said the patient's condition heart failure and an irregular heartbeat made him ineligible for a human heart transplant or a

heart pump.

Griffith had transplanted pig hearts

Tobebooks over five years, beinto about 50 baboons over five years, before offering the option to Bennett. We're learning a lot every day with this gentleman, Griffith said. And so far, we're happy with our decision to move forward. And he is as well: Big smile on his face

Pig heart valves also have been used successfully for decades in humans, and Bennett's son said his father had received one about a decade ago. As for the heart transplant, He realizes the magnitude of what was done and he really realizes the importance of it, David Bennett Jr. said. He could not live, or he could last a day, or he could last a couple of days. I mean, we're in the unknown at this point.

### Parent's genes can influence a child's educational success

For example, parents with a higher genetic propensity for learning may have a greater interest in activities such as reading that, in turn, nurture learning in their

offspring. This concept -when parents' genes influence outcomes for their offspring by shaping the environment that they provide for them -is called genetic nurture. It describes how parents' genes indirectly their children's characteris-

# Study finds COVID-19 Omicron variant neutralized by booster dose

The new COVID-19 Omicron variant is more transmissible than the Delta variant. However, its biological characteristics are still relatively unknown. The study about this variant has been published in the 'Nature Journal'. In South Africa, the Omicron variant replaced the other viruses within a few weeks and led to a sharp increase in the number of cases diagnosed. Analyses in various countries indicate that the doubling time for cases is approximately 2 to 4 days. Omicron has been detected in dozens of countries, including France, and became dominant by the end of 2021.

In a new study supported by the European Union's Health Emergency Preparedness and Response Authority



(HERA), scientists from the Institut Pasteur and the Vaccine Research Institute, in collaboration with KU Leuven (Leuven, Belgium), Orleans Regional Hospital, Hopital Europeen Georges

Pompidou (AP-HP) and Inserm, studied the sensitivity of Omicron to antibodies compared with the currently dominant Delta variant.

The aim of the study was to characterize the efficacy of therapeutic antibodies, as well as antibodies developed by individuals previously infected with SARS-CoV-2 or vaccinated, in neutralizing this new variant. The scientists from KU Leuven isolated the Omicron variant of SARS-CoV-2 from a nasal sample of a 32-year-old woman who developed moderate COVID-19 a few days after returning from Egypt. The isolated virus was immediately sent to scientists at the Institut Pasteur, where therapeutic monoclonal antibodies and serum samples from people who had

been vaccinated or previously exposed to SARS-CoV-2 were used to study the sensitivity of the Omicron variant.

The scientists used rapid neutralization assays, developed by the Institut Pasteur's Virus and Immunity Unit, on the isolated sample of the Omicron virus. This collaborative multidisciplinary effort also involved the Institut Pasteur's virologists and specialists in the analysis of viral evolution and protein structure, together with teams from Orleans Regional Hospital and Hopital Europeen Georges Pompidou in Paris.

The scientists began by testing nine monoclonal antibodies used in clinical practice or currently in preclinical development. Six antibodies lost all antiviral activity, and the other three were

3 to 80 times less effective against Omicron than against Delta. The antibodies Bamlanivimab/Etesevimab (a combination developed by Lilly), Casirivimab/Imdevimab (a combination developed by Roche and known as Ronapreve), and Regdanvimab (developed by Celtrion) no longer had any antiviral effect against Omicron.

Tixagevimab/Cilgavimab combination (developed by AstraZeneca under the name Evusheld) was 80 times less effective against Omicron than against Delta. "We demonstrated that this highly transmissible variant has acquired significant resistance to antibodies. Most of the therapeutic monoclonal antibodies currently available against SARS-CoV-2 are inactive," commented Olivier Schwartz, co-last author of the study and Head of the Virus and Immunity Unit at the Institut Pasteur.

The scientists observed that the blood of patients previously infected with COVID-19, collected up to 12 months after symptoms, and that of individuals who had received two doses of the vaccine, taken five months after vaccination, barely neutralized the Omicron variant. But the sera of individuals who had received a booster dose of Pfizer, analyzed one month after vaccination, remained effective against Omicron. Five to 31 times more antibodies were nevertheless required to neutralize Omicron, compared with Delta, in cell culture assays.



#### Maha: 22 cops test positive for Covid-19 in Nagpur

NAGPUR: Twenty two police personnel including five officers of Nagpur city police have tested positive for Covid-19, Dr Sandip Shinde, Chief Medical Officer(CMO) of Nagpur Police hospital informed on Tuesday. Dr Shinde further informed that all these police personnel have taken both the doses of vaccine against Covid-19. The CMO further said that all the patients are asymptomatic and have been put into home isolation as a precautionary measure. The officers who have tested positive include a top official of Crime Investigation Department (CID), Nagpur and a Deputy Superintendent of Police (Dy SP), and an official of State Intelligence Department's (SID) Nagpur unit also tested positive for novel coronavirus. A Police Inspector of Koradi Police Station, Second Pl of Jaripatka Police Station, a PI attached to Economic Offences Wing (EoW) and an API of Special squad of DCP Zone IV have also tested positive for Covid, Dr Shinde apprised. 17 of the infected policemen are attached to Jaripatka, Sadar, Sitabuldi, Beltarodi, Kalamna and police headquarters. These police personnel have been sent for home isolation with basic medicines as none of them are showing symptoms so far, Dr Shinde said. A total of 97 per cent personnel of Nagpur police have taken the first dose of the vaccine while the second dose was given to 98.5 per cent police staff. The one-and-a-half per cent difference in the first and second doses is showing as the cops have been transferred to other units in the last six months, Dr Shinde added. In view of people getting infected with Covid-19 cases even after taking both the doses, the Nagpur police has decided to start administering the booster dose of Covid-19 vaccine from Tuesday.

#### Kashmir valley, Ladakh reel under cold, Drass at -24.2

SRINAGAR: Drass in Ladakh experienced the seasons coldest night with temperature of minus 24.2 degree Celsius, while the famous tourist resorts of Gulmarg recorded a low temperature of minus 10.6 degree Celsius and Pahalgam minus 10.4 degree Celsius in Kashmir on Tuesday. A Meteorological Department official said that Srinagar, the summer capital of Kashmir settled at 0.2 degree Celsius for the second consecutive day on Tuesday. It was 2.0 degrees above normal during this time of the season, he said. The famous ski resort of Gulmarg in north Kashmir showed a further dip in temperature and was recorded at minus 10.6 degree Celsius against minus 10.0 degree Celsius recorded on Monday which is minus 2.7 degree below normal during this period of the season. Pahalgam, the famous resort in south Kashmir recorded temperatures of minus 10.4 degree Celsius against the minus 2.6 degree Celsius on the previous night.


# CM gives approval to creation of Specialist cadre post for MD or MS doctors
