Mumbai: 3 dead, 11 injured in explosion onboard **INS Ranvir**

MUMBAI: Three naval personnel were killed and 11 others were injured in an explosion in an internal compartment onboard INS Ranvir on Tuesday at the Naval Dockyard in Mumbai, said Mumbai Police on Wednesday. The deceased have been identified as Krishan Kumar Gopirav, MCPO I ASWI Antisubmarine Instructor aged 46, Surinder Kumar S Waliya, MCPO II Sports PT Master aged 47 and Arvind Kumar Mahatam Singh, MCPO II aged 38. The police said that all

dead bodies have been sent to JJ Hospital in Mumbai. The injured naval officers have been identified as PV Reddy (23), Yogesh Kumar Gupta (36), Gopaal Yadav (21), Shubham Dev (20), Hari Kumar (22), Shailendra Yadav (22), Tanmay Dar (22), L Surendrajit Singh (39), Komendra Singh (24), Kapil (21) and Avinash Varma (22).

LUDHIANA: Former Punjab chief minister and Shiromani Akali Dal Patron Parkash Singh Badal has tested positive for Covid. The SAD leader was admitted to Dayanand Medical College and Hospital here. Hospital sources said the exact health condition of the 94-year-old Akali Dal leader would be known only once the reports of tests come.Badal was touring his Lambi constituency and met a number of people, including party leaders, in the recent past. He cancelled his scheduled programmes on Tuesday due to backache. He was later tested positive for Covid.

Cabinet extends tenure of National **Commission for Safai Karamcharis till 2025**

NEW DELHI: The Government on Wednesday approved the extension of the tenure of the National Commission for Safai Karamcharis for three years uptill March 31, 2025. The total implication of the extension for three years would be approximately Rs 43.68 crore. The decision was taken in a meeting of the Union Cabinet chaired by Prime Minister Narendra Modi, Information and Broadcasting Minister Anurag Thakur told reporters.

"The major beneficiaries would be the Safai Karamcharis and identified manual scavengers in the country since the NCSK has been extended for 3 more years beyond March 31 2022. The number of Manual Scavengers identified under the MS Act Survey as on December 31, 2021, is 58,098. The National Commission for Safai Karamcharis (NCSK) was established in the year 1993 as per the provisions of the NCSK Act 1993.

India extends ban on international Passenger flights till Feb 28



NEW DELHI, JAN 19

Amid rising concerns over the Omicron variant of COVID-19, the Directorate General of Civil Aviation (DGCA) on Wednesday extended the ban on passenger international passenger flights till February 28

In a circular issued by DGCA, it said that the competent authority has decided to extend the suspension of Scheduled International commercial passenger services to/from India till 23.59 hrs IST of February 28, 2022.

It further reads this restriction shall not apply to international all-cargo operations and flights specifically approved by DGCA.

However, flights under air bubble arrangement will not be affected. All concerned authorities have been asked to acknowledge the receipt and ensure strict com-

Due to the coronavirus pandemic, international passenger services have been suspended in India since March 23, 2020.

NEW DELHI: With 2.82.970 new coronavirus infections being reported in a day, India's total tally of COVID-19 cases rose to 3,79,01,241, which includes 8,961 cases of the Omicron variant, according to the Union Health Ministry data updated on Wednesday.

The active cases have increased to 18,31,000, the highest in 232 days. The active cases stood at 18,95,520 on May 31 last year. The death toll has climbed to 4,87,202 with 441 fresh fa-





Air India cancels flights to US over 5G issue

NEW DELHI/ WASHINGTON, JAN 19

Several international airlines, including Air India, have cancelled flights to the US from Wednesday over uncertainty on interference between new 5G mobile phone service and critical airplane technologies.

According to CNN, Emirates, Air India, All Nippon Airways and Japan Airlines have announced service cuts.

Air India said it would suspend its flights between Delhi Airport and San Francisco, Chicago and JFK and Mumbai to Newark. "Due to deployment of the

majors AT&T and deploy new 5G services, airlines in the US have warned of potential adverse effect of it on flight operations.

The Federal Aviation Administration said the 5G cellular antennas near airports might throw off readings from some aircraft equipment that tell pilots about how far they are from the ground.

United Airlines statement said that the federal government's current 5G rollout plan will have a devastating impact on aviation, negatively affecting an estimated 1.25 million United passengers, at least 15,000 flights and muchneeded goods and tons of cargo traveling through more than 40 of the largest airports in the country annually.

"When deployed next to runways, the 5G signals could interfere with the key safety equipment that pilots rely on to take off and land in inclement weather," the airline said. The airline further said that

Troubled youth

he World Economic Forum's The Global Risks Report 2022 highlights a number of problems that plague nations — from threats of infectious diseases to those adversely affecting cyber security, climate change to the digital divide, the accumulation of economic debts to the erosion of social cohesion. The Global Risks Report also lists India's major risks: the fracturing of interstate relations, mounting debt crisis, failure of technology governance, deep digital division and widespread youth disillusionment. The risks are hardly exhaustive in characterizing the full extent of the troubles facing the nation. Many pundits had boastfully claimed that the demographics of a young population would benefit India in terms of an abundance of youthful energy and an ability to generate income and innovations through their engagement with new technology. That has not been the case. There are numerous reasons for this. To begin with, the access to quality education has been uneven for most of India's youth. College graduates and school drop-outs abound, but according to most employers, they are unemployable. Their technical skills, ability to communicate, interpersonal capabilities and general awareness about the world are below par.

Jobs are also scarce. The ones available are for a handful who are fortunate enough to have received a good education. With hardly any jobs around, and given the shrinking space of traditional livelihoods, the youth face a bleak future. Technology also divides. Not everyone has access to computers or are reasonably well-versed in basic software. Most young people have smartphones, but they are used merely to watch films, play games or send texts. The demographic dividend has actually become a demographic tax. These young people are available for political exploitation: they are easily swayed by powerful leaders. They are given some loose cash to play around with. Their propensity for violence and irrational anger stem from a sense of helplessness, a disillusionment about life. For a nation, this bodes ill. The young generation is supposed to take up the battles against climate change, social cleavages, and the growth of economic inequalities. The few who are lucky migrate to greener pastures. The remaining ones feel trapped. Economic and social crises intertwine to produce political fragmentations that divide people.

China views US as 'competitor'

as a "competitor" and treats itself also as the "lone competitor", "capable of combining its economic, diplomatic, military, and technological power to mount a sustained challenge to a stable and open international system", said a Canadabased think tank.

Citing the detailed report, titled "Military and Security Developments Involving the People's Republic of China 2021," the International Forum for Rights and Security (IFFRAS) reported that "China's military strategy remains based on the concept of "active defense.'

The report, however, also speculates if "China could be concerned that the US reemphasis on low-yield nuclear weapons in recent years indicates a lower threshold for nuclear use and could want to "de-escalate a nuclear conflict on its own terms by responding symmetrically or proportionately to limited US nuclear em-

The People's Liberation Army's evolving capabilities and concepts continue to strengthen the China's ability to "fight and win wars" against a "strong enemy" (a likely euphemism for the United States), coerce Taiwan and rival claimants in territorial disputes, counter an intervention by a third party in a conflict along the PRC's periphery, and project power globally", the report said.

The report further stated that "China might worry that Washington could conduct a limited nuclear attack on China, while threatening a more massive nuclear attack should Beijing dare to retaliate with nuclear weapons. Given the US nuclear superiority, Chinese leaders might not



be able to respond in kind." That is a huge jump in analysis, particularly when the report, while basing its analysis on current data, laments the unavailability of concrete signals from the Chinese leadership about the real objective behind its strategic nuclear expansion, the report noted.

According to the report said that international analysts believe the Chinese "paramount leader seeks to achieve national unification with Taiwan by 2049" for which "the People's Liberation Army has been building up conventional forces to deter and defeat any conventional US military intervention of Chinese efforts to take over Taiwan".

Beijing claims full sovereignty over Taiwan, a democracy of almost 24 million people located off the southeastern coast of mainland China, despite the fact that the two sides have been governed separately for

more than seven decades.

Fear of catching COVID-19 heightens disgust sensitivity

A new study has suggested that disgust sensitivity can and does change - and, during the COVIDabout getting sick with a coronavirus infection was associated with an increase in disgust sensitivity. The findings of the study were published in the journal 'Personality and Individual Differ-

Ohio State University researchers who had collected disgust sensitivity data for a larger project before the coronavirus outbreak compared those measures to similar data collected during and after pandem-

ic lockdowns.
"What hasn't been tested thoroughly is the extent to which your environment actually shapes your disgust sensitivity. What happens when you're in an envi-



ronment that has a lot of pathogens?" said Shelby Boggs, a doctoral student in psychology at The Ohio State University and the first author of the study. "Disgust sensitivity was higher in studies we ran during the pandemic, but particularly higher for people who felt concerned they would actually contract COVID-19," added Boggs. Boggs conducted the study with senior author

Russell Fazio, professor of psychology at Ohio State, and former postdoctoral researcher Benjamin Ruisch, who is now at Leiden University. Despite disgust sensitivity's origins in dodging disease, research over the years has linked high disgust sensitivity to avoidance of "others' - people of different races, political ideologies or genders, for ex-

Vijay Mallya faces eviction from luxury home in London

The fugitive Kingfisher tycoon Vijay Mallya is facing the prospect of a humiliating eviction from the luxury Central London home UK High Court ruled against him in a dispute with the Swiss bank UBS.

Mallya held a mortgage obtained from UBS on the multi-million-pound property, located along Cornwall Terrace in one of the most sought after areas of the British capital, minutes from Regent's Park and attractions such as Madame Tussaud's wax muse-

It's believed that Mallya has lived in the property along with his son Siddharth and his

95-year-old mother Lalitha. A judge sitting in the chancery division of the High Court on Tuesday refused a request by Mallya's lawyers for a stay on repaying the UBS loan after Mallya had failed to meet a previous repayment deadline in April 2020. UBS however, were unable to evict



the Mallyas due to COVID regulations. Today's ruling paves the way for UBS to re-

ossess the property It's believed that Mallya and his family own numerous other properties in the UK and elsewhere, including a sprawling country home in Hertfordshire, north of London.

Mallya has been living in London since fleeing to the


UK after being accused of a Rs 9,000 crore fraud relating to the collapse of Kingfisher Airlines. He has consistently denied the charges. He was ordered to be extradited by the UK High Court after hearings lasting three years. He remains on bail while the UK government considers what's thought to be an asylum appli-

Study sheds light on benefits of movement for creative thinking



ovement helps us to think creatively. This insight is over 2000 years old - and already known to the philosophers in ancient Greece. However, what is the connection between movement and cognition from a scientific point of view? What happens in the brain when we walk? Are people who rarely move less creative?

"Our research shows that it is not movement per se that helps us to think more flexibly," said neuroscientist Dr Barbara Handel from Julius-Maximilians-Universitat Wurzburg (JMU) in Bavaria, Germany.

She and her doctoral student Supriya Murali conducted experiments that have been described

in detail in a recent publication in the journal 'Psychological Research'. According to Handel, the freedom to make self-determined movements has been responsible for humans to think more flexibly. Accordingly, even small movements while sitting can have the same positive effects on creative thinking. However, the researcher does not derive any concrete movement suggestions from her work: "The important thing is the freedom to move without external constraints." It is important, she said, that movement is not suppressed or forced into regular patterns. "Unfortunately, this happens when people focus for example on a small screen," explained the JMU researcher. The

increased use of mobile phones and similar devices - also in the field of education at the time of the Corona pandemic - could therefore have a negative effect on cognitive processes such as creativity. How do people perceive their environment? What effect do sensory stimuli have in the peripheral nervous system and what in the brain? What influence do body movements have on the perception of sensory input? Researchers like Barbara Handel have been interested in such questions for many reasons.

In the long term, their findings could contribute to a better understanding of diseases that affect body movements as well as cognitive processes.

Common entrance test to be conducted for admissions to central universities amid pandemic

handigarh: Pertaining to the fact that scoring high in board exams may not necessarily translate into knowledge, top universities across the globe prefer to conduct entrance exams as the sole criteria or a mix of entrance and merit for admissions. While it was announced that CLAT will conduct the exam for the academic session 2022 and 2023 in 2022

itself, the Government of India suggested to conduct a common exam for admissions to all the central universities. Being one of the major reforms introduced to the Indian Education system in the recent times, the Central Universities common entrance test (CUCET) is an All-India test for admission various Under-graduate/Integrated, Post-Graduate and research programs in Central/State Universities of India. Having a major change in this academic vear. CUCET has been named the common entrance test for admissions to 41 central universities including JNU DU and BHU The

current situation of the ongoing pandemic has not only created an ambiguous situation for the students but also for the institutions across India. While the families are worried about the spread of infection, students are muddled about the current change in the admission criteria at the

undergraduate level in different universities. The pressure is mounting and with every passing day, the students are getting restless. While the entrance exams ensure a level playing field for the candidates, it also implies an equal opportunity for all, to gauge the capabilities of the individual. Since the current problem is not only faced by the students who are in

anticipation of the exam, but also for the universities across, who are indecisive on the structure of their admission

"Though it is known that CUCET is not an entirely unfamiliar entrance test but the central universities have been conducting it until the last year for admissions. While the major difference would be that the earlier version of CUCET were conducted in the offline mode and now the proposal is to conduct the test as a Computer Based Test (CBT), which, with complete details of the exam is expected to be revealed soon. The possible structure of CLICET would be a computer-

based aptitude test to test the students on Verbal Ability, Logical and Analytical Reasoning, Quantitative Reasoning, and General Awareness. There will be a domain section also that may test the students of the subjective questions. The CUCET entrance test will be

compulsory for the students who seek admission to all the universities." Said Mr Ankit Kapoor, Co-founder & Director, Pratham Test

It is anticipated that the CUCET will be conducted by the National Testing Agency (NTA). Recently, Delhi University has also hinted to conduct the admission process for the Academic year 2022 through CUCET and based on class XII marks, or will conduct their separate exam DUCET.

"The students should neither be sceptical about the paper nor about the process, instead believe that this change of conducting one exam is the change for good and will allow students to experience equal opportunity in the real sense. For this, students need to continuously strive towards honing their skills and understand the importance of aptitude building

The entrance exam like the CUCET will give not only an equal opportunity to all the students but also a chance to the universities to gauge the aptitude level of the students." He added Recently, the Vice Chancellor of Delhi University also informed that the concerned team is working on this new development and when the basic things are done, a committee would be formed which will be in charge of framing a process on the execution, and coordinate with NTA and Education ministry. Experts believe that it's a welcome decision of Delhi University and other universities to change the admission process as entrance exam is always a better medium to assess the
