#### **Gold prices decline** Rs 212; silver down by Rs 480

**NEW DELHI:** Gold prices on Monday declined by Rs 212 to Rs 49,827 per 10 gram in the national capital, in line with selling in the overseas markets. along with a rupee appreciation, according to HDFC Securities. The yellow metal had closed at Rs 50,039 per 10 gram in the previous trade. Silver tumbled by Rs 480 to Rs 63,329 per kg, compared with the previous close of Rs 63,809.

#### SC to hear plea seeking cancellation of Class X, XII offline exams NEW DELHI: The

Supreme Court on Monday agreed to hear a plea seeking cancellation of physical exams for Class X and XII to be conducted by all State Boards, CBSE, ICSE and National Institute of Open Schooling (NIOS). NV Ramana, Justices AS Bopanna and Hima Kohli agreed to list the matter for an early hearing. A lawyer mentioned the petition for urgent listing of the case before the bench stating, "This is regarding class X and XII exams. Physical classes could not be conducted due to pandemic.' "Let the matter go before the bench of Justice AM Khanwilkar," said the CJI

#### Case lodged against SP chief Akhilesh

ETAWAH: A case has been lodged against Samajwadi Party (SP) president Akhilesh Yadav for violation of the model code of conduct at Saifai police station. Returning Officer Shruti Singh on Monday informed that the case has been lodged under The Representation of The People Act and section 188 of the CrPC for disobeying official order by talking to the media within 200 meter periphery of Abhinav School polling station after casting his vote on Sunday. The case was lodged on late Sunday night on the basis of a joint report submitted by SDM Saifai Jyotsana Bandhu and Circle Officer Vijay Singh.

#### Security forces recover IEDs, weapons MALKANGIRI : A joint

team of Special Operating Group (SOG) and District Voluntary Force (DVF) recovered a major Maoist's dump of incriminating articles near the jungle area of Nadmenjeri village under Jantri gram panchavat under Jodambo police limits in the border area of Andhra Pradesh and Odisha in Malkangiri district, informed Nitesh Wadhmani, SP, Malkangiri on Sunday afternoon. Speaking to the a news agency, Malkangiri SP said, "This has led to the recovery and seizure of a large number of arms, Improvised Explosive Devices (IEDs), explosives, Maoist literature and other incriminating articles."

# Fodder Scam: Lalu Yadav sentenced to five years Jail

AGENCY RANCHI, FEBRUARY 21

A CBI court on Monday sentenced former Bihar Chief Minister Lalu Prasad Yadav to five years imprisonment in the fifth fodder scam case and imposed a fine of Rs 60 lakhs on him.

Yadav was declared guilty on February 15. Of the 99 accused in the case, 24 were acquitted, while threeyear jail terms were pronounced for the 46 accused. The fate of the remaining accused will be decided on Monday

Yadav has been found guilty of illegal withdrawals of Rs 139.35 crore from the Doranda treasury by a special CBI court in Jharkhand's Ranchi. The hearing for the pronounce-

ment of quantum of punishment for

Yadav has been scheduled for today. Yadav has been sentenced in four fodder scam cases. This case (RC 47A/97) was the fifth and the biggest in which Rs 139.35 crore was illegally withdrawn.

The Rs 950-crore fodder scam relates to the fraudulent withdrawal of public funds from government treasuries in various districts of undivided



Of the original 170 accused in the matter, 55 have died, seven have become government witnesses, two have accepted the charges against them and six are absconding. The court gave the verdict on February 15 against the remaining 99 accused, including Yadav.

The scam came into light after a

raid conducted by Deputy Commissioner of Chaibasa Amit Khare at the Animal Husbandry Department in January 1996. The CBI was roped in by the Patna High Court in March 1996 after increasing pressure to investigate the case. The CBI registered an FIR in the case at a time when Bi-

har was still undivided. In June 1997, Yadav was named an accused in the case for the first time in the chargesheet filed by the

Following the chargesheet and mounting pressure from the Opposition, Yadav resigned as the Chief Minister after which Rabri Devi succeeded him in July 1997 even while he continued to operate behind the curtains in Bihar.

Due to the bifurcation of Bihar and the formation of Jharkhand, the

case was transferred to the Jharkhand High Court in October 2001. Special CBI court began trial in the fodder scam case in February 2002. Yadav's first conviction came in September 2013 in the Chaibasa treasury case related to fraudulent withdrawal of Rs 37.70 crore.

He was handed over five years in prison leading to his disqualification from the Lok Sabha membership. He was later granted bail by the Supreme

The RJD supremo's trouble renewed again in 2017 when a special CBI court in December 2017 convicted him in the second scam case related to fraudulent withdrawal of Rs 89.27 lakh from Deoghar treasury.

## Lakhimpur Kheri: Families of victims move SC against bail to Ashish

AGENCY NEW DELHI, FEB 21

Family members of the victims of the Lakhimpur Kheri incident have moved Supreme Court challenging Allahabad High Court order, which granted bail to the prime accused in the case, Ashish Mishra, who is the son of Union Minister of State for Home Affairs Ajay Mishra Teni.

The petition was filed through advocate Prashant Bhushan.

In the Special Leave Petition, family members of the deceased have challenged the Allahabad High Court order dated February 10, 2022, wherein Ashish Mishra has granted regular bail.

The petitioner said that the Allahabad HC order is unsustainable in law. They also said that they have approached the Apex Court as the Uttar Pradesh state has failed to prefer any appeal against the impugned order.



## India, France sign roadmap to enhance bilateral exchanges AGENCY PARIS, FEB 21

India and France have inked a roadmap to enhance their bilateral exchanges on the blue economy and forge a common vision of ocean govcooperate on sustainable and resilient

coastal and waterways infrastructure. The agreement was signed during External Affairs Minister S Jaishankar's three-day visit to France which began on Sunday with bilateral talks with his French counterpart Jean-Yves Le Drian.

The roadmap scope will encompass maritime trade, the naval indus-



try, fisheries, marine technology and scientific research, ocean observation, marine biodiversity, marine ecosystem-based management and integrated coastal management, marine eco-tourism, inland waterways

cooperation between competent administrations on civil maritime issues, marine spatial planning as well as international law of the sea and related multilateral negotiations.

"India and France intend to make the blue economy a driver of progress specting the environment and coastal and marine biodiversity. Both countries aim to contribute to scientific knowledge and ocean conservation and ensure that the ocean remains a global common, a space of freedom and trade, based on the rule of law.' the Ministry of External Affairs said

in a statement on Sunday. It said the two countries wish to

contribute to the Sustainable Development Goal of the United Nations Sustainable Development Agenda, which aims to conserve and sustainably use the oceans, seas and marine resources. The two sides called for a sustainable approach to fishing that cent living co would ensure to professionals of the sector, while conserving the resource in the medium and long terms. "India and France nurture a high quality dialogue on maritime security, which enables them to raise strategic issues in the Indo-Pacific. This partnership marks a significant step-forward in India-France cooperation for maritime security, the ministry said.

## **US claims Russia has** ordered final preparations for invasion

KYIV, FEB 21

Russia on Sunday rescinded earlier pledges to pull tens of thousands of its troops back from Ukraine's northern border, a move that US leaders said put Russia another step closer to launching what they said was the planned invasion of Ukraine.

Residents of Ukraine's capital filled a gold-domed cathedral to pray for peace.

Russia's action extends what it said were military exercises, originally set to end Sunday, that brought an estimated 30,000 Russian forces to Belarus, Ukraine's neighbour to the north. They are among at least 150,000 Russian troops now deployed outside Ukraine's borders, along with tanks, warplanes, ar-

tillery and other war materiel. The continued deployment of the Russian forces in Belarus raised concern that they could be used to sweep down on the Ukrainian capital, Kyiv, a city of about 3 million people less than a three-

hour drive away. In Kyiv, life outwardly continued as usual for some on a mild winter Sunday, with brunches and church services.



Joe Biden said late last week was an already decided-upon Russian attack. Katerina Spanchak, who

fled a region of eastern Ukraine when it was taken over by Russian-allied separatists, was among worshippers crowded into the capital's St. Michael's monastery, smoky with the candles burned by the faithful, to pray that Ukraine be spared.

## UP: 27 per cent candidates in phase V have criminal cases 38 per cent out of 61 candidates

AGENCY LUCKNOW, FEB 21

Around 27 per cent of the candidates contesting in the fifth phase of polling in Uttar Pradesh assembly to be held on February 27, have declared criminal cases against them, officials informed on Monday. Around 36 per cent candidates in the fray for the fifth phase are crorepatis, they further said. The Uttar Pradesh Election Watch and Association for Democratic Reforms (ADR) have analysed the selfsworn affidavits of 685 candidates out of 693 in this phase. According to the report released by ADR here on Monday said out of 685 candidates analyzed, 185 or 27 per cent have declared criminal cases against them-



have declared serious criminal cases against themselves. Among the major parties, 42 or 71 per cent out of 59 candidates analysed from SP, 4 or 57 per cent out of 7 candidates analysed from Apna Dal Sone Lal, 25 or 48 per cent out of 52 candidates analysed from BJP, 23 or 38 per cent out of 61 candidates analysed from BSP, 23 or analysed from Congress and 10 or 19 per cent out of 52 candidates analysed from AAP have declared having criminal cases against themselves in their affidavits. Candidates with criminal background from major political parties were 29 or 49 per cent out of 59 candidates analysed from SP, 2 or 29 per cent out of 7 candidates analysed from Apna Dal Soneylal, 22 or 42 per cent out of 52 candidates analysed from BJP, 17 or 28 per cent out of 61 candidates analysed from BSP, 17 or 28 per cent out of 61 candidates analysed from Congress and 7 or 14 per cent out of 52 candidates analysed from AAP have declared having serious criminal cases against themselves in their affidavits. Out of the 685 can-

didates, 246 or 36 per cent are crorepatis. Among the major parties 47 or 90 per cent out of 52 candidates analysed from BJP, 6 or 86 per cent out of 7 candidates analysed from Apna Dal Soneylal, 49 or 83 per cent out of 59 candidates analysed from SP, 44 or 72 per cent out of 61 candidates analysed from BSP, 30 or 49 per cent out of 61 candidates analysed from Congress and 11 or 21 per cent out of 52 candidates analysed from AAP have declared assets valued at more than Rs 1 crore. The average of assets per candidate contesting in the Uttar Pradesh Assembly Elections 2022 Phase V is Rs 2.48 Crores. Among major parties, the average assets per candidate for 52 BJP candidates analysed is Rs. 9.95 Crores.



## CM is a far-sighted HSNCB prepares roadmap for person: Kashyap drug prevention in State

CHANDIGARH, FEB 21

Haryana State Narcotics Control Bureau (HSNCB) has prepared a roadmap from village, ward-level to state level to eradicate drugs. Presiding over the State Apex Committee meeting held on Monday in this regard, Chief Secretary Sanjeev Kaushal said HSNCB would coordinate with various departments for the prevention of drug abuse as per the aim of the state government and spread information in this regard by holding awareness campaigns. He said the objective of the government is to prevent and control drug smuggling and to rehabilitate drug addicts. For this, the HSNCB should prepare an institutional structure, in which the senior officers of all the concerned departments should also be involved, so that the schemes can be implemented in this direction with uniformity. He directed the officers that the Administrative Secretaries of the departments should send their suggestions to the Haryana State Drug Control Bureau within the next seven days so that the State Action Plan can be finalised at the earliest. Kaushal said the Bureau should conduct scientific, social and psychological studies in collaboration with various universities of the state to prepare a policy and effective strategy for rehabilitation.

For this, soon the draft of terms and conditions should be prepared and finalised. Besides this, periodic evaluation reports of the work being done by the Bureau should also be prepared. He said youth clubs set up by the Sports and Youth Affairs Department should also be included in the awareness campaign. HSNCB Additional Director General of Police Shrikant Jadhav informed that

#### Collusion alleged behind firing of 11 **Aadhaar operators in Yamunanagar**

YAMUNANAGAR: The 13 Aadhaar operators working in the district information technology system have urged the district administration and the government to continue their services. The same district has also been accused of harassing 13 operators working in the information technology system and not paying salary under minimum wages. It may be mentioned that the work of Aadhaar project by district information technology system has been going on since the year 2015 as per the order of Haryana government, for the implementation of which 13 Aadhaar operators certified by UIDI were appointed in different places in the district from 12 June 2018.

But after the term of two of these Aadhaar operators Shiv Kumar and Sukhwinder Kaur ended on July 15, 2018, only 11 Aadhaar operators were working in the district. Aadhaar operators were appointed under the district information technology system for updating, renewing, and any kind of change to these operators who were also being paid salary under minimum wages.

Babita, one of the 11 operators fired from the Aadhaar card operator job, sought an answer under RTI in which all the Aadhaar operators should have got the benefit of ESI from the administration but their number was not enough for PF account. In the same RTI, it was also revealed that out of the 13 names for Aadhaar operator work, only 11 names have been shown while the names of 13 Aadhaar operators were attached with the report on 31st December 2021

The same Aadhaar card operator was also accused of deducting fees of Rs 100 which was not found to be true in the investigation. Petitioner Babita has also accused the DI of the department and another person of colluding and removing 11 operators from the job and putting them under the contractor. The petitioner informed that all the Aadhaar operators have been made subject to CSC by the department in which their salary has also been halved which is not fair. She appealed to the government and administration to continue the service of Aadhaar operator She said that she was supporting his family with the work of Aadhaar operator but when the government halves his salary and transfers him to CSC, she finds it difficult to manage house expenses.



## Electric vehicles hub to be Tourism industry ended due to dual made by 2025: Thakur

transport and government institutions and also at institutional level. He said that aim of Government is to attract investment for manufacturing of Electric Vehicles and R&D ecosystem. Sate will create a separate secretariat to ensure effective implementation of new electric vehicle policy.

# Lakhimpur Kheri in eye of storm over farmers' deaths goes to poll on Feb-23

LAKHIMPUR KHERI, FEB 21

Lakhimpur Kheri, which caught national attention in October last year for the alleged killing of the farmers, will go to the polls on February 23 in the ongoing Assembly elections in Uttar Pradesh.

Bharatiya Janata Party's Yogesh Verma had won the Lakhimpur seat in the 2017 Assembly polls by defeating Samajwadi Party's Utkarsh Verma Madhur with a formidable margin of more than 37,000 votes. The prestige of the Union Minister of State for the Home Affairs Ajay Mishra Teni will also be at stake in the Lakhimpur Kheri constituency. He's a local MP, besides having been at the centre of controversy after his son was named in the FIR in the incident leading to the deaths of the farmers.

Interestingly, both the BJP and the SP have repeated their candidates. The constituency caught the eyeballs in the



ongoing polls because of the political heat generated by the Lakhimpur Kheri violence in the Parliament and also outside.

In 2012, Utkarsh Verma

Madhur from the SP had won the seat defeating the Bahujan Samajwadi Party's Gyan Prakash Bajpai. Congress has fielded Ravi Shankar Trivedi whereas the BSP has fielded Mohan Bajpai from the seat. Khushi Kinnar from the Aam Aadmi Party (AAP) is also in the fray along with AIMIM's Mohammad Usman Siddiqui. Eight Assembly constituencies in the Kheri Lok Sabha seat are Mohammadi, Gola Gokarannath, Kasta, Lakhimpur, Srinagar, Nighasan,

Dhaurahara, and Palia Kalan. A total of 28,02,835 will cast their vote out of which there are 1495069 male voters and 1307623 female voters. As many as 42,911 first-time voters have been added to the list of voters in the constituency. The BJP had swept all the seats in the district in 2017.

On October 3, eight people, including four protesting farmers, died after allegedly being mowed down by an SUV belonging to Union Minister Ajay Mishra Teni's son Ashish Mishra. A local journalist was also killed in the violence.

The incident hit national and international dailies. Ashish Mishra was arrested and was in jail. Allahabad High Court recently granted bail to Ashish Mishra in Lakhimpur Kheri violence. Since the 1977 election, the SP has won the polls here four times whereas the BJP has won thrice. The counting of votes of the seven-phased UP Assembly polls will take place on March 10.


## GM reviews performance of Northern Railway

### **New lesson**

The news that more children are going to school is most welcome in any Indian state. The govemment s role in bringing children from underprivileged households into school and keeping them there is of overwhelming importance. But this requires money. Improving the school system in terms of size, infrastructure, access, quality and affordability for all calls for funds not always available in a state s coffers. The West Bengal government s proposal for a public-private partnership model in the sphere of school education can be placed in the combined context of strained purse-strings and an aspirational population. Unused government land and buildings would be given to private investors, while the latter would upgrade infrastructure, provide recurring and non-recurring expenses, fix fees, hire teachers, and decide on the medium of instruction and affiliating board. Predictably, this is being seen by the Opposition as the first step towards privatization, which brings with it apprehensions of education being snatched away from children coming from socially and economically weaker backgrounds. Overturning the goal of expanding the educational base, that is. That the government would ensure the admission of 30 per cent of students through its own channels to address this possibility is not being considered adequate, apart from worries about political bias.

While the fears may not be baseless, the issue could be considered dispassionately too. Reports suggest that the state government is thinking of the PPP model for the buildings and premises of 79 schools lying unused, since these closed because of a lack of students. That by itself is not a bad idea. West Bengal may be on the verge of a bold step. But to make the move truly beneficial, each aspect has to be closely thought through. Medium of instruction and affiliation, for example, are sensitive matters; is it enough to leave them entirely to private players? As it is, children from marginalized groups have problems following the standard language of the state in class, let alone the English medium. And how is the government going to ensure that PPP schools do not focus on urban areas? The state should set its terms clearly, for it is the government s goals that must be fulfilled. There is no dearth of private schools. The PPP model should be distinct with the benefits, both tangible and intangible, balanced for all stakeholders.

sive, dynamic and evolving so as to meet the ever-increasing needs and aspirations of a diverse group of learners. It should be able to embrace advancementsin the field to remain current and relevant. ICT is a great enabler as well as a great disabler in this context; if we catch up with ICT, it becomes an enabler and if we lag-behind, it becomes a disabler.

Digital or virtual education is emerging as a most-potent mode of the teaching-learning world over, especially after the corona pandemic. Learning loss owing to the closure of educational institutions was mitigated to a considerable extent due to online learning. In spite of limitations of high bandwidth internet connectivity and electronic gadgets, online learning helped avoid academic sessions becoming zero, and precious years of students were saved. The corona pandemic prompted UGC to increase percentage of online teaching components from 20 to 40. Several universities resorted to LMS customised by the INFLIBNET.

In the process, teachers and students developed skills in online teaching-learning to a large extent. UGC uploaded a draft regulation on blended learning for suggestions fromacademia and permitted universities to offer online programmes. The Ministry of Education launched several ICT initiatives for improving equity, access, quality and GER. These include, SWAYAM, ARPIT, SWAYAMPRABHA, NPTEL, NDL, e-PG Pathshala, Shodhganga, e-Shodhsindhu, e-Yatra, ShodhShuddhi, Spoken Tutorials, Virtual Labs, VID-WAN etc. There is a need felt now to accelerate and scaleup the above-mentioned and new efforts for leveraging the benefits of virtual learning. Anticipating the future growth trajectory of the learning system, the central government announced several initiatives on 17th May, 2020 itself. These included the launch of PM e-Vidya pro-



gramme for multimode access to digital education encompassing Diksha (one nation-one digital platform), one class-one channel (upto class-XII), special e-Contents for the differently-abled student community and use of radio, community radio and podcastand e-Tutoring for higher edu-

All this amply demonstrates that the governmenthas been preparing for a big push with respect to digital learning, which eventually happened on 1st February, 2022 with the announcement made by Ms. NirmalaSitharaman for establishing a digital university. She informed that this university is intended to provide access to worldclass quality universal education with personalised learning experiences to students across the country at their "hands"

It will be set-up on a networked hub and spoke model. In this model, the knowledge will originate from a centralised hub and will digitally travel to spokes (smaller locations) for use. Here, the hub refers to the best public universities and institutions in India and the spokes refer to individual learners who will be beneficiaries of the digital mode of delivery of knowledge.This digital university will comply with ISTE standards for the use of technology in teaching-learning. The catch

cutting-edge ICT system. The beautyofplan is that the knowledge originating at the hubs will be in different Indian lan-

Modes of instruction in a digital or virtual university range from distance learning to live, interactive classes where students communicate with a teacher. In an asynchronous learning environment, the students are given the assignments from the self-paced courses to be completed within a timeframe. Students complete the assignments at their own pace and the interactions are limited to discussion boards, blogs, wikis etc. Oppositely, synchronous online study happens in real-time, whereby teachers and students all interact online simultaneously. This happens either through text, video, audio or in all modes. In addition to the scheduled class time, there are usually additional assignments to be completed. Therefore these lessons are socially constructed. In my view, the proposed digital university should embrace all three models of online learning to meet the needs of diverse sections of the student community dwelling in a wide-range of socio-economic contexts. An added advantage is that students can graduate from their homes without ever dislocating themselves. Moreover, online resources function as a library, and with the facility for creating online study materials, the re-

quirement of textbooks is also met with. However, the caution is that it becomes extremely difficult to keep the learners'attention at the optimum level in the online learning ecosystem', making synchronous learning extremely difficult. Teachers have to find technology-enabled creative ways to keep students' attention focussed on the screen as they are in the comfort zone of their home environment. Individualising lessons and short breaks can help students to stay engaged. Moreover, in a synchronous learning environment, teachers and

students have to be extremely disciplined and focused in order to avoid learning loss and make it as interactive as offline learning. Digital learners can be effectively engaged through gamification that provides learning material as games to bring clarity and enjoyment to students learning experience. Gamification can also assist students to increase their intrinsic motivation for accomplishing desired learning goals.

Thus, a digital university is a huge opportunity for the nation to integrate learning, actualise digital inclusion, and build the future of rich and poor alike. However, the mandate of the digital university should not be restricted to converting traditional course materials into digital forms and their delivery in online mode. Delivery of contents amounts only to having a set of data or information without knowing what to do with it. Analysis, synthesis, inference drawing, firming-up conclusions, application potential and validation of the knowledge created, and mid-course correction complete the learning cycle. How to ensure this, is the biggest challenge in online learning. Creative use of hybrid learning models may help overcome this deficiency. Hybrid learning, as understood, is not merely a mode of delivery of knowledge in a mix of online and offline learning environments. It is actually an appropriate blending of pedagogies for capacity building of learners like lecturing, tutorial, group discussion, debate, students' seminar, home assignment, dissertation, internship, case study, policy formulation, project evaluation, field study, survey, excursion, use of virtual labs etc. Digital University, if conceptualised and nurtured carefully, has the potential to transform current learning system as envisaged in

## **Smartphone app use may** reveal your identity: Study

ccording to researchers, Athe time a person spends on different smartphone apps is enough to identify them from a larger

The findings of the study were published in the journal 'Psychological Science'

Psychologists Dr Heather Shaw, Professor Paul Taylor and Professor Stacey Conchie from Lancaster University, and Dr David Ellis from the University of Bath analysed smartphone data from 780 people. They fed 4,680 days of app usage data into statistical models. Each of these days was paired with one of the 780 users, such that the models learnt people's daily app use patterns.

The researchers then tested whether models could identify an individual when provided with only a single day of smartphone activity that was anonymous and not yet paired with a user. Dr Ellis from the University of Bath said, "Our models, which were trained on only six



days of app usage data per person, could identify the correct person from a day of anonymous data one-third of the

That might not sound like much, but when the models made a prediction regarding who data belonged to, it could also provide a list of the most to the least likely candidates. It was possible to view the top 10 most likely individuals that a specific day of data belonged to. Around 75 per cent of the time, the correct user would be among the top 10 most likely candidates. Professor Taylor from Lancaster University added, "In practical terms, a law enforcement investigation

seeking to identify a criminal's new phone from knowledge of their historic phone use could reduce a candidate pool of approximately 1,000 phones to risk of missing them." Consequently, the researchers warn that software granted access to a smartphone's standard activity logging could render a reasonable prediction about a user's identity even when they were logged out of their account. Identification is possible with no monitoring of conversations or behaviours within apps themselves.

Dr Shaw from Lancaster University said, "We found that people exhibited consistent patterns in their application usage behaviours on a day-to-day basis, such as using Facebook the most and the calculator app the least. In support of this, we also showed that two days of smartphone data from the same person exhibited greater similarity in-app usage patterns than two days of data from different people.

## 50 years after Nixon visit, US-China ties as fraught as ever

t the height of the Cold War, U.S. President Richard Nixon AU.S. President Richard ...

flew into communist China's center of power for a visit that, over time, would transform U.S.-China relations and China's position in the world in ways that were unimaginable at the time.

The relationship between China and the United States was always going to be a challenge, and after half a century of ups and downs, is more

fraught than ever. The Cold War is long over, but on both sides there are fears a new one could be beginning. Despite repeated Chinese disavowals, America worries that the democratic-led world that triumphed over the Soviet Union could



be challenged by the authoritarian model of a powerful and still-rising China. The U.S.-China relationship has always been contentious but one of necessity, said Oriana Skylar Mastro, a China expert at Stanford University.

Perhaps 50 years ago the reasons were mainly economic. Now they are mainly in the security realm. But the relationship has never and will never be easy." Nixon landed in Beijing on a gray winter morning 50 years ago on Monday. Billboards carried slogans such as Down with American Imperialism, part of the upheaval under the Cultural Revolution that banished intellectuals and others to the countryside and subjected many to public humiliation and brutal and even deadly attacks in the name of class struggle. Nixon's 1972 trip, which included meetings with Chairman Mao Zedong and a visit to the Great Wall, led to the establishment of diplomatic relations in 1979 and the parallel severing of

formal ties with Taiwan, which the U.S. had recognized as the government of China after the communists took power in Beijing in 1949.

Premier Zhou Enlai's translator wrote in a memoir that, to the best of his recollection, Nixon said, This hand stretches out across the Pacific Ocean in friendship as he shook hands with Zhou at the airport. For both sides, it was a friendship born of circumstances, rather than natural allegiances. China and the Soviet Union, formerly communist allies, had split and even clashed along their border in 1969, and Mao saw the United States as a potential counterbalance to any threat of a Soviet invasion. Nixon, embroiled in the Watergate scandal at home and a war in Vietnam, was seeking to isolate the Soviet Union and exit the prolonged and bloody war that had divided American society. He hoped that China, an ally of communist North Vietnam in its battle with the U.S.backed South, could play a role in re-

solving the conflict. The U.S. president put himself in the position of supplicant to Beijing, said June Teufel Dreyer, a Chinese politics specialist at the University of Miami. Chinese state media promoted the idea that a prosperous China would be a peaceful China and that the country was a huge market for American exports, she said. It would be decades before that happened. First, the U.S. became a huge market for China, propelling the latter's meteoric rise from an impoverished nation to the world's second largest economy.

Nixon's visit was a pivotal event that ushered in China's turn outward and subsequent rise globally, said the University of Chicago's Dali Yang, the author of numerous books on Chinese politics and economics. Two years after Mao's death in 1976, new leader Deng Xiaoping ushered in an era of partial economic liberalization, creating a mix of state-led capitalism and single-party rule that has endured to this day. China's wealth has enabled a major expansion of its military, which the U.S. and its allies see as a threat. The Communist Party says it seeks only to defend its territory.

## New study finds better treatment for Parkinson's disease

arkinson's disease is a neurodegenerative disease wherein dopaminergic neurons progressively die in the brainstem. Tremor and difficulties in walking are the most commonly recognizable symptoms for people suffering from Parkinson. Although there is no permanent cure for it, a study from the University of Copenhagen has shown a ray of hope for the treatment of Parkinson's.

The study was published in 'Nature Communications'.

People are primarily treated with medicine, but in some cases, doctors use Deep Brain Stimulation (DBS). In DBS, the surgeon places a thin metal wire in the brain, which can be used to send electrical pulses. DBS is effective in treating tremors, but alleviating difficulties in walking and freezing remain a challenge.

The study, conducted in mice, demonstrate that DBS treatment of walking problems in Parkinson could be optimized by targeting specific neurons in the brainstem - possibly benefiting some of the more than 7 to 10 million people suffering from the disease worldwide.

Based on previous animal studies of motor circuits, which are responsible for the planning, control, and execution of voluntary movements, scientists have hypothesized that freezing of walking in Parkinson could be alleviated. That would require DBS to stimulate neurons in the pedunculopontine nucleus (PPN), which is located in the brainstem. The PPN was thought

to send signals from the brain to the spinal cord leading to body movements.

Over time, nearly a quarter of the patients have so much trouble walking that they often end up freezing on the spot and falling, and many become housebound.

Previous results from the group showed
that stimulation of so-called excitatory neurons

in the PPN could initiate locomotion in normal mice. It raised the possibility that these nerve cells could indeed be used to treat movement symptoms in mice with features of Parkinson's disease.

"We use a technology to target specific group of cells in the PPN in order to close in on what areas are the best to stimulate if we want to alleviate these particular symptoms. The result shows that the motor improvement is optimal if we stimulate what we call excitatory neurons in the caudal area of the PPN," explained Ole Kiehn.

"We believe that clinical trials with brainstem DBS are the right strategy to facilitate patients to walk properly again. But the variable clinical results occur because DBS would require higher precision to target the particular group of neurons in the caudal PPN. It is a very delicate area because if we were to stimulate excitatory neurons in other areas than the caudal PPN, it would cause complete immobilization instead."

In Parkinson's disease, nerve cells that produce dopamine progressively die. Since the 1960s, doctors have relied on medication to replace the missing dopamine, but it is notoriously difficult to fully control symptoms as the disease progresses.

"In many people, the movement symptoms do not respond well to medical treatment in the later stages of this disease, so there has been done a lot of research into alternative treatments, including a search for optimal targets for deep brain stimulation," explained Postdoc Debora Masini, first author of the new study, which included several different strategies to substantiate their findings.

"When we stimulated these specific neurons in the caudal area of the PPN, the animals were able to walk normally, across longer distances and with normal walking speed, as opposed to before the stimulation, where they would display symptoms of Parkinson's Disease," said Debora Masini.

"We systematically compared stimulation of different locations and cell types in a series of complementary experiments. And they all pointed towards the same conclusion. It strongly indicates these excitatory neurons in the caudal PPN are an ideal target for recovery of movement loss," she said.

The researchers hoped that the new study could aid clinicians when they pick the exact location for DBS in the brainstem.

"The mice in our study only partially represent the complexity of this disease, but the results have been very telling. Nearly everything we have learned in the beginning on how to treat Parkinson's Disease comes from animal models, including the medication we use nowadays for patients. In this sense, it is a valid approach, and we hope our study can help provide better treatment for human patients," said Debora Masini.

## FM asks banks to be more

customer-friendly

AGENCY **MUMBAI, FEB 21** 

Union Finance Minister Nirmala Sitharaman on Monday said banks need to focus more on being customer-friendly so that the process of availing credit becomes more hassle-free for borrowers. However, the minister made it clear that banks do not have to be lenient on credit underwriting standards by taking any adverse risks on a proposal. At a meeting between industry representatives and the finance minister, a startup founder in the baking business suggested for credit to be available hassle-free, to which largest lender SBI's Chairman Dinesh Kumar Khara said a startup's worries are more on the equity side and assured full support in lending if sufficient equity is on the table.

Later, he also made a mention of the government's Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE).

Stressing that the person asking the question is a woman operating an innovative enterprise, Sitharaman had a few suggestions for the banking community and also spoke out against their attitude.

"Initially, Mr Khara gave a very bland answer. And then

after being prompted somewhat, he went into talking about a scheme which has a lot of government support, CGTMSE," she said.

"Banks will have to be a lot more customer friendly. Not to the extent of taking adverse risks which you don't need to take, but you need to be a lot more friendly to customers," the minister said. Khara said the

reliance on end-to-end digitalisation of the process, which will ensure a hassle-free experience. He said in the next two months, the bank will go fully digital for lending. Also, provided there is credible cashflow visibility available to a bank, the credit growth to small businesses can touch that of personal loans over time. Tarun Bajaj, the revenue secretary who has worked in the Department of Financial Services as well, said banks need to be cognisant of the needs to lend more and support the economic growth. He added that the balance sheet of corporates is in better shape now.

Khara said it is a normal perception that banks do not sanction loans, but pointed to high levels underutilisation of sanctioned working capital limits, which generally point to slowing demand in an economy.

## SC seeks Centre's response on PIL seeking enforcement of fundamental duties of citizens India decline to 2,02,131

**NEW DELHI, FEB 21** 

The Supreme Court on Friday sought Centre and others response on a petition seeking to enforcement of fundamental duties as enshrined in the Constitution and to frame guidelines for taking appropriate adequate steps to sensitize the people and spread general awareness among the citizens in relation to the performance of fundamental duties under the Constitution of India.

The petition has sought direction to the Respondents Union of India and State Governments to the effect of ensuring performance/discharge of the Fundamental Duties by all who are entitled to enjoy the fundamental rights under Part III of the Constitution of India.

A Bench of Justices Sanjay Kishan Kaul and MM Sundresh was hearing the petition filed by Durga Dutt through advocate on record Karunakar Mahalik.

The petitioner has sought direction from the Respondents to carry out the enactment of legislation



effectuation and implementation of Fundamental Duties where required.

The petitioner Dutt, who is an Advocate-On-Record of top Court said that he has filed the petition in the public interest, "for issuance of directives ensuring adherence to the mandates as postulated under Part IV-A of Constitution of India because non-adherence to the same has a direct bearing upon the exercise and enjoyment of the Fundamental Rights guaranteed under Articles 14, 19 & 21 of the Constitution of India for formulation and operationalization of appropriate scheme providing incentives to the citizenry for their

The petitioner submitted that the Fundamental Duties are intended to serve as a constant reminder to every citizen that while the Constitution conferred on them certain Fundamental Rights specifically, it also requires citizens to observe certain basic norms of democratic conduct and democratic behavior because rights and duties are correlative.

'The Fundamental Duties are an important tool to protect the unity and integrity of several institutions including the judiciary. It is submitted that every citizen must learn how to respect the institutions of this Country. There have been cases where Fundamental Duties have been brazenly flouted by the people including the officers of the law and which in turn resulted in the violation of Fundamental rights of other citizens," the petitioner said.

The present Petition, inter alia, aims to address a very important issue of national importance and to promote commitment amongst every citizen, the petitioner said.

India logged 16,051 new coronavirus infections, taking the virus tally to 4,28,38,524, while the active cases dipped to 2,02,131, according to the Union Health Ministry data updated on Monday. The death toll climbed to 5,12,109 with 206 fresh fatalities, the data updated at 8 am stated.

The daily COVID-19 cases have remained below one lakh for 15 consecutive

The active cases comprise 0.47 per cent of the total infections, while the national COVID-19 recovery rate has further improved to 98.33 per cent, the ministry said.

A reduction of 22,056 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

The daily positivity rate was recorded at 1.93 per cent



while the weekly positivity rate was recorded as 2.12 per cent, according to the ministry. The number of people who have recuperated from the disease surged to 4,21,24,284, while the case fatality rate was recorded as 1.20 per cent. The cumulative doses administered in the country so far under the nationwide COVID-19 vaccination drive has exceeded 175.46 crore.

India's COVID-19 tally

## SIT to probe student leader **Anish Khan's death: Mamata**

KOLKATA, FEB 21

West Bengal Chief Minister Mamata Banerjee on Monday said that a special investigation team (SIT) will be formed to probe student leader Anish Khan's "mysterious" death that has sparked widespread protests by opposition

Banerjee, who also holds the Home (Police) portfolio, said that the SIT will submit its report to her within 15 days.

She also claimed that the former Left leader, who later joined the Indian Secular Front, used to keep in touch with her party, the Trinamool Congress. 'We are forming an SIT which will be set up by the chief secretary under



the DGP and it will also comprise the CID," she told a press conference at state secretariat Nabanna.

Asserting that the investigation will be impartial, she said that action will be taken against anyone found to be involved in the death of Khan.

Alleging that four people had come to their house on the night of February 18 donning police and civic volunteer uniform and pushed his son off the third floor of their house at Amta in Howrah district leading to his death, the father of the deceased has demanded a CBI investigation into the matter.

The police, however, said no law enforcer had gone to his house at that

Holding that the death of the student leader was unfortunate, the chief minister said, "We had good relations with Anish.'

"Those who are going (to Khan's house) to show their faces on television do not know that Anish used to keep in touch with us and also helped me in the election," Banerjee said.

## 2,250 square km of forest land degraded in J-K: Govt

JAMMU, FEB 21

and Kashmir government on Monday said that 2,250 square kilometres of forest area has been degraded in the Union Territory till date. However, the forest department on an average restores 100-200 square kilometres of the degraded forest area in an year, Principal Chief Conservator of Forests (PCCF), Mohit Gera said here. "Out of total of 20,194 square kilometres of the forest area in J&K, around 2,250 square kilometres forest area has degraded," Gera said. He informed that the forest department has set a target of planting 1.3 crore plants this



year and it is on course to meeting the target. Gera said that out of 3,700 traditional village ponds requiring repair and reconstruction, 57 ponds have been taken up under UT capex for repair during this financial year and so far 37 ponds have been reconstructed. The Chief ponds Secretary Dr Arun Kumar Mehta, who chaired a meeting to review the working of

forest department, directed the department to restore 1000 square kilometres forest area during the next year in convergence with the funds available under labour component. Gera informed that the campaign-'Har Gaon Hariyali' has been well received by the people at large and the panchayats in the UT are locked in a healthy competition of outdoing one

The Chief directed the Secretary department to repair all 3,700 ponds within next six months He said repair and rejuvenation of these ponds will recharge the ground water and improve the whole ecosystem of lives and livelihood in the villages. Playing his only second senior international tournament, the reigning national champion Sumit produced a flawless show to register a dominating 5-0 victory against his Russian opponent in the 75kg opening round match. The Indian will now face Ukraine's Oleksandr Khyzhniak in the second round.

Meanwhile, Narender Berwal (+92kg), Varinder Singh (60kg) and Lakshya Chahar (86kg) made exits with defeats in their respective opening round matches. Narender went down fighting 2-3 against the Spanish boxer Ayoub Ghadfa Drissi while Varinder and Chahar lost to their Russian opponents Artur Subkhankulov and Sharabutdin Ataev by 0-5 and 1-4 margin respectively.
The second day of Europe's

oldest international boxing tournament will see four Indian boxers starting their campaigns.

Shiksha will face a tough challenge against the reigning Asian champion Dina Zholaman from Kazakhstan in the 54kg opening round match. Nitu (48kg) and Anamika (50kg) are the other two Indian women to play their matches on Day 2.

Among men, Akash Sangwan, who received bye in the opening round, will play against the German pugilist Deniel Krotter in the 67kg second round match late on Monday

The prestigious tournament, which will be played till February 27, has been witnessing the participation of over 450 boxers from 36 countries around the world, including strong boxing nations such as Kazakhstan, Italy, Russia and France.

A 17-member Indian contingent, including seven men and 10 women, is participating in the tournament which is the first from the Golden Belt Series and also a testing event for International Boxing Association's World Boxing Tour format. It is also the first exposure trip for Indian boxers this year.

Want to play characters that stand out and are impactful, says Bobby Deol

ollywood actor Bobby Deol, who will be seen in a villainous role in his upcoming film Love Hostel, said he is scouting to play characters that are unusual and impactful. Written and directed by Shanker Raman, who helmed the acclaimed Pankaj Tripathi-starrer Gurgaon, the crime-thriller is set against the backdrop of rustic North India and traces the volatile journey of a young couple (Vikrant Massey and Sanya Malhotra) being hunted by a ruthless mercenary (Deol).

Citing the example of his recent outings like Class of 83 and his upcoming Love Hostel , Deol said the attempt is to break his onscreen image and look for varied roles. He also said he is not restricting himself to playing the main lead.

When I did Class of 83' I was not the main lead, I was one of the characters which is important to the story. Ditto with Love Hostel', I am playing a character in it, I am not the main lead. I enjoy doing these characters because they are very impactful, Deol, known for films such as Gupt , Soldier , Ajnabee , Humraaz , told news agency in an interview. I am trying to break my image and try to do different roles. The audience has changed so much they are ready to accept an actor with different avatars, characters. I am glad I got the opportunity to play this role, he said. The 53-year-old actor said he is looking to play strong and challenging characters, that people would not envision him, like the web-series Aashram , in which he was seen as a self-styled godman.

In commercial films, there are characters that stand out too, besides the stars, the actor observed, adding, It (cinema) is not just about heroism. The stars will be there and if you are part of a project where they are there and you have a great character to play, you also get noticed.

In Shah Rukh Khan-backed, Love Hostel, Deol will be seen as Dagar, who he says is a ruthless man. Dagar's character is someone who has been through so much in his life and what he is because of what happened and that is why he is so cold and ruthless, he said. It is difficult to play such characters, Deol said, recalling how he would feel uneasy after essaying the role of Baba Nirala in Aashram but has learnt the art to switch on and off between his roles. I have never done a negative role to that depth (referring to Love Hostel'). When I was doing Aashram' I used to feel a little uneasy, why do I have to express these emotions. I would come back to the hotel to the same actors, with whom I was being mean and rude in the scenes.

"Eventually, I learnt how to switch on and off.

There are some people who can't handle it. I have a beautiful family, have strong upbringing. When I come home, I talk to my family and feel relaxed, nothing drives me nuts. He said it is always challenging to play roles that are negative or have shades of grey as they are completely different from their real-life personality. It is always challenging to see how best I can make this character unique, Deol added.

Besides Love Hostel , the actor will be seen in season three of filmmaker Prakash Jha's Aashram and two films titled Animal , co-starring Anil Kapoor, Ranbir Kapoor and Parineeti Chopra and Apne 2 with his father Dharmendra and brother Sunny Deol. Speaking of Apne 2 , the actor said, it is always his dream to do as much work as possible with his family. To be in a frame together with them is something that I cherish and even our fans cherish that. I am looking forward to Apne 2' and I am waiting for the script to get ready. The producers will announce it, he said,

adding he will begin the shoot of Animal later this year. Love Hostel will make its debut on streaming service ZEE5 on February 25.



I'm the happiest when I make rom-coms: Gina Rodriguez

ollywood star Gina Rodriguez believes an artiste should create an art that makes them happy, and in her case it is the romantic comedies that bring absolute joy to her. Never feared losing fame in my career: Madhuri Dixit

ollywood star Madhuri Dixit Nene says she has always viewed fame with indifference and that is why there was never a fear of losing it. Dixit Nene first shot to fame with her 1988 action romance "Tezaab", four years after her debut with "Abodh", and became one of the top female stars of the '90s, featuring in blockbusters like "Dil", "Saajan", "Hum Aapke Hain Koun..!" and "Dil To Pagal Hai".

Even in the early 2000s, the actor continued to headline both critically acclaimed films and box office wonders like "Pukar", "Lajja" and Sanjay Leela Bhansali's magnum opus "Devdas", before she moved to the US with her husband Shriram Madhav Nene. "But I never feared losing fame. Fame is a different part of my life. How I live my life is more important than anything else," Dixit Nene told news agency in an interview.

The 54-year-old actor said she is more concerned about staying truthful to her craft rather than worrying about stardom. "Whether I respect everyone, work with good ethics, keep my values in life, whether I am true to my art -- these things are more important to me than, 'Oh has someone recognised me?' Or someone didn't ask me for an autograph or get into this (loop of), 'Am I losing fame?' Am I getting fame?' That is not me," she added.

When Dixit Nene broke her sabbatical and returned to India, the actor also came back to the screen with films like the 2007 musical "Aaja Nachle", "Dedh Ishqiya", "Gulaab Gang" and her last big screen release "Kalank" in 2019.

Apart from films, the actor also continued to be in the

public discourse courtesy her shift to TV as she went on to judge a series of dance reality shows throughout the last decade. In short, the actor never went out of sight.

Dixit Nene, who has been habitual to being under the spotlight, believes that fame can become an addiction for some stars but that is not the case with her. "Fame can be addictive, but it depends on the person. Some people might be addicted to fame, they can't live without it or they think they are big stars, so wherever they go people have to cheer. But for me, fame is more like a byproduct of what I do.
