SC rejects plea seeking cancellation of Class 10, 12 offline exams

AGENCY NEW DELHI, FEB 23

The Supreme Court on Wednesday dismissed a plea seeking cancellation of physical exams for Class X and XII to be conducted by all State Boards, CBSE, ICSE and National Institute of Open Schooling (NIOS), saying such petitions give false hope to students and only create more confusion.

A bench headed by Justice AM Khanwilkar slammed the petitioner's counsel for filing such a plea saying authorities are more aware of the ground realities and are capable of taking a decision with which the court should not interfere. "Such petitions give false hopes to students. Entertaining such petitions is only increasing confusion in the system. What kind of petitions are being filed?" asked the apex court. The bench said its last year's order on postponing of examination cannot become a norm to pass the same order for this academic year also. "This petition is ill-advised and premature. Authorities are yet to take a decision for exam rules and dates in respective boards. If decisions are not in accordance with rules and Act it will



The Indian activities at the UN Security Council are fully reflecting the merit of our special and privileged strategic partnership," he added

Amid escalating tension between Moscow and the West after Russian President Vladimir Putin recognised two breakaway Ukrainian regions as independent states, India at an emergency meet-



ing of the UN Security Council on Monday night called for "restraint on all sides". It stressed that the imme-

diate priority is "de-escala-tion of tensions" taking into account the legitimate security interests of all countries and aimed towards securing long term peace and stability in the region and beyond.

"Russian India partner-

ship is based on a strong and solid foundation. It is based on mutual trust," Babushkin said. "Our cooperation does not represent any threat to anyone and at the same time we keep moving shoulder-toshoulder to establish a just and equal multipolar world," he added, hoping that the intensity of India-Russia ties will continue at the same



"PM Awas Yojana, Rural Road Scheme, Water Life Mission, Connectivity of the North East, Broadband connectivity of villages... necessary provisions have been made for every such scheme in the Budget," he said. Hamirpur on verge of becoming fruit bowl of state

Orchardists of Hamirpur are trying hard to make it a fruit bowl of the state with the help of the ambitious HP Shiva project of the Himachal Pradesh government. This project, started with the aim of promoting horticulture in the low altitude areas of seven districts of the state, is also starting a new revolution in Hamirpur district. A beautiful hallmark of this is being seen in the clusters of Bhalehu and Kehdru, the villages selected for the initial phase of the project. Today, in village Bhalehu, where about 21 thousand guava plants are flourishing, while village Kaihadru is also fragrant with other fruit plants of orange and lemon species. Dr. RL Sandhu, Deputy Director, Horticulture Department said that the climate

of Hamirpur district is suitable for the fruits of sub-tropical fruit plants like Mango, Litchi, Guava, Amla and Lemon. Under the HP Shiva project funded by Asian Development Bank in Hamirpur district, 21 thousand guava saplings have been planted on 10 hectares of land belonging to 38 gardeners in PRF Cluster Bhalehu, which will start bearing fruit from next year On the other hand, 8892 saplings of Mosambi have been planted benefiting 54 gardeners of village Kaihadru. In the first phase of the scheme, a target of plantation at the cluster level has been set on 900 hectares of land in the district. So far 843 hectare area has been selected by marking 65 clusters in the district. Tata Consulting Engineering has completed the drone survey work in 54 clusters and has identified an area of about 660 hectares.

Dole deal

mpowering citizens has been a persistent challenge for democratic polities. Over the years, ✓ most democracies, including India, have usually adopted a rather instrumental approach to resolving the problem through doles. The Indian experience is singular in this respect. Governments, irrespective of political affiliations, promise freebies before every election. These include pledges to provide education, employment, healthcare and such other basic amenities for the people. Electoral pledges are not the problem per se. What must, however, be kept in mind are two issues. First, these promises, more often than not, are broken by those in power, to be resurrected before every electoral contest. Second, the packaging of these promises reveals the asymmetrical relationship between politicians and people. This imbalance has an embedded element of condescension: it is suggestive of the political class using weaponizing amenities that are, in essence, people s rights.

This problematic relationship between doles and democracy was highlighted by Priyanka Gandhi Vadra recently. During a virtual rally in Uttar Pradesh, she stated, quite correctly, that the future be it of children or that of the nation cannot be built on free rations. Meaningful empowerment needs serious investment. The consequence of this paternalism, as Ms Vadra pointed out, is there for all to see: the transition of public entitlements into a form of political capital that can end up weakening collective opposition and, in turn, perpetuate the grip of people s representatives on power. What this necessitates is reflection on the nature of democracy s compact on the part of the people politicians, who have profited from this lopsided arrangement, are unlikely to be in favour of changing it. There should be a greater, collective endorsement for a culture of accountability. This means that leaders, no matter how lofty their rhetoric the current prime minister being a classic example should be held accountable for their failure to provide rudimentary facilities. And also for curating what they are mandated to do as a form of service. The need for contemplation on doles and democracy has a contemporary resonance. India s ruling regime accuses parties interested in the upliftment of minorities of appeasement . But how is it any different from making

Secret of Venus, hidden in heat of night

The second planet in our Solar System, which shines like a bright star when seen from the Earth and named after the Roman goddess of beauty, is the ever glowing Venus. Underneath its thick mantle of acid sulfuric clouds, at the surface 460 degrees Celsius are the rule. This temperature is kept by the greenhouse effect of a virtually carbon dioxide only atmosphere. Seventy kilometres above, one has to withstand a perpetual wind storm, the product of the so called Venus superrotation1. A team of researchers has come closer to explaining the link between these infernal features.

The research was led by the Instituto de Astrofisica e Ciencias do Espaco (IAstro2) and published in the journal, 'Atmosphere'.

The study, led by Pedro Machado, of IAstro and Faculdade de Ciencias da Universidade de Lisboa (Ciencias ULisboa), presented the most detailed and complete set of measurements ever made of the speed of the wind in Venus parallel to the equator (zonal wind) and at the altitude of the bot-tom of the cloud deck. One of the novel results was the simultaneous measurement of the speed of the wind at two different heights 20 kilometres apart.

The team registered a difference in wind speed of about 150 kilometres per hour faster at the top of the clouds, which reinforced the hypothesis that energy is being transferred from the heat of the lower layers to the general circulation of the at-

mosphere.

"Winds accelerate as we move upward to increasing altitudes, but we don't know yet why," said Pedro Machado. "This study throws much light on this, because we managed to study the vertical component of the wind for the first time, that is, how the energy from the lower and hotter layers is carried up to the top of the clouds, where it leads to the acceleration of the winds.'

The temperature at the ground level reached 460 degrees Celsius and produced infrared radiation (named thermal emis-



sion), which heated the air and made it move up. This radiation passed through the most transparent regions of the bottom of the clouds, at roughly 48 kilometres above the surface. When Venus is observed in infrared, this light radiates from the heat of the surface, and the silhouettes of the clouds, opaque and dark, becomes visible.

Observing and following the clouds at one hour intervals, and using a tracking technique improved by Javier Peralta, of Universidad de Sevilla and co-author of this study, the researchers indirectly computed the speed of the wind pushing those clouds. This speed is around 216 kilometres per hour at the bottom of the cloud deck and at medium latitudes, decreasing to half closer to the poles.

This work was undertaken almost from pole to pole on the night side recovering images the team captured in the infrared with the Telescopio Nazionale Galileo (TNG), in La Palma, Canary Islands, between 11 and 13 July, 2012. On those same days and in a coordinated strategy, the Venus Express probe, from the European Space Agency

(ESA), then orbiting the planet, observed in visible light the top of the cloud deck, about 20 kilometres above, at 70 kilometres of al-

Also tracking those clouds, the researchers obtained speeds in the order of 360 kilometres per hour. Other studies, and computer simulations indicated that the speed of the wind at the bottom of the clouds is nearly constant, without significant differences between day and night. The team was then able to assume that the wind speed registered at night is the same at the lower layers of the atmosphere on the dayside. The researchers thus collected, for the first time, measurements of differences in the wind speed between two altitudes from simultaneous observations, concluding that, on the dayside and in only 20 kilometres, the wind parallel to the equator suffers a boost in speed of about 150 kilometres per hour more. The heat from the surface may be the engine that sustains these cyclonic speeds of the winds at the top of the clouds. The precision of the data collected with telescopes on Earth was comparable to the in-

frared cameras on space probes, due to the method brought to this study by Javier Peralta. "We used the same geographic referencing method of the images obtained with space probes, which was developed by NASA and complemented by the European Space Agency," Pedro Machado explained. "It's as if the telescope here on the ground was a spaceship."

With the success of this approach, the team has planned to expand their research on the vertical component of the winds with new observations from the ground coordinated with the probe currently in the orbit of Venus, the Akatsuki mission, of the Japanese space agency JAXA. This study demonstrated that the observations conducted from Earth complement the data being collected at the same time by space missions. Despite the lower spatial resolution, due to the distance our planet is from Venus, it is in general possible to have a global view of our neighbour, which space probes, due to their orbits, are not always able to get. The next ESA mission dedicated to Venus is be-

ing planned, the EnVision.
It will study the surface of the planet and try to learn about its past. Portugal will be involved in the mission, and Pedro Machado will lead the Portuguese consortium, in addition to being the co-investiga-tor responsible for one of the instruments, an infrared spectrograph. "This work shows the kind of science that will be enabled with the EnVision instruments. We are already demonstrating the great relevance of the science that will be possible with this future mission." The experience of IAstro and of the Portuguese researchers in the understanding of the dynamics of the atmosphere of Venus will help in selecting the wavelengths of light in which the EnVision mission will observe, as well as the most relevant atmospheric layers from a scientific viewpoint, thus contributing to the design and planning of the mission and its instru-

In any case, we will thoroughly clarify how the situation will develop, exchange information with European countries and the United States, and then make appropriate decisions," the prime minister said.

Though we totally enjoyed our dining out, but there was complete darkness and chaos on the roads. Story is same on the second day as well. No power. It's not that life has come to a complete halt (not sure about industry though). Everyone is managing everything. People are going over to friends/ relatives in adjourning cities, charging devices in cafes, renting

out generators, buying inverter batteries, doing online classes on phone and much more. We all are adjusting. We adjusted in June 2021, when a storm hit the city and there was no power for almost

And now, we have this luxury of comparison! Yesterday, my ds were discussing which pow er cut was worse. Very soon will have, "Things to do during power

I guess this adjusting attitude has made the authorities complacent. Otherwise, how can we afford to enjoy "medieval era" in "modern times". This is some-thing unheard of! Right to express for few has taken over the right to essentials for all. Yes, the administration is taking action. Yes, power will be restored. Yes, they are feeling the brunt of it. But it wasn't sudden or a natural calamity. It was a pre -planned, well in time informed strike (at least three weeks prior). Educational Institutes, Households, Commercial Organizations all could plan ahead but administration couldn't. Instead of doing disaster management, there should have been risk reduction management and that too well in time. While typing this write up, I'm keeping my fingers crossed that laptop battery doesn't ditch me (like UT admin) and hoping by the time, you read this, we are "back" in time.

Ireland to remove mask wearing rules among other COVID-19 restrictions

reland will remove the rules of mandatory mask wearing in indoor Lapublic facilities and on public transport starting from Feb. 28, said the Irish government on Tuesday.

Meanwhile, the specific protective measures currently in place in primary and secondary schools as well as in early learning and school-aged childcare facilities will also be removed, said the government in a statement.

The specific measures aimed at protecting local primary, secondary and pre-school children include pods, social distancing and staggering breaks, it added. Pods refer to the practice that students must be grouped in a limited number while participating in an activity. The statement also



said that from the end of this month on, people who show symptoms of COVID-19 will no long need to take a test except pregnant women, elders and people who have a high-risk medical condition or are immunocompromised. But they must self-isolate themselves until 48 hours after the symptoms resolve, it said, adding that people who are close contacts of a confirmed COVID-19 case will also no longer need to have a test except healthcare workers who are identified as a household close contact.

Following the implementation of these newly announced rules, nearly all the COVID-19 restrictions in Ireland will be removed.

The Irish Department of Health said on Tuesday that an additional 3,294 confirmed cases of COVID-19 were reported in the day, a figure not low at all for a country with a mere population of five million despite the fact the figure is only half of the level compared with a month ago. The Irish government in the statement advised the public to continue to wear masks on public transport and in healthcare settings apparently in fear of a possible rebound of the cases following the scrapping of the rules.

But these are just advices and have no legal binding. Irish health minister Stephen Donnelly told local media on Tuesday that he believed it is "appropriate" for the government to lift most of the remaining restrictions based on the current trajectory of the pandemic in Ireland as well as the progress of the

The hijab protests in Karnataka began in January this year when some students of Government Girls PU college in the Udupi district of the state alleged that they had been barred from attending classes. During the protests, some students claimed they were denied entry into the college for wearing hijab. Following this incident, students of Shanteshwar Education Trust in Vijayapura wearing saffron stoles.

Moderate to heavy snowfall disrupted normal life in the Kashmir Valley on Wednesday. It shut the only road link connecting the valley with the rest of the country and also hit the air traffic. Several flights from the Srinagar Airport were cancelled and many delayed due to bad weather, officials said. "Our snow clearing operations is underway on the runway...," a Srinagar airport official said. The Srinagar-Jammu Highway has been shut for traffic after snowfall triggered fresh shooting stones incidents. The national highway is the northernmost segment of NH 44. It runs from Srinagar in the Kashmir Valley southward to the city of Jammu. The 295-km long highway is one of the two road links that connects the valley with the rest of the country. Disaster Management Department Director Aamir Ali said it is raining heavily on the NH44 from Udhampur to Banihal. "Shooting stones at Cafeteria Morh, Maroge and Panthyal, have halted the traffic. "Navyuga Qazigund (has been) closed due to snow on the Qazigund side. Around 300 Kashmirbound trucks are stranded at Banihal," Ali said, adding no fresh traffic is being allowed from either side. Fresh snowfall and rains were recorded throughout the valley during the night. Several regions on high altitude witnessed heavy snowfall as Srinagar city too received fresh snow. According to Srinagar Meteorological Department, moderate to heavy rain and snow occurred at most places of Jammu and Kashmir with one to two feet of snow at high altitudes. "Srinagar reported 7.5 inches of snow till 8.30 am today," a MeT official said. The MeT said there was likely to be significant improvement in the weather from evening onwards. "Overall improvement is most likely from Thursday onwards though."

In this meeting, M.D. NHM Kumar Rahul, MD p.h.s.c. Bhupinder Singh, Director Health and Family Welfare Dr.G.B. Singh, Director Health Services (f.w.) Dr.O.P. Gojra, Assistant Director Dr. Balwinder Kaur, Dr.Srinivasan, Dr. Vikram World Health Organization all Civil Surgeons of Punjab State, Immunization Officers, representatives of various departments also participated. Giving more information

about the Pulse Polio Principal Campaign, Secretary Mr. Chaudhary said that this campaign would be started in the state from 27th February and would be completed on 1st March. He said that 31,08,660 children of 0 to 5 years of age would be given polio drops by the health workers across the state. Mr. Chaudhary said that on the first day of the campaign 14,468 polio booths would be set up across the state and on the second day 26,741 teams would go door to door to administer these drops to the children. Apart from this Principal Secretary Mr. Chaudhary said that 848 mobile teams and 764 transit teams have been formed in the state to administer polio drops to the children living in the high risk areas. 4379 ANMS, 19573 Asha Workers, 21201

Anganwadi Workers and about 10145 Volunteers have been deployed to make this campaign a success and 3180 Supervisors have been deployed to monitor them. On this occasion the Director of Health Department (fw) Dr. O.P. Gojra said that 8436 high risk areas have been identified by the department out of which 4297 slums, 279 construction sites, 775 construction sites, 775 migration sites, 2064 brick kilns and 1021 other sites would be provided polio drops by the personnel of the department. Dr. O.P. Gojra said that senior officers of the Director's Office have been appointed as Observers to monitor the Pulse Polio Campaign in the state which would monitor the campaign for three days in different districts of the state and ensure that no eligible child

should be deprived of polio drops. Apart from this the Director Health said that Mission Inder Dhanush was also discussed during the meeting of the task force and department aimed complete immunization of children below two years of age and pregnant women under Mission Inder Dhanush in three phases from March to May. He said that the vaccination process has been affected due to Covid but the immunization drive would be intensified in the coming days under Mission Inder Dhanush. He said that although the Government of India had initially directed to launch this special campaign in six districts of Puniab but the campaign was directed to be carried out in all the districts of Punjab by the Principal Secretary.

. Apart from Rahane, another Mumbaikar who would be in focus is young Sarfaraz Khan, whose purple patch in red ball cricket continues, having hammered a monumental 275 against Saurah-

The 41-time Ranji champions would look to secure full points from the game after Saurashtra denied them an outright win. With a batting line-up comprising skipper Prithvi Shaw, Rahane, Sarfaraz, Aakarshit Gomel, Sachin Yadav and senior stumper Aditya Tare, Mumbai would look to pile up the runs at the Narendra Modi Stadium.

Their bowlers led by pacer Dhawal Kulkarni will have to hit the right areas and the role of off-spinner Tanush Kotian and left-arm spinner Shams Mulani would be crucial if Mumbai are to take 20 opposition wickets.

Overall Mumbai, who are much stronger than the team from the coastal state, would like to dominate their opponents from ball


As per the latest developments, the women's and men's national teams will receive an equal rate of pay in all friendlies and tournaments, including the World Cup.
