Evacuated Indian students from Sumy reach Delhi

NEW DELHI: One more flight carrying 242 Indians evacuated from Ukraine landed in Delhi on Friday. Another flight with students, who were evacuated from Sumy city will reach Delhi around 11 am. India sent three flights to Poland to bring back 600 students evacuated from Sumy, one of the worst-hit in the Russia-Ukraine crisis. Over 17,000 Indians, mostly students, have been evacuated so far under the 'Operation Ganga' that has been launched by the Narendra Modi government to rescue Indian citizens from Ukraine via neighbouring countries like Romania, Hun-

Gold tumbles Rs 200; silver jumps Rs 193

NEW DELHI: Gold tumbled Rs 200 to Rs 53,033 per 10 grams in the national capital on Friday in line with weak international precious metal prices, according to HDFC Securities. In the previous trade, the precious metal finished at Rs 53,233 per 10 grams. Silver, however, jumped Rs 193 to Rs 70,449 per kg from Rs 70,256 per kg in the previous trade. In the international market, gold was trading lower at USD 1,990 per ounce and silver was flat at USD 25.84 per ounce.

Pilot killed in Army chopper crash in north Kashmir SRINAGAR: An Army

Cheetah helicopter on its way to pick up sick BSF personnel crashed near the Line of Control (LoC) in north Kashmir's Gurez Sector on Friday, resulting in the killing of its pilot and injuries to the co-pilot, officials said. The injured co-pilot has been rushed to a medical facility, they said, adding that his condition was stated to be critical. The two pilots belonged to Army Aviation Corps and were of the rank of major.

Voters reject most 'bahubalis' in UP polls

LUCKNOW: While a few bahubalis' managed wins in the Uttar Pradesh Assembly elections, a majority of them were rejected by the voters. Many alleged donsturned-politicians failed to make it to the Uttar Pradesh Assembly. These include Dhananjay Singh (Malhani), Vijay Mishra (Gyanpur), Yash Bhadra Singh Monu (Isauli) and Amarmani Tripathi (Nautanwa), son of Purvanchal strongman Yatra Amanmani Tripathi.

Bhagwant Mann to take NGT orders to compensate kin of deceased of Una fire tragedy oath as Punjab CM on 16th

CHANDIGARH, MAR 11

Punjab's Chief Minister-designate Bhagwant Mann will take oath for the top job on March 16. The 48-year-old comedian-turned politician had yesterday said that his oath-taking ceremony will not be held at Raj Bhawan, as is the custom, but Khatkarkalan in Nawanshahr district, the ancestral village of freedom fighter Bhagat Singh.

The Aam Aadmi Party Chief Ministerial candidate met with party chief Arvind Kejriwal today for the first time after an unprecedented win in the state assembly polls yesterday. The duo has a roadshow scheduled in Amritsar on March 13.

He has invited Mr Kejriwal to his swearing-in ceremony.

Mr Mann, AAP's Ione MP, contested the state polls from Dhuri, an assembly segment in his Sangrur parliamentary constituency, winning by a margin of over 58,000 against Dalvir Singh Goldy from Congress

This was his third battle for an assembly seat. He unsuccessfully contested the 2017 assembly polls against Akali Dal's Sukhbir Singh Badal for the Jalalabad seat

In 2011, he had contested from the Lehra assembly constituency in Sangrur as a Manpreet Singh Badal-led People's Party of Punjab candidate but lost to senior Congress leader Rajinder Kaur Bhattal.



Cabinet recommends for dissolution of assembly

CHANDIGARH: The Punjab Cabinet on Friday gave approval to recommend the State Governor Banwarilal Purohit for dissolution of 15th Punjab Vidhan Sabha. A decision to this effect was taken during a virtual Cabinet meeting chaired by Chief Minister Charanjit Singh Channi here at his official residence this morning Disclosing this here today, a spokesperson of the Chief Minister's Office said that the Punjab governor is authorised to dissolve the State Legislature as per sub-clause (b) of clause (2) of Article 174 of the Constitution of India. This move being a Constitutional necessity would now eventually pave a way for formation of 16th Punjab Vidhan Sabha. At the end of the meeting, the Chief Minister thanked all his cabinet colleagues, officers, employees and people for overall development and maintaining peace and tranquillity in the state during the tenure of the present government. The Chief Minister also congratulated the incoming government and hoped that the new government would earnestly implement the promises made to the people. He also hoped that the decisions taken by his government in the public interest such as reduction of electricity rates, slashing VAT on oil besides decreasing rates of sand and gravel etc. would be continued by the next government.

NGT orders to compensate kin

AGENCY SHIMLA, MAR 11

Principal Bench of National Green Tribunal has been ordered to pay the compensation to the tune of Rs 20 lakhs to the next of deceased of firecracker tragedy and Rs.15 lakhs to persons (50 pc burn injuries) Rs.10 lakhs to 25 to 50 pc and Rs.5 lakhs for 5 to 25 pc burn injuries. The bench comprising chairpersons Adarsh Kumar Goel, Judicial Member Sudhir Agarwal, and Expert Member Prof. A. Senthil Vel, passed a 13 paged order on March 8, 2022 copy of which was loaded on the NGT website Friday. The order said those victims who are being treated as outdoor patients and who had but the minor degree of burns or other forms of simple injuries are to be paid Rs. 2 lakhs each. The compensation would be in addition to any ex-gratia payment made or which may be made. The NGT said such payments may be made by the State Administration within one month, after due verification of identity through the District Magistrate, Una and requisite amount be made available by the Chief Secretary of Himachal and the amount may be recovered from the violators,

in accordance with law by using coercive measures, if necessary. The bench said this would be in addition to criminal liability. The state may also take necessary preventive measures in respect of such accidents in the light of directions already issued by this Tribunal. Chief Secretary may conduct a meeting on the subject of the concerned departments within one month, which may also be attended by the Regional Officer of CPCB, Chandigarh. The bench said the aggrieved party may have the liberty to move to this Tribunal if it desires so.

NGT said the above tragedy struck is the liability of the State for its failure in addition to the responsible persons. The persons who had taken licences had further rented out the premises. Some private persons have been identified. It is also clear that incidents are frequent. Activities are highly dangerous but are not being regulated by the State PCB, Labour Department and the District Magistrate. The State has failed to put in an appearance or give any explanation for its failure to protect the lives of citizens by enforcing the law. The reason may be negligence of the concerned officers or incompetence.

CBSE Term-II Board examinations for classes 10, 12 to be held from April 26

NEW DELHI, MAR 11

The Central Board of Secondary Education (CBSE) on Friday informed that the Term-II examinations for classes 10 and 12 are to be held from April 26, 2022.

Last year, the CBSE had announced that board examinations for 2022 will be conducted in two terms. While Term-I exams have already been held, the Term-II exams for both the classes will commence from

April 26. This time exam timings will be 10:30 am and won't be conducted in two shifts. Further details are available on the official website, stated the CBSE. According to the Board, the exam schedule has been prepared keeping the COVID-19 pandemic in mind. "As the schools were closed due to the pandemic which has led to learning loss, therefore, more gaps have been given between the examinations in almost all the subjects in both the classes," said the CBSE in a notification issued today.

giving it momentum," he added.



CS directs officers to pre-prepare action plan for coming season

CHANDIGARH, MARCH 11

Haryana Chief Secretary Sanjeev Kaushal has directed the officers concerned to prepare an advance action plan for crop residue management ahead of the upcoming season. He also directed the officers concerned to explore the possibilities of new technologies and projects in addition to the existing technologies for ex-situ management. Giving these directions while presiding over the meeting regarding ex-situ management for the upcoming season here on Friday, the Chief Secretary said there has been a significant reduction in the incidents of stubble burning last year and this year also advance action plan should be prepared to decrease the stubble burning incidents. For this, committees should also be constituted at the village level so that the incidents of stubble burning at the ground level can also be closely monitored and farmers can also be made aware of the ill-effects of stubble burning so that

stubble, he directed. said in-situ management is being done on a large scale in Haryana and with this, more emphasis is needed on ex-situ management. For this, apart from the existing technologies, possibilities of the use of new technologies and starting new projects should also be explored. He directed that the costing study of

cooperative sugar mills should be conducted to make Biomass Energy Plant, Ethanol Plant and Compressed Biogas Plant more viable.

Besides this, their number should also be increased in the State to promote maximum consumption of stubble in the State. In the meeting, Agriculture and Farmers' Welfare Department Director General Hardeep Singh informed that the department is providing subsidies to the farmers for various equipment like straw slashers,



straw balers for ex-situ management so that the farming system can be improved. He further informed that during the year 2021, 449 straw balers have been provided to the farmers on subsidy for ex-situ management. For this year, 26 industrial units have registered a requirement of 4.25 lakh metric tonnes of stubble. It

was informed that biomass projects have been set up in the state for the consumption of stubble and at present 11 projects are going on, in which 4.48 lakh metric tonnes of stubble is being used and 6.43 lakh metric tonnes have been used in the year 2022-23. Besides this, work on two more biomass power projects and one ethanol plant will also be completed by July 2022. After the completion of these plants, additional use of 4.26 lakh metric tonnes of stubble will be



New fruit processing plant to be set up at Kotkhai: Min

SHIMLA, MAR 11

Himachal Pradesh Government would set up a fruit processing plant at Kotkhai area of Shimla district so that fruit procured at apple producing area could be used to convert it to apple concentrate, Horticulture Minister Mohinder Singh Thakur said in the state assembly while replying to a query of Rohit Thakur on Friday. He said the plant is under consideration of the government so that apples procured from the Kotkahi area could be quickly used for the apple juice and concentrate. Earlier to this plant Himachal Pradesh Fruit processing and Marketing limited(HPMC) had to carry the C-grade apple to Parmano unit of HPMC to



further process the produce. During the transportation huge amounts of apples are being wasted in the process however it could be used on the spot after a plant would at Kotkhai. commissioned Minister

Parmwano in 1981 which is producing 18000 metric tonne apple concentrate every year. Minister informed that in the last three years this unit has produced 2326.31 metric tonne Apple juice concentrate from HPMC. The unit is being upgraded. Anita Dhiaman of BJP demanded a processing plant for Citrus fruit in Indora Area of Kangra district, Minister said the state should not be known as fruit state but an apple states. My home came under a subtropical area where apples could not be grown, Minister said in the state two thirds of the state fall in subtropical areas but enough resources for fruit production and processing have not been done. He said a Shiva project was also being proposed by Asian Development Bank project. After March 15, MOU for this project to be signed to bring 45000 hactare area under subtropical fruit. 

In most of the cases of sextortion, most of the victims do not even contact the police, paying amount demanded from vicious method. In most cases, while a woman is often involved in explicit video calls, men are actually behind the activity although women do participate in some events. Cases like this include checking which pages a potential victim likes and then contacting them on social media. Once connection is made, push is made for video chat. At times, female gang members are participants, although in most cases men use software and applications to hide their identities during chats. He then starts abusive conversation. Even if victims do not respond in same way, screenshot is morphed to make it appear that they are part of the lewd antics. The thugs blackmail the victim into payment after threatening that the screenshot of the pornographic video will be sent to family and friends. The general target is financially capable middle-aged men. Accused start with demanding a small amount, such as Rs 10,000 and gradually increase it. The advisory of the cyber cell regarding the increasing cases of sextortion that the complainants generally do not want to pursue the matter further. Cases of women or men approaching people for candid video chats and then blackmailing are being reported on social media. He said that in such cases a complaint can be lodged on the cybercrime website, where the identity of the victim remains confidential.

SC to hear plea seeking bail cancellation of Ashish Mishra on Tuesday

AGENCY NEW DELHI, MAR 11

The Supreme Court on Friday said the plea seeking bail cancellation of Ashish Mishra, who is the son of Union Minister of State for Home Affairs Ajay Mishra Teni and an accused in the Lakhimpur Kheri incident, will be heard on Tuesday. A bench headed by Chief Justice of India NV Ramana listed the matter to be heard on Tuesday. Advocate Prashant Bhushan. appearing for the petitioner, told the court that a witness in the Lakhimpur Kheri case was attacked last night and sought an urgent hearing. He also apprised the court that the matter was scheduled to be listed today. The bench said that it was an office mistake. Family members of the victims of the Lakhimpur Kheri incident have moved the Supreme Court challenging the Allahabad High Court order, which granted bail to Ashish Mishra. In the Special Leave Petition, family members of the deceased have challenged the Allahabad High Court order dated February 10.



2022, wherein Ashish Mishra was granted regular bail. The petitioner said that Allahabad HC's order is unsustainable in law. They also said that they have approached the Apex Court as the State of Uttar Pradesh has failed to prefer any appeal against the impugned order. "The lack of any discussion in the High Court's order as regards the settled principles for grant of bail is on account of lack of any substantive submissions to this effect by the State as the accused wields substantial influence over the State government as his father is a

Union Minister from the same political party that rules the State," the petition stated. "The impugned order is unsustainable in eyes of law as there has been no meaningful and effective assistance by the State to the court in the matter contrary to the object of the first Proviso to Section 439 of Code of Criminal Procedure, 1973, which provides that in grave offences notice of bail application should ordinarily be given to the Public Prosecutor," the petitioner said. "Even the victims were prevented from bringing the relevant material as regards the

settled principles for grant of bail to notice of High Court as their counsel 'got' disconnected from the hearing on January 18 this year before he could barely make any submissions and repeated calls to the court staff to get reconnected were to no avail and application filed by the victims/petitioners," the petition said. "Contrary to settled law, the High Court failed to form its opinion on the basis of the charge sheet on broad probabilities and has instead gone on the basis of far-fetched imaginary possibilities," the petition said.

"The observation of the High Court said that there might be a possibility that the driver tried to speed up the vehicle to save himself, on account of which, the incident had taken place, is perverse especially when there was nothing on record to show the same and there is evidence in fact in the charge sheet to the contrary showing that the vehicles had been dashing at high speeds of 70-100 km/hr from the time they left the venue of the 'dangal'; when they passed the petrol pump.

EDITORIAL Skip a beat

ne word that has gone missing from our Bengali vocabulary is "palpitation". I say Bengali because the familiarity with which it was used in Bengali middle-class homes made it lose its foreignness. Perhaps the popularity of the word was owing to the fact that the condition it represented was a recurrent one that seemed to affect a large number of Bengalis of a certain age. Any kind of excitement, major or minor, happy or sad, near or distant, could cause palpitation. I was raised by grandmothers and grandaunts, and grandfathers and granduncles, who would often clutch their hearts following an incident - a long-distance call would count as one, too — and make the pronouncement: "Amar toh palpitation shu-

Of course, sometimes it could be caused by an actual severe heart condition. But when it was not, it served a number of purposes. A: It summed up the peculiar Bengali mix of nervousness and collapse that often meets any prospect of change, even a small one. B: It was a very expressive word. It was onomatopoeic and seemed to reproduce the thudding of the heart, the specific condition it described. C: There was something vital and comic about the word, especially when the reaction far exceeded the cause of agitation. For example, I imagine Lalmohanbabu, Satyajit Ray's classic caricature of the Bengali bhadralok, suffering several palpitations as he stood among the sands of Rajasthan contemplating a camel, which was tower-ing above him. He would have to ride it. One of our female relatives would react with heavy palpitation every time her husband returned home at night, smelling of alcohol underneath his paan breath. We would know well the look of sad resignation and prolonged agony on her face that would precede the pal-pitation. The palpitation could sometimes be followed by swooning, but she would be perfectly all right in the morning. She lived long. D: The word adequately represented a state of intense agitation, yet, because it was expressed as a very specific physical reaction, which would eventually subside, its experience did not seem unmanageable. It is for this last reason that I mourn the departure of the word from our vocabulary most. As I do of "unsmart", another word that was English in origin but became absolutely Bengali in its meaning. Or "cadaverous": it came to mean hideous, but not in a pale, corpse-like way. In-laws, who tortured a woman and therefore were obviously robust in some way, could be cadaverous. Now the English words that are a part of Bengali are overwhelming in number and are mostly about consuming, in more than one way, pertaining to buying, shopping, technology or eating, or are aspirational, and often appear as proper nouns, invented to suit products.

EU increases investment plan for Africa to counter China

uropean Union recently pledged a → USD 170 billion aid package to ▲African countries with the aim to counter growing Chinese influence in Africa, a media report said. Last month, the heads of state or government of the member states of the African Union (AU) and the European Union (EU) met for the sixth European Union - African Union summit in Brussels.

During the summit, EU and AU leaders agreed on a joint vision for a renewed partnership. According to an official readout, this partnership aims to promote se-curity, peace, and sustainable and sustained economic development and prosperity for the citizens of the two Unions.

It aims to promote common priorities, shared values, and international law. This also includes the protection of human rights for all, gender equality, and women's empowerment in all spheres of

The Africa-Europe Investment Package of EUR 150 billion (USD 170 billion), announced during the summit, also supports a common ambition for 2030 and AU Agenda 2063.

Notably, the summit came a few months after the Forum on China-Africa Cooperation (FOCAC) Meeting.

During the Africa-China summit, Chinese President Xi Jinping had pledged about USD 40 billion worth of investments for Africa, a third less than Beijing's previous commitments. Even with regard to the Chinese loans, there was a significant drop in the number compared to the previous years, The HK Post reported.

According to the report, Chinese loans amounted to USD 7.6 billion in 2019 as compared to USD 29.5 billion in 2016. During the summit, Xi had underlined Europe's colonial history with Africa and in contrast noted that "over the past 65 years, China and Africa had forged unbreakable fraternity in our struggle against imperialism and colonialism". Experts believe that



the latest EU assistance is a part of the Global Gateway Initiative (GGI) that was unveiled by the EU last year as an alternative to the Chinese Belt and Road Initiative (BRI). Back in December, Commissioner for International Partnerships Jutta Urpilainen had said the European Commission (EC) is launching USD 340-billion Global

Gateway to boost sustainable links around the world. According to the official document, the new strategy aims at boosting the world's interconnectivity through building and strengthening of high standard sustainable digital, economic, transportation, research, and health systems across the world. The European Commission added that for implementing the strategy, the European Union would use the so-called "team Europe" approach, encouraging member states with their financial and development institutions, including the European Investment Bank to mobilize the private sector in order to leverage investments for a transformational impact.

Challenge of humour in workplace for women

ew research at the University of Missouri shows that using humour in the workplace is more challenging for women than factors, such as a woman's perceived status in the office and whether her humour is directed towards other

The findings of the study were published in 'Journal of Managerial Psychology'

Christopher Robert, an MU associate professor who also is serving as the interim dean of the Trulaske College of Business, conducted a study to analyze how people react to men and women using humour in the workplace. The goal was to determine if a person's gender and status in the workplace would affect how others reacted to their humour.

The researchers surveyed 92 college students after they read workplace scenarios in which men and women made humorous comments. Scenarios were adjusted so that the humorist, or the person making the humorous comment, was either a male or female, in a high or low-status position, and they also varied



whether the target of the humour was a male or female. In addition, some scenarios included humour that was more friendly or "affiliative" while others included aggressive humour. The researchers then asked the participants to determine how "foolish" they perceived the humorists to be.

One of the scenarios takes place at a meeting in which hospital personnel are discussing some of the challenges that resulted in patient

A female nurse stutters while trying to share her ideas to address a problem and is interrupted by an employee attempting to make a humorous comment, poking fun at the fact that she can't find her words.

Over 1 million children have fled **Ukraine since February 24**

ore than 1 million children have now fled Ukraine as war continues to rav-age the country, UNICEF said on Thursday. Most have fled with their families to Poland, Hungary, Slovakia, Moldova and Ro-

number of children on the move is staggering, an indication of how desperate the situation for children and families in Ukraine has become," said UNICEF Regional Director for Europe and Central Asia Afshan Khan. "Children are leaving everything they know behind in search of safety. This is heart-breaking.

So far, six trucks carrying nearly 70 tons of supplies have arrived to Ukraine. The supplies include personal protection equipment and

medical, surgical and obstetric kits. Working with partners, UNICEF said that it will be delivering medical supplies to 22 hospitals in 5 different conflict-affected areas of Ukraine, to benefit 20,000 children and mothers. In a press statement, the UN agency renewed its call for safe, rapid and unimpeded humanitarian access to reach populations in need, and for the safe passage of civilians to reach the services and protection to which they

are entitled. "Across the border, three trucks were dispatched from Copenhagen - UNICEF's warehouse and the largest humanitarian hub in the world - carrying essential supplies, such as early childhood development, recreational and hygiene kits. These supplies have now arrived in



Poland," the UNICEF said.

Additional supplies are on their way from Copenhagen and from Turkey, and are due to arrive in the coming days, it added.

To assist children and families on the move from Ukraine to Moldova, Poland, Romania and Belarus, UNICEF has set up "Blue Dots," one-stop safe spaces that provide key information to traveling families and the ability to identify unaccompanied and separated children and ensure their protection.



Sharing memories sets children on path to better well-being



new research led by the University of Otago found that toddlers whose mothers received special coaching in talking about memories could experience better well-being.

The study was published in the journal, 'Journal of Personality'. The study found that 15-year-olds told more coherent stories about turning points in their lives if their mothers had been taught the new conversational techniques 14 years

These adolescents also reported fewer symptoms of depression and anxiety compared to adolescents in the study whose mothers had

conversed with their toddlers as usual. The research was a follow-up of a reminiscing intervention in which 115 mothers of toddlers were assigned to either a control group or given training in elaborative reminiscing for a year. Elaborative reminiscing involves open and responsive conversations with young children about every day past events, such as feeding ducks at the

Project lead Professor Elaine Reese of the Depart-ment of Psychology said that adolescents whose mothers had participated in the earlier coaching sessions narrated difficult events from their lives -- such as

parental divorce or cyberbullying -- with more insight into how the experience had shaped them as people. "Our findings suggest that brief coaching sessions with par-ents early in children's lives can have long-lasting benefits, both for the way adolescents process and talk about difficult life events and for their well-being," Professor Reese said.
"We believe parents'

elaborative reminiscing helps children develop more complete, specific, and accurate memories of their experiences, providing a richer store of memories to use when forming their identities in adolescence. Elaborative reminiscing also teaches

children how to have open discussions about past feelings when they're no longer in the heat of the moment,' she added. She hoped parents and policymakers realise the importance of early childhood as the ideal time for starting to have positive conversations with children and to know that these conversations can make a differ-

ence as children grow older. "The ultimate goal is to encourage parents to have more sensitive and responsive conversations about events in their children's lives," she said.

Lead author and clinical psychologist Dr Claire Mitchell said that a great deal of research now shows

well-being can drop dramatically in adolescence.

"For some young people, this dip is the beginning of more severe mental health issues that can be difficult to treat. Thus, it is important to find ways to prevent mental health difficulties earlier in life if possible," Dr Claire Mitchell said. "As a parent of a toddler myself, I can confirm that these elaborative reminiscing techniques are enjoyable and easy to learn. Our study helps pave the way for future work with parents of young children to promote healthy interactions from the beginning that could have enduring benefits," she concluded.



Belarus' Aliaksandra Sasnovich advanced into the second round after her opponent Camila Osorio of Colombia retired from the match while trailing 6-4, 5-0. The 20-year-old Colombian was suffering from a left thigh injury since her last game in the Monterrey final.

India practice under lights to get used to Day-Night playing conditions

The Indian team will be playing their third Day-Night Test on home soil when they take on Sri Lanka in the second and final Test match of the series here at the M Chinnaswamy Stadium.

"We are playing a pink ball test after a long time. We practised under lights. We addressed the adjustments we need to make during the Pink ball Test," said India vice-captain Jasprit Bumrah in the pre-match press confer-

The last time India played a Day-Night Test match with the Pink ball was against England in Ahmedabad in February 2021.

"As I told you before there are mental changes we have to make because you do not play a lot of Pink Ball cricket. All these things we are still very new to this format like playing under light, fielding and bowling with Pink Ball are things we need to get used to and we keep all of these things in mind while in training sessions. We have not played with Pink ball much at junior level as youngsters. The adjustment depends from person to person. There is no set parameter. The red ball swings in the morning more while the Pink ball in the evening. As far as catching is concerned we practice so that we can adjust

to it," explained Bumrah.

For the Day-Night Test match, the players also have to adjust to a different time of play as the match starts in the afternoon and ends late in the evening.

as the match starts in the afternoon and ends late in the evening. "When the match ended we had an optional session in Mohali. The times are different. The sleep

patterns are different. We practice

so that we can adjust to that timing pattern," said Jasprit Bumrah.

With the match being played under lights it is still not clear whether India will play three seam bowlers or three spinners.

"We had a look at the surface yesterday but today we'll take a closer look at the pitch. After that we will have a better idea if we want to go into the match with three seamers or three spinners," the Indian vice-captain told.

All-rounder Axar Patel, who has recovered from a shin injury that forced him to miss the South Africa tour and the T20I series against West Indies, returned to the Indian set-up replacing left-arm chinaman bowler Kuldeep Yadav for the second Test against

Sri Lanka.

"Axar Patel has added a lot of value whenever he has played,

has contributed a lot and offers a lot in all departments. He was injured but he jumps straight back in when he's fit. We will discuss our combination but of course, he is valuable," said Bumrah about Axar Patel's comeback.

"We have not removed Kuldeep Yadav from the team. He has been in the bio-bubble for a long time and

a long time and hence he has been released. Staying in a bubble is not easy. The mental aspect is important. After this he will again be in the biobubble during the IPL," added Bumrah.

When it comes to Pink Ball Tests, India have played two D/N matches on home soil winning both inside three days in Kolkata and Ahmedabad against Bangladesh and England respectively. This will be India's fourth Pink ball Test overall.
