India, EU discuss

economic ties NEW DELHI: The Indian government on Wednes-day discussed economic ties with the European Union with a group of senior MPs from the Committee of International Trade of the EU. The Indian side was led by Sanjay Verma, Secretary (West) in the Ministry of External Affairs. MEA spokesperson Arindam Bagchi said the European delegation included Svenja Hahn, Jan Zahradil, Soren Gade, Bernd Lange and Arnaud Danjean. "Both sides expressed commitment for advancing economic ties with the early conclusion of trade and investment agreements," Bagchi said. The meeting also came in the backdrop of the ongoing Russia-Ukraine war which has affected global economy and trade. The EU is India's third largest trading partner, accounting for Euro 62.8 billion worth of goods in 2020 or 11.1 per cent of total Indian trade after China (12 per cent) and the US (11.7 per cent).

Pakistan's top investigative agency has opened an inquiry against former Prime Minister Imran Khan over allegations that an expensive necklace received as a gift during his tenure was sold to a jeweller for Rs 18 crore instead of depositing it to the state gift repository, according to media report on Wednesday.

The necklace Khan received as a gift was not sent to the tosha-khana (state gift repository), but given to former special assistant Zulfikar Bukhari, who sold it to a jeweller in Lahore for Rs 18 crore, the Express Tribune newspaper reported.

The public gifts can be kept in the personal closet by paying half price of it but Khan, who lost a no-trust vote in Parliament last week, deposited a few hundred thousand rupees in the national exchequer which was illegal, the report said.

According to the law, state officials are required to submit the gifts they receive from dignitaries in the tosha-khana. If they fail to submit the gift or at least half the amount the gift is worth, it is an illegal act.

PTI to boycott investigation into "foreign conspiracy" letter ISLAMABAD: Former Prime Minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) on Tuesday announced that it will boycott any meeting of the Parliamentary Committee on National Security, which may look into the cable that allegedly revealed a conspiracy to topple their government, and demanded the country's Supreme Court constitute an inquiry commission on the matter. The decision was made following a meeting of the political committee of PTI which also called for general elections at the earliest and announced a number of rallies in a bid to mobilize the support base of the party, Dawn reported.

Hry CM launches onestop digital platform 'Nagar Darshan' Portal



Cabinet reviews status of wheat procurement

GAURAV GOEL CHANDIGARH, APRIL 13

The Punjab Cabinet led by Chief Minister Bhagwant Mann on Wednesday welcomed the decision of the Union Government to accept the request of the State Government to revisit the norms of shrivelled grains for the ongoing procurement of wheat. It also decided to appeal to the Union Government to issue the order for relaxations in the norms at the earliest.

Disclosing this, a spokesperson of the Chief Minister's Office said that the Secretary, Food, Civil Supplies and Consumer Affairs briefed the Cabinet about the status of the ongoing procurement. It was informed that 14.9 Lakh MT of wheat had arrived in the Mandis out of which more than 12 Lakh MT had already been purchased. More than 2 lakh MT of wheat, out of 5 Lakh MT that arrived yesterday alone, had been purchased on the day of arrival itself, he revealed.

The spokesperson added that while welcoming the early constitution of Central teams to assess the damage of shrivel grains in the



145 posts of various categories to be filled

CHANDIGARH: In a bid to streamline the functioning of Water Supply and Sanitation department and provide better rural water supply to people across the state, the Punjab Cabinet on Wednesday gave approval to fill up 145 posts of various categories (25 Sub Divisional Engineer, 70 Junior En gineer, 30 Junior Draftsman & 20 Steno Typist) by direct recruitment through PPSC and SSS Board within a year. According to a spokesper-son of the Chief Minister's Office, the Council of Ministers had given approval to fill up 88 posts of aforementioned categories in Water Supply & Sanitation department in the year 2021. Apart from these, the Cabinet to-day also gave approval to fill 57 more posts of these categories falling vacant in the year 2022 due to retirement/promotion of officers/employees.

state, the Cabinet also appealed to the Central Government to allow relaxation in the norms of shriv-

elled grains without any value cut, since the farmer had already been penalised on account of lower yield. A formal request in this regard had already been made by the State Government, he added.

It may be noted that due to extreme heat conditions the wheat grain has become shrivelled in many places and the grain coming in these Mandis contains shrivelled grain beyond the permissible limit of 6%. Thereafter, the Department of Food and Public Distribution, Government of India, had yesterday constituted five teams to assess the extent of the problem in the state. The teams are on the way and shall shortly arrive in the State to get a first hand assessment of the extent of shrivelled grain arriving in the Mandis. This data will then help the Government of India in taking a final decision on grant of appropriate relaxation in the specifications.

The spokesperson added that the Cabinet laid absolute emphasis on farmer welfare and asked the Department to take all possible steps to ensure smooth procurement.

It also asked the Department to resolve any genuine issues of the staff deputed by the procurement agencies for procurement of wheat.


The 17th cleric of Tibetans, Karmapa Ugyen, has been granted a five-year FCRA license to the Gyuto Tantric Monastery in Dharamsala, Trinel Doraj. This license was already linked to the Karmapa. The Gyuto Tantric Monastery has been a temporary residence of the Karmapa. In 2011, the Karmapa Monastery was raided by the Himachal Police from where the police recovered a huge amount of currency from 26 countries. There was a lot of anger among the Tibetans regarding this matter, then the problems of the Karmapa also increased. This issue, which was in discussion for more than a year, left its mark in India as well as China. Along with this, the issue of benami properties of Tibetans in Dharamsala was also heated, but in the end, in 2012, the former Dhumal government of the state, giving a clear chit to the Karmapa, gave them a lot of relief by taking back this issue. The abbot of Gyuto Monastery, Lobsang Khedup, confirmed the development and explained that the FCRA license is to receive donations from abroad, especially



from the United States. The Karmapa, who suddenly arrived in India in the year 2000, obtained a Commonwealth of Dominica passport in 2017-18. India never recognized the thirty-six year old Tibetan spiritual master. After the Dalai Lama, Tibetans consider Karpama as their guru. According to officials, the monastery has been given FCRA license under the religious-cum-education category for Buddhist teachings. He said that the license is valid for five years i.e. till 2027. The move assumes significance as the border dispute between India and China in eastern Ladakh is intrinsically linked to the Tibet issue. There has been a violent face-off between Indian and Chinese armies in eastern Ladakh since May 2020.

harwad, where I live, is a small town. If the population of India in 1941 was somewhere near 36 crore, that of Dharwad was 47 thousand, seven or eight thousandth part of the total. When the Indian population crossed 120 crore, the population in Dharwad-Hubli was close to 12 lakh, a thousandth part of the total. Since Independence, numerically, the town has shown a lot higher growth than towns smaller than it and a growth much smaller than the towns larger than it. Dharwad has merged with Hubli, which lies at a distance of 20-odd kilometres to the south. To its north, at a distance of 20 odd-km, is Kittur, which is fast moving to become an extension of Dharwad. In a couple of decades, the three together are likely to have a population of about 60 lakh spread over an area 80 km long, 25 km wide, and a total of 2,000 sq km. The emerging Dharwad will then be about 250th part of India.

This rhythm of its growth is in tune with growth patterns elsewhere in India. This microcosm of India stands on a rock-system named the Dharwad Rock System by geologists that came into existence 180 crore years ago. Homo sapiens have dwelt here for several millennia and agriculture has been practised in the region for at least six millennia. It developed its own traditions of weaving and silver-work during the first millennium. Over the last fifteen centuries, Dharwad has seen a number of rulers and dynasties emerging and declining, bringing with them new cultural practices and styles of architecture. They include the Badami and Kalyan Chalukyas, the Rashtrakutas, the Bahmani sultans, the Vijayanagara kings, Adil Shah, the Marathas, Hyder Ali and the British. The resistance put up to the imposition of British rule was sig-nificant. Baba Sahib of Nargund and Chennamma Rani of Kittur fought tooth and nail to stop the British. Previously, the spread of the Portuguese from Goa, which is to the west of Dharwad, had been successfully stalled by the people of Dharwad.

During the twelfth century, it participated most actively in the Lingayat movement of Basava, challenging caste and creed discrimination and gender injustice. It generated the first move towards bringing all areas speaking Kannada together in the form of a Karnataka state. It gave rise to the most remembered movement of farmers in Karnataka since Independence. It sparked the Kannada language movement and also the freedom of expression movement by writers. Dharwad has had a wonderful mix of thinkers, writers, singers and social activists among its citizens. It also has a remarkable place in India s literary history, with three Jnanpith laureates to its cred-it: D.R. Bendre, V.K. Gokak and Girish Karnad.

Imran's bid to cling to power brought Pak closer to civilian coup

ormer Pakistan Prime Minister Imran Khan's unscrupulous and desperate attempts to cling on to power by inciting his followers to protest and rebellion was equivalent to a civilian coup, said a media report.

Khan, who became the first Pakistani Prime Minister to be ousted through a no-confidence motion, had said that he would fight "till the last ball". However, the statement actually meant using every trick, irrespective of how unethical and undemocratic it was, to cling on to power, reported Islam Khabar.

Moreover, the former premier refused to accept the new reality in the country even after his ouster as he opposed Shahbaz Sharif's candidature for the Prime Minister's post, citing court cases against him, and also threatened to resign en masse from the National Assembly if the demand was not met.

Khan's desperate attempts to stay in power followed by his unceremonious exit suggested how he was following the former US President Donald Trump who too was not ready to accept his defeat to the current US President Joe Biden. Khan, too, in a similar manner, refused to accept his ouster, alleging collusion between his political opponents and the US to topple his government.

Terming the protests by his fol-lowers as the rejection of the new government by the people, he claimed that the people of Pakistan have vowed to fight against the "for-



eign conspiracy" and the "imported government led by crooks".

Imran Khan's statement regarding Pakistan's "sovereignty and democracy" is quite contradictory to the actions he took to retain his power. The cricketer-turned-politician, who his opponents have claimed, was chosen by Pakistan's powerful army made several desperate attempts to retain his power as reportedly he even planned to sack Army Chief General Qamar Javed Bajwa. However, Khan's conspiracy failed since the information about his plan was intercepted by intelligence agencies, reported Islam Khabar.

Further, there had been repeated attempts by the Khan-led government to obstruct the no-trust motion, however, when it could not stop the motion from being tabled in the Assembly, it colluded with the President of Pakistan and the Speaker to dissolve the House. This attempt was also foiled by Supreme Court as it set aside the rejection of the no-trust motion.

When voting on the motion became inevitable, Imran Khan mulled the idea of imposing martial law in the country, which would have led to

the suspension of important institutions, including courts, according to the media outlet, which further notes his failure in this attempt as well.

Âfter all his attempts proved ineffective, Khan held his opponents responsible for the political turmoil in the country as he alleged their connivance with the US to topple the government. His praise for India as a "self-respecting nation" further suggests that he doesn't practise what he preaches, else he would have followed the example of Indian Prime Minister Atal Bihari Vajpayee, who peacefully relin-quished his power twice when he fell short of a required strength in the country's Parliament. Vajpayee later returned to power with the majority, however, Khan could not show the same statesmanship, reported Islam Khabar.

Instead, he refused to accept the defeat and threatened to gather his supporters out on the streets.

"I will not accept this imported government, I will take to the street. Only people can bring me to power and I will come back with the help of the people," the media outlet quoted him as saying before voting on the no-confidence motion.

Pakistan, which is not new to a military coup as the country had been under Army rule for over three decades, witnessed a civilian coup this time through Khan's desperate attempts to remain in power.



The United States is likely to announce a new military aid pack-age worth USD 750 million for Ukraine amid the ongoing war in the country, said a media report citing US officials. US President Joe Biden's administration is set to expand the scope of weapons it is providing to Ukraine with the Pentagon looking to transfer a range of sophisticated equipment including armoured Humvees, The Washington Post reported citing the officials.

According to the officials, the preliminary plans circulating among government officials and lawmakers in Washington included howitzer cannons, coastal defence drones and protective suits to safeguard personnel in the event of a chemical, biological or nuclear attack, however, it is not certain if all these items will be included in the final

package. Notably, the new package comes on top of over USD 1.7 billion of assistance provided to Ukraine by the US since Russia launched its military operation on February 24. Meanwhile, Pentagon Spokesman John Kirby informed that Ukrainian defence minister Oleksii Reznikov spoke with US Defense Secretary Lloyd Austin on Tuesday. The discussion was part of a "constant dialogue and conversation" between the two officials and focused in part on the weapons and other assistance being provided to Ukraine, ac-cording to The Washington Post. On February 24, Russia launched a "special military operation" in Ukraine, which the West has termed an unprovoked war. As a result of this, the Western countries have imposed several crippling sanctions on Moscow.

down on students protesting for democratic reforms in various major cities across China led to a massacre of reportedly thousands of unarmed citizens on Tiananmen Square in Beijing, revealing the brutality of the country on its own people.

The issue is still taboo in China where the families of the victims seeking to commemorate the occasion are harassed by the authorities.

The victims of the massacre are still awaiting justice as the accountability for the tragedy was never fixed. In a bid to expose the "state-led terror and suffocation", the families of victims gather at Tiananmen Square every year. "It feels that there's no end in sight. We are all at ages where death can happen any day, and we'd like to see the truth revealed and justice upheld while we are still alive," Restel-

li quoted Yin Min, mother of a 19-year old boy killed in the 1989 massacre, as saying.

However, justice remains far-fetched amid China's crackdown on the families of the victims. In fact, the Chinese authorities detained, questioned, and arrested the families of the victims and social activists who were planning to mark the anniversary of the massacre. These suppression tactics have seen a surge since Xi Jinping took the reins of China in 2013, writes Restelli

On the 30th anniversary of the massacre in 2019, families and activists were kept under surveillance to stop them from demonstrating for justice. According to Chinese rights activist Hu Jia, the state security police followed her everywhere,

even during a trek to remote mountains. Moreover, families of the victims were followed and their telephones were monitored in order to prevent them from marking the anniversary or speaking to journalists.

Further, the members of a group named 'Tiananmen Mothers' were placed under house arrest ahead of the 1989 movement's anniversary. "I asked them what date they would be leaving on, and they said they didn't know ... Human rights violations are so common in China," said Zhang Xianling, who lost her son in the massacre. In a letter published in 2016, as many as 131 'Tiananmen Mothers' recounted their ordeal while seeking justice as they said that they were subjected to constant harassment, intimidation.

PMFBY-Every cloud has silver lining

overnments can use crop insur-Jance to stabilize farm income over time, assist farmers when agriculture production is adversely impacted by a catastrophe, and improve farmers' creditworthiness. In addition, government-subsidized crop insurance programmes smooth government budgets across years by subsidizing premiums up front, leaving claims to insurers.

Natural disasters such as droughts and floods pose a great threat to agriculture in India, and financial arrangements (such as crop insurance) can play a key role in relieving fiscal pressure on government and farmers. Catastrophic events cause distress to many farmers. Without crop insurance, such distressful events could easily lead to income loss, inability to repay loans, and in the most extreme of cases, farmer suicide. Crop insurance in India has evolved to be-

come more comprehensive and wide-spread since the 1970s, when it covered only select areas and crops. In consultation with stakeholders, government decides how to design the most comprehensive and effective program, addressing issues along the way.

Pradhan Mantri FasalBima Yojana (PMFBY) replaced existing claim sub-sidy-based models in 2016. PMFBY is one of a number of government initiatives that provide farmers with some level of security when faced with risky and uncertain situations.

Despite billions in premium subsidies every year globally, stakeholders are still unhappy. There is no perfect crop insurance scheme, and PMFBY is no exception. The criticism is true to some extent, but not everything. There is an important point to note, the government is taking feedback regularly and making changes as needed in key areas of dissatisfaction. It's a continuous process. Although some states and insurers have pulled out of the scheme, still, its success is far from ordinary.

Here are some salient features and achievements that will help readers understand success:

Protection value: In the pre-PMF-BY era, the average sum insured per hectare was Rs 16,388, which increased to Rs 44,829 by 2020-21, providing adequate insurance coverage.

National Crop Insurance Portal (NCIP) - a centralized IT platform is developed linking the Central Government with all States and UTs, all participating Insurance Companies, 170,000 bank branches, and a network of 44,000 Common Service Centers (CSC) to ensure ease of enrolment of non-loanee farmers, better administration and coordination amongst all stakeholders. As compared to the pre-PMFBY period, when farmers had to line up at bank branches to enrol, often requiring multiple visits, this is a huge convenience. Crop yield estimation utilizes technology both to audit the results of crop cut-ting experiments (CCEs) with CCEApp, and to reduce the number of CCEs by using smart sampling techniques

Farmer's Direct Credit: PMFBY remits claims directly to farmer's bank accounts. On average over 1/3rdof all insured farmers receive compensation, a large operation managed effectively, allowing farmers to receive compensation quickly. This also eliminates malpractice. Overall Claim Ratio: The claim ratio for the period 2016-17 to 2019-20 was 88.6%, by no means a modest figure. Including the additional cost of insurers and reinsurers, the industry has almost a 100% combined ratio. Gross claim ratio of 88.6% translates to 540% on farmers' share of premium. Compensation for Key events: Since 2016, the weather has adversely affected nearly every state at least once, and farmers received decent compensation during these events. The scheme's ability to protect farmers from extremely adverse

weather events in Tamil Nadu, Maharashtra, Karnataka, Madhya Pradesh, Chhattisgarh, etc. shows its worth.

Timely payment for losses: The key takeaway of insurance is timely payment. PMFBY included guidelines for the timely processing and settlement of claims (subject to subsidy) through penalties for delays. Although not perfect, it improved timeliness.

Index 'plus' Insurance: PMFBY combines yield index and indemnity insurance. Yield index captures widespread calamities, while individual farm loss assessments cover localized calamities. PMFBY has captured and handled losses due to sporadic events over the past few years. Maharashtra, Haryana, Rajasthan, Uttar Pradesh are testaments to the localized losses recovered through PMFBY It doesn't mean all is well with PMFBY. In spite of the Government of India taking feedback and implementing changes as necessary, some states remain concerned about (i) high premium rates for certain crops and (ii) a premium subsidy cap on the Central Government's share that adds to the financial burden of the state. Perception of high premiums has led some states to demand a portion of premium refund during normal crop years.

There may be a solution to the above concerns by (i) changing the threshold yield calculation method (ii) giving greater weight to technologybased yields and (iii) establishing a mechanism for a fair profit sharing arrangement between states and insurers.

Threshold yield calculation is based on average yield, which is currently based on the last seven years after eliminating two of the lowest yields. A more balanced calculation can be achieved by excluding one highest yield and one lowest yield (Olympic average). According to this calculation applied to major Kharif crops in Gujarat, premium rates are dropping by about 20 percent.


MLA Kulwant inspects road construction work
