



SC halts demolition drive in Delhi's violence-hit Jahangirpuri

AGENCY NEW DELHI, APRIL 20

Supreme Court on Wednesday ordered to maintain a "status-quo" on the demolition drive conducted by North Delhi Municipal Corporation in Jahangirpuri in the national capital. The court said it will hear

tomorrow the petition challenging the special joint encroachment removal programme in Jahangirpuri of the civic bodies including the NDMC and the PWD.

A bench headed by Chief Justice N V Ramana hearing the submission of Senior Advocate Dushvant Dave ordered status quo in the present situation and said the petition would be listed before an appropriate bench.

The court's order came even as bulldozers started razing structures in the area as per orders of the BJP-controlled North Delhi Municipal Corporation and amid heavy police presence. The "encroachment removal action

programme" was scheduled to take place on Wednesday and Thursday after the area witnessed violence on April 16

during a religious procession In the hearing senior Advocate Dave mentioned that "unconstitutional, unauthorised demolition" was taking place in Jahangirpuri where riots took place. Senior Ad-

vocate Dushyant Dave also apprised the court that the demolition drive, which was scheduled to be carried out in the afternoon had begun in Jahangirpuri at 9 am today. Meanwhile, senior Advocate Kapil Sibal mentioned the plea filed by Jamiat Ulama-I-Hind's plea against employing bulldozers to raze houses of persons

suspected to be involved in

crimes. Jamiat Ulama-I-Hind moved the Supreme Court against employing bulldozers to raze down the houses of persons suspected to be involved in criminal incidents such as violence. Jamiat Ulama-I-Hind has





urged the Supreme Court to issue appropriate direction to the Centre and state governments that no lasting precipitative action be taken against any accused in any criminal proceedings and issue directions that residential accommodation cannot be demolished

Seven members of a family, including a couple and their five children were burnt alive in a fire that broke out in their shanty near Tajpur dump in this industrial town on Wednesday morning. The deceased have been identified as Suresh (54), his wife Raur Devi (50) and their children Rakhi (15), Manisha (10), Chanda (8), Geeta (6) and Sunny (2). Police said the migrant family earned their livelihood from rag picking. The incident took place at around 0200 hours in the morning when the family was sleeping in the shanty near the municipal garbage dump yard on Tibba road here. The family did not get a chance



Drug peddlers' property of Rs 2.42 cr confiscated in Haryana

CHANDIGARH: Tightening the noose around drug peddlers, Haryana Police has succeeded in getting the orders to freeze properties worth over Rs 2.42 crore belonging to five drug peddlers and their family members claiming that they earned the property from the illegal trade of drugs. Giving this information here on Wednesday, a Haryana Police spokesperson informed that the competent authority in New Delhi had ordered to freeze the movable and immovable property of accused Sukhander Singh aka Mander Singh, Deep Singh aka Babbi, Daljit Singh, Jaspreet Kaur and Chinderpal Kaur, all residents of village Panniwala Morikan in Sirsa district.

Ropar police serve notice to Kumar Vishwas, Alka Lamba

CHANDIGARH: Ropar police has reached the home of famous poet and former Aam Aadmi Party (AAP) leader Kumar Vishwas in Ghaziabad in Uttar Pradesh on Wednesday. The police had gone to serve the notice on Vishwas, who had been vocal against AAP supremo Arvind Kejriwal, regarding a case registered against him at Ropar on April 12. The police claimed that "a man had complained that while he, along with AAP supporters, was visiting villages in the state for hearing people' grievances, a few masked men intercepted them calling them 'Khalistani'. Similar incidents have been taking place regularly. All this started after Kumar Vishwas issued inflammatory statements against Arvind Kejriwal on news channels and social media platforms alleging the AAP's links with separatist elements." Acting on the complaint, a case under the IPC and Representation of Peoples Act was registered against Vishwas. In the run-up to the Punjab assembly elections, Vishwas had posted a video alleging that Kejriwal, during assembly elections of 2017, used to meet people who had sympathy with the terrorists. The police said that as a result of these statements and videos, the peaceful atmosphere of Punjab is likely to be disturbed .

He added that it is important to have all necessary docu-ments and get certified for chemical storage. He directed the officers of the Power Department to investigate the above incidents and take precautionary steps to prevent them in the future. While expressing grief over the death of labourers due to poisonous gas in the sewerage treatment plant recently, he said that in such cases SOP should be made by the labour department so that the workers who do sewerage cleaning, etc. should be ensured with adequate oxygen cylinders or other necessary equipments.

When malaria fever is confirmed, it is treated free of charge by the health department. He said that this fever is caused by the bite of female anaphylaxis mosquito. This mosquito bites at night and in the morning. That is why we should wear clothes that cover the whole body while sleeping at night. Use mosquito nets and mosquito repellent creams at bedtime. This mosquito thrives on standing water. That's why we should keep the back tray of water tanks, coolers and refrigerators clean.

Action against 14 teachers for

DHARAMSHALA: Himachal Pradesh Board of School Education has taken action against 14 teachers for negligence in work. The State Board of School Education will no longer take services from these teachers for two to three years. The Board of School Education takes the services of teachers in many tasks, including setting papers and getting answer sheets evaluated in annual examinations, in return for which teachers are paid. Out of about 14 teachers, none of the teachers did not set the paper properly, then some did not even evaluate the answer sheet correctly. Chairman of the Board of Education Dr. Suresh Kumar Soni said that the Board takes the services of teachers in many works. The board will no longer take services of teachers who take such carelessness. During the 12th examination in March 2020, one from Kangra, one from Bilaspur and three teachers from Mandi, one from Kangra, 1-1 teacher from Una, Solan Hamirpur and Bilaspur also did not perform their responsibilities properly. For this reason the board has decided not to take their services by marking them.

Tibetans have aroused great anger against China over the first arrest and subsequent disappearance of Tibetan writer Lobsang Lundup, composer Lundup Drakpa and teacher Rinchen by China. Whereas in this case a group of six UN experts has also expressed concern. UN rights experts have detailed three specific cases of gross violations of rights by China in Tibet and expressed serious concern at the repressive actions by China against a large number of Tibetans for their rightful participation in the promotion of Tibetan culture, In which China's actions against Tibetans through education that criticize Chinese rule in Tibet. In sharp words, UN experts asked China to disclose their location and whereabouts. Outlining the legal basis for the arrest, detention and conviction of Lobsang Lundup and Lundup Drakpa, experts questioned China about the compatibility of these measures with international human rights norms and standards. With special reference



to the case of Tibetan teacher Rinchen Ki experts asked China to provide an explanation on legal grounds for Rinchen Ki's arrest and detention. Tibetan writer Lobsang Lundup, better known by his per name Dhi Lhaden, was arrested in June 2019 while he was working at a private cultural education center in Chengdu, Sichuan province. For the first 18 months, he was detained without trial, barring him from visiting family. In 2021, a Chinese cour imprisoned Lobsang Lundup for a period of four years, without the presence of his family, for allegedly disturbing social order in a closed-door trial. Lobsang Lundup Amdo hails from the village of Dida in Pema County in the Tibetan traditional province of Golog. He taught Tibetan language, history and Buddhism in Tibet

Punjab achieves 50 percent Chhina inaugurates road repair of wheat procurement target of 130 LMT SACHIN MOUDGILL, SARABJIT LUDHIANVI LUDHIANA, APR 20 **CHANDIGARH, APR 20**

Punjab has successfully accomplished 50 percent of total procurement operations within 20 days after commencement of wheat procurement from April 1, 2022. In a statement issued here, an official spokesperson of Punjab Government informed that out of the total estimated arrival of 130 LMT of wheat, the state Mandis recorded the arrival of 67.50 LMT so far, of which 65.40 LMT had been procured during the ongoing Rabi Marketing Season (RMS). "Nearly 27 percent more wheat arrived in mandis this year as compared to corresponding period of last year, with 53.35 LMT of wheat had arrived till date in the previous Rabi Marketing Season", he added.

Pertinently, as many as 61.95 LMT of wheat purchased by government agencies while the remaining 3.45 LMT by private agencies. Sangrur district leads the state with the arrival of 7.27 LMT of wheat, of which 7.18 LMT had been procured till April 19. After Sangrur, Ferozepur and Patiala falls at second and third place with the arrival of 5.40 LMT and 5.31 LMT wheat respectively. Notably, the wheat was sown over 35.02 Lac hectares in the state and the target for wheat production, as per estimates, was 171 LMT out of which 130 LMT expected to reach the grain markets during the ongoing procurement season. Meanwhile, the state government warned the traders, firms and individuals involved in procuring wheat directly from farmers without paying market fee and Rural Development Fund (RDF) to immediately stop this practice or be ready to pay heavy penalty.



Active COVID-19 cases in country rise to 12,340

AGENCY NEW DELHI, APR 20

With 2,067 new coronavirus infections being reported in a day, India's total tally of COVID-19 cases rose to 4,30,47,594 while the active cases increased to 12,340, according to the Union Health Ministry data

updated on Wednesday. The death toll climbed to 5,22,006 with 40 fresh fatalities, the data updated at 8 am stated. The active cases comprise 0.03 per cent of the total infections, while the national COVID-19 recovery rate remained at 98.76 per cent, the ministry said.

An increase of 480 cases has been recorded in the active COVID-19 caseload in a span of 24 hours.

The daily positivity rate was recorded at 0.49 per cent and the weekly positivity rate was recorded at 0.38 per cent,



according to the health ministry. The number of people who have recuperated from the disease surged to 4,25,13,248, while the case fatality rate was recorded at 1.21 per cent. cumulative doses The

administered in the country so under the nationwide far COVID-19 vaccination drive has exceeded 186.90 crore. India's COVID-19 tally had

crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19. The country crossed the grim milestone of two crore on May 4 and three crore on June 23 last year.

The 40 new fatalities include 34 from Kerala, three from Maharashtra, and one each from Uttar Pradesh, Mizoram and Nagaland

A total of 5,22,006 deaths have been reported so far in the country including 1,47,830 from Maharashtra, 68,649 from Kerala, 40,057 from Karnataka, 38,025 from Tamil Nadu, 26,160 from Delhi, 23,502 from Uttar Pradesh and 21,200 from West Bengal.

The ministry stressed that more than 70 per cent of the deaths occurred due to comorbidities.

"Our figures are being reconciled with the Indian Council of Medical Research,' the ministry said on its website, adding that state-wise distribution of figures is subject to further verification and reconciliation.

New spectre

Inflation's resurgence is a threat to India's budding economic revival. Soaring prices of food, fuels and much else have firmly ensconced it centre stage, pushing aside other problems and testing economic management. At the start of the new fiscal year, growth expectations lie lowered, monetary tightening is on the anvil, and it is debatable how long fiscal policy can withstand the adjustment or financing pressures of higher food, fuel and fertilizer prices. The biggest setback is its interruption of the nascent upturn in the business cycle. This is a serious risk as households and businesses postpone or scale down expenditures even before these had resumed properly or taken off. In the backdrop of their emasculated state, during the pandemic and before that, an inflationary resurgence does not augur well for a strong recovery

That prices were rising all of last year is well-known. But the price growth had skipped foods; that in fuels was countered by reduced levies and a freeze on price increases last November, while firms absorbed more input costs and passed on less to the consumers. At the start of the year and until February, when the budget was framed and monetary policy reviewed, retail inflation was expected to be moderating during the last quarter itself. Subsequent developments have overridden that understanding. For one, the Russia-Ukraine war and the related economic sanctions have pushed up the global prices of oil, commodities, fertilizers, food grains, metals and more; a fresh round of disruptions to world trade has compounded these. Then, from mid-March onwards, the government steadily passed on higher import costs to retail prices of all fuels, cooking and transport petrol, diesel, LPG, LNG, CNG and so on. More recently, the Omicron outbreak in China has added to global supply woes with its strict lockdowns in major cities. Inflationary pressures persist abroad as well. It has been noted that the inflation rates in the United States of America and the European Union exceeded India's last month. However, the respective wellsprings and economic contexts are very different. In the advanced countries, inflation is a result of their large fiscal packages in the wake of the pandemic, exacerbated by the related supply deficiencies and de-mand distortions; fresh scarcities caused by the military conflict aggravated it further. The presence of both demand-pull and cost-push forces is compelling the central banks in the US and other advanced countries to raise interest rates and scale back liquidity measures.

Will China gain greater arms sales because of Russia's war?

hina is currently the world's fourthlargest military equipment exporter in the world. With significant numbers of countries set to spurn Russia after its invasion of Ukraine, and unwilling to face consequent sanctions, new sales opportunities could arise for Beijing.

Every year, the Stockholm International Peace Research Institute (SIPRI) releases data on arms exports. In its most recent report, issued in March, SIPRI calculated that China sold 4.6 % of international weapon exports from 2017-21.

Interestingly, this compared to China's 6.4% share of the global arms market in the preceding five-year period. This represented a 31% drop for China in terms of global arms sales, considerably lower than the 4.6% drop in global arms sales in 2017-21 compared to 2012-16.

In fourth place from 2017-21, China trailed only the USA, Russia and France. However, it came in ahead of traditional heavyweights such as Germany, Italy and the United Kingdom. Nearly half of Chi-nese weapon exports - 47%, in fact - went to closest ally Pakistan, while Beijing's next largest clients were Bangladesh and Thailand at 16% and 5% respectively.

Islamabad's dependence on China is in large part due to deteriorating relations with other countries, particularly the USA. Important Pakistani buys include J-10C and JF-17 fighters, SH15 155mm truck-mounted howitzers, VT4 tanks, HQ-16 and HQ-9 SAMs, Type 054A/P frigates and Hangor-class submarines. In all, some 79% of Chinese arms ex-

ports were destined for Asia in 2017-21. In this timeframe, 48 different countries procured Chinese equipment. Given the relative strength of China's position on the arms export table, it is perhaps surprising that China also appeared fifth in the international list of arms importers, behind India, Saudi Arabia, Egypt and Australia.

In 2017-21, China soaked up 4.8% of global arms imports, compared to 2012-16



when it imported 4.4%. SIPRI reported that 81% of China's most recent imports came from Russia, while 9.1% emanated from France and 5.9% from Ukraine.

At this point, it is important to issue a caution about SIPRI's data. The appearance of France is odd, and is mostly because SIPRI attributes helicopter sales to France, even though Airbus Helicopters claims not to be selling or licensing military helicopter sales to the People's Liberation Army (PLA) anymore. SIPRI noted: "Chinese arms imports remained stable between 2012-16 and 2017-21, and mainly came from Russia in both periods. However, China's arms imports are likely to decrease in the next few years as its industry is now capable of producing most types of major arms.

China is known as a supplier of affordable and functional military equipment, including small arms, armored vehicles, artillery, naval vessels, aircraft and missiles. This image has begun to change as China starts exporting higher-end equipment as it climbs higher up the value chain. Examples are the sale of 36 J-10C fighters to Pakistan, and the recent delivery of HQ-22 (FK-3) surface-to-air missiles (SAM) to Serbia. It remains to be seen how dramatically President Vladimir Putin's invasion of Ukraine will impact Russian arms sales. From 2016-21, Russia was the world's second-largest arms supplier, accounting for 19% of global exports. However, this represented a 26% drop compared to the preceding five years.

Undoubtedly, Russian sales will be hit by its war. Some countries will be put off dealing with Moscow and the fear of Western sanctions, plus Russian industry will struggle to produce equipment at rates it did previously as it faces the impact of sanctions. Electronic componentry and microchips will be more difficult to source, for instance. There are already unverified reports that some Russian arms plants have been forced to cease production as they struggle to source components. Russian defense industry's growing plight may open the door to some countries changing allegiance from Russia to China when they next go about buying military equipment. However, this is unlikely to represent a ma-

jor boom for Chinese military exports. In a piece for The Jamestown Founda-tion, John S. Van Oudenaren and Yani Na-jarian wrote: "Given Russia's clientele of authoritarian or hybrid regimes in Asia, the Middle East, Africa and Latin America, China would seem a logical candidate to fill in the gap. Upon closer examination, however, many of the major buyers of Russian arms appear unlikely to replace these purchases in favor of Chinese imports. Particularly since major Western arms exporters such as the US and France have shown little compunction about exporting advanced military technology to authoritarian regimes in the Middle East and Africa, and are likely to capture much of any market share lost by Russia.'

Furthermore, it should be remembered that Russia's major arms clients include India and Vietnam, both of which will never buy from China. Others like Egypt and Algeria could be more amenable to buying from China, however.

Buying Chinese does come with attendant customer risks, however. China, like Russia, is not renowned for aftersales support, and equipment can rapidly decline into non-functional machinery. The more sophisticated the equipment it sells, the more maintenance support it will require from China.

As an example, Jordan put its Chinesemanufactured CH-4 armed drones up for sale less than two years after buying them. Other nations such as Morocco, Nigeria and Turkmenistan have also moved on from Chinese armed drones to Turkish ones. A RAND Corporation study entitled "Defense Acquisition in Russia and China" stated: "The design of Chinese defense contracts also does little to encourage transparency and accountability. The language of contracts is simplistic and perfunctory, without clear technical or schedule obligations, which is unsurprising given that there is no formal legal authority in the defense industry to adjudicate contract fulfillment."







Singh, 36, got a breakthrough film debut with 2010's romcom "Band Baaja Baarat", backed Yash Raj Films, and has since starred in movies such as "Goliyon Ki Raasleela Ram-Leela", "Bajirao Mastani", "Padmaavat", all directed by Bhansali, and others like "Lootera" and "Gully Boy".

He is awaiting the release of "Jayeshbhai Jordaar", a social comedy written and directed by debutant filmmaker Divyang Thakkar.

When asked about what keeps him going in his film journey, Singh said he has become even more obsessed with the craft over the years.

"I must mention Mr Bhansali, who has really moulded me as an artiste along the way. I have learnt that the craft of acting is limitless. There are no boundaries, you can make your own rules as you go. I just want to keep exploring.

"My hunger for characters, stories, and work is becoming even more insatiable. I'm obsessed with films, characters, and this whole world. As obsessed as I was 10 years ago, if it's possible, I'm even more obsessive about my craft now," the actor told reporters here.



It would be dumb to do method acting in commercial movies, says Nawazuddin Siddiqui

ctor Nawazuddin Siddiqui says he can easily straddle the world of larger than life commercial films and quieter, more reflective independent cinema, being aware of the "kind of acting" both require from him. Siddigui, star of acclaimed dramas like the "Gangs of Wasseypur" series, "Photograph", "Raman Raghav" and "Manto" has often broken out and featured in big scale entertainers, like "Kick", "Bajrangi Bhaijaan" and his upcoming action drama "Heropanti 2".

In an interview with a news agency Siddiqui said commercial films package the performance of an actor and present them in a "new form". "There's a certain presentation of performances in commercial films. That form is entirely different. If you expect to use method acting here, then you're dumb. This is for fun, the audience of these films comes to enjoy. So, if you sit down to dissect my performances, maybe you'll find a lot of flaws. But if you take it as pure fun, one

would really enjoy," the actor said. Siddiqui, 47, is regarded one of the most versatile performers in the Hindi cinema today and has shown an impressive variety and rage through his characters. In 2019 alone, he played the role of Bal Thackeray in Thackeray, featured as a gentle street photographer in Ritesh Batra's critically-acclaimed Photograph and a Dubaireturned man looking for a bride in the comedy drama "Motichoor Chaknachoor".

Though Siddigui is certain he wouldn't use method acting when he is featuring in commercial films, the actor said he is not averse to dive deep with his performance in such projects provided there's no clash with the film's world.

In "Heropanti 2", where he is cast as a don opposite Tiger Shroff, the actor said the role offered him a chance to "have fun" and not "intellectualise" his character.

"Those 'acting' bits do come in when you see potential to be more serious and do the scene. 'Heropanti 2' also has

those sequences. There's 'dialogue-baazi' but it also has a realistic touch. But you can't intellectualise it, there's no scope. "If you do that, then the audience will get alienated. You need to know what

kind of acting is required, otherwise, the text and the subtext will differ. But here, the text is everything- what I'm saying, it is in your face- there is no in-depth study of what the dialogue meant, the how's and why's of it," he added.

"Heropanti 2" is the sequel to the 2014 film of the same name, which was directed by Sabbir Khan. The new film has been made by director-choreographer Ahmed Khan.

Siddiqui said he comes from stage training, where he was comfortable doing "all kinds of plays".

So, even as he awaits the release of "Heropanti 2" on April 29, he is also equally excited for his international project, Bangladeshi director Mostofa Sarwar Farooki's "No Land's Man", which he hopes gets a proper screening.
