## **Two Al-Badr** terrorists killed in Pulwama

encounter SRINAGAR: Two Al-Badr terrorists were killed dur-

ing an encounter in the Mitrigam area of Pulwama, the Jammu and Kashmir Police said on Thursday. "We had received infor-

mation about three terrorists in Mitrigam village of Pulwama on Wednesday and as soon as the police launched cordon and search operation, firing began from the opposite end," said Vijay Kumar, the Inspector General of Police (IGP). According to the IGP, these two terrorists were a part of the group of four terrorists killed earlier this month, in the Shopian encounter (April 14). The police have recovered two AK 47 rifles from their possessions. Earlier on Sunday, three terrorists, including a deputy commander of Lashkar-e-Taiba (LeT) and a Pakistani terrorist were killed in an encounter in Pulwama.

#### Gold declines by Rs 442; silver tumbles Rs 950

**NEW DELHI:** Gold in the national capital on Thursday fell by Rs 442 to Rs 51,010 per 10 grams in line with decline in international precious metal prices, according to HDFC Securities. In the previous trade, the

precious metal settled at Rs 51,452 per 10 grams. Silver also declined by Rs 950 to Rs 64,167 per kg from Rs 65,117 per kg in the previous trade. In the international market, gold was trading lower at USD 1,885 per ounce and silver was flat at USD 23.25 per ounce. "Gold prices traded weak with spot gold prices at COMEX trading at USD 1,885 per ounce on Thursday. Gold prices fell to a two-month low as the dollar rallied on expectations of aggressive monetary policy tightening by

# Heatwave, coal shortage fuel blackouts across country

AGENCY NEW DELHI, APR 28

A potent combination of sweltering summer and acute coal shortages have triggered blackouts across many parts of the country as states struggle to manage record demand for electricity and low feedstock at power

With Chandigarh recording a maximum temperature of 39 degrees Celsius on Wednesday and predicted to see a spike by two to three notches on Thursday, experts have warned that the extreme heat so early in this year is particularly dangerous. The maximum tempreatures will be seen on Saturday and Sunday, which may go up to 46 degrees Celsius. From Jammu and Kashmir to

Andhra Pradesh, consumers are facing power cuts ranging from 2 hours to 8 hours. Factories are the worst hit as the industrial sector is the first port of call for regulating electricity sup-After the hottest March on record,

a large part of the country continue to experience extreme heat in April, sending power demand to an all-time high. The total electricity shortage in the country has hit 623 million units, surpassing the total shortage in At the heart of the crisis are low



inventories of coal -- the fossil fuel that produces 70 per cent of India's electricity. While the government insists that there is enough coal available to meet the demand, the reduced availability of railway rakes to transport coal has led to coal inventories being at the lowest pre-summer levels in at least nine years. Also, with international energy prices shooting up following the war in Ukraine, coal imports have dipped. Besides measures to increase coal supplies to power plants, the Union government has asked states to step up coal imports for the next three years to build up in-

Thermal plants across the country are grappling with coal shortages, indicating a looming power crisis in the country, All India Power Engineers Federation (AIPEF) said.

Peak power demand met or the highest supply in a day was 200.65 GW on April 27 while peak power shortage was 10.29 GW.

Latest data showed that 147 nonpit head plants with total capacity of over 163 GW monitored by the Central Electricity Authority (CEA) had 26 per cent of the normative coal stocks on April 26. These plants had

14,172 thousand tonnes of coal against the norm of 57,033 thousand

Uttar Pradesh, India's most populous state, has a 3,000 MW deficit. Against the demand of around 23,000 MW, the supply is just 20,000 MW, resulting in load shedding in rural areas and smaller towns.

According to the data made available by the state power department, at present, electricity is being supplied in rural areas on an average of 15 hours 7 minutes against the scheduled 18 hours. Similarly, electricity is being supplied on an average of 19 hours 3 minutes against the scheduled 21 hours 30 minutes in towns and 19 hours 50 minutes against 21 hours 30 minutes in tehsil headquarters. However, 24 hours of electricity is being provided at district headquarters. Samajwadi Party President Akhilesh Yadav hit out at the BJP government in Uttar Pradesh for failing to provide sufficient electricity. The government claims to provide 18 to 20 hours of power in rural areas while only 4 hours of electricity is being made available and there is a blackout all night in many places. Kashmir valley is facing one of its worst power crisis as unscheduled and prolonged cuts in supply in the holy month of Ramzan have left the people distraught.

# Delhi-Centre power row: SC to decide on referring dispute to Constitution bench AGENCY NEW DELHI, APRIL 28

The Supreme Court on Thursday reserved its order on whether or not to refer to a five-judge Constitution bench a contentious issue of who control administrative es in Delhi.

The Central government has sought a hearing by a five-judge bench on the matter pertaining to a legal dispute between the Delhi government and the Centre regarding the control over administrative services in the national capital.

The Aam Aadmi Party-led Delhi government strongly opposed the plea of the Central government. A bench of Chief Justice of India

NV Ramana, Justices Surya Kant and

Hima Kohli reserved orders on an application filed by the Centre seeking referral to a Constitution bench for a holistic interpretation of Article 239AA

The bench said, "We will decide whether or not to refer it to a fivejudge bench as early as possible. In case, we constitute a five-judge bench

to hear the issue, we would like the arguments to be completed before May 15."

Solicitor General Tushar Mehta appeared for the Centre while senior advocate Abhishek Manu Singhvi

represented the Delhi government. Delhi government filed petitions in the apex court on control over serv-

ices and challenging the constitutional validity of the amended GNCTD Act, 2021 and the Transaction of Business Rules, which allegedly give more powers to the Lieutenant Governor respectively, saying they are "prima facie correlated".

General Tushar Mehta contended that the case should be heard by a Constitution Bench and not a three-judge one as it involved several crucial constitutional questions of law.

The Central government contended that despite a Constitutional bench comprehensively evaluating a scheme of governance for the national capital, the administration continued to suffer on a daily basis due to a lack of clarity in relation to the executive authority.

Ministry of Home Affairs (MHA) has decided to introduce changes in the Civil Registration System (CRS) in India as the country has been facing challenges in terms of timelines, efficiency and uniformity leading to delayed and under-coverage of births and deaths in the country.

The plan has been mentioned in MHA's Annual Report 2020-2021, pointing out that it will be taken up to address the challenges faced by the system in providing prompt service delivery to the public.

The history of CRS in India dates back to the middle of the 19th century. In 1886, a Central Births, Deaths and Marriages Registration Act was promulgated to provide for voluntary registration throughout British India.

Post-independence, the Registration of Births and Death Act (RBD Act) was enacted in 1969 to promote uniformity and comparability in the registration of births and deaths across the country and compilation of vital statistics based thereon. With the enactment of the Act, registration of births, deaths and stillbirths has become mandatory in India.

The Registrar General, India (RGI) at the Čentral Government level coordinates and unifies the activities of registration throughout the

# Chief Minister to launch Nirmal Sarovar Yojana on May 1

**CHANDIGARH, APRIL 28** 

Haryana Chief Minister, Sh. Manohar Lal will launch Nirmal Sarovar Yojana in the state on May 1, 2022, under which 111 Nirmal Sarovars will be inaugurated across the State.

Sharing more information in this regard, spokesperson of Haryana Pond and Waste Water Management Authority said that on May 1, 2022, a State-Level Function would be organized at Sonipat and Nirmal Sarovars would be inaugurated at 111 places by the representatives of the Parliamentary and Assembly Constituencies under the leadership of the Chief Minis-

The spokesperson said that under the Amrit Sarovar Yojana launched by Prime Minister, Sh. Narendra Modi, Nirmal Sarovars will be built in Haryana. In the first phase, 1650 ponds have been identified in all 22 districts of the state, which includes 115 urban and 1535 rural ponds.

The spokesperson said that the development of these ponds would be done as per the prescribed norms such as the minimum area of the pond should be one acre or more along with the proper depth of the pond and construction of embankments with proper slope etc. Besides this, trees like Bud, Peepal, Neem, etc. will be planted on the banks of these ponds ensuring a healthy environment. The wastewater flowing into the ponds will be treated so that it can be reused for drinking purposes for the animals, fish farming and irrigation. The rejuvenation of the ponds will also improve the depleting groundwater level. The spokesperson said that as per the data collected by Haryana Pond and Waste Water Management Authority as of April 27, 2022 as many as 18827 (rural 17971 and urban 856) ponds located on government land have been identified in the state

through PDMS software. The wastewater flowing into these ponds is being treated through Constructed Wetland Technology so that the water from these renovated ponds can be used for above mentioned purposes. Apart from this, groundwater recharging

work is also being done. The spokesperson informed that out of the first 18 model ponds identified in the year 2019-20, work on 9 ponds has been completed and the remaining 9 ponds are likely to be completed by December 31, 2022. Apart from this, the work of treatment of sewage water of Tributary drain no-4 in Gohana, Sonipat is also being done through Constructed Wetland Technology. The spokesperson said that as per the guidelines issued by the Chief Minister, Sh. Manohar Lal, the Authority has prepared the second and third phase action plans for the financial years 2021-22 and 2022-23 respectively for the restoration.


#### **Tempos risking lives** of students

#### **Punjab and Haryana** face long power cuts

**BAHADURJEET SINGH** RUPNAGAR: Punjab and Haryana are both facing a power shortages of about 2000 MW leading to the imposition of long power cuts for 6 to 8 hours on rural domestic consumers and of lesser duration in cities. On Wednesday there was a shortage of 282 lakh units in Punjab. The power supply was 1684 lakh units against the demand of 1966 lakh units. With the rise in day temperature, the maximum demand is around 9600 MW with a shortage of 2050 MW. The power cuts for the urban industry is of 6 hours, rural consumers power cuts are for upto 12 hours, and in cities unscheduled power cuts are imposed. The PSPCL got a big relief as one unit of 210 MW at Rupnagar thermal plant, which was under shut down due to boiler leakage is ,was revived on Thursday.One unit of the thermal plant is on annual maintenance. The 660 MW unit of Talwandi Sabo, which was also shut down few days back due to boiler leakage, may also come on Friday. Rupnagar thermal plant has 8.3 days coal stock, while Lehra Mohabbat thermal plant has 4 days

# Ordinance approved by Cabinet yet to be promulgated by Governor

GAURAV GOEL CHANDIGARH, APR 28

Two weeks back on April 13, Punjab Cabinet in a meeting presided over by Chief Minister Bhagwant Mann approved the Punjab Rural Development (Amendment) Ordi-

The aforesaid Ordinance seeks to amend Punjab Rural Development Act, 1987 in line with the revised principles laid down by the Department of Food and Public Distribution, Ministry of Consumer Affairs and Public Distribution, Government of India on February 24, 2020.

However, the aforesaid Ordinance is yet to be promulgated by Punjab Governor B.L. Purohit even after passage of two weeks since its approval by the State Cabinet for the reasons best known to the concerned authorities.

Meanwhile, an Advocate at Punjab & Haryana High Court, Hemant Kumar, recently raised legal (read constitutional) questions over the timing of decision of Bhagwant Mann's Cabinet pertaining to approval to the aforesaid Ordinance.



The Advocate asserts that under Article 213 of Constitution of India, any Ordinance can be promulgated by the Governor of a State only when the Legislative Assembly of that State is not in session.

He says as far as current 16th Punjab's Assembly is concerned, it got duly constituted on March 11, 2022 vide issuance of statutory notification by Election Commission of India (ECI) under Section 73 of Representation of the People Act, 1951 however its First Session was summoned via a Notification dated 16 March 2022 issued by the State Governor under Article 174(1) of Constitution of India on March 17, 2022 i.e. a day after Bhagwant Mann took Oath of Office and Secrecy as Chief Minister of Punjab.

After administering Oath to all newly elected MLAs by Pro tem Speaker, Inderbir Singh Nijjar, AAP MLA from Amritsar South on March 17, 2022, there was election of Kultar Singh Sandhwan, AAP MLA from Kotkapura as regular Speaker of Punjab Assembly on March 21, 2022. It was followed by passage of two Bills viz. Punjab Appropriation Bill, 2022 and Punjab Appropriation (Vote on Account) Bill, 2022 in the House.

Thereafter on March 22, 2022 after the House was adjourned sine die by newly elected Speaker Sandhwan, it was however not prorogued by the Governor under Article 174(2)(a) of Constitution of India. Prorogation means formal discontinuance of meetings (Session) of House by the State Governor by issuing a formal Order which is different from adjourning the House sine-dine, which however is ordered by the Speaker, asserts Hemant. After a few days, the House was reconvened by the Speaker on April 1, 2022 and on that day the Punjab Assembly passed a resolution reaffirming claim and right over Chandigarh as Punjab's Capital seeking its immediate transfer to the State. Interestingly, after the House was adjourned sine die by the Speaker that day, it was still not prorogued by the Governor.

Hemant says he constantly kept an eye over the issuance of requisite Notification by Punjab Governor regarding prorogation ever since the House was adjourned sine die second time by the Speaker on April 1, 2022.

However, such Notification came to be published in Punjab Government Gazette Extraordinary on 18th April, 2022. However, the Order by Punjab Governor BL Purohit in this regard is dated 16 April 2022. The Advocate wonders why there has been a delay of two days in this regard i.e. signature of prorogation Notification by the Governor and its Gazette Publication by Punjab Vidhan Sabha Secretariat. Amidst all this, the question arises if the House got prorogued with effect from April 16 or April

## **PSPCL** facing financial strain over non-payment of govt dues: AIPEF pending payments of electricity bills up to March end-

All India Power Engineers Federation (AIPEF) Spokesperson V K Gupta on Thursday said Punjab State Power Corporation Ltd. (PSPCL) is facing financial strain due to non-payment of pending electricity dues by various government departments and balance subsidy for the last financial year on account of free power to agriculture and subsidised power to other sets of domestic and industrial consumers. In absence of timely support from the Punjab government, PSPCL has been forced to go for the shortterm loan of Rs 500 crore even for the purchase of power in April this year, he said in a statement here. The

ing this year from 47 government departments to PSPCL is Rs 2650 crore. The biggest defaulter is rural water supply connections whose frozen amount is of over Rs 1277 crore with more than 10500 connections.

Similarly, the frozen amount of urban water supply connections with 3900 connections is Rs 485 crore and the pending payments against the current bill of urban water supply amount to Rs 76 crore. Local self-government owes PSPCL more than Rs 431 crore. The departments which owe more than Rs 95 crore each are Health and family welfare. Home Affairs and Justice, and water supply and sanita-

# **EDITORIAL Intrinsic value**

eighbourhoods in Calcutta with names like Kadapara, Garanhatta, Bagmari, Entally (Hentally), Halsibagan, Keoratala and Nonapukur tell us that these were all part of the mangrove ecosystem — the Sunderbans — that the city pushed away as it grew. The names, Garia (Kandelia candel), Garan (Ceriops sp.), Hental (Phoenix paludosa), (K)Halsi (Aegiceras corniculatum), Keora (Sonneratia apetala), are of mangrove plants, while kada (swamp), and nona (brackish) are attributes of the unique habitat of the bag (Panthera tigris).

The Sunderbans today are about half of what they were in the 1830s and possibly a quarter since Job Charnock's time, but they are still among the largest mangrove deltas in the world, and one of the 257 natural World Heritage sites and a Ramsar site. For three quarters of the 19th century, the Sunderbans witnessed constant assault. It was not until William Schlich, the Conservator of Forests in 1874, that the importance of the Sunderbans for purposes other than cultivation was realized. Schlich argued, "It is our duty to see that the supply [of firewood and timber] is not exhausted... the demand is certain to increase, and we must... make sure that the increase... is provided for. It has been said that the supply is inexhaustible, but such is not the case... the western part of the Sundarbans, which is that nearest to Calcutta, is already exhausted to a large extent, and... fuel-cutters proceed more to the east year after year." He suggested that "... if the Sundarbans remain open to all comers, and if certain restrictions are not introduced, it seems no doubt that the supply will fall short of the demand... Sundarbans should be taken under forest management without de-

It was the 'instrumental value' — because of the existence of much-needed wood, fish, and honey that saved the Sunderbans through changes in management policy. For a proximate forest, it is the instrumental value that saves it from obliteration. The Sunderbans were brought under forest management in 1875. "Reserved" and "Protected" forests were constituted under Act VII of 1878. By 1890, about 4,480 square kilometres in 24-Parganas were "Protected" forests. The Sunderbans functioned as a production unit, run by the State until 1980. This changed after the National Forest Policy of 1988 and a 1997 Supreme Court judgment leading to the discontinuation of forest working plans, eliminating harvesting the forest for firewood and timber. By this time, the intrinsic value had been instated. The process started with the 10th general assembly of the IUCN in New Delhi in 1969, followed by Project Tiger in 1973 when the Sunderbans were designated as one of the first nine tiger reserves in the country.

# Human greed leads to chronic land degradation

and is being degraded and damaged in an unsustainable manner due to human activities, according to a new UN report.

Up to 40 per cent of earth's land has already been degraded, mainly through modern agriculture and if business as usual continues, the report projects an additional degradation by the year 2050 of an area almost the size of

The second edition of the 'Global Land Outlook' (GLO) from the United Nations Convention to Combat Desertification (UNCCD), which comes ahead of the UNCCD's COP15 in Africa, sheds light on the way land resources - soil, water and biodiversity are currently mismanaged and misused and how it threatens the health and continued survival of many species on Earth, including our own.

The report, however, says that there is hope of containing climate change and species loss if the lands are restored and protected.

Land degradation, it says directly affects half of humanity and threatens roughly half of global GDP (USD44 trillion).

The report highlights nations' current pledge to restore 1 billion degraded hectares by 2030 requires USD 1.6 trillion this decade - a fraction of annual \$700 billion in fossil fuel and agricultural subsidies.

The GLO 2 report has been in the making for five years with 21 partner organizations, and with over 1,000 ref-

It offers an overview of unprecedented breadth and projects the planetary consequences of three scenarios



2050: business as usual, restoration of 50 million square km of land, and restoration measures augmented by the conservation of natural areas important for specific ecosystem functions.

It also assessed the potential contributions of land restoration investments to climate change mitigation, biodiversity conservation, poverty reduction, human health and other key sustainable development goals. "At no other point in modern history has humanity faced such an array of familiar and unfamiliar risks and hazards, interacting in a hyper-connected and rapidly changing world. We cannot afford to

underestimate the scale and impact of these existential threats. Conserving, restoring, and using our land resources sustainably is a global imperative, one that requires action on a crisis footing...Business as usual is not a viable pathway for our continued survival and prosperity," the report warned.
GLO2 also mentioned hundreds of

examples from around the world that demonstrate the potential of land restoration.

The report comes ahead of the UNCCD's 15th session of the Conference of Parties to be held in Abidjan, Cote d'Ivoire (COP15, 9-20 May).

"Modern agriculture has altered the

face of the planet more than any other human activity. We need to urgently rethink our global food systems, which are responsible for 80 per cent of deforestation, 70 per cent of freshwater use, and the single greatest cause of terrestrial biodiversity loss," Ibrahim Thiaw, Executive Secretary of the UNCCD, said.

"Investing in large-scale land restoration is a powerful, cost-effective tool to combat desertification, soil erosion, and loss of agricultural production. As a finite resource and our most valuable natural asset, we cannot afford to continue taking land for granted," Ibrahim added.

# China's inadequate response to unprecedented crisis disappoints Sri Lanka

This phone call came after China International Development Cooperation Agency (CIDCA) pledged an urgent emergency humanitarian aid of RMB 200 million to Sri Lanka. Although China extended humanitarian assistance, it refused to restructure the

debt of the island nation.

According to True Ceylon, China's offer of assistance to bail out Colombo from its current economic crisis is widely seen as inadequate.

Earlier, Sri Lanka had requested China for financial assistance and restructuring of its debt owed to China, which constitutes about 10 per cent of its total external debt burden.

# Girls' performance in mathematics now equal to boys

In mathematics, the gender gap favouring boys in early grades grad-Lually disappears, according to a new publication by UNESCO's Global Edu-

cation Monitoring Report. The report calls for us to think harder about gender inequality and the barriers that still hold girls back from realising their potential. Deepening the debate on those still left behind, an annual UN-ESCO gender report, analysed data from 120 countries in primary and secondary education to offer a global pic-

The findings show that in the early years, boys perform better than girls in mathematics but, this gender gap disap-



pears later. This research confirms that the gender gap in learning has closed even in the poorest countries. And in

some countries, the gap is now reversed.
For example, by grade 8, the gap is in favour of girls in mathematics by 7 percentage points in Malaysia, by 3 points in Cambodia, by 1.7 points in Congo and by 1.4 points in the Philippines. However, biases and stereotypes are still likely to affect learning outcomes. Even though girls catch up in mathematics in upper primary and sec-ondary education, boys are far more likely to be overrepresented among the highest performers in mathematics in all countries. In middle- and high-income countries, girls in secondary school are scoring significantly higher in science. Despite this advantage, girls are still less likely to opt for scientific careers, indicating that gender biases could still be obstacles to the pursuit of further education in the science, technology, engineering and mathematics (STEM)

Girls outperform boys in reading While girls perform well in mathematics and science, they perform even better in reading. More girls achieve minimum proficiency in reading than boys.

The largest gap in primary education is in Saudi Arabia, where 77% of girls but only 51% of boys in grade 4

achieve minimum proficiency in reading. In Thailand, girls outperform boys in reading by 18 percentage points, in the Dominican Republic by 11 points and in Morocco by 10 points. Even in countries where girls and boys are at the same level in reading in the early grades, as in Lithuania and Norway, the gap in favour of girls rises to roughly 15 percentage points by age 15.

"Although more data is needed, re-

cent releases have helped paint an almost global picture of gender gaps in learning outcomes right before the pandemic. Girls are doing better than boys in reading and in science and are catching up in mathematics. But they are still

far less likely to be top performers in mathematics because of continuing biases and stereotypes. We need gender equality in learning and ensure that every learner fulfils their potential," said Manos Antoninis, Director of UN-ESCO's Global Education Monitoring

The researchers examined studies by the Latin-American Laboratory for Assessment of the Quality of Education (LLECE), Programme D'Analyse Des Systemes Educatifs de la CONFEMEN (PASEC), Southeast Asia Primary Learning Metrics (SEA-PLM) and Trends in International Mathematics and Science Study (TIMSS) surveys.





England Cricket Board on Thursday announced the appointment of all-rounder Ben Stokes as the men's Test team captain.

Stokes succeeded Joe Root in becoming the 81st captain of the England men's Test team. The ECB Interim Chair and Chief Executive Officer approved the appointment on Tuesday evening following the recommendation by the Managing Director of England Men's Cricket, Rob Key.

"I had no hesitation in offering the role of Test captain to Ben. He epitomises the mentality and approach we want to take this team forward into the next era of redball cricket. I am delighted that he has accepted, and he is ready for the added responsibility and the honour. He thoroughly deserves the opportunity," said Rob Key in an official statement.

Meanwhile, the newly appointed captain Stokes said, "I am honoured to be given the chance to lead the England Test team. This is a real privilege, and I'm excited about getting started this

> and fastest 500 ever. Although this is not his score of 578, 37 are 6s & 42 are 4s. Till today, Brian Lara was holding record for the highest individual score in first-class cricket. with 501 not out for Warwickshire against Durham at Edgbaston in 1994. This score included 72 boundaries (10 sixes, 62 fours). So, with Nehal's 79 boundaries, not only is this record broken but he

also has maximum 6s to his credit in a single innings of cricket history. For IPL scouts, watching this innings would have been a feast. India B B Nimbalkar held highest individual score of 443 not out. Don Bradman's highest score in domestic cricket is 452 not out. It is worth mentioning that If it were not an outright win against Kapurthala with 7-0 points , Ludhiana won't be in the semifinals. Nehal's unbeaten 151 in the preceding match definitely put the team in a commanding situation but in the end, the opposite batters seemed all set and almost went towards a draw. Then Nehal took the ball in his hand and unseated three set batsmen in quick succession thereby taking his team to semifinals. # I will bowl above 155kmph one day: Umran Malik

AGENCY MUMBAI, APR 28

Young pace sensation Umran Malik says he would want to cross the 155kmph speed mark one day but his main focus remains on bowling at the right areas as he claimed his maiden five-wicket haul in the IPL here.

The 22-year-old from Jammu took Sunrisers Hyderabad on the verge of a win with figures of 5/25 before Rahul Tewatia and Rashid Khan pulled off a heist for Gujarat Titans by hitting four sixes in the final over to win the match by five wickets.

Though his efforts went for a losing cause, Umran was rightly adjudged the player of the match for his fiery spell of fast bowling, one of the finest in IPL history.

The idea was to bowl fast and maintain length and plan the wickets. Like I dismissed Hardik bhai with a bouncer and shuffled up (Wriddhiman) Saha and bowled him out with a yorker," Malik said after the match on

"I tried to mix my bowling, and target the wickets as it is a small ground. Otherwise our bowling has done well.

Asked if he still fancies touching the 155kmph mark, he said: "I just want to bowl at the right areas and good wickets and if I have to bowl above 155mph, God willing, I will do one day.

Malik has been clocking in excess of 150 kmph consistently throughout the season and has picked up 15 wickets in eight matches at 15.93 average

Introduced into the attack as late as the eighth over, Malik bowled devastatingly quick deliveries to scythe through the Gujarat Titans top-order, becoming the first IPL bowler to pick up all the first five wickets of an innings.

He rattled Shubman Gill's off stump for his first wicket, before removing Hardik Pandya with a combination of pace and bounce.
