# Punjab government releases Rs. 100 crore to Sugarcane farmers

#### SHASHI PAL JAIN CHANDIGARH, JULY 30:

In consonance with the firm commitment of Punjab Chief Minister Bhagwant Mann to ensure well being of the farmers, the state government today deposited Rs 100 crore in the accounts of sugarcane farmers. Disclosing this here today a spokesperson of the Chief Minister's Office said that on the directions of the Chief Minister the funds were transferred by Sugarfed in accounts of sugarcane cultivators on Saturday. The due amount to be paid to the sugarcane farmers by Sugarfed atRs.195.60 crores. now stands

Out of this Rs. 100 crore will be paid by August 31 this year and the remaining Rs.95.60 cores will

be cleared by September 15. After this, there will be no pending payment left with the Government owned nine Sugar Mills at Ajnala, Batala, Budhewal, Bhogpur, Fazilka, Gurdaspur, Morinda Nakodar and Nawanshahr. Pertinently, with the payment of this Rs. 100.00 crore the Government has already paid Rs.424.02 crores to the sugarcane farmers out of total pending sugarcane payment of Rs.619.62 crores. These payments are related to the season 2021-22. The spokesperson further said that Bhagwant Mann Government is making sincere efforts to ensure that pending payments to the farmers is made with before upcoming sugarcane season of 2022-23 without any inordinate delay



## National Highway-152D will write a new script for development in the state: Dushyant Chautala

#### BUREAU CHANDIGARH, JULY 30

Haryana Deputy Chief Minister, Sh. Dushyant Chautala informed that the newly constructed National Highway-152D from Ambala to Narnaul has been opened for the general public from today so that it can be tested. This national highway will write a new chapter of development as it will prove to be a boon for the daily commuters.

The Deputy Chief Minister, who also holds the portfolio of the Public Works Department, informed here today that the National Highway-152D project will reduce the travel time from Ambala to Jaipur by 4 to 5 hours. This will lead to a major diversion of the traffic of NCR, due to which the problem of pollution will also be solved. Also, it will provide the shortest, fastest, and safest route from Ambala to Kotputli on Jaipur Highway and will accelerate the pace of all-around industrial development and economic development of the entire Haryana state. Sh. Dushyant Chautala informed that National Highway No. 152D is a 6-lane Access Controls Greenfield Corridor constructed under the Bharatmala Project, which is about 227 km long from Ismailabad (Gangheri) of Kurukshetra district to Narnaul. This highway is part of the Ambala-Kotputli corridor which passes through about 112 different villages in 8 different districts of Haryana namely Kurukshetra, Kaithal, Karnal, Jind, Rohtak, Bhiwani, Charkhi Dadri and Mahendragarh and is further passed through Narnaul bypass and then NH- 148B which meets Delhi Jaipur Highway at Paniyala Mode near Kotputli.

The Deputy Chief Minister further informed that this entire corridor is equipped with advanced traffic management system and closed tolling system.

In this, interchange has been constructed at 16 different places for entry and exit and every incident on the highway will be fully monitored by the control centre through ATMS.

CHANDIGARH :Shalby Hospital Mohali on Saturday announced the launch of robotic knee replacement surgery in association with Anhad Robotics, Ludhiana. Addressing a press conference here today Dr. Gagandeep Gupta, ortho & joint replacement surgeon at Shalby Hospital said, "Robot-assisted knee replacement surgery is a new innovation, which has brought sea changes in the orthopaedics field. It rules out any human errors and apprehensions over any harm or fault in functioning of robotic equipment are proved to be wrong." He further said that the robotic system is designed to help the surgeon not only plan the surgery based on a patient's unique anatomy, but also position the total knee implant using a combination of computer and robotic assistance. It allows the surgeon to collect patient-specific data during the procedure to build a 3D model of the patient's knee to help plan the surgery. During the procedure,

## This isn't the Parliament people of India deserve

f the Indian Parliament was a mobile app, based on the first nine days of performance and output of the Monsoon Session, it would not be hard to hazard a guess as to the likely ratings people would have given it.

For nine days, both the Houses witnessed a sustained bedlam, controversial exchanges, suspensions of Opposition members, unruly behaviour and protests, resulting in huge loss to a critical national resource - parliamentary time - besides creating avoidable opportunity costs. What could not be debated in the two Houses of Parliament was made up for by both sides --- the Treasury and Opposition - on social media and television channels. Maybe in anticipation, the Lok Sabha secretariat published a comprehensive list of unparliamentary words under Rule 382 of the Rules of Procedure and Conduct of Business, including among them ashamed, crocodile tears, corrupt, drama, derogatory, dictatorial, eyewash, fudge, incompetent, disgrace, hypocrisy, misinformation, partisan, scandal and shame most of which could have come handy otherwise during the session.

The biggest of these controversies was fuelled by the Opposition, when a senior Congress leader used the phrase "rashtrapatni" for President Droupadi Murmu, and later even justified it saying he was a Bengali, whose grip over Hindi was shaky. Was it a shame? But that would have been expunged from the House records.

The face-off between two senior leaders, Sonia Gandhi and Smriti Irani, exposed the hypocrisy of our current partisan polity where lies, misinformation, drama and crocodile tears would have been useful. No longer parliamentary expressions, alas!

The action of suspensions of Opposition members who were demanding a discussion on price rise, Agnipath scheme, GST on food items, among others, could no longer have been characterised by terms like jumlajeevi, dictatorial, deceived, eyewash. Nor could members have used words like fabrication, foolish, gag, ignore or humiliated in the context of a response. In his epic, 1984, George Orwell, created NewSpeak, an autocratic template to control language to control thought to control people. The Parliament is where our representatives must speak up, debate, discuss, and pass new laws, amend or rescind archaic ones. # Do our recent health crises offer teachable moments?

t is a global warning. The cosy thought that "it-can't-happen-here" is past its expiry date. It can, and it will. African researchers have been sounding the alarm about monkeypox outbreaks for years. It was shrugged off as an African problem. Today, it is spreading across the world. The World Health Organisation (WHO) has declared the disease a global health emergency. More than 18,000 cases of monkeypox have been reported from 78 countries. At the time of writing, there have been four cases in India, the most recent one in New Delhi. The patient has no history of foreign travel.

Another telling development -- the United States just reported its first polio case in nearly a decade.

Then, there are heatwaves, exacerbated by climate change. These are no longer confined to countries fabled for their hot weather. This summer, Europe, which is known for its temperate climate, has been frying in devastating heat. Nearly 2,000 people are reported to have died of intense heat in the Iberian Peninsula alone

First, traditional labels like "developing country" and "developed country" no longer apply in many situations. We know this from our experience, and we should remember it as we brace ourselves for another public health emergency while continuing to grapple with the long shadow of the coronavirus pandemic.

Everyone is affected, though not equally. No one can afford to think that he or she is somehow immune to whatever is ravaging denizens of poorer and distant lands.

Third, it is time to accept that no country in the world is fully prepared for the uncertainties of the present and the foreseeable future, and that the Global South and the Global North do not exist in

preparedness since the deadly summer of 2003, when temperatures of over 40 degrees Celsius led to hospitals in France being over-whelmed by patients, particularly the elderly, the report said. Now, many European cities have surveillance systems and heat action plans. The DW report cautioned against treating high temperatures "as a novelty" and flagged good practices from countries more experienced in dealing with extreme heat. It cited the example of Ahmedabad's heat action plan, set up in 2013 in response to a heat wave in 2010 that led to over 1,000 deaths.

Employers in Europe will have to change their attitudes to working outdoors or in poorly ventilated spaces, even if it comes at the cost of productivity, the DW report noted.

As the climate crisis continues to trigger heatwaves around the world and temperatures shoot up, rich and poor countries are faced with the question of how to remain liveable. Some can temporarily protect themselves with air-conditioning and working indoors but this is not sustainable.

Extreme and unseasonal heat also impacts agriculture as we saw with the wheat crop in northern India. Soaring temperature poses risks to critical infrastructure too. In London, Luton airport had to suspend flights after heat damaged the runway.

In France, nuclear power plants had to modify their operations as the cooling water became too warm.

What can India learn from these converging crises? The key takeaway -we cannot afford to be complacent and preparedness is everything, whether in dealing with monkeypox or heatwave or the after-effects of the Covid-19 pandemic.



in part because it is a new way of exploring mindfulness the practice of paying attention to the present moment and becoming aware of your physical sensations, thoughts and emotions in a nonjudgmental way. It also offers a sense of agency, a feeling of control that has been sorely lacking as the pandemic grinds on.

"It's being positive about the things that life has to offer, regardless of whether the circumstance is what you imag-ined or wanted," said Ashley Ward, 26, whose 2020 TikTok video about romanticising has been viewed more than 3 million times. "You can't control everything in your life, but

you do have control of how you view your situation."

The trend draws wisdom from different domains, like mindfulness, positive psy-chology and the Danish custom of hygge, but "it's being presented in a way that's engaging and keeps it fresh," said Eric Loucks, an associate professor of epidemiology, behavioural and social sciences, and medicine at Brown University in the US, and the director of the school's Mindfulness Center.

Loucks' research and his new book, The Mindful College Student, illustrate how mindfulness can decrease stress and symptoms of depression, and improve sleep quality and physical activity levels.

he latest British venture of the Rupert Murdoch empire has been the establishment of a TV channel called TALK TV. I use the word "establishment" cautiously and ambivalently, because the channel has had a shaky and disappointing start. For months, huge hoardings in Britain's cities urged its population to tune in to the channel with

Very few did. Morgan is famous for notorious en-

benign pictures of he journalist, ex-bditor of the counters on TV. In one incident, he in-terviewed Donald Trump, who walked out of the interview when he didn't appreciate the tack of the questioning. The satirical magazine Private Eye constantly refers to Morgan as Piers Moron, an epithet he doesn't deserve as he is very smart if "egotistically challenged" -- my way of saying compromisedly vain.

Despite the featuring of Morgan as their star, Talk TV tanked -- which is the English idiomatic allegory for fish who die and plunge to the bottom of the waters. Its viewing figures could in no way justify the sum that Murdoch reputedly paid him.

Nevertheless, in Britain, whether or

not it's true, there is a prevalent opinion that the media, especially the popular newspapers and the BBC, are decisive factors in the formation of opinion and consequently influence democratic politics. When John Major's Tory Party won the election in 1992, the Sun newspaper led with the headline "It's The Sun Wot Won It!"

More recently, after the resounding defeat of Jeremy Corbyn's Labour Party in the 2020 general election, the leftwing elements insisted that it was the media's negative propaganda against Mr Corbyn and not the electorate's evaluation of his policies which led to his party's defeat.

The Tory Party constantly moans about the BBC having a left-wing bias in all its presentations and reports.

None of these contentions, as even Rupert Murdoch admitted after he reprimanded the Sun's editor for the "Sun Wot Won It" headline, are verifiably true. And yet politicians persist in sucking up to the media.

The latest example of which is that Hedgie Sunak and Liz (Un)Truss(worthy) consented to have their second televised debate about their candidature for the PM of the UK on -- yes -- Talk TV. Now both of them have a battery of advisers who know that Talk TV is not a platform that will influence anyone, but

they consented to go on it because they want to suck up to Rupert Murdoch so that his other media outlets will remain in thrall, or at least friendly, to them through this contest and through a general election when that comes. In a paradoxical sense, the appearance on the very-sparsely-visited Talk TV turned out to be a success of sorts because the presenter, one Kate McCann, on hearing the opinions of Hedgie and Untruss, fainted on the set halfway through the debate, which was then curtailed.

The two contenders rushed to sympathise and all the newspapers and the other TV channels, including the BBC, reported this incident.

### V.Joy likely to replace education Minister Sivankutty in Kerala

THIRUVANANTHAPURAM: Varkala MLA V.Joy is expected to replace Education Minister V.Sivankutty, who would be exalted as the secretary of the Thiruvananthapuram District CPI-M in Kerala. According to sources, during his official trip to the national capital, Sivankutty had called on party general secretary Sitaram Yechuri and the issue was discussed. Incumbent district secretary Anavoor Nagappan was a surprise choice to the party's state secretariat when it was reconstituted and hence he is moving out, they said. Meanwhile, the move is also being seen as a step to avoid any sort of embarrassment to Sivankutty and also the Pinarayi Vijayan government. Sivankutty and five other leaders have been asked to be present in the court on September 14

in connection with a case of vandalism against them on the floor of the Assembly in 2015. If Sivankutty is hauled up by the court, it would come as a huge setback to the education Minister as students look up to him. Of late, there have been issues in the district unit of the party and Sivankutty, who is known for his organisational skills, will be able to handle it better. He was also acknowledged as a successful Mayor of the Trivandrum Corporation. Sivankutty won from the Nemom Assembly constituency in the state capital city and was the party's 'unofficial' nominee to the state cabinet from the capital district. Vijayan is also mulling to hand over the Education portfolio to some other senior party Minister and Joy is likely to get the Cooperation portfolio.

**ANANTNAG:** Poru Kalnag village in the Kokernag area of Jammu and Kashmir's Anantnag district is around 40 km from the district headquarters. A remote area located on a hillock, this village has around 250 households with a population of 1,100. Overlooking the beautiful mountain range of Pir Panjal, the view here may be scenic but the village lacks even the most basic facilities, especially health care. The fact that there is no road connectivity to nearby hospitals and medical centres further compounds the situation. "The village has witnessed the deaths of at least 10 people en route to the hospital. The government has forgotten us, and failed in delivering even basic health care. There is no proper road connectivity and patients and their attendants are forced to walk 6 km to get to the main road before they get transport to reach the sub-district hospital, which is 12 km away," local resident Qasim Boker told 101Reporters. # Maha: Governor sparks an inferno with 'anti-Marathi' remarks, douses it after uproar

## AGENCY MUMBAI, JULY 30

Maharashtra Governor Bhagat Singh Koshyari again landed in a hot soup - this time after his perceived 'anti-Marathi' remarks, but after a major political row, he made a tactical retreat, here on Saturday.

The stinging salvos were fired in Mumbai on Friday when he lauded the contributions of the Gujarati and Rajasthani communities to the progress and development of Maharashtra, at a ceremony. "If you remove Gujaratis and Rajasthanis from the state, especially Mumbai and Thane, then nothing will be left. Mumbai will lose its tag of the country's commercial capital without them," Koshyari Koshyari declared.

The utterances sparked into a political inferno with all major political parties - the Shiv Sena, Nationalist Congress Party, Congress, the ruling Chief Minister Eknath Shinde faction



and his ally Bharatiya Janata Maharashtra Party and Sena Navnirman flaying though Vanchit Koshyari, Bahujan Aghadi's Dr Prakash Ambedkar patted the Governor. Chief Minister Shinde termed it as the Governor's 'personal views' which he did not support and said that the

contributions of the Marathis to the state and Mumbai can never be denigrated. "Mumbai has progressed

and got fame as the financial capital because of the hard work of Marathis. The Governor must ensure that the Maharashtrian's pride and image are not hurt by his utterances," said Shinde in Nashik. BJP's Deputy CM Devendra Fadnavis categorically said: "We don't support the Governor's views" and was supported by ex-minister Ashish Shelar, though MLA Nitesh Rane took an

Marathis are famed the world over for their achievements in all sectors and fields. Their contributions to the progress of Mumbai and Maharashtra is significant, and even the Governor is aware of this in his hearta We are not with him," said Fadnavis. Ex-CM and Shiv Sena President Uddhav Thackeray said Koshyari has "insulted" the people of the state and now deserves to be shown 'Kolhapuri chappals (footwear)'. "He regularly keeps making such controversial statements and does not maintain the dignity of the august office he occupies. He is trying to divide communities and even the Hindus by naming Mumbai and Thane where civic polls will be held shortly. Now it's time to consider whether this parcel named Koshyari should be packed off from here or put behind bars," said an agitated Thackeray.

## **Delhi's excise policy row:** 'Transparent' or riddled with 'irregularities'?

### **NEW DELHI, JULY 30**

With Delhi Lt Governor V.K. Saxena greenlighting a CBI probe into the Delhi government's revamped excise policy and directing the Chief Secretary to submit a report on the role of officers in its implementation at once triggered a fresh round of the continuing slugfest between the ruling AAP and the BJP.

Even as the controversy refuses to die down, the Delhi government is planning to roll back to the old scheme of retail liquor sale in the city. According to sources, the old excise policy will be implemented for the next six months as the government is working to streamline a new policy for 2022-23.

As per the Delhi government's new excise policy which came into force in November 2021, Delhi was divided into 32 zones with each zone having 27 liquor vends. The new policy included shutting down government-run liquor shops. The move was



aimed at curbing the liquor mafia and black marketing, increase revenue and improve consumer experience, and ensure equitable distribution of liquor vends. Moreover, the government also made the rules flexible for licensees such as allowing them to offer discounts and set their own prices instead of selling on MRP fixed by the government. Following this, heavy discounts were offered by vendors, which attracted large crowds at the wine shops. However, after protests by the Opposition, the Excise Department withdrew discounts Excise for some time.

## Does Ghusuri tragedy signal a return of the illegal liquor trade in Bengal?

### KOLKATA, JULY 30

In December 2011, a major tragedy took place at Sangrampur in the Magrahat police area in Diamond Harbour Block of South 24 Parganas district. On a chilly winter evening over 150 people died after consumption of methanol-laced illicit liquor. The initial death figure on that very day was reported at 143, which later went up to 172. However, since then, hooch-related deaths have become extremely rare in West Bengal. There have been two incidents after the Sangrampur tragedy so far. But in none of the two incidents, was the death toll anywhere near the figure reported in Sangrampur. In September 2015, 14 people died in Moyna block in Tamluk sub- division of East Midnapore district. In this case also methanol-laced hooch was the culprit. The latest such incident was at Ghusuri in the Malipanchghora police station area in Kolkata, adjacent to Howrah district, this month which has claimed 13 lives so far. Is the Ghusuri tragedy a signal of the return of the black days of regular hooch-related deaths. However, people who have detailed knowledge of such incidents, feel that Moyna or Ghusuri are aberrations and in the present liquor distribution and state ere is nothing to indicate

that such tragedies will be regular affairs. But at the same time they say that even such minor tragedies can be avoided if the ruling parties and sections of the police do not pamper the hooch operators. ## Personal staff row: Vijayan govt says it only has 489 employees, when Chandy had 612

#### THIRUVANANTHAPURAM, JULY 30

The ruling CPI-M in Kerala on Saturday said that its personal staff's strength is far less than that of Oommen Chandy government during 2011-16.

The clarification comes in the wake of criticism over reappointing personal staff of State Minister for Fisheries Saji Cherian, who resigned early this month, in the offices of other state ministers.

Both the Vijayan and Chandy government had 21 cabinet ministers.

Substantiating its claims with figures, the state government said while the Chandy government had 612 personal staff members, the first Pinarayi Vijayan government (2016-21) had 448 and his second government that assumed office in May 2021 now has 489 staff members.

Cherian handled three portfolios --Culture, Fisheries and Youth Welfare -- which have been distributed among V.N.Vasavan, V.Abdurehman and P.A. Mohammed Riyas respectively. Along with the portfolios, 17 of Cherian's personal staff members have also been absorbed in the offices of these three



ministers. When Cherian had 24 staff members, four of them who came from deputation have returned to their parent department, while three of them have been dropped, it said. Currently, Vijayan leads with 33 personal staff members, followed by his son-in-law P.A.Mohammed Riyas and Abdurehman who both have 28 each and State Transport Minister Antony Raju has the least with 19 members.

As per the rules, all personal staff are eligible for lifelong pension and other benefits upon completion of two years. Hence, there is always a mad scramble to get absorbed as staff ministers' staff.

## **Kishan Reddy slams TRS govt** for neglecting Musi works

#### HYDERABAD, JULY 30

Union Minister for Tourism and Culture, G. Kishan Reddy on Saturday slammed the Telangana government neglecting Musi for development riverfront saying this resulted in the

The BJP leader said the state government only made announcements like setting up of a corporation for Musi riverfront development. He recalled that the government appointed chairman and members to Musi Riverfront Development Corporation. "Only announcements were made. Nothing happened on the ground." Kishan Reddy said nothing was for the development of Musi river and this led to the areas on the banks of the river getting flooded again due to heavy rains.

### Groundswell against prohibition in Nagaland; 'Explore possibilities to charge toll on basis of weight of vehicles' Mizoram goes back to being dry

#### NEW DELHI, JULY 30

Concerned over safety hazards due to overloaded trucks on national highways, a Parliamentary Standing Committee has asked the Ministry of Road, Transport and Highways to explore the possibilities of reforming the provisions to charge toll on the basis of weight of the vehicles, instead of axle-based toll collection.

The Committee strongly feels that overloaded vehicles not only cause severe damage to the roads, but also pose a significant safety risk to other vehicles plying on the road, said the report recently tabled in the Parliament.

It recommended that the Ministry may



explore the possibilities of reforming the provisions to charge toll on the basis of weight of the vehicles, instead of axle-based toll collection. The Committee feels that the implementation of weigh-in motion system to issue automated challans/penalty would eliminate the possible collusion of corrupt officials with the heavy vehicle owners and help curb the menace of overloading.

#### AIZAWL/KOHIMA, JULY 30

Christian-The two dominated northeastern states of Mizoram and Nagaland continue to be "completely dry", but prohibition is not effectively implemented in Nagaland where the ban on liquor came into force 33 years ago. The Nagaland Liquor Total Prohibition (NLTP) Act, 1989, prohibits possession, sale, consumption, manufacture



of liquor, import and export. Replacing the 'Mizoram (Prohibition and Liquor

(Prohibition) Act, 2019, the Mizo National Front (MNF) government imposed prohibition on the sale and consumption of liquor on May 28, 2019.

In Mizoram, following the government's crackdown on the wine trade, there is confusion over the sale and consumption of wine made from grapes. But often a debate surfaces in the public domain on whether prohibition should be given more teeth or be relaxed

altogether in both the states. Suggesting lifting of ruling prohibition, Democratic Nationalist Progressive Party (NDPP) legislator K. T. Sukhalu felt that the revenue generated from the sale of liquor can be utilised to improve education and healthcare facilities. Sukhalu, advisor for school education, said the revenue generated by the state is not sufficient to improve the health and education facilities

## India's first monkepox patient recovers, to be discharged

THIRUVANANTHAPURAM: Kerala Health Minister Veena George on Saturday announced that the country's first ever monkeypox patient has fully recovered and will be discharged later in the day. The 35-year-old Kerala native arrived here from the UAE on July 12 and had tested positive for the virus two days later. When he developed the symptoms, he was taken to a hospital at Kollam and from there he was shifted to the Trivandrum Medical College Hospital and was under close observation. "The entire treatment protocol was planned by the National Institute of Virology, Pune and at repeated intervals samples was taken and tested. By now all the samples have tested negative two times and the patient has fully recovered and is perfectly fine," said George. Initially, concerns were raised over the infected man's close contacts with his parents after his arrival, as well as 11 other passengers who had travelled with him. But health authorities had assured that all the contacts were closely observed, allaying fears. George also said that two other positive cases in the state who also arrived from the Middle East, were in stable condition and recovering fast.

## **Speeding Mercedes** mows down e-rickshaw driver in Noida

NOIDA: An e-rickshaw driver was killed after being hit by a speeding Mercedes here in the city after which the alleged driver of the car was arrested, an official said on Saturday. The deceased was identified as Ravi Kumar (29), a resident of Sector 8, Noida. The official said the incident took place on Friday between Sector 31 and 32 when the offending vehicle was going towards sector 63. "On the way, the car met with an accident in which an e-rickshaw driver was critically injured," Station House Officer Manoj Kumar told IANS The police official said the e-rickshaw driver was rushed to a nearby hospital where he succumbed during the treatment. Accordingly, the police registered an FIR under sections 279 (rash driving), 304A (causing death by negligence) and 427 (Mischief) of the Indian Penal Code and the alleged driver, who worked at an IT company, was arrested. However, a social media post by popular Bengali actress, Sreelekĥa Mitra, on this count has spiced the virtual world. Taking a potshot on the recovery,



Mitra commented that probably some deficiencies on part of Chatterjee were reasons behind the presence of the sex toys in Mukherjee's residence.

"Was Partha unsuccessful. Nation wants to know?" Mitra's post read. an actress with Mitra, declared Leftist leanings and a

habitual Trinamool Congress basher, had earlier ridiculed the Chief Minister Mamata Banerjee after she received a literary award from the West Bengal government for her collection of poetries.

## ED probes infusion of illgotten gains in real estate, entertainment industry

#### KOLKATA, JULY 30

Ill gotten gains from the multi-crore West Bengal School Service Commission (WBSSC) scam may have been invested by Partha Chatterjee and others in real estate and film production, an Enforcement Directorate (ED) source revealed. The agency has got access to several documents that are now being scanned. "The names of several people have cropped up. We are finding out more about their activities and connections with Partha Chatterjee and Arpita Mukherjee. Many are them are real estate developers. We have also received some tip-offs regarding financing of several multi-storied complexes in south Kolkata by Partha Chatterjee. The former minister may have also used his clout to obtain land from original owners who may not have agreed to offers by developers," an ED official said. Among property documents seized, there are ownership deeds of



several flats, some of them i the names of Chatterjee's relatives and associates. In most cases, the developers had ties with the suspended Trinamool Congress leader who wielded significant clout and was even considered No. 2 in the hierarchy after party supremo and Chief Minister Mamata Banerjee. "We are also trying to ascertain activities of Echhay Entertainment Pvt Ltd apparently owned by Arpita Mukherjee. Even Arpita Mukherjee's mother has claimed that her daughter owned a production firm. Was money pumped into the film industry both in West Bengal and neighbouring states? Infusion of black money in film production is not new.

## Navy recovers bodies of all missing students on Andhra beach

#### VISAKHAPATNAM, JULY 30

The Indian Navy on Saturday recovered five bodies of the engineering students who went missing at the beach in Andhra Pradesh's Anakapalli district on Friday. The Indian Navy and Coast Guard completed the search operation with two helicopters and four boats at Pudimadaka beach off Bay of Bengal. A total of six students were drowned and one was rescued in the tragedy that struck a group of students who had entered the waters. Bodies of P. Ganesh and K. Jagadeesh were recovered on Saturday morning. Later, the bodies of B. Satish Kumar and Rama Chandu were found. The rescue workers also pulled out the body of S. Jaswanth Kumar. The body of G. Pavan Kumar (19) was recovered on Friday. Local fishermen with 20 boats helped in the search operation. Police and the revenue department also assisted the rescue personnel. A joy trip of 15 friends at the beach turned tragic when one of them drowned and five others went missing. Fishermen rescued another youth identified as S. Teja. He was shifted to a KGH Hospital at



Visakhapatnam. According to police, the students of a private engineering college at Anakapalli town had gone to the beach, about 50 km from Visakhapatnam. Seven of them had stepped into the waters. They were apparently pulled deeper into the waters by strong waves. The beach where the incident occurred is not a tourist place but some people visit the place despite warning signs installed there. District Superintendent of Police S. Gauthami, who was supervising the rescue operations along with other top officials, said though the marine police do the patrolling to warn people going closer to the coast, an unfortunate mishap occurred on Friday.

Chowdhury's derogatory remarks about the first tribal woman president of the country on July 28 triggered a major political controversy. BJP leaders grabbed the political opportunity to corner the main opposition party and demanded an apology not only from Chowdhury but also from Congress president Sonia Gandhi. According to media reports, the Lok Sabha witnessed



heated arguments between Union Minister Smriti Irani and Sonia Gandhi over issue. Speaking in the Lower House of parliament, Irani alleged that the Congress president has "sanctioned the humiliation of Droupadi Murmu". CVoter-IndiaTracker conducted a nationwide survey on behalf of IANS to know people's opinion about the whole issue. The survey found that people were divided on the BJP's demand of an apology from Sonia Gandhi for Chowdhury offensive remarks.

### 'Sextortionist' siblings held from Uttar Pradesh, **Rajasthan: Delhi Police**

**NEW DELHI:** Two brothers allegedly members of a 'sextortion' gang were arrested from Uttar Pradesh and Raiasthan, police here said on

Saturday The arrests were made following a complaint by a person who alleged that the accused had extorted Rs 12,42,850 from him, they said. Police had earlier arrested three members of the gang, but Ahmad Khan and Aamir Khan were absconding.

They were nabbed on Thursday from Uttar Pradesh and Rajasthan, Deputy Commissioner of Police (Crime) Amit Goel said

Both are real brothers and members of a sextortion gang which has duped over 100 people, he said.

The accused used to target people through social media with fake profiles of women and sending them 'friend requests' to potential targets. After some time, they would ask the person to come on a video call and would ask them to perform some private acts, which they then would secretly record, police said. They would then leverage the video to extort money from these people, they added.

## Mumbai Police hunt for two suspected 'Bangladeshi terrorists' carrying Indian passports

MUMBAI: The Mumbai police have launched a manhunt for two suspected "Bangladeshi terrorists" carrying Indian passports, who were scheduled to fly to Serbia from Chhatrapati Shivaji Maharaj International Airport, but were barred from boarding the flight, an official said on Saturday.

According to the police, the Foreign Return Citizen (FRC) desk of the airport had received an email on July 18, informing them that two men travelling with Indian passports under the names of Sujan Sarkar and Sameer Roy were "Bangladeshi terrorists"

The sender of the email also urged the authorities to arrest the duo, the official said.

On receiving the email, all the agencies concerned, including the police, were alerted about the two suspects and a search was launched for them, he said.

## Process simplified for grant of CLU, approval of layout and building plans in Punjab

**CHANDIGARH:** The Local Bodies Department has simplified the procedure for granting Change of Land Use (CLU) and approval of layout and building plans. On the pattern of Punjab Housing and Urban Development, the Local Bodies Department has designated the Commissioners in respective municipal corporations and Additional Deputy Commissioner (Urban Development) in other urban bodies as the competent authority for grant of CLU and give licence to develop a colony.

The competent authority would have to take technical advice from their senior town planner for residential and industrial projects of up to 25 acres and commercial projects of up to 2 acres. For commercial projects above 2 acres, chief town planner at the local government headquarters would give technical advice.

# India records 19,673 covid cases, **39 fatalities in a day**

#### NEW DELHI, JULY 30

India's covid case tally rose by 19,673 in a day to reach 4,40,19,811 while active cases reached 1,43,676, according to the Union Health Ministry data updated on Sunday. The death toll has climbed to 5,26,357 with 39 more fatalities, the data updated at 8 am stated.

Active caseload increased by 292 in a day and comprise 0.33 per cent of the total infections, while the national covid recovery rate was 98.48 per cent, the ministry said.

The number of people who have recuperated from the viral disease surged to 4,33,49,778 while the case fatality rate was recorded at 1.2 per cent.

The daily positivity rate was 4.96 per cent and the weekly positivity rate was recorded at 4.88 per cent.

According to the Union Health Ministry, 204.25 crore doses of covid vaccine have been administered in the country so far. The 39 new fatalities include seven in West Bengal, four in Maharashtra, three in Delhi, two each from Chhattisgarh, Gujarat, Haryana, Himachal Pradesh, Jammu and Kashmir, Kerala, Madhya Pradesh, Punjab and Uttar Pradesh and one each in Assam, Goa, Karnataka, Nagaland, Sikkim, Tripura and Uttarakhand.

## PM Modi urges states to clear pending power dues

**NEW DELHI:** Emphasising that the energy sector will play a huge role in accelerating India's progress over the next 25 years, Prime Minister Narendra Modi on Saturday urged states and union territories to clear pending power dues as soon as possible.

The prime minister wondered that if the common man could pay his electricity dues regularly, why was it that some states failed in paying theirs. Addressing the 'Ujjwal Bharat Ujjwal Bhavishya - Power @2047' programme, the Prime Minister said, "Eight years ago, we took the initiative to transform every part of the country's power sector. To improve the power system, work was done simultaneously in four different directions - generation, transmission, distribution and connection." "In the last 8 years, about 1 lakh 70 thousand MW power generation capacity has been added in the country.



# Union Home Minister presides over regional conference on drug trafficking, national security in Chandigarh

## Drug addiction and drug trafficking are a matter of concern for the entire world, Haryana Chief Minister

In the regional conference on drug trafficking, national security organized under the Chairmanship of Union Home Minister, Sh. Amit Shah to root out the drug abuse menace from the northern states and formulating proactive strategies here today, Haryana Chief Minister, Sh. Manohar Lal said that drug addiction and drug trafficking are a matter of concern for the entire world. This problem is not limited to any one country rather the entire world is fighting against this societal evil, said Sh. Manohar Lal.

The Chief Minister said that due to various reasons not only our youth, but children are also falling prey to substance abuse. To tackle this social issue, we need to put up a joint fight to break this network, said Manohar Lal.

He said that if the one state police take strict action against drug peddlers and those involved in illegal drug trafficking, then these drug dealers and peddlers shift to neighbouring states.

"The network of drug dealers is spread all over the country. Law enforcement agencies of various states are putting up a tough fight to break this network. However this problem can be curbed if the law enforcement agencies of different states work untidily with mutual coordination," said Sh. Manohar Lal.

## Haryana Police succeeded in catching drug smugglers

The Chief Minister said that according to the decisions taken in the earlier conferences on the issue of drug smug-



gling and national security, Haryana has not only taken effective steps, but their results are also coming. More than 200 NDPS Act cases are registered in Haryana every month. Till June 30, 1913 cases were registered in the state in which 2661 accused were arrested. Also, till June 2022, around Rs 32 crore recovered from 253 drug smugglers has been seized and the process of confiscation of property worth Rs 13 crore is going on, shared Sh. Manohar Lal.

The Chief Minister said that the State Police has been directed to thoroughly investigate every case and tighten the noose of those involved in this illicit trade. As a result of this, Haryana Police has succeeded in nabbing drug smugglers even from the inaccessible areas of remote states like Telangana, Orissa and Madhya Pradesh.

142 drug de-addiction

centres operational in the state

The Chief Minister said that under the NDPS Act, 142 drug de-addiction centres have been opened in the state. Apart from these, mental health and drug de-addiction wards have been opened in all government medical colleges. De-addiction centres are also being opened in civil hospitals in every district of the state. So far these centres have been opened in 13 districts.

Psychiatrists are providing de-addiction services in civil hospitals in all the districts where de-addiction centre are yet to be established. So far these centres have been opened in Hisar and Rohtak jails, shared Sh. Manohar Lal.

The Chief Minister said that the State Government has constituted Haryana State Drug Prevention Committee to identify, treat and financially rehabilitate drug addicts and bring them back into the mainstream of society. This Committee will also work to make people aware by doing research about the social, economic, health and other harms caused by drugs, he added.

## Drug smugglers caught in a systematic manner by identifying the drugs hotspots

The Chief Minister said that Haryana Police is maintaining effective coordination with the Narcotic Control Bureau to deal with the inter-state smuggling gangs.

We have also assigned some cases to NCB for research purposes. Hence while working amicably, a massive crackdown against drug abuse and smugglers have been launched. For cooperation at all levels with neighbouring states, we have established a centralised secretariat at Panchkula in Haryana. In this secretariat eight states of northern India collect and share information about drug trafficking.

Through this centralized system, hundreds of drug traffickers have been arrested and our struggle against drugs has been strengthened," said Sh. Manohar Lal.

The State Government has established the Haryana State Narcotics Control Bureau.

Furthermore, under the ambitious State Action Plan against drug abuse hundreds of policemen under the guidance of an officer of ADG rank has been dedicatedly working to completely eliminate this social evil, said the Chief Minister.

Furthermore under this plan, apart from taking strict action against drug

smugglers, 18 departments of the government are engaged in spreading awareness about drug abuse, informed Sh. Manohar Lal.

He said that the Narcotic Control Bureau had last year identified the drughotspots based on the number of cases registered in 272 districts of the country. There are 10 districts in the state of Haryana. The police of these districts are engaged in nabbing the drug smugglers in a planned manner, added the Chief Minister.

## IT equally supporting in the fight against drugs

Sh. Manohar Lal said that in the fight against drugs the support of IT is completely utilised which is further supporting in tracing the violators. Through a mobile app named 'Prayas', we are collecting data about drug addicts and taking effective steps for their de-addiction. As a pilot project, State Action Plan has been implemented in Kurukshetra, Ambala, Yamunanagar, Panchkula, Jind, Hisar, Fatehabad and Sirsa districts, under which work is being done to upload the relevant data in Prayas App. Through a mobile app named 'Saathi', we are tracking the sale of medicines so that synthetic drugs can be curbed.

As a pilot project, work is being done to upload related data in the Saathi app for monitoring of banned drugs under the State Action Plan in district Sonipat. The Chief Minister suggested that in order to track such banned drugs, which are possible to be used as intoxicants, it should be made mandatory by the Central Government to get them unique serial numbers.
