tant sub-inspector (ASI) of police in Hoshiarpur district allegedly shot himself dead on Saturday. Before killing himself at Hariana police station, 52-year-old ASI Satish Kumar put out a video accusing Tanda SHO Onkar Singh of his death. He accused the SHO of humiliating him

Meanwhile, the Hoshiarpur SSP has ordered a inquiry into the incident. The SSP termed the incident unfortunate and said the SHO has been sent to police lines to ensure a fair and im-

partial probe into the mat-The SSP said the police department stands with the family of Satish Kumar at this hour of grief. In the video, the ASI alleged: "On September 8. he was on duty as investigating officer stationed at Hariana police station. Inspector Onkar Singh Brar of Tanda police station arrived there and asked him how many cases were lined up in the high court the next day. He told the SHO that there was only one case. When he asked him the details, he told him that the IO concerned knew them." The ASI alleged that the SHO asked him unnecessary questions and humiliated him. He said he wished that the SHO shoot him instead of hu-

Now, people to get NoC online for regularisation of properties: Aman Arora

SHASHI PAL JAIN **CHANDIGARH, SEPT 10:**

In a bid to ensure quick and timely disposal of applications for regularization of properties situated in unauthorized colonies in the state, Chief Minister S. Bhagwant Mann led Punjab Government has introduced a facility of online submission and processing of applications on the regularization portal for obtaining NoC. The state government has also fixed a deadline of maximum 21 working days to complete the whole process to issue the NoC.

Revealing this, Punjab Housing and Urban Development Minister Mr. Aman Arora made it clear that this facility of regularization could be availed only by those allottees/residents whose properties fall under the unauthorized colonies developed before March 19, 2018.

Mr. Aman Arora said that the person concerned can now log on to www.punjabregularization.in portal dedicated to regularization of plots and buildings situated in unauthorised colonies, which will be processed online. Till now, the applications were processed offline so the applicants had to wait a long for getting issued

Due to ignorance, a considerable number of people had purchased properties in unauthorised colonies which had mushroomed in the past few years. These allottees/residents had invested their hard earned money to purchase plots or other establishments in these colonies, the Minister

To give a reprieve to them the regularization portal has been revamped, said the Cabinet Minister, while adding that new features have been added on the portal to facilitate



the allottees/residents of unauthorized colonies interested in applying for regularization of their property. Now, the portal extends a large number of facilities such as online submission of application, online payment, status checking of application and online disposal of the same. This one single

portal is designed for regularization of plots and buildings falling within MC and outside MC area for quick disposal of applications, he added.

To ensure quick and timely disposal of applications, the Housing and Urban Development Minister further stated that the officials involved in the process of dealing the applications would be required to take action in a fixed timeline which will be monitored. The whole process to issue the NoC would be completed maximum within 21 working days from the submission of the application on the portal, he said.

Notably, Punjab Government had notified a policy on 18.10.2018 to regularize plots falling in unauthorized colonies developed before 19.03.2018. However, plot holders are facing issues for getting their plots regularized under this policy, since applications were processed offline.

Sidhu Moosewala murder: Sixth shooter Deepak Mundi arrested

CHANDIGARH, SEPT 10

In a major breakthrough, Punjab Police, in a joint operation with central agencies and Delhi Police, have arrested Deepak alias Mundi, sixth shooter in Punjabi singer Sidhu Moosewala's murder case, along with his two associates.

The two others arrested along with Mundi are Kapil Pandit and Rajinder alias Jok-

DGP Gaurav Yadav (officiating) said Mundi along with two associates was caught from near Nepal border in West Bengal. Mundi was the shooter in Bolero module, while Kapil Pandit and Rajinder provided logistical support, including weapons and hideouts.

Mundi's who was arrested 104 days after Moosewala's killing is being brought to Mohali by air.

Shubhdeep Singh Sidhu, popularly known as Sidhu Moosewala, was shot dead in Punjab's Mansa district on May 29, a day after the state police had pruned his security cover on a temporary basis.

He, along with his friend and cousin, was driving to Jawahar Ke village in Mansa when six shooters waylaid his vehicle and sprayed bullets into him. After the killing, Canada-based gangster Goldy Brar, who is a member of the Lawrence Bishnoi gang, had claimed responsibility for the

Police had identified six



Mundi, Manpreet Singh and Jagrup Singh Roopa—who were part of the two modules allegedly involved in the

While the special cell of the Delhi Police had nabbed Fauji, Kashish and Sersa, the Punjab Police neutralised Roopa and Manpreet in an encounter in Amritsar. In the 1,850-page chargesheet filed in a Mansa court last month. the Punjab Police had said Brar had coordinated with gangsters Lawrence Bishnoi, Jaggu Bhagwanpuria and some others to execute Moosewala's killing. According to the chargesheet, Brar had given the information on Moosewala's security withdrawal to the shooters and had asked them to hurry up and kill him. The Canada-based gangster had executed the murder plan to avenge the killing of Akali youth leader Vicky Middukhera, who was killed last year. The name of Shaganpreet Singh, who was said to be Moosewala's manager, had figured in Middukhera's murder. The chargesheet included Sections 302 (murder), 307 (attempt to murder), 341 (wrongful restraint), 326 (voluntarily causing grievous hurt by dangerous weapons or means) and 148 (rioting, armed with deadly weapon) of the Indian Penal Code and also the Arms

UK PM Liz Truss, PM Modi agree on 'vital importance' of bilateral ties in phone call

British Prime Minister Liz Truss spoke to Prime Minister Narendra Modi on Saturday and agreed on the "vital importance" of the India-UK bilateral relationship.

In their first phone call since Truss assumed office earlier this week, Modi conveyed his condolences on the death of Oueen Elizabeth II on behalf of all Indians and paid tribute to the 96-yearold late monarch's "lifetime of serv-

The two leaders said they looked forward to meeting in person in the near future. "The Prime Minister

dra Modi this afternoon, following the death of Her Majesty The Queen," Downing Street said in a readout of the phone call. "The Prime Minister thanked Prime Minister Modi for his heartfelt condolences, which he said were on behalf of 1.3 billion Indians. The leaders acknowledged the grief felt by the many people of the UK and India, and paid trib-

ute to Her Majesty the Queen's life-time of service," the statement said. 'The two agreed on the vital importance of the UK-India relationship and looked forward to meeting in person in the near future," it added.



Modi had tweeted soon after the news of the Queen's passing away in Scotland on Thursday, describing her as a "stalwart of our times"

"I had memorable meetings with Her Majesty Queen Elizabeth II during

UK visits in 2015 and 2018," Modi recalled in his tweet. "I will never forget her warmth and kindness. During one of the meetings she showed me the handkerchief Mahatma Gandhi gifted her on her wedding. I will always cherish that gesture," he said. The UK and India are in the midst of negotiating a free trade agreement (FTA), with a Diwali deadline

set by Truss' predecessor Boris Johnson for the completion of a draft agreement. The new Prime Minister, who took formal charge at 10 Downing Street on Tuesday with an audience with the late Queen.

Editorial

Era ends: Elizabeth II one of a kind, she'll be missed

The death of Queen Elizabeth II brings to an end the Second Elizabethan Era, a momentous time in the history of the world when it was just recovering from the ravages of World War II up to the present day when it is again in great economic strife. Her sense of commitment to her people as Britain's longest-reigning monarch was unwavering through all the triumphs, tragedies and crises of the personal, family, national and global kinds.

Her image and the values she stood for had resonated far beyond a shrinking British Empire. She occupied the throne with a "dignity and decency in public life", which Prime Minister Narendra Modi applauded as her greatest quality. The sense of loss in many people across the world is itself a fine tribute to Queen Elizabeth II of Britain, who held a place in billions of hearts, across boundaries and cultures.

At a time when huge scepticism prevails about hereditary rule in emerging generations of people who have no experience or knowledge of being ruled by a monarch, she represented a rock-like, even stoic, presence. She was the ceremonial head of an old colonising power fast losing its relevance in the modern world, that has seen huge changes in the seven decades she was the Queen, but as an empathetic figure, she was much re-

Her final year may have been dominated by personal grief at her steadfast husband's passing but she shirked no responsibility or duty right down to her very last days. Just 48 hours before a peaceful end to a life lived in the public eye, she formally appointed Liz Truss as the fif-teenth Prime Minister of the UK during her 70-year reign at an audience at her beloved home Balmoral Cas-

Elizabeth II had played her role in rallying Britain during the Covid-19 pandemic and, after the Duke of Edinburgh's death had returned to public life again to celebrate her Platinum Jubilee year. It was said of her that she could walk into a room full of people but everyone she spoke to was made to feel that he/she was the only person there. Seen in a wider context, she was the ceremonial head of state not just in Britain but in several dominions which are a part of the Commonwealth notably Canada, Australia and New Zealand, among others. In Britain, she was the great unifier who had kept things together in most difficult times after the war when the Empire had just lost India, its crown jewel.

ueen Elizabeth II is dead. God save King Charles III. With the death of the gracious Queen at the age of 96, a piece of irritating, amusing and constant reactivity will have to die: the politically necessary satirical British magazine Private Eye regularly ran a spoof feature about Prince Charles waiting for his mother's demise. In each issue which featured this dilemma. Charles would be addressed in his bath or other environment playing with his toys or talking to his plants by his gay Comptroller of the Royal Toothbrush or other such factotum. This person would say something ambiguous, which Charles would interpret as his mother's death. He would spring out of the bath and rush, naked, to wherever in order to finally assume the throne, only to discover that he misinterpreted the message his factotum had con-

I read this piece of satire each fortnight with a broad smile, as I am sure did thou-



sands of Private Eye's regular readers. Alas, the context of the joke has ended. Charles has, without rushing out of a bath naked, attending to his mother's deathbed in Balmoral, Scotland, acceded to the throne and issued a moving tribute to the life, duty and his genuine love and respect for his mother.

Elizabeth II, the longest reigning monarch in British history, is dead. The nation will go into official mourning for weeks, even with the cricket-analogous contention that she "had a good innings". At the age of 96 one could extend the analogy to say she seemed to have had a follow-on.

Contemporary British monarchs are not expected to do anything much. They support charities, they are chairs of charitable institutions, they open Parliaments and shake the hands of designated Prime Ministers, appointed by their political parties to give them the royal assent. They accept the resignations of Prime Ministers who have been dismissed by their own political parties. They preside as titular heads over Commonwealth conferences. They breed corgis and race horses and lend their names to a myriad of good humani-

tarian causes. But they are not "mon-archs" in the sense of Henry VIII or the first Elizabeth. They are royalty.

This demotion began with Oliver Cromwell wag-

ing a republican war against Charles I, wining that war and chopping off Charles Stuart's head. Though several kings have succeeded to the throne after the shortlived seventeenth century republic of Cromwell, their powers atrophied and have now ended up with King Charles III who, as Prince of Wales till Thursday, was parodied for talking to plants and selling organic produce from his Duchy of Cornwall enterprise.

In a sense, Britain, which prides itself as the mother of parliamentary systems and has demonstrably replaced the monarchy with titular royalty, retains a trait of tribalism. They want a chief, a hereditary King or Queen, rather than an elected President. The British royalty, besides their massive inherited wealth in land and assets, is supported by the State and therefore by the taxpayer. Britain is happy to pay. The subsidies to royalty don't come under question in this acknowledged democratic and fairly-elected Parliament not under Tories or under Labour. Yes, it's a tribal na-

tion in that respect.
Poor Liz II didn't have a happy, straightforward family. Her eldest son Charles, now the King, abandoned Diana, his wife and the mother of his two sons and took up with Camilla Parker-Bowles, now Queen Consort. Her daughter Anne went through relationships and divorces. Her son Andrew got involved with the paedophilic sexscandal of a friendship rwith Ghislaine Maxwell, the convicted pimp of underage girls, and her demanding master, the late Jeffrey Ep-

And then of course there was the embarrassment of Elizabeth's grandson Harry and his American wife Meghan Markle attacking the British royals over "racism". The feud between Prince Harry and his multi-million dollar contracted-by-American-media wife Meghan Markle and his brother and father still continues. There is no doubt that the tittle-tattle from Meghan has to be about

the British royal family. Why anyone is interested in her views on anything is, gentle reader, beyond my under-standing. If she had a theory about why apples fell to earth instead of going upwards, I might be interested.

The TV tells me that Har-

ry and Meghan went up to Balmoral with the rest of the family. One believes that in times of grief petty differences are forgotten. But is that true when millions of dollars are in pursuit of the gossip of dissension? Gentle reader, I ask this question as I write this column hours after the announcement of the Queen's death. The hours and days to follow will tell us whether the royal family absorbed their emotions with dignity or whether some of them — and perhaps, gentle reader, you know who I have in mind — exploited even this eventuality for their PR advantage.

Societies with tribal inclinations require chiefs. Britain has through its history found the balance between iconic authority and real effectual power. Perhaps Queen Victoria had some say in what the East India Company did and she was designated the titular ruler when India, after the defeat of the 1857 Mutiny or the First War of Independence, passed to the Raj, but she never had any say in what her viceroys were doing there.

Chronic headache, nausea could be sign of brain cyst, say doctors

eadache, one of the most commonly encountered but oftenignored health problems, could be pointing towards a more serious condition such as a cyst in the brain, Brain cysts are fluid-

filled sacs that appear due to the build-up of fluid in the brain.

Approximately 1.2 per cent of the population is affected by brain cysts. In India's context, this is a big number given the country's population size is 1.3 billion, said Dr Manish Vaish, the director of the neurosurgery department in Max Super Speciality Hospital at Vaishali in Ghaziabad.

Cysts are often seen in children, however, can also be present in adults with men being 59 per cent more likely to develop brain cysts compared to women, Dr Vaish told PTI.

"Symptoms of brain cyst depend on its location and size. Sometimes small cysts may not show any symptoms but often become troublesome once their size increases. Symptoms can either be because



of the pressure put by a cyst on brain tissue or disruption of normal flow of the cerebrospinal fluid (CSF), a protective fluid that creates a cushion around the brain," he said.

Headache is the most common symptom of brain cysts. Therefore, it is extremely important that if a chronic headache is accompanied by any other symptom, one should consult a specialist, Dr Vaish

Diagnosis of cysts is often through the work-up done for some other reason. However, in patients where the quality of life is affected by cysts, diagnosis is done through physical examination and imaging like CT scans and MRI.

"Brain cysts with no symptoms are often not treated with any intervention and your doctor is likely to monitor these through scans.

Depending on the size, symptoms, and location, the available option for management is imageguided cyst drainage, surgical cyst removal or placement of a shunt. The shunt is a bypass created for the continuous flow of

CSF," Dr Vaish added. Dr Kunal Bahrani, Director of Neurology at Fortis Escorts Hospital Faridabad, said, "A brain cyst containing pus, blood, cerebrospinal fluid (CSF) or other tissue materials.

The immunisation schedule now extends to adults and senior citizens to overcome these problems. In particular, there is the coronavirus pandemic. By this time, adults should have taken two doses. In addition, those who are eligible should have also received a booster. Every year, depending on the evolving strain, new flu vaccines are released. Everyone — particularly the elderly should take an annual flu vaccine.



Even though the flu infection itself is ondary bacterial infections like pneumonia, ear infections and sinusitis. Some of these can be fatal.

Children should receive three doses of the pneumococcal vaccine before one year. It is also recommended for those between 19 and 65 years of age and unimmunised, if there are health-compromising conditions such as heart or liver disease, absence of the spleen, diabetes, cigarette smoking or organ transplants.

By the time you are 65 years old, you should receive one dose of vaccine irrespective of childhood immunisation status. Pneumococcal pneumonia can be challenging to diagnose in the elderly and even fatal. Household pets can carry rabies. Members of the pet-rearing household should have prophylactic immunisation against rabies with three doses of pre-exposure immunisation. Many people do not appreciate the danger of rearing cats

But cats (unlike dogs) tend to roam free and can carry the rabies virus without exhibiting symptoms. Many older adults have not been immunised in childhood against hepatitis B. Although the vaccine has been available since 1980; it was incorporated as part of India's universal free immunisation schedule in 2017.

Mysterious deaths in Argentina linked to Legionnaires' disease



he four victims reported high fever, ache and troubled breathing. Seven other cases have also been identified, from the same clinic where the patients were being treated.

Four people who died under mysterious circumstances in a clinic in the Argentine city of San Miguel de Tucuman were victims of Legionnaires' disease, health officials have

confirmed.

Health Minister Carla Vizzotti told reporters that the disease had been identified as the underlying cause of double pneumonia in the recent deaths. They all suffering were from high fevers, body ache and had trouble breathing.

Legionella bacteria causes symptoms ranging from flu to severe lung infection and pneumonia in humans.

The Health Ministry said all the patients belonged to a risk group. They included smokers and people with a history of respiratory disease, obesity, dia-betes and high blood pressure.

Other cases identified at same clinic Seven other

symptomatic cases have been identified. All the patients were employees at the clinic where the four fatalities eventual

were being treated. Four of them have remained in the hospital, and three were under respiratory assistance at home, with less severe symptoms, said Luis Medina Ruiz, health minister of Tucuman province, on Satur-

Legionnaires' disease, which was first identified at a 1976 meeting of the American Legion veterans group in the US city of Philadelphia, is caused by contaminated water or unclean air-conditioning systems.

After the outbreak in Tucuman, doctors tested the patients for Covid -19, the flu and hanall ruled out. Samples were then sent to the Malbran Institute in Buenos Aires, where tests confirmed Legionnaires' Hector Sale, pres-

ident of the Tucuman provincial medical college, said the infection is not normally transmitted person-to-person, and that no close contact of any of the 11 infected people showed symptoms.

Solid, sewage management far from satisfactory, NGT raps Ghaziabad civic bodies

NEW DELHI, SEP 10

Coming down heavily on Ghaziabad Nagar Nigam (GNN) and Ghaziabad Development Authority (GDA), the National Green Tribunal (NGT) has observed that the overall situation of solid and sewage management is far from satisfactory, finding a gap of 500 tons per day in waste processing.

The principal bench of NGT headed by Justice (retd.) Adarsh Kumar Goel was dealing a plea, which was pending since 2018, for the remedial action for scientific management of waste at Indirapuram, Vasundhara and Vaishali areas of Ghaziabad.

"For solid management, one site measuring 33.108 acres at Galand Village and the waste to the extent of 20,000 MT is being deposited at pipeline road. Further, another private



land on an abandoned brick kiln site is being used for dumping waste. Thus, the gap appears to be of 500 tons per day," said the recent tribunal order. "With regard to sewage management, except one STP (Sewage Treatment Plant), none of the STPs are complying with respect to fecal coliform.

Govindpuram, Bapudham and Noor Nagar Morty for 56 MLD (million litres per day) of capacity are receiving only 11, 1 and 18 MLD respectively. It is not clear how Indirapuram STP is having treatment capacity of 70 MLD against the installed capacity of 56 MLD. Further, 10 drains are discharging BOD ranging from 29 to 218 mg/l of BOD into river Hindon," it read.

Further, the green court held that the civic bodies are liable to pay a compensation of Rs 200 crore for restoration purposes.

"..GNN has to deposit Rs. 150 crores and GDA Rs. 50 crores. The compensation be deposited with the District Magistrate Ghaziabad by the above authorities within two the tribunal directed

Man accuses Lingayat seer of exploiting his wife

A man on Saturday accused Lingayat seer Omkara Shivacharya Swami of Renukashrama in Avaragola of sexually exploiting his wife repeatedly for the past one-and-a-half years. Chandrashekar

Shivamogga has alleged that his wife has been sexually exploited by the accused swamiji in the ashram. He maintained that he has been trying to get his wife out of the clutches of accused swamiji. His wife has told him that she would commit suicide if anything comes out. He has also released an audio clip containing the conversation between him and the swami. In the audio, Chandrashekar is pleading with Swami to send his wife back to him. He also tells Swami that he had used his



wife for a long time. He tells Swami that he has the video as evidence and he should send her back if he does not want any trouble.

Chandrashekar maintained that married his lover after three years of courtship. However, as they could not have children even after five years, his wife started visiting the mutt. Later, she started visiting the mutt frequently. "I caught them red-handed during a festival," he alleged.

However, the incident got a twist when the wife came forward and rubbished the allegation of her husband. She claimed that her husband is a drunkard and has been blackmailing the swamiji for Rs 30 lakh. "My husband could stoop down to any level for

money," she said. "I challenge him to produce the video that he claims as evidence. Even I want to watch it. Swamiji has helped me to come out of my decision to end life. I could not bear the torture and abuse of my husband. My father has sold one acre of land and I have given all my gold to him," she alleged.

"We have special respect for the swamiji as our family follows his mutt," she said. The woman has also lodged a police complaint against her husband in connection

Mangolpuri stabbing: Youth killed for attending Ganesha immersion, claims family

NEW DELHI, SEP 10

The family of Mangolpuri stabbing incident victim on Saturday alledged that their son was murdered for being an ardent Lord Hanuman devotee and participating in Ganesha idol immersion. On Friday evening, Arman was brutally killed while his two brothers suffered injuries after being stabbed by a group of assailants led by one Shahrukh. The same group later stabbed two more youths -- Vicky and Ravi -- as they were associates of their rival. While police claim it to be a fallout of a personal rivalry, the family is giving a religious reason. "Arman was a devotee of Lord Hanuman, he used to go to Akhada and worshipped Lord Hanuman. He also participated in Lord Ganesha idol immersion. This irked Shahrukh, who along with his aides, killed him," the family alleged. A senior police official said that they got a call at 4.36 p.m. that three persons were stabbed in K Block in Mangolpuri. The injured persons identified as Armaan, Monty alias Moin Khan, and Fardeen were moved to Sanjay Gandhi Memorial Hospital where Armann was declared brought dead. Fardeen was admitted in the ICU of the hospital. Fardeen told the police that at around 2.15 p.m., he was going on his motorcycle when his vehicle touched one Shahrukh's bike. This led to an altercation with Shahrukh's aide Shahbir and Fardeen left the area after the argument. "Fardeen's brother Monty decided to resolve the matter peacefully with Sharukh. Monty, along with his cousin Arman, went to meet Shahrukh where they had a heated argument. Sharukh and Shahbir asked their associates to bring knives and finish the three brothers.

3 arrested as ex-RJD MLC's son creates ruckus inside police station in Patna

PATNA, SEP 10

Three people were arrested after a group of around 50 people, led by RJD ex-MLC Anwar Ahmed's son Asfer Ahmed, created a ruckus inside Pirbahore police station, police said on Saturday. Asfer Ahmed allegedly misbehaved with the police personnel and grabbed DSP Ashok Singh's collar and tore his uniform in the incident which took place late on Friday night.

"We were investigating an incident wherein some police personnel were assaulted by local goons of Sabzibagh and Pirbahore area. During the clash, we managed to arrest two persons for attacking police personnel on Thursday night. When I went to the crime scene for the investigation on Friday evening and detained a trader for questioning, Ahmed and his supporters came to the police



station and abused the cops. When I came out from the office of SHO, Ahmed also misbehaved with me as well and used abusive language," Singh said. "We were ensuring that he was detained on the basis of suspicion but he was not ready to listen to me. We also said that if his guilt would not be proved, he would be released. hunting/poaching by a few locals are grave issues here,

and community help is the need of the hour," he elaborates. According to Ganvir, securing the habitat of crocodiles is possible only with the help of locals. In accordance with this principle, people in the surrounding villages have been asked not to catch fish from the nullah that winds through the park.

Apart from regular fishing and hunting, there is also a demand for crocodile scales and skins among quacks and traditional healers. The forest healers. department has involved

"For the first time, we have seen the crocodiles lay eggs in six locations, and some have hatched too. It boosts our confidence," Ganvir says. The initial funding of Rs 12 lakh for the project was provided through the Compensatory Afforestation Fund Management And Planning Authority. Based on the initial success, the mugger mitra project has been extended for another two years.

Six drown in Ganesh idol immersion in Harvana

CHANDIGARH: Six people lost their lives during the Ganesh idol immersion in two incidents in Haryana, police said on Saturday. In the first incident, nine of 20 people were swept away by the strong current in the canal when they were carrying an idol for immersion in Jhagadoli village, Mahendragarh district. While four died, others were rescued and hospitalised by the district administration. In the second incident, two people drowned in the Yamuna river in Sonipat district. "The news of the untimely death of many people due to drowning in the canal during Ganpat immersion in Mahendragarh and Sonipat districts is heart-wrenching. We all stand with the families of the deceased in this difficult time. NDRF team has saved many people from drowning, I pray for their speedy recovery," Chief Minister Manohar Lal Khattar said in a tweet.

Class 12 student among 3 missing as snake boat overturns in Kerala

THIRUVANANTHAPURAM: Three people, including a class 12 student, are feared missing after a snake boat overturned in the Pamba river on Saturday in Kerala's Chennithala area. The boat was a participant of the Aranmula, Uthrattahi boat race as part of the Onam festivities. Police said that Adidevann, the Class 12 student, went missing first and the two others jumped into the water in search of him. The famous Aranmula Uttrathathi boat race is on Sunday and as per tradition, the boat first enters the Pamba river for some rituals and then proceed for Aranmula. Scuba divers are engaged in the search for the three who were part of the snake boat race team. Heavy under current in Pamba river due to incessant rains in the past few days led to the overturning of the snake boat However, locals said that children were seen jumping in the boat which would have toppled it in the Pamba river. Chengannur MLA and former minister Saji Cherian, while speaking to media persons, said that scuba divers, fire force and police are jointly searching for the missing people. Aranmula panchayat president Vijayamma told the media that 50 people were in the boat when it capsized. Notably, incessant rains in the central areas of Kerala have led to a rise in water levels in most of the rivers. With the snake boat race being held after months of preparations, several snake boats deployed by various regions are engaged in a fight

for supremacy in the waters. India logs 5,554 fresh Covid cases, 18 deaths

NEW DELHI: In the past 24 hours, India logged 5,554 new Covid-19 cases and 18 deaths, the Union Health Ministry said on Saturday. The new fatalities increased the nationwide death toll to 5,28,139. The active caseload has come down to 48,850 accounting for 0.11 per cent of the country's total positive cases The recovery of 6,322 patients in the last 24 hours took the cumulative tally to 4,39,13,294. Consequently, India's recovery rate stands at 98.70 per cent. While the daily positivity rate declined to 1.47 per cent, the weekly positivity rate stood at 1.80 per cent. Also in the same period, a total of 3,76,855 tests were conducted across the country. increasing the overall tally to over 88.90 crore. As of Saturday morning, India's Covid-19 vaccination coverage exceeded 214.77 crore. Over 4.06 crore adolescents have been administered with a first dose of Covid-19 jab since the beginning of vaccination drive for this age bracket.

Addressing the media, Rai said the Delhi government has deployed two mobile veterinary clinics and set up 11 rapid response teams to collect samples. Four teams have been formed to create awareness



The city government has also set up a special control room helpline 8287848586 for queries related to lumpy virus. However, he said that there is no threat for human beings with this virus. The deceased has been identified as 28-year-old Vineesh, a resident of Cherukol in Alappuzha district.



Surge in distress calls to TN health helpline after NEET results Janaspandana 'commission rally'

CHENNAI, SEP 10

The Tamil Nadu government's health helpline set up for providing counselling to NEET aspirants is flooded with calls from students

who failed to crack the exams.

After the NEET results were announced on Wednesday midnight, the number of calls to the helpline has increased manifold.

The psychological counselling for NEET-UG aspirants began in Tamil Nadu on July 19 as several students in the state had died by suicide last year after failing to crack the exam. Staff working with 104 helplines told IANS that callers are in a distressed state of mind and many callers wanted to know how they can cope up with the reality that they could not crack NEET.

The counsellors told IANS that most of the students who had approached them were those who



had got more than 90 per cent marks in core science subjects like Physics, Chemistry and Biology in their Tamil Nadu plus two board examinations.

A counsellor from 104 helpline who is attending to calls said: "Most of the students who are calling have

been doing consistently good in academics and scoring high marks in core science subjects. However, they failed to clear the test and hence are dejected and in a highly disturbed and distressed state of

She said that they feel that all their studies went in vain and that there was no other option other than ending their life. It may be noted that 1,32,167 students appeared for NEET-UG examinations from Tamil Nadu this year and of which 67,787 qualified.

The helpline staff also said that they had tried to reach out to the 19year-old girl from Ambattur in Chennai who died by suicide immediately after the results were

False charges by litigants after adverse order tend to demoralise judges: SC

NEW DELHI, SEPT 10

Deprecating the tendency of making allegations against judges after adverse orders are passed against litigants, the Supreme Court has said that it would ultimately demoralise judges."Nowadays, there is a tendency to make such allegations against the judicial officers whenever the orders are passed against a litigant and the orders are not liked by the litigant concerned. We deprecate such a practice," a Bench led by Justice MR Shah said.

'If such a practice continues, it will ultimately demoralise the judicial officer. In fact, such an allegation can be said to be obstructing the administration of justice," said the Bench, which also included Justice Krishna Mu-

The top court dismissed petitions seeking transfer of proceedings pending in a court at Dhaulpur in Rajasthan to a court of competent jurisdiction in Noi-da, Uttar Pradesh. "No ground is made out to transfer any of the proceedings as sought to be transferred," it said in an order passed



last week. One of the grounds on which the proceedings were sought to be transferred was that the petitioners believed they were not getting a fair trial and the respondents, being "local bigwigs",

could influence the court there. If the petitioners were aggrieved by any judicial order, the proper remedy would be to challenge it before a higher forum, it said, adding that merely because some adverse orders were passed against the petitioners, it couldn't

be said that orders were passed under influence. "We deprecate such a stand and the ground on which the proceedings are sought to be transferred. Merely because some orders are passed on the judicial side (in the present case in the execution proceedings), which may be against the petitioners, it cannot be said the court that passed the order was influenced," the Supreme Court Bench noted. The petitioner alleged that when the warrant issued by the

executing court was sought to be carried out, a false FIR was filed and, therefore, he feared for his

After completing my post-graduation in organic chemistry, I was set to leave for the United States for advanced studies. Still, at the very same time, I got selected for NSD (National School of Drama). Everyone got annoyed when I told my family I wanted to go for NSD. Initially, I had a negative impression of Bollywood. I did not want to be in movies. I believed that Bollywood was where actresses were expected to show themselves. I was content doing plays and theatre till I met my late husband, Gyan Shivpuri, who motivated me to do films. I began auditioning and feel grateful and fortunate to have worked in great classics such as Dilwale Dulhaniya Le Jayenge, Pardes, and Umrao Jaan.

What were the challenges you faced in



taking acting as your career choice?

I came from a small town in Uttar Pradesh and then shifted to Dehradun. At that time, venturing into the entertainment industry was frowned upon, and no one took my career choice seriously. I was often questioned, "Kya nautanki karogi? I had to convince my family to understand that acting is a serious business and that one must be formally trained to be an actor. Hence, I decided to join the NSD, which took a lot of convincing. Thankfully, my father, Haridutt Bhatt, supported me. Still, it was not as easy as it was difficult to explain to my family that choosing acting or theatre as a profession requires certain skill sets and equally hard work.

Tell us about your journey with theatre.

I participated in a play when I was seven but do not remember much about it. Since then, I have been involved with theatre, which has continued during my school and college days. During my MSC in chemistry, I performed a play by Betlot Bretch, "The Three Penny Opera." There were people from NSD conducting the workshop. That is when I realised this is what I wanted to do with my life. That is when I decided to attend the National School of Drama. Whatever plays I did in theatre are precious to me, but one called "Mitron Marjani" is one I performed all over the country and is one of my most memo-

rable performances. Despite your successes in Bollywood and television, you are still associated with theatres. What keeps you motivated?

Theatre will always be my first love, and acting on the screen will be my last. I can never leave the theatre. As an artist, I feel content doing both together, and I never bothered about the medium, only wanting to do good roles. One should have confidence in themselves and the determination to pursue it. I not only perform in theatres across Îndia.

2. Did those rejections stop you from pursuing your career? Being overweight makes us feel like we don't belong in this world. People tend to body shame us. We can't even get clothes our size because they don't make them. Yes, it was painful, but I never considered quitting my job because of it. But I chose to be strong and made fun of my obesity, so you have no power to make fun of me. Others may not be as courageous as you, but you should always accept and love yourself.

3. Now when you have registered yourself in the industry. Do you still want to continue doing plus-size characters? I am thrilled to play Amma Ji because it has given me a distinct identity on In-

dian television. There are very few people who are in my competition in the industry when it comes to character. So, being overweight, I have the benefit of roles specifically written with me in mind. 4. Your character, Amma Ji, has become a household name. Were you

expecting this kind of love when you started Bhabiji Ghar Par Hai? I was nervous about playing a mother's role when the role was offered to me I was asked to portray the mother of Rohitashv Gour.
