# India's G-20 presidency to be inclusive, ambitious: PM

AGENCY BALI, NOV 16

India's G-20 presidency next year will be inclusive, ambitious, decisive, and action-oriented, Prime Minister Narendra Modi assured on Wednesday at the closing session of G-20 Summit here in Indonesia.

The Prime Minister said that India is taking charge of the G-20 at a time when the world is simultaneously grappling with geopolitical tensions, economic slowdown, rising food and energy prices, and the long-term ill-effects of the pandemic.

"At such a time, the world is looking at the G-20 with hope. Today, I want to assure that India's G-20 presidency will be inclusive, ambitious, decisive, and actionoriented," he said.

"Over the next one year, we

will strive to ensure that the G-20 acts as a global prime mover to envision new ideas and accelerate collective action," the Prime Minister added.

Modi said that the sense of ownership over natural resources

is giving rise to conflict today, and has become the main cause of the plight of the environment. "For the safe future of the planet, the sense of trusteeship is the solution. LiFE i.e. 'Lifestyle



### **Sunak greenlights 3,000 UK visas for Indians hours after meeting Modi**

**LONDON:** UK Prime Minister Rishi Sunak has given the go-ahead for 3,000 visas for young professionals from India to work in the UK each year. The British government said India is the first visa-national country to benefit from such a scheme, highlighting the strength of the UK-India Migration and Mobility Partnership agreed last year.

"Today the UK-India Young Professionals Scheme was confirmed, offering 3,000 places to 18-30-year-old degree-educated Indian nationals to come to the UK to live and work for up to two years," the UK Prime Minister's Office said in a tweet.

This announcement in the Downing Street readout came hours after Sunak met Prime Minister Narendra Modi on the sidelines of the 17th edition of the G20 Summit. This was their first meeting after the first Indian-origin British PM assumed office last month.

"Prime Ministers @narendramodi and @RishiSunak in conversation during the first day of the @g20org Summit in Bali," PM Modi's Office said in a tweet.

### Modi holds bilateral talks with French President

BALI: Prime Minister Narendra Modi on Wednesday held bilateral talks with French President Emmanuel Macron in Bali on the sidelines of the G20 Summit. Besides Macron, PM Modi is also scheduled to meet seven other world leaders today. He is slated to have bilateral agreements with heads of Indonesia, Spain, Singapore, Germany, Italy, Australia and the United Kingdom.

On the second day of his official visit to Bali, PM Modi will participate in the Digital Transformation Session at the 17th edition of the G20 Leaders Summit.

#### Meet Hayer slams Amit Shah for defaming Pb in Gujarat polls

Decrying Union Minister Amit Shah's bogus statement on law and order situation in Punjab, Aam Aadmi Party (AAP) senior leader and Punjab Cabinet Minister Gurmeet Singh Meet Hayer on Wednesday said that it is just a futile attempt by BJP to malign the Punjab's image to gain political mileage in the poll-bound Gujarat.

on Wednesday.


According to the police, Aftab's family shifted to an unknown location without informing the police.

"When the Manikpur police took Aftab's statement after calling him to

Vasai, Aftab's family shifted to an unknown place. Aftab's family is not in contact with Manikpur police either," the police told.

The victim in the case, Shraddha Walker's family had registered a missing complaint about her in PS Manikpur. Later, Aftab was called for questioning twice.

"Aftab stated that he and Shraddha don't stay together anymore," the sources said. The police sources said that the family shifted without the knowledge of the police because they



had an idea of the son's activities. "That's why they shifted in haste without informing the police. Aftab also came home at the time of shifting. Aftab collected some of his belongings from the house. The family shifted only after the first summons issued by the Manikpur police," the sources said. The police had called Aftab for the second time on November 3, when the case came to light. The police officers from Manikpur Police station went to Delhi on November 8 in relation to the case.

### Bank ATM looted in Una

UNA (HP), NOV 16

A case of robbery has come to light in the ATM of Punjab National Bank located at Pandogha Kaswa in the Una district of Himachal Pradesh. There was the cash of about 10 lakh rupees in the ATM. The cash was extracted by cutting the ATM machine with a masked cutter. The incident took place on Tuesday night, according to a spokesman of the Police department.

He said that some masked men first blackened the CCTV with spray paint, and then looted the ATM. In the initial police in-

vestigation, 2 persons are seen coming into the CCTV, whose faces were covered with masks. On the other hand, the police are tracing the vehicles and people who crossed the Pandogha barrier on Tuesday night, so that they can get clues about the robbers. According to the information received at the police control room about a robbery at PNB's ATM in Pandogha at around 2. A.M, the police blockaded the border area. Punjab police were also informed as Pandogha is located near the HP border with Punjab. SP Arjit Sen Thakur also reached Pandogha on Wednesday and inspected the spot.

### SC stays Bombay HC observations prohibiting feeding of street dogs

NEW DELHI, NOV 16

Observing that nobody should stop feeding stray dogs as canines may become aggressive, the Supreme Court, in an interim order on Wednesday, stayed certain observations of the Bombay High Court in which it was said that who are interested in feeding stray dogs to "formally adopt" them and directed that no nuisance must be created by people while feeding them.

A bench of justices Sanjiv Khanna and JK Maheshwari sought a response from Nagpur Municipal Corporation (NMC) and Animal Welfare Board on a plea against the Bombay High Court order over guidelines on stray dog feedings.

The court stayed the certain observation of the Bombay High Court related to persons interested in feeding



dogs having to adopt them till the next date of hearing.

The top court while hearing the matter passed various remarks including one that whether street dogs have any residence to live in. The court said

"where do street dogs live and do the canine have any residences to live in?"

Supreme Court further expressed concern about keeping the street dogs in captivity and said that they are not meant to be kept in captivity. The court

insist that people who feed dogs must adopt them.

In an interim order, the court di-

rected the Nagpur Municipal Corporation to ensure and take steps for the general public to feed the street dogs at the appropriate locations identified and demarcated by them. The court also asked the general public to ensure that no public nuisance is caused by feeding stray dogs. The court asked the concerned municipal corporation to note down details and names if any feeders who are creating public nuisance but not to take any coercive step against them till the next date of hearing. The court said that proceedings before Bombay HC will continue and also clarified that the concerned corporation to deal with the issue of the nuisance caused by the street dogs in accordance with the law.

#### Delhi Court defers Minister Satyender Jain's bail plea till today

The CBI Court at Rouse Avenue on Wednesday deferred for tomorrow the pronouncement of the order on bail petitions of Delhi Minister Satyender Jain, two others in the Money Laundering case.

Enforcement Directorate (ED) arrested Satyender Jain on May 30.

Special CBI Judge Vikas Dhull on Wednesday said, the order copy is not ready for all three accused. It will take some time. Will pass the order tomorrow 2 pm.

The Court on November 11, had kept the order reserved after the conclusion of arguments from all sides.

arguments from all sides.

During arguments, it was submitted on behalf of Jain that the investigation related to the applicant has been completed and a charge sheet has been filed. No case of money laundering is made out against the applicant.

Senior advocates N. Hariharan and Rahul Mehra submitted that it is alleged that a conspiracy for money laundering was hatched in 2010. At the time neither Jain was an MLA nor a Minister. So



spiracy for money laundering? It was also submitted that as per the charge sheet the other accused have admitted that the money allegedly laundered belongs to them. Jain has nothing to do with the companies in question. On the other hand, the bail plea was opposed by the ASG for ED. The ASG S V Raju submitted that there are witnesses and materials sufficient to make out a case of money laundering against the accused.ASG submitted that the accused was involved in money laundering with other accused. He sent money to Kolkata-based companies and that money belong to

#### 8 lakh, 37 thousand, and 909 metric tonnes of paddy were purchased: DC Dr. Sangeeta Tetarwal

KAITHAL: Dr. Sangeeta Tetarwal said that till yesterday, 8 lakh, 37 thousand, and 909 metric tonnes of paddy have been procured by the procurement agencies in various mandis of the district at the minimum support price, whereas in the same period last year, 7 lakh, 56 thousand, and 575 metric tonnes of paddy were procured in the district. The Food and Supplies Depart ment has purchased the maximum of 4 lakh, 35 thousand, and 857 metric tonnes of paddy among the procure-

He said that proper arrangements have been made in the mandis for the convenience of the farmers. So far, 8 lakh 37 thousand, and 909 metric tonnes of paddy have been procured. The Food and Supplies Department procured 4 lakh, 35 thousand, 857 metric tons, HAFED 2 lakh, 19 thousand, 188 metric tons, and Haryana Warehousing Corporation 1 lakh, 82 thousand, 864 metthe mandis, 8 lakh, 36 thousand, and 35 metric tonnes of paddy have also been lifted.

#### Govt has started electricity surcharge waiver scheme: SDM **SANJAY VERMA**

He informed that the freezed surcharge will be waived in proportion to the continuous payment of the next 6 bills. If the consumer does not deposit his principal amount in lump sum or in fixed installments.







## SC orders retrial in 2018 Kathua rapemurder, accused to be tried as adult

NEW DELHI, NOV 16

Supreme Court on Wednesday set aside a Jammu and Kashmir Court order and ordered a fresh trial of the accused in the alleged 2018 rapecum-murder of an eight-year-old girl from a nomadic community.

"The accused is to be tried as an adult and not a juvenile in the Kathua case," a bench of the Supreme Court, headed by Justice Ajay Rastogi and also comprising Justice J Pardiwala, ruled.

The Supreme Court passed the judgement on the issue of juvenility of one of the accused, who was earlier held as a juvenile by the Chief Judicial

Magistrate Court Kathua.

The Jammu and Kashmir government had claimed that the High Court had erroneously affirmed the order of a trial court holding the main accused to be a



medical opinion regarding the age in absence of any other conclusive evidence should be considered to determine the age range of the

"Whether the medical evidence can be relied upon or depends on value of evidence. "Thus order passed by CJM Kathua is set aside and thus

the accused is held not to be a juvenile at the time of crime," the apex court said, in its verdict.

According prosecution, the eight-year-old girl from the nomadic community of Bakerwal was allegedly kidnapped from Kathua's Rasana area on January 10, 2018, and was found dead on January 17 that year.

According to a 15-page charge sheet, the victim was kidnapped, drugged, hit by a stone, raped and strangulated inside the temple premises by the accused.

On June 10, 2018, a trial court in Pathankot had sentenced three convicts in the case - Sanji Ram, Deepak Khajuria and Parvesh Kumar – to life imprisonment.

While Ram was the mastermind of the crime and the caretaker of the temple where the child was allegedly raped, Khajuria was a police officer. Special Police Officer

Surender Verma, head constable Tilak Raj and sub-inspector Anand Dutta were awarded five years in prison for destroying evidence.

The Jammu and Kashmir trial court had acquitted the seventh accused, Vishal sevenin accused, Vishal Jangotra, son of Sanji Ram, by giving him the "benefit of

#### **Forgotten luminary**

urendranath Dasgupta's first volume of A History of Indian Philosophy (1922) marked a watershed moment in the evolution of Indian thought. Unfortunately, neither Dasgupta nor his substantial body of writings is remembered outside the world of philosophers, academics and interested students. Of all of Dasgupta's work, Philosophy (published in five volumes), the last of which was barely completed on account of his sudden death in 1952, is the most account of his sudden death in 1952, is the most renowned. Each volume was reviewed by major scholars of that time, such as Sarvepalli Radhakrishnan, Louis Renou and F.W. Thomas.

Although the works of Indologists like Max Mueller and Vivekananda's speeches and writings had made the Western world take serious note of India's heritage, Dasgupta's was the most systematic and comprehensive, based on primary materials in San-skrit, Pali and Prakrit, that was widely hailed in the acskrit, Pali and Prakrit, that was widely hailed in the academic world. There are many reasons why Dasgupta's work made a difference. He was among the foremost Sanskritists of his time. Besides, his deep knowledge of Western science and philosophy together with exposure to the stimulating environment of Cambridge equipped him ideally for the task. His logical analysis made him overtly critical of some of the established lines of thinking. He did not allow his personal emotions, mystical experiences and spiritual attainments to cloud his analytical thinking.

In the first volume of Philosophy are covered the Vedas, Brahmanas and the early Upanishads, the six systems of Hindu thought together with Buddhist and Jaina philosophy; the second volume deals with the Sankara School of Vedanta (continued from the first)

Sankara School of Vedanta (continued from the first) and the philosophy of the Bhagavad Gita, among others; the third with the principal dualistic and pluralistic schools and philosophical ideations of some Puranas; the fourth with Indian Pluralism in the philosophical realm; and the last volume examines southsophical realm; and the last volume examines southern Saivism, Saiva philosophy in the Puranas and other important texts. Such was the single-handed, majestic sweep of Dasgupta the like of which was not attempted earlier or since. Dasgupta remained amazingly productive till his last day, though eye and heart ailments made him virtually bedridden for the last eight years of his life. Many of his other works like Yogaas Philosophy and Religion and Indian Idealism are considered influential, but his lasting fame rests on Philosophy. # **Congestion in traffic may** contribute to lower birthweight

There is a wealth of data highlighting the negative health effects of vehicle-related air pollution, but there is little research on how bottleneck traffic, rather than overall traffic volume, can lead to negative health outcomes

Now, a new study led by a Boston University School of Public Health (BUSPH) researcher has found that traffic-congestion">traffic congestion may be linked to

lower birthweights.
Published in the journal Science Advances, the study found consistent associations between traffic delays and a nine-gram reduction in birthweight among infants born to parents who reside in areas with heavy traffic, such as highways or freeways. More than 11 million people live within 150 meters of highways, and the study results showed that up to 1.3 million pregnant people, representing 27 per cent of US births, may be exposed to high levels of traffic-congestion">traffic congestion annually.

"For years, we've had detailed models to predict air pollution, but these models largely omit traffic congestion">traffic congestion">traffic congestion">traffic congestion">traffic congestion

largely omit traffic-congestion">traffic congestion - because it could not be measured at a large scale," says study lead and corresponding author Dr. Mary Willis, assistant professor of epidemiology at BUSPH. "If there are 10,000 vehicles on a road doing stop-and-go traffic, the air pollution concentrations, and likely composition, is very different compared to 10,000 vehicles at free-flow speeds. Our results show that there are likely health impacts specific to congestion, which are not included in most environmental risk assessments or cost-benefit analyses--and we think that those should start to be included in the conversation." Traffic delays have risen steadily across the country since 1982, and the researchers chose to examine potential links to low birthweight because it can lead to im-



mediate and long-term consequences, such as difficulty breathing, cardiovascular disease, cognitive impairment, and premature mortality.

This study is the first to examine the impact of congestion on birth outcomes, in part due to challenges measuring traffic delays in large geographic areas. Willis and colleagues utilized almost 580,000 birth certificates in Texas and measured congestion levels through data from connected vehicles and devices that reflect actual driving volumes and speed. After controlling for background air pollution levels, transporta-

tion noise, and other environmental co-exposures, the results also indicated that mothers who lived closer to highways and freeways experienced slightly larger impacts from traffic jams, with 260,000 pregnancies occurring in the highest-congestion areas. While a nine-gram reduction in weight is a relatively small decrease, the researchers say this finding lends important implications for population and environ-mental health. "A nine-gram decrease alone isn't a clinically significant result on its own, but this result indicates that some sort of biological impacts may be happening,

which will push some babies into a clinically relevant adverse impact of low birth weight," Willis says. "When you multiply that by 27 percent of all births being in highcongestion areas, that small decrease in birthweight does translate into a substantial potential impact at the population level." This data can also inform congestion-related policies and programs, which occur at the local level, unlike tailpipe emissions, which are primarily regulated at the federal level. The researchers note that stop-and-go traffic further increases air pollution through the extra wear on the brakes.

#### A simple 'thank you' among couples can go a long way

The findings of new research suggest that gratitude from one's partner may be a powerful tool for couples as it increases relationship satisfaction and commitment while protecting couples from the corrosive effects of ineffective arguing and financial stress.

Individuals who feel appreciated by their partners have better-functioning relationships that are more resilient in the moment when the appreciation is expressed and over the long term, said researcher Allen W. Barton, a professor of human development and family studies at the University of Illinois Urbana-Champaign. Over a 15month period, Barton's team examined the effects that expressed gratitude conveying appreciation to one's partner - and perceived gratitude - feeling valued and appreciated by one's partner - had on the relationships of 316 African American couples.

This study was really motivated to understand gratitude in relationships and if it can protect couples from challenges and hardships, be it negative communication or broader factors like financial strain," Barton said. "Much of the prior research looked at the relational effects of expressing gratitude, but one could make the argument that



feeling appreciated by one's partner is important, too. And we tested both to see whether one was more influential for couple relationships than the other," Barton said.

The majority of those in the study were middle-aged and lived in small communities in rural Georgia. While most of the participants were employed, about 65 per cent of the couples had joint incomes that were less than 150 per cent of the federal poverty level and could be classified as working poor, Barton said The total number of children residing with the participants ranged from one to eight, averaging three. The married couples had been together for about 10 years while the unmarried couples had been cohabiting for nearly seven years when the study began.

#### **Aerobic exercise lowers risk** of metastatic cancer

The amount of glucose (sugar) consumed by internal organs rises during intense aerobic exercise, according to the researchers, which decreases the amount of energy available to the tumour.



Prof. Levy and Dr. Gepner: "Studies have demonstrated that physical exercise reduces the risk for some types of cancer by up to 35 percent. This positive effect is similar to the impact of exercise on other conditions, such as heart disease and diabetes. In this study we added new insight, showing that high-intensity aerobic exercise, which derives its energy from sugar, can reduce the risk of metastatic cancer by as much as 72 percent. If so far the general message to the public has been 'be active, be healthy', now we can explain how aerobic activity can maximize the prevention of the most aggressive and metastatic types of cancer."

The risk of severe neurological symptoms and complications, such as worsening seizures, declining language and motor skills, and even death after contracting the flu, made the research, led by the Murdoch Children's Research Institute and the University of Melbourne, conclude that the safe administration of the seasonal influenza vaccine should be a priority in people with SCN1A-positive Dravet syndrome.

The choice for parents to vaccinate children with this syndrome is complicat-



ed, according to paediatric neurologist Dr Katherine Howell of Murdoch Children's, because seizures can be brought on by both infection and immunisation. Despite the syndrome being linked to the high incidence

of protracted seizures during infections, according to Dr Howell, the effects of influenza had not yet been researched.

#### **ASCI releases half-yearly** complaints report for 2022

handigarh: The Advertising Standards Council of India (ASCI) released its halfyearly complaints report (April to September, 2022). During the period, it processed 3,340 complaints against 2764 advertisements that were in poten violation of the ASCI code. About 55% of these ads were spotted across the digital domain, followed by 39% in print and 5% on television. As compared to 2021-22, ASCI saw a 14% rise in the number of complaints while witnessing a 35% increase in the number of ads processed. Education remained the most violative sector with 27% of the complaints related to it - 22% belonged to the classical education category while 5% were from the ed tech sector. These were followed by personal care (14%), food & beverages (13%), healthcare (13%) and gaming (4%). ASCI's surveillance remains strong, picking up 65% of the ads processes suo motu. 98% of consumers' complaints were received by the artificialntelligence-based complaints management system TARA. The introduction of TARA has given consumers a comprehensive, hassle-free redressal process. About 16% of the total complaints recorded were from consumers, followed by 15% from the government, while intra-industry complaints comprised 3%. Of the 2,764 potentially objectionable ads processed, 32% were not contested by the advertisers, 59% further were found in violation of the ASCI code and 8% were found not to be violating the code.

Manisha Kapoor, CEO and Secretary-General, ASCI, said: "Looking at the rapid growth of digital advertising, we have invested heavily in ad-surveillance technology. We will continue to upgrade and streamline our processes to provide a more responsive platform to all stakeholders, including consumers, brands and government bodies. In our constant pursuit of transparency, we have released a comprehensive report about the kinds of complaints and outcomes that ASCI has looked into during the first six months of the financial year." Of the total complaints received by ASCI, 28% of the violations were by influencers. Of the 781 complaints processed against influencers, 34% were from the personal care category, followed by food and beverage at 17%, and virtual digital assets at 10

Gupta said that a garbage processing plant is being established near Jhuriwala to dispose of the city's waste. This plant will be based on the most

For this, the Haryana Urban Development Authority had transferred the land to the Municipal Corporation in the year 2017. The work has been started here only after taking clearance from the concerned departments.

In the last 2 years, the progress of the processing plant slowed down due to the Covid-19

pandemic. Meanwhile, due to an interim decision of the Supreme Court and the new guidelines of the central government, some work has stopped. On this, he has asked the top officials of the state's Urban Development Authority, Panchkula district administration, Municipal Corporation, Pollution Control Municipal Board, Forest Department to complete this project with joint efforts. Along with this, he has asked the officials to seriously study the interim decision of the Supreme Court and the guidelines

Indian middle-order batter Suryakumar Yadav saw a decline in his rating points, but nonetheless retained his top spot in the ICC T20I Player Rankings issued on Wednesday.

After superb performances in Super 12 of the ICC T20 World Cup, Suryakumar Yadav dethroned Pakistan's Mohammad Rizwan to become the top batter. But his rating points declined from 869 to 859 after a poor 14 against England in the semifinal, which Indian lost.

Suryakumar still finished the tournament with 239 runs in six innings at an average of 59.75, a strike rate of 189.68, the highest among batters and three half-centuries.

England batter Alex Hales continued to impress, smashing 86\* off 47 balls against India in semis, which helped him jump 22 spots to reach number 12 position among batters.

He finished the tournament



with 212 runs at an average of 42.40 and two fifties, as the second-highest batter for England. Ever since his comeback to the national side this year after 2019, he has scored 430 runs at an average of 30.71 and a strike rate of 145.27.

Babar Azam's match-winning half-century in the semis against New Zealand helped him climb to number three in the rankings. Rilee Rossouw of South Africa jumped to the seventh position while Kiwis batter Glenn Phillips dropped to the eighth spot. Both had scored centuries in this T20 World Cup.


