At least 56 killed, 700 injured in Indonesia earthquake

AGENCY JAKARTA, NOV 21

At least 56 people died in an earthquake that hit Indonesia's main island Java on Monday, Channel News Asia reported citing an Indonesian government of-

In the morning, a shallow 5.4 magnitude earthquake hits Indonesia's western province of West Java, according to the United States Geological Survey (USGS).

The earthquake's epicentre was on land in Cianjur, about 75km southeast of Jakarta, and at a depth of 10km. According to CNA citing sev-

eral reports, stated that around 700 people were injured in the West Java town.

"The latest data showed that 46 people were killed. Victims kept coming from many areas. Around 700 people were injured,' Herman Suherman, the head of the administration in Cianjur, told broadcaster Kompas TV.

He also earlier told broadcaster Metro TV that many of the injured "had fractures from being trapped by the ruins of buildings".

A 5.6- magnitude earthquake rattled the Indonesian capital of Jakarta for several seconds on



Monday, the country's weather and geophysics agency (BMKG) said, adding there was no potential for a tsunami.

The epicentre was determined to be at 6.840 degrees south latitude and 107.107 degrees east longitude. Java's largest city is the national capital of Jakarta.

Java is a volcano-dotted island that lies between Sumatra and Bali and is situated at the geographic and economic centre of

Haryana launches CHIRAYU scheme to benefits 29 lakh families

300 MW canal top and floating solar power projects to be set up in Punjab: Aman Arora

With an aim at further ramping up renewable energy while utilising natural sources optimally, the Chief Minister S Bhagwant Mann led state government has decided to install Solar Power Photovoltaic (PV) projects with a total capacity of 300 MW in Punjab. These projects include 200 MW Canal Top Solar PV Power Projects and 100 MW Floating Solar PV Power Project on the Reservoirs and Lakes. This decision was taken in a high-level meeting chaired by Punjab New and Renewable Energy Sources Minister Mr. Aman Arora in his office at Punjab Civil Sec-

Mr. Aman retariat-1 here. Arora said that the proposed 200 MW Canal Top Solar Project would be installed in a phased manner, under which 50 MW would be installed in the first phase, while projects of remaining capacity would be installed in subsequent phases. These projects will be executed in Build, Operate and Own (BOO) mode by Punjab Energy Development Agency (PEDA), he added. Discussing the feasibility for setting up of these projects, the Cabinet Minister said that Viability Gap Funding (VGF) has been proposed to be claimed from the Department of Economic Affairs under the Ministry of Finance (GoI),

SC says Gujarat Morbi Bride collapse incident was an "enormous tragedy" NEW DELHI, NOV 21 The Supreme Court on Monday said

that the Morbi Bride collapse incident which claimed over 140 lives was an Gujarat High Court which is already hearing a suo motu case on the same issue, to hold periodical hearings.

"It is an enormous tragedy and this will require weekly monitoring to see the award of contract, credential of the party awarded the contract, attribution of responsibility for those guilty," observed a bench of Chief Justice DY Chandrachud and Justice Hima Kohli.

The apex court noted that a divi-

sion bench headed by the Gujarat High Court Chief Justice has already taken a suo motu note of the incident and has passed three orders, it will not hear the petitions as of now.

It asked petitioners to approach

the High Court with their pleas seeking an independent probe and award of dignified compensation to those who lost their family members.

The British-era bridge on the Machchhu river in Morbi collapsed including 47 children.

The top court was hearing a plea filed by the person who lost his two relatives in the incident, seeking a CBI probe, award of dignified compensation to those who lost their family members, the need to fix responsibility against officials of the Nagar Palika and that the agency entrusted to maintain the bridge is held accountable. It was also hearing a PIL seeking direction to appoint a judicial

commission under the supervision of a retired top court judge to initiate a probe on the Morbi Bridge collapse incident. During the hearing, the bench said the Gujarat High Court had already taken suo motu cognisance of the Morbi bridge collar October 30 hence it wouldn't hear the case. It said the High Court would 'undoubtedly be seized of ensuring a regulatory mechanism so that such incidents do not recur." "We are of the view that the High Court would also bring to bear its time and attention on other aspects of the matter which have been highlighted above while recording the submissions of the learned counsel of the petitioner," the

Naxalites set fire to 5 vehicles, 4 mobile towers in Chhattisgarh

KANKER: A group of Naxalites set fire to as many as five vehicles and four mobile towers in Atangarh assembly limits of Chhattisgarh's Kanker district on the intervening night of Sunday and Monday, an official said.

Besides, the Naxals also blocked the Antagarh-Narayanpur state highway by cutting down five trees in the Tadoki police station area, according to Kanker Superintendent of Police (SP) Shalabh Sinha, who has confirmed the news of the incident.

According to SP Shalabh Sinha, the Nax-

als carried out as many as eight incidents in Antahgarh town last night. They burned the PV-45 Jio mobile tower in the Koyalibeda area and also set fire to other Jio towers in Jiram Terai area, in Sirsangi of Antagarh area and in Badrangi. They blocked the Antagarh-Narayanpur state highway and road from Koylibeda to Marda village by cutting down trees. The Naxals also burned a private bus just a kilometre from Koylibeda police station and ablaze JCB, Hyva, grader and tractor in Markanar, SP Sinha said.

Reddy is the head of a Hyderabad-based Aurobindo Pharma company and is engaged in the liquor business. Babu is the head of a company named Pernord Ricard.

In a major expose, the Karnataka police have exposed global terror plot in the Mangaluru autorikshaw blast case. Karnataka ADG (Law and Order) Alok Kumar said Shariq, the injured passenger who was traveling in the ill-fated autorikshaw, was being handled by a handful of people belonging o terrorist groups including Mussavir Hussain and Arafat Ali. "The immediate handler of Shariq was Arafat Ali, who is accused in two cases. He had links with Mussavir Hussain, an accused in the Al-Hind module case. The main handler of Shariq was Abdul Matin Taha. Another 2-

3 handlers also worked with Shariq, but they are yet to be identified," he told reporters in a press conference here on Monday. Shariq was planning more blasts in coastal cities of Karnataka, Kumar said. The accused was given to ISIS ideology and made bomb at his home.

On September 19, he along with two others carried out a trial blast at Tunga River bank in Shivamogga. The police have also filed a case against Shariq for impersonation. Kumar said Shariq was in possession of Aadhar cards belonging to three persons including one by name Prem Raj Hutagi who is a railways employee working as a gangman in Tumakuru



366 drug smugglers held with 8kg heroin, Rs 1.22 cr drug money in week

rooms across the state in violation of the guidelines of the Election Commission.


In the letter, the example of Nahan assembly constituency was given in which it is feared that Congress leaders are trying to enter the strong room along with ITBP jawans.




Leaders demand forced transfers be withdrawn and false police cases be quashed

Policy for all

Recently, the idea of promoting gender considerations in the foreign policy discourse has gained traction. This is pertinent, taking into consideration the growing influence of the global South in refurbishing the pathways to sustainable development. In fact, gender is not a standalone issue but a collective priority shared by the 17 sustainability targets. In this context, development partnerships are considered to be pivotal in forging effective alliances and bridging the gap between partners and

India's development cooperation has multiplied. It has partnered fellow developing countries utilising a budget of \$7.66 billion. During the surge in Covid-19, India's vaccine diplomacy campaign, 'Vaccine Maitri', placed it on the global geopolitical front as the 'first responder in emergency situations'. Although New Delhi is opening alternative modes of financing, there is a need to include gender as a distinct objective in its interventions. This can be discerned from the statement made by India's external affairs minister, S. Jaishankar, at the BRICS Academic Forum in 2021 in which he argued that Narendra Modi's appeal for a human-centric globalisation is closely related to the broader inequalities that existed way before the pandemic entered the global scene. To achieve 'development through diplomacy', India's development cooperation should not only emphasise on but also put into practice its human-centric aspect. Although India's Development Partnership Administration has described its approach as 'human-centric', it needs to streamline gender objectives in its initiatives. For instance, it has been observed that the potential contribution of the female population towards triggering the economic growth engine remains undervalued. Increasing social resilience of the communities is a longterm strategic goal that India's development cooperation must accentuate. This not only includes promoting women's rights but also the inclusion of the marginalised sections to create parity across platforms. Moreover, a gendered dimension in development cooperation is linked with socio-economic progress on a long-term scale. Incidentally, the sustainable development agenda lays down gender equality as a holistic and interconnected goal to be realised across the SDG targets. Several countries, including Canada and Germany, have released their Feminist Foreign Policies; India is yet to come up with one. However, there are reservations regarding FFPs. As Amrita Narlikar points out in her critique of the German FFP, FFPs should not only be about including women in policy debates but also other ethnicities, races.

Process for appointment of new Pakistan army chief begins

process for the appointment of a new army chief is likely to begin today. The government is hoping that Pakistan President Dr Arif Alvi will not create any hindrance in the appointment process, Dawn reported.

Notably, the tenure of incumbent Chief of Army Staff (COAS) General Qamar Javed Bajwa will end on November 29. However, Pakistan's new army chief will likely be appointed before November 27, as per the Dawn report.

Smartwatches have potential to detect emerging health problems: Study

kin-like electronics combined with Artificial Intelligence are being developed by researchers in order to detect potential emergent health concerns.

This study was published in the journal Matter with the title "Intrinsically stretchable neuromorphic devices for on-body processing of health data with artificial intelli-

tronics are becoming increasingly common, they have yet to realise their full potential. Precision medical sensors that are placed on the skin to do health monitoring and diagnostics could be made possible by this technology in the near future. It'd be like having a cutting-edge medical institution at your disposal at all times.

Such a skin-like device is being developed in a project between the U.S. Department of Energy's (DOE) Argonne National Laboratory and the University of Chicago's Pritzker School of Molecular Engineering (PME). Leading the project is Sihong Wang, assistant professor in UChicago PME with a joint appointment in Argonne's Nanoscience and Technology division. Worn routinely, future wearable electronics could potentially detect possible emerging health



problems -- such as heart disease, cancer or multiple sclerosis -- even before obvious symptoms appear. The device could also do a personalized analysis of the tracked health data while minimizing the need for its wireless transmission. "The diagnosis for the same health measurements could differ depending on the person's age, medical history and other factors," Wang said. "Such a diagnosis, with health information being continuously gathered over an extended period, is very data intensive.'

Such a device would need to collect and process a vast amount of data, well above what even the best smartwatches can do today. And it would have to do this data crunching with very low power consumption in a very tiny space.

China opens new big data centre in Lhasa

hinese government has set up a new centre for big data operations in Lhasa, raising fear among analysts and human rights experts this could be an-

other means of monitoring or increasing policing of the local population.

The big data centre which began last month is reported to be the first such initiative at the regional level and a step toward big data integration and application sharing, China Daily reported.

tre will boost digital services, including government affairs, economic development, social governance, people's livelihoods, market supervision, finance, border prosperity, ecological environment protection, emergency fire control and cultural tourism.

However, rights experts and analysts are skeptical about claims made by state media, given the recent introduction of dual-use policy measures that infringe upon

the personal freedom of Tibetans.

Back in September, New York-based
Human Rights Watch (HRW) reported that Chinese authorities are significantly increasing policing, including an arbitrary collection of DNA from residents in many towns and villages throughout the Tibet Autonomous Region (TAR). The rights watchdog said the available information indicates that people cannot decline to provide their DNA and that police do not need credible



evidence of any criminal conduct. A report from Lhasa municipality in April stated that blood samples for DNA collection were being systematically collected from children at kindergartens and from other local residents. A report from a Tibetan township in Qinghai province in December 2020 stated that DNA was being collected from all boys aged 5 and above.

"The Chinese government is already subjecting Tibetans to pervasive repression," said Sophie Richardson, China director at Human Rights Watch. "Now the authorities are literally taking blood without consent to strengthen their surveillance capabilities.


These mass DNA collection drives appear to take place in all seven prefectures or municipalities in the TAR, covering the western part of the Tibetan plateau.



Farmers are given financial assistance in the case of accidents

KARNAL: Deputy Commissioner Anish Yadav said that during the agricultural work in the state of Haryana, financial assistance was provided to the victims of accidents while coming and going from fields, villages, market yards, and such places, under the Mukhya Mantri Kisan Evam Khetihar Jeevan Suraksha Yojana, by the Market Committee. He told me that farmers and agricultural labourers have to work day and night in the fields. Due to this, there is a possibility of many types of accidents. For this, financial assistance is given by the government, including Rs. 5 lakh in case of death during an accident, Rs. 2 lakh and 50 thousand in case of permanent disability due to a spinal cord fracture or otherwise, and Rs. 1 lakh, 87 thousand, and 500 rupees in all other cases. Similarly, Rs. 1 lakh and 25 thousand rupees for a fracture of a limb or permanent injury, Rs. 75 thousand rupees for a complete finger fracture, and Rs. 37 thousand rupees for a partial finger fracture are given through the market committee as a government

He said that for this, it is necessary to have a police report and a postmortem; in the case of disability, a certificate; and in the case of organ loss, a photocopy of the remaining organ should be submitted along with the claim. The applicant has to apply to the secretary of the concerned market committee within two months of the accident.

Children with clubfoot deformity examined at medical camp




KARNAL: A special camp was organized for children suffering from congenital clubfoot deformity under the chairmanship of Dr. Balwan, officiating PMO at District Civil Hospital, Karnal. Also in the camp, Children's doctor, Dr Pruthi, Dr Rajnish DMS, Orthopedic Specialist Dr Saurabh, DEIC Manager Dr Archana, Physiotherapist Dr Shruti Nagpal, Dr Hari Om, Psychologist Dr Hawa Singh, all the team of doctors were specially present


Children suffering from clubfoot were invited to this camp. Parents of affected children were motivated to complete clubfoot treatment for five years. Orthopedic specialist Dr Saurabh said that clubfoot is a disease which, if treated in normally. And if the treatment is not done on time, then the bones of children's feet become hard and stiff and such children cannot walk normally

DEIC Manager, Dr. Archana said that under the National Child Health Program, apart from clubfoot disease, congenital heart diseases such as heart defects, squint, blindness, deafness, cleft lip and palate, Down's syndrome, physical and mental retardation, dental eases are treated free of charge After this, all the children were examined by Dr Saurabh. After the examination, three children were plastered, 20 children were given club foot shoes and braces by Sujata Saini, Program Executive from Anushka Foundation. Currently, 48 children are undergoing treatment in the Civil Hospital of Karnal district, out of which three children's legs have been completely cured and the treatment has been completed. The rest of the children are being treated. The clinic is open every Saturday from 9 am to 3 pm. Children affected by clubfoot are treated very easily by the Ponseti method in three stages, in which the first stage is casting, children with clubfoot are given a cast (plaster) every week for four to eight weeks. The second step is tenotomy, which is a minor procedure in which the Achilles tendon is cut, which is then reshaped. The third phase is bracing which lasts for three to five years.
