The incident occurred between 1 pm and 1:30 pm on Friday, the police official stated. Before coming to the police, Kambli's wife got herself treated at Bhabha Hospital, he added.

16 children fall ill after eating poisonous Jatropha fruit in Mirzapur

MIRZAPUR: As many as 16 children have fallen il after allegedly eating poisonous Jatropha fruit in a colony in Chunar police station area on Saturday a senior official here said. The children had consumed the poisonous fruit "mistaking it for almond," the official said, adding the condition of all the

children is stable. The children were admitted to the Divisional Hospital and are being treated under the supervision of Mirzapur Medical College Principal R B Kamal.

"The children were first brought to the Community Health Centre. After giving first aid, the children were admitted to the Divisional Hospital," Kamal said. "Some children of Chunar's Kansiram Awas Colony were playing in the nearby LIC campus after coming from school.

BUREAU GORSIAN KHAN MO-HAMMAD (LUDHIANA), **FEBRUARY 5:**

In a historic initiative aimed at ensuring supply of cheap sand and gravel to the public, the Punjab Chief Minister Bhagwant Mann today dedicated 16 public mines here to the masses thereby ensuring pit head price of sand to Rs 5.50 per cubic feet.

Interacting with the media persons after dedicating 16 public mining sites spread over seven districts here today, the Chief Minister said that the state government has fulfilled another poll guarantee made with the people. He said that the state government has eradicated the sand mafia which had flexed its muscles in the past to ensure that people get cheap sand. Bhagwant Mann said that now the sand will be sold at just Rs.5.50 in each of these public mining sites thereby giving a major reprieve to the people.

The Chief Minister said that only manual excavation of sand will be permitted in these public mining sites and no mechanical excavation of sand will be allowed. He categorically said that no mining contractor will be al-



lowed to operate in these public mining sites. Bhagwant Mann said that sand from public mining sites will only be sold for use in construction of non-commercial projects. The Chief Minister said that sale of sand will happen only till sunset and a government official will always be present to regulate the extraction of sand at each

public mining site. He said that the state government has built an app which will give complete information to people about public mining sites and will

even facilitate online payments. Bhagwant Mann said that 16 mines have been dedicated to the people and by next month 50 more such mines will be operational across the state.

The Chief Minister said that an app has been launched that will be linked to Google maps and will guide the person to the nearest public mine. He said that it will ensure supply of cheap sand to the people and check their exploitation by contractors and transporters. Bhagwant Mann said that it will

boost the rural economy as a large number of youth and labour will be engaged in this exercise, leading to higher incomes. The Chief Minister said that it will eliminate middlemen in the sale and purchase of sand and gravel, leading to empowerment of the common man. He said that it is now one of the lowest rates at which sand is available to any person across the country. Bhagwant Mann said that the presence of public min-

ing sites will automatically distort the prices.

SC to get five new judges today

AGENCY NEW DELHI, FEB 5

The Supreme Court is all set to get five new judges, taking its strength to 32 against the sanctioned strength of 34, on Monday when three chief justices -- Justice Pankaj Mithal, Justice Sanjay Karol and P V Sanjay Kumar -- of high courts of Rajasthan, Patna and Manipur respectively will take oath alongside two other senior high court judges.

Justice Ahsanuddin Amanullah of the Patna High Court and Justice Manoj Misra of the Allahabad High Court will also be administered oath of office by the Chief Justice of India

(CJI) as Supreme Court judges in a ceremony to be held at the court's auditorium in its new building complex. The senior most among the five judges, whose names were officially announced by the Centre on Saturday, is Justice Mithal whose parent cadre is the Allahabad High Court. He was serving as the Chief Justice of the Rajasthan High Court since October 14, last year. Born on June 17, 1961, Justice Mithal is a 1982 commerce graduate from Allahabad University. He completed his LLB in 1985 from Meerut College and enrolled as an advocate in the Bar Council of Uttar Pradesh the same year.

Pakistan's former president Musharraf dies after prolonged illness

After a long bout of serious illness, former Pakistan President and chief of Army staff Pervez Musharraf died today at the American Hospital in UAE's Dubai after spending years in self-imposed exile. He was 79.

There's no official communica-tion if his body will be brought back to Pakistan, though his family has been trying to bring him back home since last year.

Mr Musharraf's organs were malfunctioning because of an ailment called amyloidosis. This disease af-



fects connective tissues and organs, inhibiting normal functioning. It's a rare disease caused by a build-up of an abnormal protein called amyloid in organs and tissues throughout the body

Facing charges back home for the assassination of former Prime Minister Benazir Bhutto in 2007, Mr Musharraf has been living in Dubai for the last eight years. He had earlier expressed his desire to spend the "rest of his life" in his home country, and wanted to return to Pakistan as soon as possible.

The former President was the tenth president of Pakistan after a successful bloodless military coup in 1999. He served as the 10th Chairman Joint Chiefs of Staff Committee of Pakistan (CJCSC) from 1998 to 2001 and the 7th top general from 1998 to 2007

EDITORIAL Wages of sin

ike a Frankenstein monster, terrorism nurtured by the Pakistani deep state for decades is coming back to bite it with devastating effects. The recent suicide bombing inside a mosque in Peshawar's high-security zone, killing nearly 100 worshippers, raises disturbing questions over Islamabad's longheld policy of using terror outfits to further its cause. The resurgence of Tehreek-e-Taliban Pakistan (TTP) is, in a way, a perverse payoff for Pakistan's policy of supporting the Afghan Taliban. The TTP has, of late, stepped up its attacks after calling off its most recent ceasefire with Islamabad. The victory of the Taliban in Afghanistan has actually rejuvenated the TTP and the Afghans have refused to play mediator. Contrary to the earlier expectations of strategic advantage with the return of the Taliban in the neighbouring country, Pakistan is actually feeling the heat in the wake of increased terrorist attacks targeting its assets. The military bosses in Rawalpindi had earlier hoped to expand their strategic footprint in the region after the American withdrawal from Afghanistan. However, the situation has quickly changed on the ground. In the past, Islamabad struck a deal with the terror outfit under which several militant leaders, who had declared war on the Pakistani state, were released. Pakistan is now paying the price for appeasement with the blood of its citizens. Instead of surrendering their arms, the TTP leaders set out their own conditions for talks that virtually asked Pakistan to hand over its control of the former tribal areas to them. The militants used the peace negotiations to reorganise themselves.

The spurt in terror strikes could not have come at a more inopportune time as Pakistan is in the grip of a worsening political and economic crisis. It has also led to the weakening of the state authority, providing a favourable environment to the outlawed groups with a strong ally across the border. The TTP has claimed responsibility for the Peshawar mosque attack to avenge the death of its commander Umar Khalid Khurasani, who was killed in Afghanistan in August last year. The terror outfit has upped the ante against Pakistani soldiers and cops since November last year when it abruptly ended a ceasefire with the government. It has been warning the police and the military to stay away from operations against its fighters in the restive Khyber Pakhtunkhwa province that borders Afghanistan. The Peshawar attack shows that the confidence of both China and America in Pakistan's counter-terrorism capabilities is highly misplaced. Islamabad's problems are compounded by the Afghan Taliban's brazen sheltering of Tehreek leaders and fighters. Time is virtually running out for Pakistan. Its leaders must now take an unambiguous stand against terrorism in any form. If it wants Afghanistan to not harbour terrorists, it should first dismantle the terror infrastructure on its own soil

Indian gold market on rise

ndia, the world's secondlargest consumer of gold jewellery, has experienced rapid change over the last few years due to evolving demographics witnessing growing demand for lightweight and studded jewellery, reported Asian Lite International citing World

"India is a strong pillar of support for the global gold markets as the second-largest consumer of gold jewellery. While weddings and festivals act as important drivers of jewellery demand, our rich cultural heritage and historic status as a major global force in world commerce underpin this strong socio-economic relationship with gold. Over time, we have



created countless reasons and joyous occasions to accumulate gold. Bridal jewellery segment alone accounts for nearly half of the market share with rural India being the largest consumer of gold jewellery in the country," said Somasundaram PR, Regional CEO, India, World Gold Council.

The gold jewellery exports in India have grown from USD 7.6 billion in 2015 to USD 12.4 billion in 2019. Bridal jewellery dominates the gold jewellery landscape, enjoying 50-55 per cent of market share in India, reported Asian Lite International

Plain gold jewellery maintains 80-85 per cent of market share, the majority of which is 22-carat although the market for 18-carat jewellery is growing. Daily wear jewellery accounts for 40-45 per cent of the market.

Plain gold jewellery exports accounted for 38 per cent of gold jewellery exports from India in 2021. Over the last decade, nearly 90 per cent of India's jewellery exports have flowed to just five major markets: namely, the UAE, the US, Hong Kong, Singapore and the UK, reported World Gold Council.

Meanwhile, South India dominates Indian gold jewellery consumption, accounting for 40 per cent of the country's total jewellery demand.

Aside from gold, India has a sizeable and vibrant silver jewellery market and is the world's largest fabricator of silver jewellery, reported Asian Lite International.

"Our 2019 consumer survey, carried out by Hall & Partners, found that 60 per cent of the women surveyed owned gold jewellery, closely followed by 57 per cent who owned silver

jewellery, but only 26 per cent owned diamond jewellery," reported World Gold Council.

Meanwhile, Platinum jewellery did not appear among the top purchases by female consumers, as this market is still in its infancy in India.

Notably, India was the largest consumer of gold before being overtaken by China in 2009. In 2021 India bought 611t of gold jewellery, second only to China (673t) but comfortably ahead of all other gold-consuming markets, a recent World Gold Council report revealed.

However, it was unexpected to them that several global events, such as the Covid-19 pandemic and the Russo-Ukrainian war, were significant factors in patients' anxieties.

"We anticipate practical implications of our results in clinical psychiatry and psychology and broader research into mitigating suffering through mindfulness, using the strategy of self-acceptance to regulate attention," concludes group leader Toshiya Murai.

True stories can win out on social media: Study

revious studies have claimed that lies spread more quickly online and are more popular with the general public than the truth, but a recent study offers a more positive conclusion.

Researchers found that posts on the social media site Reddit that included news articles fact-checked as true received more engagement and positive reaction than posts with news labeled as false.

In one measure, Reddit posts linking to true information received nearly twice as many upvotes -- the equivalent of 'likes' -- as posts that were marked as false.

That contrasts with a widely reported 2018 study of Twitter users that found false stories diffused more rapidly and widely than those that were true.

While the results of the Twitter study were troubling, this new research cautions against 'painting with too broad a brush' about how people act on social media, said Robert Bond, lead author of the study and associate professor of

communication at The Ohio State University

"We found that the true information received a lot more attention and engagement on Reddit than false information." Bond said.

Bond conducted the study with Kelly Garrett, professor of communication at Ohio State. An early view, uncorrected version of their accepted study was published online in the journal PNAS Nexus.

"The findings that Twitter users were more likely to share false information may have less to do with human nature and more about how people behave on different social media platforms," Garrett said.

Twitter and Reddit differ in many ways, including their technical attributes. social norms and people they serve, the researchers noted. That may be a key for differences in how users of the two platforms respond to true versus false information

One important difference is that



Twitter has a short message format, with many messages generating no reaction at all, and with very few extended discussions. In contrast, Reddit has complex, threaded discussions, and users often engage in sustained conversations.

For this study, the researchers examined all political posts on Reddit between 2016 and 2018 that included a link to a news article. They specifically looked for posts with a comment linking to one of three fact-checking organizations: PolitiFact, Snopes or the

Washington Post Fact Checker. All posts included a news article that one of these organizations had labeled as true, false or mixed.

This resulted in a dataset of 10,308 posts that included links to 10,785 comment threads that could be classified as being true or false, according to the fact-checkers. These posts received about 8.3 million comments from about 783,000 unique comment authors.

The results clearly showed more engagement with posts including true information.

Posts in which the fact-checked information was true received an average of 929 comments, versus false posts, which received 581 comments on average.

Posts that linked to true information also led to longer conversations - an average of 323 hours, versus 234 hours for those labeled false.

Findings showed that commenters were faster at posting fact checks for

false stories than for true stories. And the researchers found that, after a factchecking comment was posted, the commenting rate for posts with false information dropped off more quickly than posts that were labeled as true.

The researchers did a second analysis that further showed the importance of fact-checking to how Reddit users reacted.

Reddit is organized into what are called subreddits for different communities. That means that the same news article could be posted in different subreddits - and some of the posts could include the fact check, while others did not.

The study examined engagement with posts that did not include a comment with a fact check - even though a fact check was available.

"Among threads that did not receive a fact check, we found little substantive difference in engagement. Posts with false information received about as much engagement as posts with true information," Bond said

"That suggests Reddit users were responding to fact checks and were more engaged with those they knew were labeled as true."

This study can't say why true stories were more popular on Reddit than they were on Twitter, Garrett said. But there are some plausible reasons why that may be. For one, each subreddit has clear rules about what are acceptable posts and moderators who monitor what is posted and can take down posts that violate rules.

"Reddit is a community that has watchdogs, both the moderators and other users. They often look for untrue information and correct it, and the community is responsive to those corrections," Garrett said. "That's a very encouraging sign and a pretty stark contrast to what was found in the Twitter data. We saw vibrant conversation around true stories on Reddit. And that's great news.'

He said that the Solid Waste Management Rules, 2016, Rule 15, clearly stipulate the roles

responsibilities of the local authorities and village panchayats regarding scientific disposal of the solid waste produced and remediation of legacy waste sites. He said that the State Board, in its directions has raised the issue that at present total legacy waste to the tune of 1,90,796 tonnes is lying in ULBs namely Dharamshala, Mandi, Baddi, Solan, Kullu, Manali, Bilaspur, Una, Santokhgarh, Baijnath, Chowari, Dalhousie, Rewalsar, Sarkaghat and Hamirpur. It has observed that the progress of legacy waste remediation work in most of the above-said ULBs is sluggish and lags behind the timeline stipulated in the Solid Waste Management Rules, 2016.

Dipa Karmakar admits to doping violation after facing 21-month ban

NEW DELHI: Indian gymnast Dipa Karmakar has admitted to "unknowingly ingesting banned substance" after being suspended for 21 months for the use of a prohibited substance.

The 29-year-old Tripura girl was tested positive for higenamine (S3. Beta-2 Agonists as per the World Anti-Doping Agency prohibited list) which was found in her dope sample. The positive sample was collected on behalf of the Federation Internationale de Gymnastique (FIG) in the scope of an out-of-competition control on 11th October 2021. Higenamine was added to the World Anti-Doping Agency's list of prohibited substances in 2017.

"Today marks the end of one of the longest battles I have fought for myself and my career. In October 2021, my sample was obtained for out-ofcompetition testing and sent for assessment. The result was positive for a banned substance which I unknowingly ingested and could not determine the source of. I decided to take a provisional suspension with the hope of a swift resolution with

the international federation," wrote Karmakar on Karmakar's ban period will end on the 10th of July

2023 as it was counted from the day the sample was collected which is the 11th of October 2021 "I am happy that the matter has been amicably resolved. My suspension has been reduced by 3 months and backdated by 2.5 months, allowing me to return to the sport I love in July 2023," wrote Dipa Karmaka

Nagpur; From the epic face-off between Sachin Tendulkar and Shane Warne to Harbhajan Singh's web over Ricky Ponting, Tests between India and Australia have witnessed several legendary rivalries.

Here's a look at some of the ongoing battles which will be reignited during the upcoming Test series that will be key in deciding the ICC World Test Championship finalists, as per ICC.

Virat Kohli-Nathan Lyon Virat Kohli's dream-like start as India Test skipper at Adelaide was ruined by Nathan Lyon's 7-152, which handed Australia a 48-run win in the opening Test of the series in 2014/15. Among his wickets was Kohli, who fell to a miscued pullafter a masterly 141.

Since then, Kohli-Lyon battles have become even more engaging. While Kohli has succeeded in scoring runs against the bowler, Lyon has gotten the better of Kohli on seven occasions.

Adding further flavour to the contest

is the fact that Kohli has struggled a bit against spinners of late. Lyon will look to take advantage of the turning tracks in India but Kohli, going great guns in the white-ball game, can never be counted

Cheteshwar Pujara-Josh Hazlewood Cheteshwar Pujara's defiance has tested and tormented Australia's bowling attack in recent vears. Few other bowlers have been more frustrated by Pujara's stonewallingthan Josh Hazlewood.

Hazlewood identified Pujara's resilience as one of the reasons why Australian pacers could not make regular breakthroughs in the Test series in 2018/19. The batter faced 1258 balls over the series and managed to tire the Australia bowlers with his obdurate batting. He repeated the feat in 2020/21, wherein he faced 928 balls, keeping the Australia bowlers on the field for a long time. India won both series 2-1.

Australia's premier fast bowler

Hazlewood has dismissed Pujara six times in the past, and would love to see his back as soon as possible in India. Pujara's early departure can provide a big boost to Australia's quest for regaining the Border-Gavaskar Trophy.

Ravichandran Ashwin-David Warner David Warner has been Australia's mainstay at the top for almost a decade. He has scored more than 5000 runs in Australia at an average of 58.39. This includes 19 centuries and 14 halfcenturies.

However, his record visibly changes in India. He averages 24.25 from eight Tests, with no century to his name. This is mainly due to the presence of Indian off-spinner Ravichandran Ashwin. He has dismissed Warner on $10 \, {\rm occasions}$ in Tests, with five of these dismissals coming in India. Ashwin appears to have an overall advantage over the left-hander. Warner has scored 388 runs in India for Australia and has

made three fifties in eight matches and 16 innings. An aggressive batter like Warner

will probably take the attacking route against the wily off-spin of Ashwin, making this battle a mouthwatering prospect.

Rohit Sharma-Pat Cummins Though the two skippers have not faced each other on many occasions in Tests, the match-up between them will be interesting.

Both Rohit Sharman and Pat Cummins have had great success with their leadership so far. While Cummins has dismissed Rohit twice in Tests, they have never faced each other in India.

India's captain, who will also open the India batting, will look to provide solid starts at the top while Cummins will try to get rid of Rohit early on to establish Australian dominance.

Ravindra Jadeja-Steve Smith: With a Test batting average of 60.89, Steve Smith is one of the modern-day greats. His record is exemplary across nations, and the same holds true against India. He has an overall Test average of 72.58 against India, and also averages 60.0 in India in Test cricket.

At the same time, India all-rounder Ravindra Jadeja has managed to get the better of Smith on a few occasions. He has picked Smith's wicket four times in Tests. Apart from this, Jadeja's sharp fielding has also proved deadly for his opponent, as Smith realized after being caught short of the crease during the Sydney 2021 Test between the two nations.

Jadeja will be an even bigger challenge for Australia's finest batter on pitches suited to his style of bowling.



PCB threatens not to take part in World Cup 2023 if Asia cup moves out of Pak

NEW DELHI: After Asian Cricket Council (ACC) decided that a neutral venue will be announced for Asia cup 2023, Pakistan threatened to pull out from ICC World Cup scheduled to be held in India later this year. Yesterday, the ACC has decided that a new venue for Asia cup 2023 will be finalized in the month of March this year

According to a source, "PCB isn't happy with this thinking that Asia cup could be relocated to some neutral venue, name of UAE is on top of the list which might get the hosting but if it happens then Pakistan will not travel to India for ICC World Cup 2023." The ACC chairperson Jay

Shah already revealed that India will not travel to Pakistan for the Asia cup due to security reasons and the tournament will be played at some neutral venue, the new venue will be decided in the second round of the Executive Board meeting of ACC members in the month of March. Last year the Asia cup was held in UAE and the probability of the nation hosting it again is high.

Qatar has also shown interest in staging the tournament as a neutral venue amidst political tensions between the neighbouring countries. It has already hosted a few cricket tournaments and franchisebased cricket leagues
