

DO IN TURKEY, SYRIA

The deadly 7.8 magnitude earthquake that hit southern Turkey in the early hours of Monday have claimed more than 1500 lives in nearby regions as well as Syria, CNN reported.

At least 284 people have been killed and close to 2,300 people were injured in Turkey, the American broadcaster reported citing the country's Vice President Fuat Oktay. He also reported that more than 1,700 buildings were damaged across 10 Turkish cities. In Syria, at least 237 people were killed and 639 injured, Syrian state-run news agency SANA reported, citing a Health Ministry official. One of the largest

earthquakes to hit Turkey in more than a century, it caused vibrations throughout the area, collapsed buildings, and forced people to flee into the streets. Condolences poured in from worldwide after the massive quake hit Turkey claiming numerous lives. Prime Minister Narendra Modi took to Twitter and condoled the loss of life in the massive earthquake that rattled Turkey and nearby areas and claimed more than 100 lives. Turkish President Recep Tayyip Erdogan said on Twitter that "search and rescue teams were immediately dispatched" to the areas hit by the quake. Moreover, External Affairs Minister S Jaishankar also tweeted and expressed grief over the loss of lives in the tragic earthquake that jolted both Turkey and Syria.

India to send rescue, medical teams to Ankara

NEW DELHI : India on Monday said that it will despatch rescue and medical teams to Turkey following a 7.8 magnitude earthquake that killed over 500 people and toppled buildings in central Turkey and northwest Syria today.

The prime minister's office (PMO) said that a meeting was held and it was decided that the search and rescue teams of NDRF and medical teams along with relief materials would be dispatched immediately in coordination with the Government of the Republic of Turkiye.

SC gets five new judges, CJI administers oath of office

Chief Justice of India DY Chandrachud on Monday administered oath of office to the five new judges as the Supreme Court judges.

President Droupadi Murmu had on Saturday signed the warrants to appoint five new judges to the Supreme Court.

The new judges were inducted after a swearing-in ceremony today in the Supreme Court.

Rajasthan High Court (HC) Chief Justice Pankaj Mithal, Patna HC Chief Justice Sanjay Karol, Manipur HC Chief Justice PV Sanjay Kumar, Patna HC judge, Justice Ahsanuddin Amanullah and Allahabad HC judge, Justice Manoj Misra took oath as judges of the top court.



The Supreme Court Collegium on December 13 last year had recommended these names for the elevation. On February 3, an apex court bench

led by Justice Sanjay Kishan Kaul gave a word of caution to the Centre saying that

things would get "uncomfortable" if the government continues to delay judicial appointments and transfers.

Justice Kaul had told Centre, "If you keep them pending ... you will make us take some very, very difficult decisions.'

With the swearing-in of five new judges, the strength of the top court went up to 32 from 27 and only two vacancies remain. The Supreme Court has a

sanctioned strength of 34 judges.

The Supreme Court Collegium on January 31 recommended two more names for elevation to the apex court. These two names are Allahabad High Court's Justice Rajesh Bindal and Gujarat High Court Chief Justice Aravind Ku-


mar. After August 26, 2021, when nine Supreme Court judges were appointed together, this is the second time when so many judges have been appointed in one single batch.

Both Houses of Parliament adjourned over Adani row

Both Lok Sabha and Rajya Sabha were on Monday for the day till 11 AM on Tuesday amid ruckus by opposition parties demanding a joint parliamentary committee probe into allegations made by a US-based short seller against the Adani Group.

The ongoing Budget Session of Parliament resumed today after it was adjourned on Friday following repeated disruptions due to uproar by the Opposition demanding a debate on the New York-based Hindenburg Research report against the Adani Group. Soon after the proceedings of the day began both the houses were adjourned till 2 PM today. A discussion on Motion of Thanks to the President's Address was scheduled to be taken up in both houses today. Congress president and Leader of Opposition in Rajya Sabha Mallikarjun Kharge on Monday said that the Opposition is ready to speak on President's address but the "first priority" is that Prime Minister Narendra Modi give a reply on the ongoing Hindenburg-Adani row.



Police's multi-pronged drive against drug menace bearing fruit

In order to eliminate the drug mafia, Punjab Police on the one hand is preventing drug consignments from across the border as well as from other states from reaching Punjab, while on the other hand it is tightening the noose on small and big distributors in the states.

The third important aspect of this 360 degree action is to make the public aware about the necessity to stop the consumption of drugs among the young generation. For this too, Punjab Police has donned a new avatar. It is raising public awareness. Plays are being performed in the nooks and crannies of the state. Sports clubs are being run in drug-affected areas. They are creating awareness among the youth in schools and colleges. By organizing tournaments like cricket, kabaddi, hockey, community policing is being done by connecting with the public.

The new idea of Punjab Police is to change the lifestyle of the youth. They should be made aware of a healthy lifestyle. The police believe that if the evening time of the youth is disciplined then they will stay away from drugs. The biggest help in this comes from sport. The campaign is progressing through a large number of players deployed in the Punjab Police.

Police are also running sports clubs in drug-affected villages and urban areas. It explains the importance of sports to children and youth besides giving them training in sports. One such club is Kapurthala Sports Club. International hockey coach Ripudaman Singh regularly visits these activities. He plays with children and youth. They are taught the tricks of games. The bad effects of drugs are also made known. Senior officers like SSP also visit here from time to time. People never get tired of praising these efforts. The lifestyle of children is changing through games. Now they don't

wander in their spare time. They are happy playing sports. People are confident that their children will remain safe from drugs now

The campaign is named - Sports over Drugs. That is, games are more than drugs. The aim is to keep the new generation away from addiction by promoting sports from childhood. Children can play whatever game they want to play. Police are lending a helping hand. Football clubs have been opened in Sangrur. Police organized a kabaddi tournament and seminar in Subhanpur of Kapurthala. Pathankot Police organized a cricket tournament on January 8 this year. Minister Lalchand Katarachak was also present along with senior officers of police and administration there.

Police and public are coming closer with this campaign. Mutual trust is increasing. The police is also adopting other methods of regular public relations. Street dramas are happening. Environment is being created through Gram Panchayats. Meetings and seminars are being conducted in schools and colleges. Oaths are being administered to stop drug addiction. This message is also being conveyed by NCC cadets in districts like Batala, Rupnagar etc. Hoshiarpur police has been conducting street plays since May last year to warn people about the dangers of drugs. In the border districts of Ferozepur, Fazilka, Taran Taran, Gurdaspur, these methods are being specially implemented to rope in Gram Panchayats.

Meetings of police-administrative officers are also held regularly to solve the drug issues of villages and towns. Due to this, the reach of the police is getting deeper. Information is also being received about the smugglers gangs and their helpers who have made inroads for years. This has also helped the police in cracking down on them. This new environment has certainly given the Punjab Police an upper hand in the fight against drug addiction.





Operation Akraman: 1116 arrested as part of special drive against illegal activities

CHANDIGARH, FEB 6

Under Operation Akraman-IV, a special drive to Clean-Up the crime and criminal elements across the state, Haryana Police has successfully conducted a series of coordinated raids and arrested 1116 accused while lodging 573 FIRs under various sections of IPC, NDPS, Arms and Excise Act.

Disclosing this here today, Director General of Police (DGP), Sh. P.K. Agrawal informed that the Police Department had been collecting pinpointed intelligence on criminal activities in the State including trafficking of illegal arms, narcotic substances and illicit liquor. 1327 teams comprising 7109 Police personnel under the command of SsP/DCsP conducted coordinated raids starting early morning on 5th February throughout the day till evening on crime and

The element of surprise and simultaneous targeting of criminals at

multiple locations led to very encour-aging results. A total of 50 illegal firearms and 25 cartridges were seized. Similarly, 301 kg 462 gram ganja, 159.24 gram heroin, over 49 kg poppy husk, 1.155 kg opium, 34.42 gram smack, 83.22 gram sulpha, 3.19 gram charas and 108 prohibited tablets/capsules/injections were also recovered.

During these raids, the raiding teams have also managed to nab 12 most wanted/wanted criminals and 3 other offenders carrying cash rewards

Police has also arrested 188 proclaimed offenders and 15 bail jumpers. Among the arrested POs and Bail Jumpers, many of them were reported to be evading their arrest for a long time. In addition, 248 other accused involved in various cases were

KARNAL: Despite providing free operation to economically weak eye patients, out of 1100 eye donation branches across the country, only 50 organisations are actively working. North India's first Karnal-based Madhav Eye Bank dedicated to eye donation in every way by Dr. BK Thakur is known nationwide for active eve donation. In the workshop of Eve Bank Associa tion of India (EBAI), it has come out that out of the closed eye



donation organizations, 700 organisations have been re-registered, but for their activation, eye donation organizations need to be run in remote areas of the country. Presently, there are 15,000 blind people in Haryana and 2 to 3 lakh blind people in the whole country. Data of blind people is also increasing with the population. One lakh people die every day in the country but the number of people who donate eyes is still

10 per cent i.e. 1000 donate eyes. According to Dr. BK Thakur, the state of awareness in Haryana is better than other states of the country, if every eye doctor in Haryana is given a target of 100 to 150 eye blindness prevention operations per year, then in the coming four-five years Haryana will not only be free from blindness but will also be an example for the country. Out of 1100 organisations registered for doing pious work of eye donation, 900 which are completely closed will have to work actively on the lines of North India's first Madhav Eve Bank to become active. 




Who will end desolation of eyes of elders of old age home

uch crucial data on Indian life is gathered by non-governmental organizations. The most important are employment data from the Centre. for Monitoring Indian Economy and the Annual Status of Education Reports from Pratham. The governmentconducted National Achievement Survey measures learning outcomes among school students in even greater detail than ASER; but unlike ASER, it does not collect family and social data. No less invaluable are the government reports of the Unified District Information System for Education Plus with intensive statistics about schools, teachers and pupils. The 2022 ASER for rural schools has just appeared. Its depressing survey of learning outcomes has received much attention already. I will focus instead on some background factors, drawing on both ASER and UDISE+.

The number of rural children in private schools rose by nearly 8% between 2006 and 2018 but then dropped nearly as much by 2022. Pandemic-stricken families could not pay the fees. Many small private schools closed down, partly in consequence. All this is well known. What ASER reports additionally is a gender disparity: 15-25% more boys go to private schools. Virtually everyone sends their daughters to school today, but will 'invest' more to educate their sons.

There is a countering corollary. Primary schools have nearly 52 lakhs more boys than girls. After that, the scene changes. Arunachal, Assam, Ladakh, Meghalaya and Nagaland have more girls than boys all the way up from Class 6; six more states (including Bengal) from Secondary and another six at Higher Secondary level. Despite their head start in infancy, more boys are dropping out thereafter, generally from the pressure to start earning, perhaps far from home. Needless to say, girls work too, especially in domestic labour, paid or unpaid; but remaining in the neighbourhood, they often continue on the rolls, sometimes even after marriage

There is also a degree of positive social change, including girls' aspiration for better employment. Yet there are states where girls' enrolment still languishes at every level: by over 10% in Gujarat, Haryana, Madhya Pradesh and Maharashtra. Needless to say, enrolment does not mean attendance. ASER found attendance at government schools to dip from 88.6% in Tamil Nadu to under 60% in Bihar, MP and UP. Any figure under 75% (found in twelve states) suggests habitual absence, dropout or ghost enrolments. Teachers are missing as well, sometimes because they play truant but chiefly owing to unfilled posts.



C ingapore has seen tremendous growth as a wealth management centre in recent years.

In the ten years from 2012 to 2021, assets under management have increased more than three-fold from SGD1.6 trillion (USD1.2 trillion) to SGD 5.4 trillion, according to data from Singapore's central bank, MAS (Monetary Authority of Singapore). In just one year, 2021, it grew 16 per cent, the last year's data is available.

Three-quarters of this came from outside Singapore, with just under a third from Asia-Pacific countries. Indeed, some call Singapore the Switzerland of the East.

Recently, the trend of setting up family offices has been growing and has accelerated since the start of the pandemic and Singapore has managed to take a large slice of this market as well.

Family offices are privately held companies set up to manage the wealth and investments of the uber-rich.

These family offices are usually set up with the objective of managing the financial and investment needs of affluent families or individuals including providing financial solutions, budgeting, insurance, charitable giving, wealth transfer



and succession planning, and tax services. Family offices are different from traditional wealth management in that they offer a total solution to managing the financial and investment needs of an affluent individual or family.

Between 2020 to 2021, Singapore has seen the number of family offices set up in the city-state climb from 400 to 700. No data is available for 2022 at the moment but anecdotal evidence suggests that this trend continues to grow.

Chung Ting Fai, a lawyer who helps set up family offices, told Reuters that in late 2022, he had one enquiry a week from people

who want to move at least USD20 million into Singapore. That's up from about an enquiry a month in 2021. while in January this year, he received two enquiries a week.

In October last year, Bloomberg reported that Indian billionaire Mukesh Ambani ranked 10th richest man in the Forbes billionaires list for 2022, is establishing a family office in Singapore. The office will be set up by Reliance Industries, the bil-

lionaire's firm. It is being believed that opening a family office in Singapore will help Ambani achieve his greater goal of turning his retail-to-refining business global. It will also

help him buy assets abroad. He is in good company.

The likes of ultra-rich individuals like hedge fund billionaire Ray Dalio and cofounder of Google Sergey Brin have chosen Singapore to establish their family offices. So have British inventor James Dyson famous for his bladeless fans and hair dryers and vacuum cleaners, and Zhang Yong, founder of China's Haidilao hotpot restaurant chain.

As it started to signifi-cantly ease COVID restrictions, being the leading Asian country to do so, Singapore has seen a fresh wave of affluent foreigners looking to park their wealth

here. This is especially so among the Chinese as they became disenchanted by their government's draconian COVID policies. These mainlanders have become impatient and are keen to look at alternative destinations for their wealth.

Although China has now abandoned its zero-COVID policy, these wealthy Chinese are expected to continue to explore options out-side of their home country, in part also due to concern about President Xi Jinping's common prosperity drive that aims to reduce inequal-

Besides the Chinese, Malaysian and Japanese citizens are also looking to set up family offices in Singa-

What attracts ultra-rich foreigners to Singapore to set up family offices is its tax-friendly regime and comparatively safe and secure environment. It is also seen as politically stable with clear transparent rules and an incorruptible system. Singapore also is an international financial centre which allows investment firms the ability to offer their clients a varied range of products and investment opportunities to

suit their needs. The arrival of the wealthy is leading to Singapore's resident population growing again after many expatriates left at the height of the pandemic. In 2022, the island received 30,000 more permanent residents and 97,000 more foreigners on work or long-term visas, lifting its population to 5.64 million.

However, the flood of the global rich squeezing onto the tiny island is causing some pain to the local population. Prices of cars, housing and other goods have escalated significantly. Deputy Prime Minister

Lawrence Wong signalled in August last year that the wealthy may face more taxes to boost inclusive growth. Singapore's new resi-

dents have sent rents surging 21 per cent in the first nine months of last year. Home prices have also jumped over the past two years with mainland Chinese buyers continuing to be the top foreign buyers of expensive private properties.

The steep rise in golf memberships is but one sign of how the price of the symbols of affluence on the island has gone bonkers.

Accordingly to the membership brokerage firm, Singolf Services, the membership cost to Singapore's prestigious Sentosa Golf Club has more than doubled since 2019 to reach SGD 880,000 (USD 665,000) for foreigners.

Desmond Teo, Asia Pacific family enterprise leader at consulting firm EY commented to Reuters that the inflows of money support Singapore's financial services sector and startups, creating a "rich ecosystem" that makes the country more attractive to new stakeholders. "When you hit a certain critical mass, the critical mass itself is an attraction,

Razia Sultana – First and only woman ruler of Delhi sultanate

Thenever I go to pay my obeisance at Gurdwara housed in Qila-Mubarak or pass by the fort as it is located in the heart of Bathinda City, the reminiscences of Razia Sultana echo in my ears, first and only muslim woman ruler of Delhi sultanate. This fort, the oldest surviving structure, was constructed by Raja Dev in 90-110 AD and Gurdwara was built in the sacred memory of Shri Guru Gobind Singh Ji, the 10 th Guru of Sikhs. Razia Sultana has a historically significant connection with this fort and consequently Bathinda as she was kept as a prisoner in this very fort, from April to August 1240 by Altunia, the then Governor of Bathinda, her childhood lover. Being first powerful woman ruler and having connection with Bathinda (not in good taste), it is imperative to share her remarkable life having significant place in the history with the readers. She was born in 1205, a beloved daughter of Mamluk Sultan Shamsuddin Il-

tutmish and Turkan Khatun who was the daughter of Qutbud-Din Aibak, famous for laying the foundation stone of Qutub Minar which was completed by his successors, Iltutmish and Firuz Shah Tughluk. Iltutmish was a slave of Qutubud-Din and but virtue of his loyalty, honesty and bravery was appointed as a provincial governor and trusting him further, Aibak offered the hand of his daughter, Qutab Begam for marriage. Unfortunately Aibak met with a tragic death in the game called "Chaugan" similar to polo in 1220. Though Aram Shah took over the throne but opposition of Forty Turkic Nobles commonly called Chihalgam's coupled with Aram Shah's incapability paved the way for Iltutmish's coronation in 1221. Iltutmish decided his elder son Nasiruddin to be his successor, but his son's death in 1229, changed the course of destiny for Razia, who has already exhibited her administrative capabilities and bravery when Iltutmish left Delhi for

Gwalior Expedition putting Razia incharge to handle the administrative affairs. On his return, astonished and impressed by her excellent performance picked Razia to be his successor and proudly expressed his impressions stating,"the little girl is superior to many sons"

Since childhood, she was raised as a bold girl, trained in military skills and professional warfare along with her brothers. She used to accompany his father in his military expeditions. However, inspite of the fact that Iltutmish decided Razia to be his successor and her vast administrative and military experiences, her ascendance to the throne was neither smooth nor hassle free. After the death of Iltutmish, Muslim nobility was against a woman ruler and got appointed her step brother Rukan-ud- din as Delhi Sultan. The new ruler proved a big failure and remained immersed in royal pleasures and Shah Turkan Iltutmish's widow was de-facto ruler for all practical purposes. After six months of ill- rule, Razia with the popular support of the common people, overthrew his kingdom becoming new ruler on 10 th November, 1236.

Taking over the reins of the sultanate, with the formal name of Jalatat-ud-Din Razia, she gave up traditional woman's attire including purdah and started wearing gender neutral attire, shocking the Muslim religious community. She proved to be an efficient, capable and brave ruler and was widely respected by her officials and public. She ordered coins to be minted in her name as "Pillar of Women, Queen of Times, Sultana Razia, Daughter of Shan-ud-Din Iltutmish." She led from the front and conquered many territories strengthening her kingdom. On the welfare state, she established educational institutions and public libraries emphasizing new learning of science and literature from all cultures. Her popularity with the

masses success and self-righteous attitude in appointing his own men in key posts ignoring the recommendations' of nobles, especially putting Yakut on high ranking post, rumored to be Razia amorous relation with him suffocated the nobles who also considered a woman ruler an insult to the male warriors They under the leadership of one of the Nobles, Malik Ikhtiar-ud-Din Altunia raised a revolt and though she bravely faced the revolt but in the ensuing battle she was defeated and taken into custody and imprisoned in Bathinda fort. Either out of love or fear, she married her one time lover Altunia but both of them were murdered near Kaithal on their way to Delhi for taking the revenge of their defeat.

Some of the Historians are of the opinion that Altunia's revolt was not to cause harm to Razia but he was more interested in winning over her love which ultimately proved true as both got married. This is short life story of Razia as short as her rule and left a rich legacy manifesting a female leadership in a male dominant society and empowering the womanhood equally as she abolished taxes on widows and granted them more rights

This all was in the 13 th century and she deserves all praise and appreciations for her vision and this paved the inspirational path for the coming generations to follow. In the end, the following words of Minhaj Shiraj, will be a befitting tribute to her remarkable stature- "Razia was endowed with all the qualities befitting a sovereign- she was prudent, benevolent, benefitted to her kingdom, a dispenser of justice, the cherisher of her subjects and a great warrior. Her downfall was a result of jealously of Turkish Nobels."



Session Court awards life imprisonment to a migrant for murdering his brother

The complainant stated that both the accused Shiripal and deceased namely Taliban resident of village Dharampur (Uttar Pradesh) were staying together at the waterpump room of the agricultural land owned by one Piara Singh of England and being cultivated by him at Simbal Mazara where the accused murdered Taliban during the intervening night of February 4 and 5 of 2021. Taliban was having injuries on his head and near the left eye and a lot of blood was lying on the ground. He was also happened to be real brother of the accused Shiripal. Further, since Shiri Pal, real brother of Taliban was not found present at the spot, as such, they suspected that Taliban had been killed by Shiri Pal and that after committing crime he had absconded.



CM assures redressal of residents woes arising out new floor construction **CHANDIGARH, FEB 6**

Vidhan Sabha Speaker Gyan Chand Gupta has solved the problem caused by allowing construction above 3 floors in Panchkula. Vice President met Chief Minister Manohar Lal late on Monday evening regarding this problem of city dwellers. The Chief Minister has assured them that as per the demand of the city dwellers, it will be resolved soon. It is worth noting that last year, the Haryana Urban Development Authority had allowed construction above 3 floors on residential plots by changing the Floor Area Ratio (FAR) in Panchkula city. After this permission, many people built houses up to 4 floors, due to which the air and light of their neighbouring houses were affected. Cracks also appeared in many houses and at some places the buildings started to head many houses and at some places the buildings started to bend. Many organizations like RWA and local citizens contacted the Legislative Assembly Speaker Gyan Chand Gupta regarding the problem. Former Chief of Army Staff General VP Malik also raised this issue before the Speaker. General VP Malik, in a memorandum to Legislative Assembly Speaker Gyan Chand Gupta on September 12 last year, said that due to opposition from RWA and local residents, the 4storey construction with ground floor parking was stopped for some time, but recently such constructions have started again. Due to this, the flow of fresh air in the neighbouring houses was interrupted and the sunlight was also stopped.





'HOSTAGE' TILL THE END! FARAZ MAINTAINS JUHI-JAHAN-ADITYA'S **BRILLIANT ACTING**

any films and web series have been made on the terrorist attacks in India. Among these, the names of 'Major', 'Mumbai Diaries 26/11', 'Hotel Mumbai', 'The Attack of 26/11', 'Phantom', 'Special Ops', 'Stage of Siege' and 'Mumbai Meri Jaan' are prominent. In this, from the terrorist attack to the bravery of our security agencies, it has been shown. But for the first time a film has been made on a major terrorist attack in another country across the border, whose name is 'Faraj'. Directed by famous director Hansal Mehta, the film shows the ideological difference between humanity and terrorism while giving an important message to the contractors of Islam. Shashi Kapoor's grandson Jehan Kapoor has made his ough this ollywood debut th



I want my Islam back from people like you, he responds when Nibras asks him what he wants. Faraj refuses to abandon his Muslim and Hindu girlfriends in India since the terrorists want to spare him because he is a Muslim and give him the choice of leaving after sparing his life. He doesn't flee for his life but instead bravely engages the ruthless terrorists since he doesn't want to abandon his pals. He constantly questions terrorists about the true nature and goals of Islam, disregarding the possibility that he too will be crushed to ant size.

He stays in the human family all the way to the end, and he must pay the price by taking his own life. That terrible night has been faithfully reenacted by director Hansal Mehta. Hansal doesn't waste any time and dives right into the main plot in the first ten minutes of the movie, which effectively hooks you in from the start. The novel advances the discussion of tolerance vs. intolerance and faith vs. hate, and it is a relief to see humanity's self-sacrificial side in the end. In contrast to earlier terror instances, this lights the bravery of a regular ster rather than any security agency officer. While the police commissioner's role has provided humorous moments, Juhi Babbar's portrayal of the mother appears to be filled with unease, despair, and bullying due to her status. Hansal Mehta does not stress strongly in the form of his screenplay the two conflicting ideologies that he begins a debate about in Islam—one who believes in killing in the cause of Jihad and the other who finds violence unacceptable. I discovered Faraj is the name of the movie, however although though Faraj's bravery triumphs in the end, his backstory could have used a bit more development. Even though the movie doesn't really move you emotionally, its excellent and timely intentions cannot be contested. Although the writing has its flaws, the film's photography and background music are both excellent technically. Strong conversations stick in the mind. Acting-wise, Aditya Rawal demonstrates that he is twenty. Aditya portrays a young terrorist willing to do anything for Islam. Jahaan Kapoor, the acting grandson of Shashi Kapoor, inspires optimism. Juhi Babbar introduces herself as a skilled actor in the part of Faraj's mother. Aamir Ali, Sachin Lalwani, and Jatin Pareek are just a few actors who have performed in character.

Faraaz, produced by Anubhav Sinha's Benaras Mediaworks, would have been just another terror-themed thriller but for the deeper and wider resonances that it has for the subcontinent as a whole and for the fact that it completes a trilogy of sorts with the director's Shahid (2012) and Omerta (2017). Faraaz's mother Simeen (Juhi Babbar) is the one who makes the most noise. She initially comes out as a spoiled bully, but as the movie goes on and she loses her privileges, we witness a helpless mother. Juhi makes her long-awaited return to the screen with a skillful performance that highlights the character's bravery and grace.

The outspoken and liberal-leaning filmmaker Hansal Mehta always picks topics for his films that are simultaneously vital to society's challenges and now relevant. This time, he has created a movie through Faraj centered on the

true tale of a terrorist attack on a neighbouring country, but the story, which started with terrorism, ends with humanity.

On July 1, 2016, a calm evening in Dhaka, the city of the neighbouring Bangladesh, was turned into a night of terror when five teenage terrorists carrying weapons and grenades stormed the Artisan Cafe. 22 people were brutally murdered in this ter-

rorist attack, including an Indian woman. While Faraj (Jahan Kapoor), held hostage by Islamic fanaticism despite the fear of gunpoint, raises questions, educated English-speaking Nibras (Aditya Rawal) thinks that Islam is in danger and that killing unbelievers will take him and his companions to Jannat. I want my Islam back from people like you, he responds when Nibras asks him what he desires.
