Centre gears up for crackdown on Khalistani supporter Amritpal

AGENCY NEW DELHI, MAR 20

With a fresh FIR citing the Arms Act against Khalistan supporter Amritpal Singh, who is being chased by the Punjab police, the Centre seems to be moving in to take over the case as a terror investigation. Top anti-terror body National Investigation Agency (NIA) may probe Amritpal Singh and seven of his aides over the charge of possessing illegal arms - Arms Act cases are included in the NIA Act. The Khalistani leader has been named "Accused Number one" in the new case.

Meanwhile, Four of Amritpal Singh's top aides, arrested and flown to Dibrugarh in upper Assam, have been charged under the stringent National Security Act (NSA), which allows the police to detain suspects in any prison across the country.

The 'top secret' action was a coordinated effort between Aam Aadmi Party-ruled Punjab, the Centre, and BJP-governed Assam, say officials. An Indian Air Force aircraft was used to transport the accused, further signalling the union government's increasing involvement to dissipate the issue, which has the potential to hamper peace, invoking painful memories of the state's disturbed past.

However, the BJP remained tight-lipped about the coordination between states governed by rival parties. Assam Chief Minis-



ter Himanta Biswa Sarma yesterday said it was just a "police-to-police' cooperation. "There were arrests in Assam as well when we sent people to Bihar's Bhagalpur jail for security reasons. Maybe the Punjab Police feels the prisoners should be held in Assam for a few days," he said.

Sources say Punjab Chief Minister Bhagwant Mann had discussed the plan to arrest Amritpal Singh with Home Minister Amit Shah in a meeting on March 2.

So far, the police have arrested 112 associates of Amritpal Singh -- 34 of them on Sunday. Several members of his 'Waris Punjab De' group have been detained for questioning. Among those arrested was Daljeet Singh Kalsi, the man who handles Amritpal Singh's finances

Suspension of internet, SMS services to continue till Tuesday in Punjab

CHANDIGARH: Amid the ongoing crackdown against the 'Waris Punjab De' chief Amritpal Singh, the suspension of mobile internet, SMS and dongle services will continue till Tuesday noon, the Punjab government informed. "All mobile internet services, all SMS services (except banking and mobile recharge) and all dongle services provided on mobile networks, except the voice call, in the territorial jurisdiction of Punjab suspended till March 21 (12:00 hours) in the interest of public safety," the department of Home Affairs and Justice, Government of Punjab informed in a statement on Monday

India, Japan resolve to expand ties

NEW DELHI, MAR 20

Prime Minister Narendra Modi and his Japanese counterpart Fumio Kishida on Monday vowed to expand the India-Japan global strategic partnership, holding that

it is important for a peaceful, stable and prosperous Indo-Pacific besides benefitting the two countries in diverse areas. The Japanese prime

minister arrived in Delhi this morning on a nearly 27hour visit amid global geopolitical turmoil over the Ukraine conflict and increasing concerns over China's aggressive behaviour in the Indo-Pacific. In his media statement, Modi

Sisodia's judicial custody till April 3

AGENCY **NEW DELHI, MAR 20**

The Rouse Avenue Court on Monday extended the judicial custody of former Delhi Deputy Chief Minister Manish Sisodia for 14 days, in connection with the Delhi Excise Policy

Notably, Sisodia is currently under Enforcement Directorate (ED) custody and was virtually produced in court. The case pertains to the alleged irregularities in the framing and implementation of the excise policy of GNCTD.

Special Judge MK Nagpal on Monday extended Sisodia's Judicial custody till April 3, 2023. The bail petition in the matter is listed for arguements on March 21, 2023.

Sisodia was on Monday produced before the Court virtually as presently he is in Custody of the Enforcement Direc-

torate till March 22. Former Delhi Minister and Aam Aadmi Party (AAP) leader Manish Sisodia in his bail petition in a trial court stated that no fruitful purpose would



be served to keep him in custody as all the recoveries have already been made.

Sisodia also stated that he has joined the investigation as and when called for by the Central Bureau of Investigation (CBI).

The other accused persons arrested in this case have already been granted bail. Sisodia further stated that he holds the important constitutional post of Deputy CM of Delhi and has deep

roots in the society. Sisodia was recently arrested by the Enforcement Directorate in a money laundering matter related to alleged irregularities in the framing and implementation of the excise policy of GNCTD.

ISRO set to launch LVM-III rocket with 36 OneWeb satellites on 26 March

SRIHARIKOTA, MAR 20

Indian Space Research Organisation (ISRO) on Monday said that the launch of the Launch Vehicle Mark-III (LVM3-M3)/OneWeb India-2 mission is scheduled for March 26, 2023.

The mission launch will take place from Satish Dhawan Space Centre in Sriharikota, Andhra Pradesh.

The official social media handle of ISRO took to Twitter and said, "LVM3-M3/OneWeb India-2 mission:

This mission marks OneWeb's second satellite deployment from India, highlighting the collaboration between the UK and Indian space industries"



IIT Mandi Researchers develop new method for producing metal oxide layers for solar cells

AGENCY SHIMLA, MAR 20

Researchers at the Indian Institute of Technology, Mandi have made a significant breakthrough in the development of metal oxide layers for use in advanced architecture silicon solar cells.

The results of this work is published in the journal of Materials Science: Materials in Electronics, co-authored by Dr Kunal Ghosh, Associate Professor, School of Computing and Electrical Engineering, IIT Mandi and his Ph.D scholars Mr. Syed Mohd Hussain and Md Sadullah from IIT Mandi.

Metal oxides such as nickel oxide, are an important class of semiconductors used in advanced architecture silicon solar cells. Nickel oxide films with thicknesses in the

nanometre range- a hundred thousand times smaller than the

thousand times smaller than the width of a single human hairmust be produced for this purpose.

The current methods for developing nanometric thin films of nickel oxide are prohibitively expensive, as the equipment required for production has to be imported. Additionally, the precursors used for the development of the films, such as nickel acetylacetonate, are also expensive, making it less likely for such technology to be commercially viable.

Giving an information, residents Sampooran Singh Salaria retired sub-divisional officer, Parminder Singh, Harbhajan Lal, Rooplal Dogra, Savinder Singh, Aman etc. told that thrice an application was given to Deputy Commissioner Pathankot on March 31, 2022, June 28, 2022 and February 27, 2023 respectively. But no action is being taken by any concerned department. He said that, the untreated sewerage flowing in the drain from Bharoli Kalan comes to our homes. Editorial

Struggle for survival

The aftermath of elections in three states is as good a time as any to focus on the many shades of the media landscape in the Northeast. In a region that has seen as much conflict as Kashmir has over the decades, insurgency is now less of a factor for journal-ists to contend with. Journalists in Tripura, Manipur, Meghalaya and Nagaland all say that the violence from militant groups is less, that non-State actors have lost the support that they used to get from the citizenry, as also the refuge that neighbouring countries such as Bangladesh and Myanmar gave them. Militancy has also gone down because major groups such as Ulfa are engaged in peace talks.

Non-State actors demanding coverage of their press releases on Page One in states like Manipur and Nagaland is a thing of the past. They have two ways of marking their existence, said one editor — via violence and by their presence on the pages of newspapers, without which they would not exist. Citizens are increasingly standing up to the violence and, today, they take whatever news coverage their statements get.

Journalists and citizens are primarily up against the State actors in this region. Tripura leads in attacks and arrests, followed by Assam and Manipur. All three states have chief ministers from the Bharatiya Janata Party. The Rights & Risks Analysis Group and the Assembly of Journalists between them document the attacks on media outlets, journalists and social-media users. There were 15 attacks in Tripura, 5 in Assam, and 3 in Manipur in 2021. There are no updated total figures at this point.

Tripura has had a BJP chief minister in the last five years. The colourful remarks of the former chief minister, Biplab Deb, on all manner of subjects led to unflattering comments on social media which prompted several arrests. Media criticism of his handling of the Covid-19 pandemic also led to threats and attacks. Women who work in rotating shifts are more likely to be frail: Study

recent study head-ed by York Univerresearchers discovered a relationship between shift work and frailty among middle-aged and older employees in among women on rotating

hours.
While there is a large body of research suggesting the disruptions to circadian rhythms that shift workers experience are linked to various illnesses, this study was the first to take a comprehensive or "holistic" look at the connection between shift work and frailty.

"We cannot ignore the negative health outcomes related to shift work, including cardiovascular diseases, diabetes, stroke and certain cancers," says York Faculty of Health PhD student Durdana Khan, a trainee with the York Centre for Aging and Research and Education. "Our study is the first to investigate the relationship between shift work and frailty for middle-age and older adults." For the study, which will be pub-



lished in the May edition of the Journal of Occupational and Environmental Medicine, Khan, along with York professors Heather Edgell, Hala Tamim and Michael Rotondi, and immunologist and epidemiologist Chris Verschoor of the Health Sciences North Research Institute, looked at 48,000 participants across Canada from the Canadian Longitudinal Study on Aging and followed up at three vears to measure for

Frailty is defined as someone's likelihood towards disease and death. The researchers used an index that looks at 52 factors that can likely lower lifespan, including depression, osteoarthritis, history of heart attacks and mobility issues. Mildly frail people are considered those that have at least five factors. Having at least 11 factors would put people in the 'very frail' category.

The study found one in five adult Canadians were involved in shift work, defined as work that falls outside of a nine-tofive schedule. People who had a history of shift work had a higher likelihood of frailty compared to people who only worked daytime hours. More than one in four were found to be mildly frail.

Over 70 countries express concerns over Afghan women's rights



s the Taliban continues to suppress women and restrict their fundamental rights in the country, the European Union (EU) along with more than 70 countries in a joint newsletter on Sunday expressed concern over the situation and said that these restrictions undermine economic and social stability and development in Afghanistan, Khaama Press reported.

The letter further stated that one of every three aid workers in the country is a woman, and as a result, they are no longer allowed to assist women and other people in need.

According to the statement, restrictions on Afghan women working for domestic and international non-governmental groups would prevent millions of Afghans from receiving humanitarian aid, Khaama Press re-

Ban on education and other fundamental rights of women is undermining inclusive governance and the recognition of human

rights, the statement read further.

The de facto authorities have restricted women's and girls' freedom of movement since August 15, 2021, preventing girls from attending secondary education, excluding them from the majority of the workforce, and forbidding them from utilising public parks, gyms, and bathrooms.



Leaders with low self-esteem likely to create 'toxic' stress at workplace

t's already proven that stress is a primary cause of common and fatal dis-Leases such as heart attacks, diabetes, asthma, cancer, osteoporosis, anxiety, depression, sleeplessness, memory loss,

and premature ageing. But how much of a role does 'toxic' leadership play in workplace stress, and what are the signs of a toxic leader? Recent data has shown that three-fifths of the world's employees say their job impacts their mental health more than anything else. Backed up by 40 years of research, well-being expert Professor Simon L. Dolan PhD says that leaders with low self-esteem are most likely to pass on stress to their teams.

"The stakes for leadership have always been high," Professor Dolan states, "but knowing you're affecting people's mental health is cause for leaders to take stock and ensure they're do-



ing all they can to be their best and have their most positive impacts on people.' Toxic at the top

Almost every working adult will have experienced a bad boss at some point in their working career. But at

what point does a bad boss become a truly toxic leader, and what can you do

Professor Dolan, a respected scholar in human resources, has trawled decades of research to create De-Stress at Work. The guide is designed to help people understand if their manager or leader affects their mental health, and what can they do to deal with it.

"Leadership can make or break an organization," Professor Dolan argues, with good leaders motivating teams to be creative and productive. But on the other side of the coin, a bad leader can demotivate teams, cause low morale and the effect on teams can be devastating."

After extensive research, Professor Dolan suggests the main characteristics to identify a toxic leader are those who: are jealous of their team's success; are constantly concerned about competition

or workplace 'enemies'; often take credit for other people's work; constantly compare themselves to others; consider their self-worth to be solely driven by their latest results.

"Whether knowingly or not, a toxic leader is one who abuses their authority and violates trust to satisfy their own ego," Professor Dolan continues.

The truth about leadership. Leadership requires hard work and there can be a stereotype of leaders having almost superhuman characteristics of stamina and strength, Professor Dolan argues.

He says: "This can be really harmful because they are required to hide their feelings even when under immense pressure. Pretending to be a superhuman causes a lot of damage to the mind and body - really the key is to be realistic about your strengths and weaknesses.

"A leader needs to be able to proac-

tively manage their emotions well enough to project calm and rational to their teams.

In order to do this, they need to equip themselves with emotional regulation tools, Professor Dolan suggests.

In De-Stress At Work, Professor Dolan offers practical solutions to tackling work-related stress both individually and on an organizational level, from best practice communication methods for companies, down to individual re-

laxation techniques for employees. "However, although leaders are expected to be confident, it is important not to confuse this with over-confidence," Professor Dolan says. "A great leader needs to be respectful, supportive and nurturing of growth - not just some-one who is self-assured."

He also highlights the importance of validation - leaders who offer recogni-

tion for a job well done can provide an essential source of people's perception of psychological success and self-es-

Who is susceptible? Professor Dolan argues that specific inherited characteristics, early experience in life, and, learned cognitive predispositions make individuals susceptible to the effects of stressors.

He explains: "There are many factors that contribute to a toxic personality, including a compulsive need to display their worth to others, but mainly out of a lack of deep-rooted self-esteem. This is usually a culmination of a lack of ethical and emotional development throughout their lives."

Typical reactions to stress vary depending on personality traits, such as neurotic anxiety, introversion and extroversion, rigidity, flexibility.







Haryana Deputy Chief Minister, Sh. Dushyant Chautala, in response to a question raised by a member of house during Vidhan Sabha session, informed that the ration card holders whose cards have been discontinued are being thoroughly investigated. According to the rules, if they are found eligible, their ration card will be issued again and remaining ration will also be provided.

He informed that on the basis of data provided by the Citizen Resource Information Department (CRID), 8,41,817 families have been found ineligible for pink cards. Due to the discontinuation of their ration cards in December, 2022 ineligible families have not been provid-



ed ration for the month of January, 2023. It was further informed that that ration has been allocated to 31.59 lakh BPL/AAY families for the month of January, 2023 as compared to 26.94 lakh families for the month of December, 2022.

The Deputy Chief Minister stat-

ed that the annual income should be less than Rs. 1.80 lakh for making Priority Household (BPL) ration card. He informed that the eligibility criteria for inclusion of identification of a family as Priority Household (BPL) in the State has been issued by the Rural Development Department and Urban Local Bodies, Haryana vide their notification dated August 3, 2022 and August 31, 2022 respectively and accordingly the beneficiaries are identified by the CRID, Hary-

He further informed that under the National Food Security Act, 2013, pink cards (AAY) have been issued to 3.02 lakh families as fixed by the Government of India, such families having income less than 1.80 lakh per annum are placed at the bottom of the list of families.
