WFI sexual harassment case: Court seeks status report from Delhi Police on investigation

NEW DELHI: Delhi's Rouse Avenue Court on Wednesday sought a status report from the Delhi police on the investigation in the FIRs lodged by the wrestlers against WFI chief and BJP MP Brij Bhushan Sharan Singh alleging sexual harassment. The plea moved by the woman wrestlers has sought monitoring of the investigation by the court, and direction for the statement of the victim before the court. It has also sought direction to produce a status report on the investigation of the matter

Additional Chief Metropolitan Magistrate Harjit Singh Jaspal sought a status report from Delhi Police on the plea. The matter has been listed on May 12. The copies of 2 FIRs were also filed in the court in a sealed cover.

8-day remand for Imran Khan as court indicts him in Toshakhana graft case





ISLAMABAD, MAY 10

An anti-corruption court in Pakistan on Wednesday sent former prime minister Imran Khan on an eight-day physical remand to the sions court here indicted him in a separate graft case. Meanwhile protests and riots are continue across Pakistan and Army has been deployed in several parts to maintain the sit-

The 70-year-old chairman of the Pakistan Tehreek-e-Insaf (PTI) was taken into custody by the paramilitary Rangers on Tuesday on the orders of the National Accountability Bureau (NAB) by barging into a room of the Islamabad High Court.

Khan was produced in the Anti-Accountability Court No. 1 presided by judge Muhammad Bashir, the same judge who had convicted former premier Nawaz Sharif and his daughter Maryam in a corruption case of having properties in London. Maryam was later on set free in the case by the Islamabad High Court. However, Sharif's case is still

At the start of the hearing, the NAB lawyers requested the court to grant a 14-day remand of Khan to probe the allegations against him in the Al-Qadir Trust case in which he is accused of looting Rs 50 billion of the national treasury. But Khan's lawyer opposed the plea and asked the judge to release him as the charges were fabricated.

Khan was arrested on Tuesday in the case, sparking massive country-wide protests

Imran's aide Asad Umar arrested from court premises

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) leader Asad Umar was arrested from the Islamabad High Court's (IHC) premises a day after the country's former prime minister Imran Khan was arrested, reported Geo

The Secretary General of PTI was apparently arrested by the Anti-Terrorist Squad of the Islamabad police today Umar was taken into custody while waiting outside the IHC Bar Association's office, where they were drafting a plea to submit to the IHC. He had requested a meeting with the PTI Chairman Imran Khan through a petition, according to Geo News.

PTI lawyers attempted to prevent the police from apprehending the force, but Umar was carried away despite their best attempts.

Earlier today, Imran Khan's party called for a nationwide protest against his arrest.

Karnataka is heading for a hung assembly, five of six exit polls have predicted, and the majority of them predicted a slight edge for the Congress. Their predictions also indicate that HD Kumaraswamy's Janata Dal Secular is likely to play kingmaker.

The majority mark in the 224seat assembly stands at 113 seats.

Only one exit poll – Zee News Matrize agency – has predicted an upper limit of 118 for the Congress. two others predicted an upper limit of 114 and 117 for the BJP.

News Nation-CGS has predicted that the state's ruling BJP will cross the majority mark with 114 seats, the Congress will win 86 seats and the JD(S) 21. The



Suvarna News-Jan Ki Baat has also given an edge to the BJP, predicting it will emerge as the single largest party with anything between 94 and 117 seats. The Congress, it said, will get 91-106 seats and the JD(S) 14-24 seats. Four other exit polls are counting on the Congress emerging as the single largest party, slightly ahead of the BJP in the race.

Haryana Police unearth Rs 100 crores pan-India cyber

BUREAU CHANDIGARH, MAY 10

After the coordinated raids on cyber thugs in Nuh district, pan-India cyber frauds to the tune of Rs 100 crore linked to these criminals have been unearthed. These thugs used to cheat people across the country with fake SIM, Aadhaar Cards etc. and used to deposit money in fake bank accounts to avoid arrest. People from Haryana to the national capital, Delhi and UP to Andaman-Nicobar have been targeted by these fraudsters. With their arrest, about 28,000 cases of cyber fraud have been traced across the country.

This was revealed by Superintendent of Police, Nuh Sh. Varun Singla while addressing a press conference in Nuh today. He informed that on the intervening night of April 27/28, 102 teams of 5000 policemen had raided 14 villages of the district simultaneously. During this raid, around 125 suspected hackers were detained. Out of these, 66 accused were identified and arrested. All were produced in the respective Courts and taken on remand for 7 to 11 days. Following the arrest, in order to unearth the whole nexus, Director General of Police, Haryana Sh. P.K. Agrawal deployed a team of 40 Cyber Experts from all across Haryana to be closely associated with the interrogation of these Cybercriminals. Sustained Interrogation of the Cybercriminals apprehended was thus carried out with the help of the Cyber experts and intricate details as regard the Modus operandi being adopted by the Cyber frauds as well as detailed information about sources of fake SIMs and Bank accounts were obtained. The mobile phones and SIM cards seized during the raid were also technically examined

and relevant details were also sought

from TSPs/ISPs, Banks, NPCI, UPI

Intermediaries, UIDAI, DoT, Social platforms Media Facebook, WhatsApp, OLX etc.

At the same time, the assistance of the Indian Cyber Crime Coordination Center of the Union Ministry of Home Affairs was also requested to provide the linkages of fake bank accounts, SIMs, mobile phones etc. used by these cyber miscreants with the cybercrime complaints received nationwide. During this analysis, it has come out that the cyber thugs have so far defrauded around 28000 gullible people, to the tune of more than Rs 100 crore, from 35 states and union territories across the country. Already 1346 FIRs have been registered against these cyber fraudsters across the country. The details of these cyber criminals is being sent to concerned senior Police authorities of these States to fix the culpability of these Cybercrimi-





HP to adopt e-stamp model completely by next year: CM

DINESH AGARWAL SHIMLA, MAY 10

The authorized stamp vendors will have one year period to switch over completely to selling of e-stamp papers in Himachal Pradesh. This will reduce an annual expenditure of Rs. 30-50 crore on the State exchequer which is being presently spent on printing of physical stamp papers. However, till the time being, the Government has decided to continue with the dual system of stamps, i.e. Physical and estamp paper from 1st April 2023 to 31st March 2024 and thereafter physical stamp papers will be discontinued completely. Furthermore, the State Government has decided to discontinue the printing of physical stamp papers with immediate effect and decided to collect the stamp duty on emode through the e-stamping system. The Government will authorize the stamp vendors as authorized collection centers for e-stamp papers. For the benefit of the consumers, e-stamps can be generated through the portal



of Stock Holding Corporation of India Limited (SHCIL), which serves as the Central Record Keeping Agency. Stamp vendors will be authorized to generate estamps through the portal at a nominal commission. At present, stamp vendors are allowed to sell physical stamp papers with an upper ceiling of Rs. 20,000 per day whereas this limit will be 2 lakh rupees per

day with fully adopting estamping system, benefitting the vendors as well.

"Although the e-stamping system was introduced in Himachal Pradesh in the year 2011, the State Government has now decided entirely to switch to e-mode", stated Chief Minister, Thakur Sukhvinder Singh Sukhu. The cost of printing stamp papers is Rs. 20,

Rs. 22 and Rs. 23 per stamp paper for denominations upto Rs. 500, Rs. 1000 to Rs. 5000 and Rs. 10,000 to Rs. 25,000 respectively. E-stamping is a win-win situation for both the State Government and the common people. The State Government has also studied the e-stamping model in three tehsils in Rural and Urban areas of Punjab, where it has improved ease of doing business and has generated revenue with minimizing the chance of fraud or re-use. Further, there is no provision to generate duplicate e-stamp certificates, if the original one is misplaced. Each stamp paper has a unique identification number which can't be tempered with. Data is stored safely with the SHCIL and verification of genuineness can be done using an inquiry model. "The State Government was promoting technology in various departments to provide improved services at the door steps and facilitate people of the State. Roping in the technology will also bring transparency in functioning of the government

departments" said Sh. Sukhu.

In Kangra, 437 infants are in the grip of acute malnutrition

Although many schemes are being run by the central and state government to reduce the malnutrition of children. Despite this, in district Kangra, 437 children in the age group of 0 to 5 years are victims of severe Although malnutrition. malnourished children are 0.68 per cent of the total number of children aged 0 to 5 years in the district, despite this figure, the department is making efforts to reduce malnutrition among severely malnourished children. According to the department, malnourished

children recover within a month, but for this awareness and timely proper care is necessary. The number of severely malnourished children is 59 in Nagrota Suriyan block of the district, which is the highest in the district and the least severely malnourished children are in Panchrukhi block. The main severe reason for malnutrition among children in the age group of 0 to 5 years is low birth weight and providing complementary feeding in time. According to the information, the food of the children is pleased, but many people do not get the food of the children done at the time

due to setting, if it remains

for one month, then the food is put forward, this also affects the seriousness of the children. due to being malnourished. However, awareness programs are organized from time to time by the Women and Child Development Department. The reason for the number of severely malnourished children in Panchrukhi being only 2 is that protein rich food prepared by CSIR was distributed in this block, which is helpful in removing malnutrition. At the same time, a campaign was also launched by the district administration in this block, due to which the number of severely malnourished children is less in this block.

'The Kerala Story': SC agrees to hear film makers' plea against ban by WB on May 12

NEW DELHI, MAY 10

Supreme Court Wednesday agreed to list for hearing on May 12 plea of makers of the 'The Kerala Story' challenging the decision of the West Bengal government to ban the screening of the movie in the State. After senior advocate, Harish Salve, appearing for filmmakers, mentioned the plea for urgent listing, a bench headed by Chief Justice of India DY Chandrachud agreed to hear it on Friday. "We are losing money every day and now there is another State which says it will do the same," said Salve. CJI said, "Ok list on Friday, serve copies on the State of West Bengal." West Bengal Chief Minister Mamata Banerjee has ordered an immediate ban on the screening of the film in the State to avoid "any incident of hatred and violence and to maintain peace in the State". The makers contended that the State government has no power to ban a movie that has been certified



for public viewing by the Central Board of Film Certification. State government cannot cite law and order issues to stop the screening of the movie, which will result in the violation of the fundamental rights guaranteed to them, the plea of filmmakers said. They also alleged that the movie is facing a 'shadow' ban in Tamil Nadu and sought protection for screening the film in the southern State. The plea also challenged the de facto ban imposed on the movie by the State of Tamil Nadu by issuing an "alert" anticipating

protests in connection with the release of the film due to which theatres in the State withdrew the film. On Tuesday, the bench agreed to list on May 15 an appeal against the interim order of the Kerala High Court refusing to stay the release of the film. The High Court had declined to stop the release of the film while observing that there was no allegation against a religion, but only against the organisation Islamic State or ISIS. The High Court watched the trailer of the film before refusing to stay its was nothing offensive to any particular community in it while hearing a batch of pleas challenging the CBFC challenging the CBFC certification granted to the film. Earlier, the Supreme Court declined to interfere with the release of the movie and asked the High Court to decide the pleas. The apex court had then said, "Think about the labour of actors, producers who put in a lot of work. A filmmaker invests a lot of money and time in making the film. Leave it to the market, the market will decide if it is not up to the mark. Jamiat Ulama-I-Hind had

earlier approached the Supreme Court seeking a stay on the release of the movie in theatres and OTT platforms saying the movie was likely to cause hatred and enmity between different sections of society in India. The plea said the film

demeans the entire Muslim community and it will result in endangering the life and livelihood of the entire Muslim

Editorial Petty concern

ean-Paul Sartre, the well-known French existentialsign philosopher, was an avowed Marxist and a passionate opponent of French imperialism. He had supported the Algerian war of independence against France and had befriended Frantz Fanon who had been active in the Algerian cause. During this war, Sartre had asked soldiers of the French Foreign Legion who were fighting against the Front de Libération Nationale of Algeria to stop fighting and desert the army, advice that predictably brought accusations of treason against him. And yet, the French State took no action against Sartre. When President Charles de Gaulle was asked why, his answer was:
"One does not arrest Voltaire!"

De Gaulle obviously did not mean that a Voltaire

should not be arrested and prosecuted if he was alleged to have committed a murder or a robbery or some similar crime. What he meant was that as far as possible an iconic thinker like Voltaire, or Sartre, should be left free to think and express himself, even when one disagreed with his thought, since progress in thought was an essential condition for social progress. He recognised that a nation had to show respect to its iconic thinkers whether or not one agreed with them; indeed, the existence of such thinkers and the respect shown to them are important elements of what defined a nation.

To be sure, there would always be an intolerant fringe that differs from this perspective; indeed, the building in Paris where Sartre lived was bombed by right-wing elements during France's Algerian war. But the State did not hound Sartre.

Contrast this with what is happening in India. Amartya Sen is an iconic intellectual of this country, and he deserves the nation's respect not only for his out-standing intellectual work but also for his steadfast commitment to the values upon which modern India is founded, values that have never been officially repudiated by any regime, no matter how much the right-wing may dislike them. And yet, he is being hounded in the most unseemly manner by Visva-Bharati, an institution in whose establishment and growth his family had played a significant role. He is being accused of unauthorisedly occupying 0.13 acres of university land and threatened with forcible eviction from this land.
One would, of course, be asked: should unauthorised

occupation, if it is at all the case, go unrectified? The answer, clearly, is: no. Let us assume for argument's sake, though it is far from established, that the university's assertion is correct and that Sen's house is located on a plot of land that exceeds the original lease of 1.25 acres by an additional 0.13 acres; but rectification can take several forms, the most obvious one being for the university to lease this additional 0.13 acres to him over and above the 1.25 acres which it claims were originally

Air pollution association with risk of dementia

n worldwide study commissioned by the journal Lancet three years ago revealed 12 modifiable risk factors for dementia, including three new ones: excessive alcohol consumption, brain damage, and air pollu-

The findings of the study were published in the journal of Alzheimer's Disease, a team of researchers led by experts at the University of California San Diego expands on how exposure to the final of those new factors, ambient air pollution, such as car exhaust and power plant emissions, is connected with a significantly increased risk of acquiring

dementia over time.

Senior author William S.

Kremen, PhD, professor of psychiatry and co-director of the Center for Behavior Genetics of Aging at UC San Diego School of Medicine, and colleagues examined baseline cognitive assessments of approximately 1,100 men participating in the ongoing Vietnam Era Twin Study of Aging. Average baseline age was 56, with 12 years of follow up.

They additionally looked at measures of exposure to particular matter (PM2.5) in the air and nitrogen dioxide

(NO2), which is created when fossil fuels are burned, and assessments of episodic memory, executive function, verbal fluency, brain processing speed and APOE genotype. APOE is a gene that provides instructions for making a protein crucial to the transport of cholesterol and other fats in the bloodstream. One version or allele of APOE

called APOE-4 has been iden-

tified as a strong risk factor gene for Alzheimer's disease. The researchers found that participants with higher levels of exposure to PM2.5 and NO2 in their 40s and 50s displayed worse cognitive functioning in verbal fluency from age 56 to 68. And persons with the APOE-4 allele appeared even more sensitive, with those exposed to higher PM2.5 levels showing worse

outcomes for executive function and those with higher NO2 exposure showing worse outcomes involving episodic memory.

Executive function refers higher-level cognitive skills used to plan, control and coordinate mental behaviors and acts. Episodic memory is the ability to recall and re-experience distinct, specific past events. "The 2020 Lancet report concluded that modifying 12 risk factors, which include others like education and depression at midlife, could reduce dementia incidence by as much as 40%," said first author Carol E. Franz, PhD, professor of psychiatry and co-director of the Center for Behavior Genetics of Aging. "That report placed ambient air pollution

as a greater risk for

Alzheimer's and related dementias than diabetes, physical activity, hypertension, alcohol consumption and obesity. Our findings underscore the importance of identifying modifiable risk factors as early in life as possible -- and that the processes by which air pollution affects risk for later-life cognitive decline begins earlier than previous

UAE, Thailand agree to launch CEPA negotiations

Human eyes play 'tricks' on minds: Study

new study has shown that the human visual system can 'trick' the brain into making inaccurate assumptions about the size of objects in the world around them. The research is published in the journal PLoS ONE.

cations for many aspects of everyday life, such as driving, how eye witness accounts are treated in the criminal justice system, and security issues, such as drone sightings.

The research team from the University of York and Aston University presented participants with photographs of full-scale railway scenes, which had the upper and lower parts of the image blurred, as well photographs of small-scale models of railways that were not blurred.

Participants were asked to compare each image and decide which was the 'real' fullscale railway scene.

The results were that participants perceived that the blurred real trains were smaller than the models.

Dr Daniel Baker, from the University of York's Department of Psychology, said: "In order for us to determine the real size of objects that we see around us, our visual system needs to estimate the distance to the ob-

"To arrive at an understanding of absolute size it can take into account the parts of the image that are blurred out - a bit like the out-of-focus areas that a camera produces - which involves a bit of complicated mathematics to give the brain the knowledge of spatial scale. "This new study, however,



shows that we can be fooled in our estimates of object size. Photographers take advantage of this using a technique called 'tilt-shift miniaturisation', that can make life-size ob-

ects appear to be scale models.' The findings demonstrate that the human visual system is highly flexible - sometimes capable of accurate perception of size by exploiting what is known as 'defocus blur', but at other times subject to other influences and failing to make sense of real-

world object size. Professor Tim Meese, from Aston University, said: "Our results indicate that human vision can exploit defocus blur to infer perceptual scale but that it does this crudely.

'Overall, our findings provide new insights into the computational mechanisms used by the human brain in perceptual judgments about the relation between ourselves and the external world.



Optimal treatment for excessive daytime sleepiness



ena Zeraatkar and Tyler Pitre of McMaster University have found that the medicine solriamfetol is the most effective therapy for excessive daytime sleepiness (EDS) in persons with obstructive sleep apnea (OSA).

A positive airway pressure (PAP) mask, which employs compressed air to maintain lung airways during sleep, is the primary therapy for OSA.

Some patients with OSA, however, still have EDS and may benefit from anti-fatigue medicine

Zeraatkar and Pitre published their findings in the Annals of Internal Medicine. "The most important thing

Zeraatkar and Pitre made their findings by conducting a systematic review of 14 clinical trials of anti-fatigue medications involving 3,085 people, as well as analysing data from MEDLINE, CENTRAL, EM-BASE and ClinicalTrials.gov in a specific network meta-analysis. They conducted their re-

search from October 2022 to January 2023. Senior author Zeraatkar said that while solriamfetol is likely the best medication for EDS, the drugs armodafinil-modafinil pitolisant are also effective in combatting fatigue. Solriamfe-tol can also raise blood pressure, especially risky for people with OSA, as many of them also have cardiovascular issues.

"It would be interesting to see how effective these anti-fatigue medications will be for treating related illnesses such as chronic fatigue syndrome and long COVID, now that we know they work for a similar condition," said Zeraatkar, an assistant professor of the Department of Anesthesia.

Expats find it easier to settle down in India -**HSBC** Research

CHANDIGARH: International citizens moving to India have experienced a relatively high level of ease when it comes to settling in the country, finds new HSBC research that delves into factors that enable people to settle down in a new country and feel a sense of belonging. Of the expats who have relocat ed to India, 80% said they settled into the host country in less than a year - with it taking on average 7.4 months to feel like they belonged, less than the global average of 8.3 months. 

South Africa qualifies for ODI World Cup 2023 CHELMSFORD: South Africa automatically qualified for ODI World Cup 2023 after the first

ODI between Ireland and Bangladesh in Chelmsford was abandoned due to constant rain on Tuesday. Ireland would not be able to qualify automatically for the 2023 ICC Men's Cricket World Cup. Eight teams have made their entry to the 2023 ICC Men's Cricket World Cup, with South Africa edging Ireland for the final spot after the latter's Super League clash against Bangladesh in Chelmsford as per ICC. The most recent changes in the race for automatic spots had come after Sri Lanka's unsuccessful series against New Zealand, and South Africa's two recent wins over the Netherlands in a home series. South Africa had given themselves every chance of qualifying automatically for this year's ICC Men's Cricket World Cup in their final series against Netherlands at home. The series victory moved the Proteas past the West Indies and into the eighth and final spot on the ICC Men's Cricket World Cup Super League standings. But their chances for automatic qualification still hinged on Ireland's ODIs against Bangladesh. A 3-0 series victory for Ireland would have brought them level on points with South Africa, assuming they incurred no penalty points.

A resurgent Kolkata Knight Riders will look for their third victory in a row in their fight for survival when they face a struggling Rajasthan Royals in the IPL in Kolkata on Thursday.

Facing must-win scenarios, the two-time champions showed tremendous resilience to bounce back into reckoning after their wins over Sunrisers Hyderabad and Punjab Kings, both in dramatic last-ball finishes.

The wins have not only boosted their sagging morale but also taken the side to sixth place from eighth on the points table.

As things stand, four teams including KKR and Rajasthan Royals, are locked on 10 points in a mid-table traffic rush for the playoffs. RR may be ahead on net run rate (NRR) but the equation could change quickly if KKR continue their winning run, as a victory for either side will take them into the top-four.

While KKR are high on confidence after two thrilling wins, the Royals -- last season's runners-up -- would be at their lowest ebb after three defeats. The Royals had posted 200-plus totals but were done in by some baffling strategies in two of their three losses, which has led to a must-win scenario for them as well. In terms of key battles and team strategies, KKR would once again rely on Varun Chakravarthy, who has been the central character in both their previous wins. Having defended nine runs in the last over against SRH, Chakravarthy's 3/26 made all the difference against Punjab Kings. At a time their seasoned slow bowler Sunil Narine is finding it difficult to get wickets, Chakravarthy has emerged as KKR's spin spearhead with 17 wickets so far this season. While KKR's think-tank refuses to give up on Narine who has just one wicket in the last eight matches, it's Chakravarthy's four overs which would again be crucial. With the KKR team management not bowling World Test Championship final-bound Shardul Thakur against PBKS, the pace department looked woefully short on experience.

Had it not been for the heroics of Rinku Singh and Andre Russell, the seam duo of Vaibhav Arora and Harshit Rana had almost lost the match after leaking 36 runs in the last two overs against PBKS. It remains to be seen if

KKR utilise the services of a "fitagain" Shardul in the crunch match. Against a batterheavy Royals with the likes Yashasvi Jaiswal, Jos Buttler and Sanju Samson in fine form, KKR would hope their bowlers get their act While together. KKR need to plug the gaps in the pace bowling department, the Royals must take a fresh look at their bowling strategy. Defending 214 against SRH, the Royals' decision to give Kuldip Yadav the penultimate over instead of Obed McCoy backfired as the rookie seamer conceded 24 runs. The biggest positive for KKR in their win
