Four charred to death in major fire in Bareilly

BAREILLY: Four workers were charred to death and three others were injured in a major fire in a foam factory in Fareedpur area of Bareilly district here in Uttar Pradesh, police said here on Thursday. Chief Minister Yogi Adit-

yanath has expressed grief over loss of lives in the fire incident. He has directed the district administration officials to speed up the relief work and to take the injured immediately to the hospital and provide them proper treatment. Superintendent of Police (Rural) Raj Kumar Agarwal said that there is a factory near Megi Nagla on Lucknow highway where foam mattresses, plastic furniture and other items are manufactured.

ISRO conducts integrated test on Semicryogenic Engine

BENGALURU: In a breakthrough in developing 2000kN semi-cryogenic thrust engine for heavier satellites of the GSAT series. Indian Space Research Organisation carried out its first integrated testing at the newly commissioned semi-cryogenic facility of ISRO's Propulsion Complex (IPRC) in Tamil Nadu's Mahendragiri

The very first test was conducted on Wednesday on an intermediate configuration of the 2000kN Semicryogenic Engine. The intermediate configuration, designated as Power Head Test Article (PHTA), comprises all the engine systems except the thrust chamber. The test is the first of a series of tests planned to validate the design of the propellant feed system, including the low-pressure and high-pressure turbo-pumps, the gas generator, and control components, the Bengaluru-headquartered space agency said.

LG can't have administrative supervision over all issues of Delhi: SC

AGENCY NEW DELHI, MAY 11

The Supreme Court's five-judge bench led by Chief Justice of India (CJI) Dr Dhananjaya Yeshwant Chandrachud, in a unanimous verdict on Thursday said that the Lt. Governor cannot have all the administrative supervision over all issues relating to UT of Delhi.

The Apex Court said that the LG's (Lieutenant Governor) powers do not empower him to interfere with the legislative powers of the Delhi assembly and elected government.

The Top Court said that the rights to control services must reside in the democratically elected government.

The Supreme Court in its judge-

ment said that except on subjects of public order, police and land, all services, including Indian Administrative Services (IAS) even if not recruited by the NCT (National Capital Territory) government, would be controlled by the Delhi government as per Constitutional scheme of governance.

The Apex Court passed the verdict on the issue of the power tussle between the Delhi government and LG over transfer and appointment of officers. Supreme Court held that if administrative services are excluded from the legislative and executive domains, the



ministers would be excluded from controlling the civil servants who are to implement the executive decisions.

Maha political crisis: Apex Court refers case to larger bench

NEW DELHI: The Supreme Court on Thursday while hearing a batch of petitions on the Maharashtra political crisis referred to a larger bench of seven judges to consider the 2016 Nabam Rebia decision on the powers of Assembly Speakers to deal with disqualification pleas. "The correctness of the decision in Nabam Rebia (supra) is referred to a larger bench of seven judges," A five-judge bench of Chief Justice DY Chandrachud and Justices MR Shah, Krishna Murari, Hima Kohli and PS Narasimha said. The court noted that it appears that some aspects were not considered in Nabam Rebia's judgement. Among them was, whether the temporary disablement of the functions of the Speaker under the Tenth Schedule is prone to misuse by MLAs who anticipate that disqualification petitions will be instituted against them or by MLAs against whom disqualification petitions have already been instituted, the court noted. The court also said that whether a "constitutional hiatus" in the operation of the Tenth Schedule ensues because of the temporary disablement of the Speaker was not considered in Nabam Rebia's judgement.

Pakistan SC calls arrest "illegal"

AGENCY ISLAMABAD, MAY 11

The Supreme Court of Pakistan on Thursday declared Pakistan Tehreek-e-Insaf chief Imran Khan's arrest "illegal," and also directed for his immediate release, reported ARY News.

The major relief for the former prime minister came shortly after he was presented in court. Khan, who was removed from office as prime minister last year in April, was ordered by the SC to present himself at 4:30 pm, but he was produced at around 5:40 pm, more than an hour later.

He was carried in a 15-vehicle convoy.

Khan was ordered to appear in court after Chief Justice of Padescribed the PTI leader's detention from the Islamabad High Court (IHC) premises as a mighty disgrace to the country's legal system, as per ARY News.

The CJP made the comment while presiding over a three-person bench debating the PTI's appeal challenging Khan's arrest. The bench also contains Justices Muhammad Ali Mazhar and Athal Minallah in addition to the Chief Justice of Pakistan.

Ever since Khan's arrest, Pakistan has been witnessing a situation of unrest. Several protests have broken out across the country as PTI has urged its supporters to come out in support of Imran Khan. On the other hand, the PTI has asked its supporters to stay away from the top court, ARY News reported.

Mr Khan has alleged he was tortured in the NAB custody and was not allowed to even use the washroom. The former cricketing superstar, who remains popular in Pakistan, alleged he was given an injection to induce a slow heart attack.

Mr Khan's arrest follows months of political crisis and came hours after the powerful military rebuked the former international cricketer for alleging that a senior officer had been involved in a plot to kill him. Some protesters took out their wrath on the military, torching the residence of the corps commander in Lahore and laying siege at the entrance to the army's general headquarters in the garrison city of Rawalpindi.







US concerned over China taking 1.2 million DNA samples in Tibet

SANJAY AGGARWAL DHARAMSHALA, MAY 11

US Secretary of State Anthony Blinken has expressed deep concern over reports of a largescale DNA collection campaign by China in Tibet. The Central Tibetan Administration in Dharamshala has also been continuously opposing it. The report said that DNA samples of more than 1.2 million Tibetans, including children under the age of five, have been taken, which is a matter of concern. US Secretary of State said that we are also concerned by reports of the proliferation of large-scale DNA collection in Tibet as an additional form of control and surveillance of the Tibetan population. In an effort to socially control Tibetans, the Chinese authority has resorted to frequent surveillance and overpolicing, including the arbitrary collection of DNA samples from Tibetans. A report released in September 2022 by Human Rights Watch stated that blood samples for DNA collection were being systematically collected from children in kindergartens and other local



residents. In December 2020, a report from a Tibetan township in Qinghai province stated that DNA was being collected from all boys aged 5 and above. He said such mass DNA collection campaigns were conducted in all seven prefectures or municipalities in the TAR, which covers the western part of the Tibetan Plateau. The report highlights that the collection drives are part of an ongoing effort by Chinese authorities to establish a grassroots police presence across the region and indicates ambiguity around the conditions under which a resident may refuse to provide a sample.





Minor spectacle

he coronation of King Charles III, watched by millions across the globe, was a grand spectacle. Pomp and pageantry have always been central to British statecraft, particularly its celebration of the monarchy, ever since Queen Victoria assumed the grand title of Empress of India in 1877. The British Empire, in full bloom until the independence of India in 1947 began the process of decolonisation, may no longer be there to pay the bills, but Britain hasn't entirely forgotten the 'ornamentalism' that marked its imperial heyday. "Gold fillings in a mouth of decay" was how a left-wing writer once chose to describe the institution that was celebrated last Saturday.

Understandably, there were sharply divergent views of the coronation, including those who saw it as a nonevent and, at best, equal in importance to the opening and the closing ceremonies of the Olympic Games. Within Britain and some parts of the Anglophone world, the formal anointment of Charles III was a semi-mystical event. Moreover, since this was the only coronation in living memory — the previous one happened in 1953, a long time ago — they wallowed in the television coverage, although the ratings were less than those of the funeral of Queen Elizabeth a year ago.

Seven decades ago, at the dawn of the long Elizabethan era, the televised coverage was elementary and lacked the glitz and technological sophistication of today. At the same time, the coronation of Queen Elizabeth II had a greater global importance because despite the weariness of a painful victory over Hitler's Germany and Tojo's Japan, Britain was an important player in international affairs, third only to the United States of America and the Soviet Union. Despite all its pretensions of restoring its status as a player of consequence — the proverbial Singapore of the West — the grim reality is that Britain is increasingly being seen as a declining power with oodles of heritage. Some of that heritage, including all the Cullinan diamonds extracted from Africa under circumstances that can at best be called controversial, was on display at the coronation. Some of the other treasures, such as the iconic Kohinoor diamond, were wisely kept away from the coronation.

In many ways, the British monarchy has tried to modify its image and keep up with the times. Although its constitutional role is very limited and the scope of the royal prerogative nominal, the monarch plays an important role as a symbol of British nationhood. Keeping his/her head above controversy and steadfastly treading a sensible middle ground have been the expectations from the monarch since Queen Victoria

China's attempts to install friendly government in Nepal suffer setback

nese leadership to Anese readers... friendly government in Kathmandu have suffered setbacks, say specialists, according to South Asia Democratic Forum (SADF).

The Communist Party of China (CPC) has for quite some time, 'pushed for a united leftist party in Nepal that would enjoy widespread support and govern in the favour of officials in Beijing'. To do so, the CPC supported merging the 'two largest communist parties to establish a strong communist force in Nepal'.

The newly formed party which was called the Nepal Communist Party (NCP), comprised the Communist Party of Nepal-Unified Marxist Leninist (CPN-UML), headed by K P Sharma Oli, and the Communist Party of Nepal (CPN-Maoist Centre) of former rebel leader Pushpa Kamal Dahal (also known as 'Prachanda').

The unified communists under the banner of the NCP came to power in 2018. With this, it appeared that Beijing had successful-



ly consolidated its influence in Kathmandu. However, the Communist 'unity party' was short-lived and split in March 2021. This led to the exit of the NCP from power and resulted in a government led by the Nepali Congress (NC).

According to SADF, it is of course hard not to perceive the NCP split as a 'a major setback to Beijing's Nepal policy'. Under the then-new Prime Minister Sher Bahadur Deuba (NC), the Nepali government's criticism of India was toned down, another indicator of China's declining influence in Kathmandu.

It appeared that after the November 2022 general elections, Beijing was re-

gaining some of the political space in Kathmandu it enjoyed under the NCP rule. Nepal witnessed the return of the CPN-UML and the CPN-Maoist Centre to power as part of a broader coalition. The withdrawal of the pro-Chinese CPN-UML from the current ruling coalition was however a major set-back for Beijing.

It appeared that after the **November 2022 general** elections, Beijing was regaining some of the political space in Kathmandu it enjoyed under the NCP rule. Nepal witnessed the return of the CPN-UML and the CPN-**Maoist Centre to power as part** of a broader coalition.

To make things worse, the exit of the CPN-UML from the coalition was the consequence of a larger behindthe-scenes political ma-

noeuvre by Prachanda. A presidential election took place earlier in 2023. Instead of supporting the candidate of his coalition partner, the PM decided to promote Ram Chandra Poudel from the opposition Nepali Congress. The

takeover of the presidential office by Poudel marks another Chinese defeat.

His predecessor, Bidhya Devi Bhandari, had a 'discernible proclivity toward China'. Prachanda's decision therefore led both to the drop-out of CPN-UML from the ruling coalition but also to the removal of a "pro-Chinese" communist face in the supreme post', according to Asian Lite.

Healthy diet linked with greater physical fitness in middle-aged adults

lated to higher phys-Lical fitness in middle-aged people, according to a study.

The findings of the study were published in the European Journal of Prenal of the European Society of Cardiology (ESC).

"This study provides some of the strongest and most rigorous data thus far to support the connection that better diets">diets may lead to higher fitness," said study author Dr. Michael Mi of Beth Israel Deaconess Medical Center, Boston, US. "The improvement in fitness we observed in participants with better diets">diets was similar to the effect of taking 4,000 more steps each day.

Cardiorespiratory fitness measures the body's ability to deliver and utilise oxygen during exercise, and it takes into account the health of several organ systems, including the heart, lungs, blood vessels, and

It is one of the most powerful indicators of health and lifespan. While exercise improves car-



diorespiratory fitness, there are disparities in fitness among persons who exercise the same amount, indicating that other factors have a role. A healthy diet has been linked to a variety of health advantages, but it is unknown if it is also linked to fitness. The purpose of this

study was to see if a nutritious diet is related to physical fitness in communitydwelling individuals.

Framingham Heart Study includes 2,380 participants.

The average age was 54 years, and 54% of the participants were female. To determine peak VO2, participants performed a maximal effort cardiopulmonary exercise test on a cycle ergometer. This is the gold standard of fitness evaluation and represents the quantity of oxygen consumed during the most intense activity imaginable. Participants also completed the Harvard semi-quantitative food frequency questionnaire to assess intake of 126 dietary items during the last year ranging from never or less than once per month to six or more serv-

ings per day. The information was used to rate diet quality using the Alternative Healthy Eating Index (AHEI; 0 to 110) and Mediterraneanstyle Diet Score (MDS; 0 to 25), which are both associated with heart health.


How brain interprets taste

aste is a complicated neurological experience that has the potential to reveal vast, and maybe startling, information on how the brain makes sense of sensations and the organisation of brain networks. A National Institutes of Health-fund-Ph.D., an associate professor in the Department of Biology in the Dodge Family College of Arts and Sciences, aims to better understand how the brain processes taste and how those neural connections might change.

Taste is associated with a variety of brain functions, including the pleasure of tasting something sweet. Taste is a component of flavour, and it includes the pain felt while tasting a hot pepper. There is, however, a knowledge deficit on how taste and flavour preferences develop and alter through time.

Taste is a component of flavor; it contributes sensations like saltiness and sweetness. When we're eating food, we get a lot of pleasure from taste and flavor, but taste is actually a sensory system that we really don't fully understand in terms of how it works in guiding eating behavior and also how it works in the brain," Lemon said.

This project will build on a discovery made by Lemon's research group while studying a part of the brain where taste sensations can excite neurons in the midbrain region. Importantly, many other senses from various parts of the body are processed in the same neural location, with preliminary data suggesting some body senses can activate brain cells excited by tastes. By determining



how neurons are receiving signals for taste and touch sensations, Lemon's study hopes to better understand how these integrations happen and whether it is reflective of an emotional correlation

'There is a part of the brain that takes in sensory information from basically almost all over the body, and taste is a part of this. We're wanting to understand, essentially, how taste is mapping into this part of the brain, along with all of these other body sensations as well, with the idea that if we can understand this it might actually tell us more about how taste works and how the taste system and other senses are organized, and why there appears to be neural overlap between

Researchers discover how DNA repair can go wrong and lead to disease

re frequently come to an under-standing of what causes a con-dition. We know, for example, that tumours are produced by mutations in crucial sites in the genome, resulting in a lack of control over cell development. We know that the start of Huntington's disease, as well as other disorders that cause muscle atrophy and loss of coordination and balance, is connected to the proliferation of short, repetitive DNA se-

What we don't understand is how these genomic processes occur. Catherine Freudenreich, professor and chair of Tufts' Department of Biology, and her colleagues discovered mechanisms by which the natural process of DNA repair fails and mutations occur in a study published in the journal Nature Communications, opening up new avenues for understanding the origins of many diseases and



developing therapies to treat them.

"DNA breaks and repair events occur thousands of times per day in each of us," said Freudenreich. "Most of the time, repair works the way it should. But we now have a better understanding of how

things can go wrong, and we can apply this knowledge to new therapeutic strate-

Erica Polleys, a postdoctoral researcher in the Freudenreich Lab, concentrated on the gene repeats found in Huntington's disease--a long repetition of 60 or more copies of the sequence cytosine-adenine-guanine, or CAG, on one strand of DNA and cytosine-thymineguanine, or CTG, on the complementary strand. "We've engineered yeast to have a CAG repeat sequence, because their cells are similar to human cells in many ways and they are easy to work with," said Polleys, "We can use simple model organisms to uncover how cells deal with repairing breaks and errors near repetitive sequences and use that knowledge to get an understanding of how human diseases like Huntington's disease or cancers de-It has been widely understood that

DNA repeats can form structures that branch away from the linear chain of DNA, much like a cord or a hose will form branching twists if wound too tightly. These branches form barriers to natu-

ral replication and repair and introduce errors in the genome.

Freudenreich and Polley's examination of the mechanisms of DNA repair near Huntington's disease-like repeats revealed that repeats would expand or contract in number depending on which strand of the double stranded DNA was being repaired. When the CAG side of the strand was being removed during a repair, the repeats contracted, and the DNA was at risk of large deletions, often fatal to the cell. When its complementary CTG strand was being removed and repaired, the repeats expanded, but only by one or two copies at a time. The researchers hypothesize that this is how the repeats accumulate in neurons of Hunt-

ington's disease patients. A key observation was that DNA breaks near expanded repeats occurred a lot more frequently when the repeats

were exposed as a single strand of DNA, something that occurs during many repair processes. This "fragile site" can lead to deletion of a nearby important gene, which can kill the cell, or result in diseases like cancer.

DNA fragility can happen near other sequences that make the DNA form branched twists. Genomic analysis could reveal more mutation hotspots that lead to cancer, or the accumulation of repair errors that lead to many conditions of aging. Observing changes in repeat length provided more detail about what was happening, but not how it was happening. The Tufts team picked apart the repair mechanism further, deleting some proteins to see how they affected the fragility of the yeast genome. Removal of one protein led to a faster recruitment of other proteins that untwist the DNA, leading to more successful repairs.

Mr Vij said that under the leadership of Chief Minister the structure of the health department was being completely changed. Instructions have been given to the officers of the department to make the broken PHCs new in the state. About 162 PHCs have been identified, which would be demolished and constructed new. Apart from this, ECG and X-ray machines will be made available up to the PHC level, so that good health facilities can be provided to the people.

The news came as five players were suspended by their clubs on Wednesday: Athletico Paranaense's Pedrinho and Bryan Garcia; Cruzeiro's Richard Coelho, Fluminense's Vitor Mendes and America's Nino

On Tuesday, Santos said they suspended defender Eduardo Bauermann for his involvement in the illegal betting ring.

Prosecutors allege that the players received payments by a criminal group to commit infractions during matches. The group won handsome payouts by betting that the misdemeanors would occur. According to prosecutors, the organization lured players by offering an upfront payment of up to 500,000 reais (around 100,000 U.S. dollars).

ECG and X-ray facility will be provided at PHC level: Anil Vij

CHANDIGARH, MAY 11

Haryana Health and Family Welfare Minister, Sh. Anil Vij said that about 162 PHCs have been identified in the state, which will be reconstructed and their design will be same. Apart from this, ECG and X-ray facilities will also be provided at the PHC level.

Sh. Vij was addressing the people at inauguration of 46 health services by Chief Minister Sh. Manohar Lal in Yamunanagar today.

Sh. Vij said that "I have ordered my department to make new PHCs. He said that there was a time when a doctor used to sit in a dilapidated PHC/hospital and there was a line of 200-300 patients in front of him, unless we change the environment, we cannot get complete results from them. He said that "I have given orders that ECG and X-ray machine facilities should be provided upto the PHC level". He said that the department has prepared a scheme to provide this facility so that better facilities can be provided to the people. Sh. Vij said that before our government, people were treated by giving blue yellow pills, but since our government has come into power, we have decided that whatever medicine we will purchase WHO GMP certified. Similarly, US-FDA certified equipments are being taken for hospitals because unless there are good equipments doctors cannot give good treatment. He said that there was a time when hospitals did not even have X-ray machines; today we are trying to facilitate X-ray machines, ultrasound, MRI and cath labs operational in all district hospitals. He said that currently cath labs are operational in four districts of the state including Ambala, Faridabad and Gurugram and we

have saved thousands of lives so far. He

said that due to the vision of the Chief

Minister, we want to completely change

the system/structure of the health depart-

Sh. Vij said that we have changed the empanelment policy that we have decided to empanel only NABH hospitals. He said that with one of our decision, about 400 private hospitals in the state became NABH. Similarly, government hospitals are being certified. Apart from this, all the health facilities are being connected through e-Upchar so that the information of the patients can be made available through online in all the health facilities. He said that we are trying to completely change the health department at many places including Ambala City, Ambala Cantonment, Yamuna Nagar, Panipat and today 46 more health services are going to be added in the same. He said that today health services are being inaugurated in 17 districts of Haryana by pressing the button from the hands of Chief Minister Sh. Manohar

KARNAL: Dr. Aditya Pratap Dabas, Deputy Director of Agriculture and Farmers Welfare Department, told that instead of planting paddy crop department asked the farmers of district Karnal to im-. prove the ground water level and increase crop diversification.
