Lok Sabha proceedings were adjourned till 5 pm on Tuesday amid protests by opposition parties on the violence in Manipur.

Amidst the din, the House passed the The Biological Diversity (Amendment) Bill.

The Bill was introduced in Parliament on December 16, 2021 by Bhupender Yadav, Union Minister for Environment, Forest and Climate Change. The bill would amend the Biological Diversity Act, 2002.

The Bill was moved to a joint committee on December 20, 2021 due to concerns that the amendments favoured industry and contradicted the spirit of Convention on Biological Diversity (CBD)

The joint committee submitted its report in Parliament on August 2, 2022 with the recommendation that the Bill may be passed after the inclusion of their recommendations. Many MPs spoke on the advantages of the amendments to the bill and said its benefit includes aligning bio-diversity with the Companies Act. Yadav said the bill is significant as the world is facing triple crisis of climate change, desertification and ecological imbalance. Earlier, as soon as the House met for the day, Op-

The Special Court also acquitted Aruna Chadha another accused involved in this case.

One of the accused Chanshivroop Singh S/o Sh.Harminder Singh, a resident of Punjab has been declared as Proclaimed Offender in this case.

Special Judge Vikas Dhull after hearing final arguments said, "prosecution has failed to prove offence under Section 306 read with 120-B IPC charge dated 10.05.2013 due to which deceased Geetika Sharma had no option but to commit suicide and the possibility of deceased Geetika Sharma committing suicide due to other reasons, as discussed hereinabove also cannot be ruled out.

Cloudburst damages two bridges, five houses in Kullu

KULLU, JULY 25

A cloudburst occurred in Gadsa valley at Panchanala in Kullu district in Himachal Pradesh on Tuesday, administration confirmed that two bridges and five houses were washed away in the flash flood and rising water level, and a number of other houses were also partly damaged.

According to the information received at the district headquarters here on Tuesday, a

cloudburst occurred in Panchnala, Gadsa Valley, around 0409 hours. The impact of the cloud burst caused heavy losses to public communication, infrastructure, and property, isolating the two patwar circles of the area from the natural disaster. Deputy Commissioner Kullu Ashutosh Garg said that five houses have been completely damaged and 15 houses have been partially damaged due to the cloudburst. Two bridges have been washed away due to the cloudburst.

Man falls in Karnataka waterfall while posing for Instagram reel

A man slipped and fell into a waterfall before being swept away by the current while filming an Instagram Reel in Karnataka's rain-battered Udupi district Sunday eve-

ning. The man has been identified as 23-year-old Sharath Kumar, from Bhadravathi in Shivamogga district. The incident, captured on camera by the man's friend, took place at the Arasinagundi waterfalls, located just 6 km from Kollur village.

In a video that is now viral on the internet, the man can be seen standing on a rock overlooking the waterfall, swollen after heavy rainfall in the state. The man then lost his balance and in an instant, fell into the waterfall before disappearing under the roaring waves

The police and emergency services soon reached the spot to carry out a search and



rescue operation, however the man's body could not be recovered. The rescue operation will continue today, the police said.

Torrential rains have pounded Udupi district in the last couple of days, inundating several areas. The Nandavara, Aladka, and Gudina areas near Bantwal taluk were the worst hit, with water entering homes and forcing residents to flee. The active southwest monsoon has triggered a flood scare in Karnataka, as many small streams have overflowed and inundated low-lying areas.

Phangnon Konyak becomes first woman member from Nagaland to preside over Rajya Sabha

Days after being nominated to the panel of Vice-Chairpersons of Rajya Sabha, the first woman member from Nagaland Phangnon Konyak on Tuesday presided over the House proceedings.

She was in the Chair when the Constitution (Scheduled Tribes) Order (Fifth Amendment) Bill, 2022 was passed.

In a move to bring about gender equality, Vice President and Rajya Sabha Chairman Jagdeep Dhankhar last week nominated four women



members (50% of the total number) to the panel of Vice-Chairpersons.

All women members nominated to the panel are first term Parliamentarians

"The panel reconstituted before the Monsoon Session contains a total of eight names, out of which half are women. This is the first time in the history of the Upper House that equal representation has been given to women members in the panel of Vice-Chairpersons," said a media release from the Vice President's Of-

Phangnon Konyak belongs to the ruling Bharatiya Janata Party (BJP)

and is the first woman to be elected as Member of Rajya Sabha from Nagaland in April, 2022. She is the second woman from the State to be elected to either House of the Parliament or the State Assembly.

Konyak is a member of Committee on Transport, Tourism and Culture, Consultative Committee for the Ministry of Development of North Eastern Region, Committee on Empowerment of Women, House Committee and Member, Governing Council of the North-Eastern Indira Gandhi Regional Institute of Health and Medical Sciences, Shillong.





CM announces to release Rs 49 crore for girls, boys hostels at PU

SHASHI PAL JAIN CHANDIGARH, JULY 25

Punjab Chief Minister Bhagwant Mann on Tuesday said that the state government will soon release around Rs 49 crore for construction of new boys hostel and expansion of girls hostel at Panjab University.

The Chief Minister, who inspected the sites where these hostels will come up, said that five new floors will come up over the existing two storey building of the girls hostels whereas six storey boys hostel will also come up in the university. He said that these hostels will be constructed while keeping in view the futuristic needs of the students. Bhagwant Mann said that these hostels are the need of hour to ensure that students can focus on their education while studying in university and don't have to shelve money while living in PGs or other places. The Chief Minister said that Panjab University is the part of great cultural legacy of the state and has produced eminent personalities who have left in-



delible imprint in various fields. He said that the staff, students and senate members had called on him and urged to construct these hostels. Bhagwant Mann said that keeping in view the needs of the students these hostels will be constructed on modren lines. The Chief Minister said that Punjab government is committed for the holistic development of the university as 175 colleges of the state are affiliated to it.

He said that it is a matter of great pride and satisfaction that number of MLAs from his party have also studied from this university only. Bhagwant Mann said that the hostels will not only have rooms with four walls but they will also provide a conducive atmosphere for education. The Chief Minister said that the hostel will have dining hall, common rooms along with neat and clean washrooms. He said that instead

of earlier practice of constructing washroom after every six rooms now the bathrooms will be constructed after every four rooms to facilitate the students. Likewise, Bhagwant Mann said that 38 rooms will also be constructed with attached bathrooms for the research scholars and others.




HP bags gold medal for digital excellence in rural sector

In this, activities like trekking will remain closed in places up to 1500 meters high in Kangra district. The District Magistrate said that the police administration and the concerned subdivisional officers have been instructed to ensure compliance of the orders, along with this, the District Tourism Development Officer has been asked to convey the information about these orders to all hotel operators so that tourists do not turn towards trekking sites at any level. Dr Nipun Jindal said that high places are prone to landslides due to rains and in this regard trekkers have put their lives at risk during monsoon earlier also. Many times the administration has also taken out the people stuck at high places during trekking with great difficulty. He said that trekking has been banned to avoid any untoward incident. Dr. Nipun Jindal said that people have been instructed not to go near rivers, drains and potholes due to rain. Due to the monsoon, there is a danger of sudden rise in water level in rivers and ravines in Kangra district. He said that instructions have also been given to all the sub-divisional officers that slums and shanties should be removed with immediate effect and proper arrangements should be made for the rehabilitation of those people.

According to information received, there are 140 drinking water schemes of Jal Shakti Department in Jawali assembly constituency. 72 tube wells, 58 water supply, 10 lift irrigation are currently running. To run these drinking water schemes, 117 pump operators, 144 beldars, 34 fitters and 06 watchmen are



working in Jal Shakti Vibhag. But instead of operators, Beldar, Fitter and Chowkidar are working to run the drinking water schemes. Many schemes and tubewells are lying closed due to non-availability of pump operators due to which machinery costing lakhs of rupees is rusting. Xen Ajay Kumar Sharma of Jal Shakti Department told that there is a lot of shortage of pump operators in the department. As a result, at many places, only Beldars are doing the work of pump operators. He said that we have informed the government about this. Whenever pump operators are recruited, pump operators will be appointed on all these schemes.

Several social and civil society organisations held a joint demonstration at the Deputy Commissioner's office here demanding the intervention of President Draupadi Murmu to stop the ongoing violence in Manipur and restoration of peace and communal harmony. A State Cabinet meeting was held here today under the Chairmanship of Chief Minister, Thakur Sukhvinder Singh Sukhu, which decided to launch 'Mukhya Mantri Van Vistaar Yojna'. The scheme aims to include barren areas of hills or mountains across the State with the objective of expanding green cover, preventing soil erosion and excessive runoff on degraded and refractory hills slopes. To ensure the effective implementation of this Yojana, a Task Force will be constituted under the Chairmanship of Principal Chief Conservator of Forests,



the Head of Forest Force (HoFF). Further, it was decided that the maintenance of selected areas will be done for seven years and the work will ' of plantation maintenance outsourced, preferably involving local inhabitants. The Cabinet decided to

make Trauma Centre and Emergency Department, IGMC, Shimla functional to facilitate the patients. It would ensure that all the related six departments, Neurosurgery, Radiology, Plastic Surgery, Anaesthesia, create and fill-up additional Orthopaedics and General 136 posts of nursing and Surgery will function in three shifts round the clock.

The Cabinet decided to fill up 87 posts of different categories in various Municipal Councils and Nagar Panchayats in the State. The Cabinet also decided to set up Project Management Unit in Revenue Department to deal effectively with natural calamities along with creation and filling up of 14 posts of different categories.

It was also decided to create posts of Assistant District Attorneys for newly established Civil Courts at Dharampur and Padhar in Mandi district and for newly established Additional District and Session Courts at Nurpur, Dehra, Palampur, Paonta Sahib and Rohru and

seven posts of Deputy District Attorneys for POCSO Courts and Special CBI Court. Nod was given to create

Editorial Looking away

Speaking at a public event in Moirang, Manipur, in January, the Union home minister, Amit Shah, drew a distinction between pre-vious Congress governm-ents and the Bharatiya Janata Party, which rules both in New Delhi and Imphal. The Congress, he said, had coined the slogan, 'Look East', for India's Northeast, while the BJP under Prime Minister Narendra Modi had changed it to 'Act East'. "We do what we promise," said Shah. If Shah still believes that the BJP is delivering on its promise to Manipur, then it's a commitment Manipur — and India — can do without.

Six months after Shah's comments, the northeastern state is aflame. While it's easy to describe the horrific violence that has engulfed Manipur since early May as 'inter-ethnic clashes', it is cynical politics that has brought India to this moment. The fire also threatens to burn, irreparably, India's quarter-century-old ambitions of turning its Northeast into a bridge of connectivity with Southeast Asia and East Asia. More than 140 people have died in the violence and tens of thousands have been forced to flee their homes for refugee camps. A British legacy of restricting the Meitei people of Manipur to the Imphal valley and the Kuki and Naga communities to the hills has become the Modi government's endowment to the future: a deep partition that will be hard to reverse.

All of this has drawn global attention, especially after a video went viral in which a mob of men is seen parading naked women, groping them. At least one of the women was also gang-raped. On Sunday, a state department spokesperson in the United States of America said Washington was deeply concerned by the situation in Manipur. The US ambassador to India, Eric Garcetti, has previously spoken of how Washington was willing to help India bring peace back to Manipur if New Delhi asked for assistance. The European Parliament has condemned the Indian government's inaction and provocative statements from BJP leaders that legislators in Brussels have blamed for fuelling the fire.

In terms of India's foreign policy, New Delhi's Act East approach is the pillar of diplomacy that is likely to suffer the most grievous long-term consequences. Bordering Myanmar, Man-ipur has long been the gateway to Southeast Asia that Indian strategic thinkers wanted to exploit to enhance economic cooperation with that region. A trinational highway connecting India, Myanmar and Thailand is the marquee project of the Act East policy. In early July, the Union transport mi-nis-ter, Nitin Gadkari, anno-un-ced that around 70% of the highway was ready. But the highway enters India in Manipur, at the border crossing of Moreh.

Can probiotics help slow agerelated cognitive decline?

A ccording to the findings of a new study, eating a probiotic may help avoid the deterioration in memory and thinking that can occur with ageing. This study could pave the path for new, non-invasive treatments that use the gut flora to slow cognitive loss in the elderly.

The researchers found that when study participants with mild cognitive impairment received the probiotic Lactobacillus rhamnosus GG (LGG) for three months, their cognitive scores increased. This cognitive improvement was also associated with changes in their gut microbiome.

"The implication of this finding is quite exciting, as it means that modifying the gut microbiome through probiotics could potentially be a strategy to improve cognitive performance, particularly in individuals with mild cognitive impairment," said Mashael Aljumaah, a microbiology doctoral candidate at the University of North Carolina at Chapel Hill and North Carolina State University. "This adds a new layer to our understanding of the microbiome brain-gut connection and opens up new avenues for combating cognitive decline associated with aging."

Aljumaah, who is also affiliated with King Saud University in Saudi Arabia, will present the findings at NUTRITION 2023, the annual flagship meeting of the American Society for Nutrition held July 22-25 in Boston. "Many studies focus on severe forms of cognitive diseases such as Alzheimer's and dementia, but these conditions are more advanced, making them significantly harder to reverse or treat," said Aljumaah. "In contrast, we focused on mild cognitive impairment, which can include problems with memory, language, or judgment. Interventions at this stage of cognitive impairment could slow down or prevent the progression to more severe forms of dementia."

The study involved 169 participants between 52 and 75 years old who were divided into two groups depending on whether they had no neurological issues or mild cognitive impairment. Within each group, participants either received the LGG probiotic or a placebo in a double-blind, randomized clinical trial lasting three months. The researchers selected the LGG probiotic because prior research had shown its potential beneficial effects in animal models.

To investigate the study participants' gut microbiomes, the researchers used 16S rRNA gene sequencing to identify and compare bacteria present in stool samples. They then used whole genome sequencing to gain insights into the functional roles of the bacteria identified.

The analysis revealed that microbes in the genus Prevotella were present in a higher relative abundance in participants with mild cognitive impairment than those with no cognitive impairment. This suggests that gut microbiome composition could serve as an early indicator for mild cognitive impairment, offering opportunities for earlier interventions to slow cognitive decline. For study participants who had mild cognitive impairment and received the LGG probiotics, the Prevotella relative abundance decreased. This change coincided with improved cognitive scores, suggesting that cognitive health in older adults could be improved by manipulating the gut microbiota. "By identifying specific shifts in the gut

microbiome associated with mild

cognitive impairment, we're exploring a new frontier in preventive strategies in cognitive health," said Aljumaah. "If these findings are replicated in future studies, it suggests the feasibility of using gut microbiome-targeted strategies as a novel approach to support cognitive health."

The researchers are now working to understand the specific mechanisms of how microbes like Prevotella influence the gut in a way that improves brain health. Specifically, they are exploring how certain molecules produced by these bacteria modulate the functionality of neuroprotective hormones that can cross the blood-brain barrier.

Pakistan: Gurdwara Sahib in Kasur district slowly collapsing due to neglect



"Severe and widespread drought, in addition to an extremely harsh winter, have impacted farmers...," reported the Food and Agriculture Organization.

Referring to Afghanistan, the FAO added that 80 percent of Afghan families are dependent on agriculture for their livelihood. "With 80 percent of families dependent on agriculture for their food and income, humanitarian livelihood support is critical," FAO added.

The FAO mentioned in a report published in 2022, "Every USD \$1 spent to protect rural livelihoods saved around USD \$7 in additional humanitarian assistance, generated further income for Afghan families and

supplied food in local markets." Moreover. the organization added that FAO requires USD 252.4 million to assist eight million people in Afghanistan in 2023, according to TOLO News. Abdul Baseer Taraki, an economist, said that since the Taliban is not recognized, there is less assistance. "Currently, our country is not recognized, the banking system is problematic, the business is down and we are forced to accept less than 30 to 40 percent of assistance," he said. However, Abdul Latif Nazari, the Deputy Minister of Economy, said that the main reasons for poverty are the imposed sanctions on Afghanistan and the suspension of international assistance for infrastructural projects, reported TOLO News.

Study reveals why we lose fat, muscle during infection

A lthough infections can cause a variety of symptoms, one typical indication is the loss of fat and muscle, a process known as wasting. Salk researchers wanted to discover if wasting was useful in battling infections.

Researchers in Professor Janelle Ayres' lab discovered the wasting response to T brucei infection in mice occurs in two phases, each regulated by different immune cells. While fat loss did not benefit the fight against infection, muscle loss did—a surprising clue that some wasting may help manage illness. The findings, published in Cell Reports on July 24, 2023, can inform the development of more effective therapeutics that spare people from wasting and increase our understanding of how wasting influences survival and morbidity across infections, cancers, chronic illnesses, and more.

"We often make assumptions that conditions like wasting are bad, since they often coincide with higher mortality rates," says senior author Ayres, Salk Institute Legacy Chair and head of the Molecular and Systems Physiology Laboratory.

"But if instead we ask, what is the purpose of wasting? We can find surprising and insightful answers that can help us understand the human response to infection and how we can optimize that response." Defending the body from an invader re-



quires a lot of energy. Prior studies suggested this immune-related energy consumption had the unfortunate consequence of wasting. But Ayres and team were curious to know whether wasting could be beneficial and not just a side effect.

Specialized immune cells called T cells are slow to respond to infections, but when they do respond, they adapt to fight the particular infection. Ayres was interested to know whether it was these T cells causing wasting. If T cells are responsible for the condition, that would indicate wasting is not simply an unproductive side effect of energy-hungry immune cells. The cells of interest are called CD4+ and CD8+ T cells. CD4+ T cells lead the fight against infection and can promote the activity of CD8+ T cells, which can kill invaders and cancerous cells. The two T cell types often work together, so the researchers hypothesized their role in wasting may be a cooperative effort, too.

To work out the relationship between CD4+ and CD8+ T cells and wasting, the researchers turned to the parasite T brucei. Because T brucei lives in fat and can block the adaptive immune response—which includes T cells—it was a perfect model infection for their questions about fat wasting and how T cells mediate that process. The team investigated 1) the role of CD4+ and CD8+ T cells during T brucei infection and 2) how removing CD4+ and CD8+ T cells changed the longevity, mortality rates, parasite symptoms, and amount of parasite present in infected mice. The researchers found that CD4+ T cells acted first and initiated the process of fat wasting, CD8+ T cells indicated the process of muscle wasting. The CD4+ T cells induced fat wasting had no impact on the ability for the mice to fight T brucei or to survive infection. The CD8+ T cell-induced muscle

wasting, however, contrary to the traditional assumptions about wasting, helped the mice fight T brucei and survive the infection. "Our discoveries were so surprising that there were times I wondered if we did something wrong," says first author Samuel Redford, a current visiting researcher and former graduate student in Ayres' lab. "We had striking results that mice with fully functioning immune systems and mice without CD4+ T cells lived the same amount of time—meaning, those CD4+ T cells and the fat wasting they caused were completely disposable in fighting the parasite. And beyond that, we found that normally cooperative T cell subtypes were working totally independently of one another."

The findings illustrate the important role of immune cells in both fat and muscle wasting and the necessity to understand the function of such responses to inform therapeutic interventions. "We can learn so much about our immune systems by looking at the environments and infections we have co-evolved with," says Ayres. "While T brucei is an interesting and important case, what is exciting is extrapolating our findings to understand, treat, and overcome any disease that involves immune-mediated wasting—parasites, tumors, chronic illnesses, and so much more."



Punjab police in joint OP with STF conduct CASO in Ferozepur range; 19 nabbed, drug money recovered

BUREAU CHANDIGARH, JULY 25

Further intensifying the ongoing campaign to make Punjab a crime-free and drug-free state as per the vision of Chief Minister Bhagwant Mann, Punjab Police in a joint operation with Special Task Force (STF) on Tuesday continued its special Cordon and Search Operation (CASO) focused on drug trafficking, antisocial elements and criminals for the second day. Today's CASO was conducted in the Ferozepur Range on the directions of Director General of Police (DGP) Punjab Gaurav Yadav.

The development came a day after the Punjab Police made 41 arrests after registering 33 FIRs and recovering drug money and narcotics from their possession during a CASO in Bathinda range. The operation was conducted from 1 pm to 5 pm simultaneously in both the police districts of Ferozepur range including Ferozepur and Fazilka, and SSPs were asked to plan this operation in a meticulous amid manner massive



deployment of the Police Force The operation was conducted under the overall supervision of ADGP Law and Order Gurinder Singh Dhillon and DIG Ferozepur Range Ranjit Singh Dhillon

Divulging details, Special DGP Law and Order Arpit Shukla said that the Police teams have arrested 19 anti-social elements after registering 15 first information reports (FIRs) during the operation. The Police

teams have also recovered Rs 13.96 lakh of drug money, 320 grams of heroin and a huge quantity of Lahan (Raw material used to make liquor) from their possession, besides, impounding 27 vehicles of suspected persons. He said that the strong force

of 1300+ Police personnel carried out CASO in over 62 drug hotspots identified in both the districts. Apart from arresting anti-social elements, Police teams have also rounded

up around 50 suspicious persons

for questioning, he said. The Special DGP said that the intent to carry out such operations was to instil a sense of safety and security among the common people and increase the presence of the Police force in the field to infuse fear among the anti-social elements. Govt to give ownership rights of lands to the tenant farmers



Crores of rupees have been embezzled by showing more goods in stock register: Audit resports

INDRI (MAINPAL KASHYAP) : Crores of rupees have been embezzled by 32 panchayats of the block by showing more goods in the stock register. This has been revealed in the audit reports for the years 2020-21 and 2021-22. According to the audit report, the material shown in the stock register by the sarpanches is not physically present. Besides, some sarpanchs had huge cash outstanding as per record which he did not deposit with the administrator. By this,

an amount of Rs 13542790 has been embezzled by sarpanchs. Report of embezzlement has been sent by department to higher officials. BDPO Saheb Singh has sent notice to sarpanches and said that they will soon recover embezzled amount.Significantly, the tenure of sarpanches was completed in February 2021. According to the rules,



the sarpanches had to hand over the stock register and the cash with them to administrator. But he didn't do that. According to the report, an amount of Rs 6113526 has been embezzled by 18 panchayats of the block. According to audit report, an amount of Rs 158500 has also been embezzled by the village secretary of Garhi Birbal. This amount was the amount of land lease done in the year 2020-21. During the audit, it was revealed that the amount received from the lease was not entered in the cash book by the village secretary. Advocate Rajesh Kaushik says that all the cheques drawn by the Sarpanch are also signed by the village secretaries.


