29,295 vacancies filled in J-K after abrogation of Article 370: Govt

NEW DELHI: A total of 29,295 vacancies were filled in Jammu and Kashmir since the abrogation of Article 370 in the erstwhile state, the Central told the Rajya Sabha on Wednesday. Union Minister of State for Home Nityanand Rai shared the input in a written reply to a member. "The Government of Jammu and Kashmir has carried out several governance reforms, including in the area of recruitment in Government. After the abrogation of Article 370, a large-scale recruitment drive has been carried out and the Government of Jammu and Kashmir has filled 29,295 vacancies," said Rai, adding that recruiting agencies have advertised 7,924 vacancies and examinations in respect of 2.504 vacancies have been conducted.



Range Ajay Maluja and SSPs were directed to plan this operation amid the massive deployment of the Police Force.Divulging details, Special DGP Law and Order Arpit Shukla said that the Police teams have arrested 79 anti-social elements after registering 66 first information reports (FIRs) during the operation. The Police teams have also recovered Rs 68,500 of drug money, 128 grams of heroin, 115 kg poppy husk, 2560 intoxicant tablets and a huge quantity of illicit liquor and Lahan (Raw material used to make liquor) from their possession, he added.

He said that, apart from this, the Police teams have also arrested three Proclaimed offenders (POs) and rounded up 293 suspicious persons for questioning.

The cloudburst buried and washed away the fruits, gardens, and fertile lands, damaging





Against art

ave the artists of the Western world united? Hollywood's scriptwriters and actors are on strike; Lin Silicon Valley, artists, fan-fiction writers and those at the helm of venerable news organisations as well as social media companies have their arms locked in unity too — against the potentially regressive powers of Artificial Intelligence. The Writers Guild of America is demanding that generative AI not be used to create new — unpaid — content out of works conceived by its members; the WGA has been joined by the Screen Actors Guild - American Federation of Television and Radio Artists, which fears that studios may use digital avatars of movie stars without their express approval. The grievances are beginning to assume eclectic, global dimensions. As the AI revolution spreads, it is likely to encounter similar resistance from all those whose creative labour it seeks to replicate and then, eventually, supplant. The rumblings also lay bare a formidable policy challenge: negotiating the evolving, complex and, hence, grey relationship among creative labour, new technology, the question of consent and intellectual property rights. Unsurprisingly, the thrust of the agitators lies on the need of regulating AI. This demand has global echoes. China's internet regulator, for instance, has outlined a proposal to rein in rogue avatars of generative AI such as chatbots. Europe is a step ahead in the race though. The European Union has already framed a set of regulations that stipulates, among other things, a ban on facial recognition technology along with appraisals of AI products before their commercial release.

The scrutiny of AI by artists as well as the noises being made in support of AI's endorsement seems to mirror an older clash of principles and, possibly, class. On the one hand are the advocates of the laissez-faire spirit—this time, a cartel comprising technology titans and pliable, complicit governments—who stand against any form of restraint in spite of AI's discernible plagiaristic potential and its ability to upend large segments of the labour market. Confronting them is a versatile constituency of workers, conscientious legislators and, in the case of China and Europe, a concerned State. The outcome of this battle could be decisive for the future of both capital and labour. The contestants would do well to remember an unchanging truth: technology's evolution is to be welcomed, but not its misapplication.

Most alternatives lack nutritional value of cow's milk

ore people are consuming plant-based milk substitutes such as oats, soy, and almonds, but do plant-based products provide the same nutrition as cow's milk? According to the findings of a new survey, the majority do not.

Cow's milk is an important source of calcium and vitamin D, both of which are identified in the 2020-2025 Dietary Guidelines for Americans as nutrients of public health concern for underconsumption. Cow's milk is also a major source of protein in the American diet. To assess how the nutritional content of plant-based milk alternatives compares to that of cow's milk, researchers examined more than 200 plant-based milk alternative products being sold in the U.S. in 2023 — many more products than were included in previous studies. Compared to cow's milk, only 12% of the milk alternative products contained comparable or greater amounts of all three nutrients studied: calcium, vitamin D, and protein

Abigail Johnson, assistant professor and associate director of the University of Minnesota School of Public Health Nutrition Coordinating Center, will present the findings at NUTRITION 2023, the annual flagship meeting of the American Society for Nutrition held July 22-25 in Boston. "Our results provide evidence that many plant-based milk alternatives are not nutritionally equivalent to cow's milk," said



Johnson. "Based on these findings, consumers should look for plant-based milk alternative products that list calcium and vitamin D as ingredients. They may also want to consider adding other sources of calcium and vitamin D to their diets."

The University of Minnesota's Nutrition Coordinating Center maintains a database of approximately 19,000 foods for assessing dietary intake in human research. "We know from our dietary assess-

ments for nutrition studies that consumers are choosing more plant-based milk alternatives," said Johnson. "This project aimed to increase the number of these milk alternatives available in the Nutrition Coordinating Center's database of

The study included nutrition information from nutrition facts labels and ingredient information for 233 plant-based milk alternative products from 23 different manufactur-

ers. For each product, the researchers applied a nutrient calculation program to estimate full nutrient information.

They then compared the nutritional content of different products within a category — for example, almond milk, oat milk, and soy milk — to each other and to cow's milk. Compared to dairy milk, just 28 of the plant-based alternatives had similar or more calcium, vitamin D and protein.

ucts included in the study were made from almonds, oats, or soy. The researchers found that 170 of the plant-based milk alternatives were fortified with both calcium and vitamin D and that the level of fortification tended to be similar to dairy milk. Specifically, 76% of the oat-based products, 69% of soybased, and 66% of almond-based alternatives were fortified with both calcium and vitamin D. The median protein content was 2.0 grams (g) of protein per 240 milliliters (ml) of liquid, with a large variability that ranged from 0 to 12 g. Only 38 (16%) of the milk alternatives studied had a protein level greater than or equal to the 8 g per 240 ml found in cow's milk. Soy- and pea-based alternatives were more likely to have higher protein.

"Our findings point to a need to ensure that consumers are aware that many plant-based milk alternative products in the marketplace today are not nutritionally equivalent to cow's milk," said Johnson. "Product labeling requirements and dietary guidance to the public are among the approaches that may be helpful in alerting and educating consumers."

Next, the researchers plan to explore other nutrients in plant-based milk alternatives that make them different from cow's milk. For example, many of these products contain fiber, suggesting that they may help meet some nutritional needs that cow's milk doesn't.

Afghanistan: Ban on Women's beauty salons comes into effect

mid public protests and UN concern, the ban on women's beauty salons in Afghanistan came into effect on Tuesday following the deadline given by the Ministry of Vice and

Virtue on July 4, reported TOLO News.

Taliban, in a new verbal decree, banned women's beauty salons in Kabul and other provinces

across the country.

According to the order, women's beauty parlours in Afghanistan were no longer allowed to operate after July 23, according to Khaama Press.

The United Nations said that the forced closure of women's beauty salons could have a negative impact on the economy of women. The Deputy Spokesperson for the Secretary-General Farhan Haq also asked the Taliban authorities to halt the mandate of closing beauty salons, TOLO News reported. "The Secretary-General supports the efforts by the UN Assistance Mis-



sion in Afghanistan (UNAMA), which has called on the de facto authorities to halt the edict closing beauty salons. UNAMA has said that this restriction on women's rights will impact negatively on the economy and contradicts support for women's entrepreneurship, and we're seeking a reversal of the bans," Haq added.

Meanwhile, beauty salon owners said that some of the women are the breadwinners for their families. Following the ban, they would not be able to support their families, TOLO News reported. Mastora, a beauty salon owners and the salon owners are the salon owners.

lon owner said that over ten other women in her salon financially support their families.

"This shop is the sole means through which ten people support their families and are breadwinners of their families. They all come here because of problems," said Mastora.

Huma, another beauty salon owner said, "Today they took our bread and our work from us. We are very upset."

Days after the Taliban issued the decree, several women makeup artists protested against the move, urging that the order be rescinded, Tolo News reported.

Food allergy in infancy linked to childhood asthma

ccording to a world-first study, having a food allergy as a baby is connected to asthma and impaired lung function

Alater in childhood.

The research, led by Murdoch Children's Research Institute and published in the Lancet Child & Adolescent Health, found that early life food allergy was associated with an increased risk of both asthma and reduced lung growth at six years of age. Murdoch Children's Associate Professor Rachel Peters said this was the first study to examine the relationship between challenge-confirmed food allergy in infancy and asthma and poorer lung health later in childhood.

The Melbourne research involved 5276 infants from the HealthNuts study, who underwent skin prick testing to common food allergens, including peanut and egg and oral food challenges to test for food allergy. At six years, children were followed up

with further food allergy and lung function tests.

The study found by six years of age, 13.7 per cent reported a diagnosis of asthma. Babies with a food allergy were almost four times more likely to develop asthma at six years of age, compared to children without a food allergy. The impact was greatest in children whose food allergy persisted to age six as opposed to those who had outgrown their allergy. Children with a food allergy were



also more likely to have reduced lung function. Associate Professor Peters said food allergy in infancy, whether it resolved or not, was linked to poorer respiratory outcomes in children.

not, was linked to poorer respiratory outcomes in children.
"This association is concerning given reduced lung growth in childhood is associated with health problems in adulthood including respiratory and heart conditions," she said.

cluding respiratory and heart conditions," she said.

"Lung development is related to a child's height and weight and children with a food allergy can be shorter and lighter com-

pared to their peers without an allergy. This could explain the link between food allergy and lung function. There are also similar immune responses involved in the development of both food allergy and asthma."

"The growth of infants with food allergy should be monitored. We encourage children who are avoiding foods because of their allergy to be under the care of a dietician so that nutrition can be catered for to ensure healthy growth."

Food allergy affects $10~{\rm per}$ cent of babies and $5~{\rm per}$ cent of children and adolescents.

Suba Slater's, son Zane, 15, is allergic to eggs, sesame and peanuts and has asthma.

"As a newborn he developed eczema on his back and I thought because I was breastfeeding, there was something in my diet causing the rash," she said. "We took him into hospital for tests, which confirmed the multiple food allergies."

Suba said she wasn't well informed of the link between food

allergy and asthma prior to Zane's diagnosis.
"We were very focused and vigilant around the food allergy

aspect given our eldest child also has allergies," she said. Having this link shown through this research and making parents and medical professionals aware of it is extremely important. After we discovered Zane had food allergies we didn't know to lookout for asthma and it wasn't on our radar.

"Looking back, he most likely had asthma long before we could hear that he was struggling with his breathing. If we had been aware of the association we would have sought medical help much sooner."

Suba said Zane had participated in several food challenges at the Murdoch Children's but his asthma had complicated his participation at times.

"By taking part in the food challenges we have found out that Zane is now able to tolerate egg in baked goods and certain nuts much more and has learnt how to include these foods in his diet," she said.

"But before he does a challenge he is required to take a spirometry test to make sure his lung function is at its best in case the allergenic food triggers his asthma. There are times where he

IBM Report: Average cost of a data breach in India touched INR 179 million in 2023



said that the state government has worked with all due diligence to make life normal.

Despite this, the people of the state were facing it boldly and the state government was standing with the people of the state. VB recommends slew of steps to uphold sanctity of dope test

CHANDIGARH: A day after finding irregularities in conducting dope test for issuance and renewal of arms licenses in the state, Punjab Vigilance Bureau(VB) on Tuesday recommended slew of steps to ensure no arms license should be issued to any ineligible person or substance user in order to prevent misuse of weapons. An official spokesperson of the VB said that the teams of VB, during the statewide surprise checking of government hospitals on Tuesday, found some irregularities and loopholes including photograph of the candidate was not found affixed on the DOPE tests register and paging of the DOPE tests register was not done. Even, the DOPE test report was given manually, which should not be given to the person concerned manually. After finding these malpractices in the process, he said that the Punjab Vigilance Bureau will write to the higher authorities to make the dope test mechanism more robust so that sanctity for the same is upheld. The VB suggested that a copy of DOPE test report must be kept in record of the concerned hospital, and doctors and technicians should be deployed on rotation for DOPE testing so that there is no intervention of any agent. The VB also suggested that the register regarding daily DOPE tests should be checked and countersigned by senior officials on a regular basis.

Drainage being cleaned in Barnala: Meet Hayer

In order to give the best of civic amenities to the people of Barnala, the Minister for Environment and Water Resources Mr. Gurmeet Singh Meet Hayer, has got storm water drain cleaned for the first time ever in past more than three decades. Passing 4.5 kms across the city the storm water carries rain water from parts of city and empties into Lasara drain thereby solving the problem of rain water stagnation in the city. Once the work is completed, city will get huge respite from water stagnation issues. The work is being conducted at a cost of Rs 50 lakhs. Minister Gurmeet Singh Meet Hayer said that the storm water has not been cleaned for the past more than 35 years. The clogged pipes had been drowning city as there was no



place for thr rain water to drain out, he said. He added that the storm water had existed as an open drain before 1987. In the early 1988, municipal council Barnala got it covered and since then the drain had been collecting rain water from the city and draining it into Lasara drain. Arising from the Bajakhana T-point, the drain runs across various areas of city including Nehru Chowk, Jaura Pump (near Pakka College Road), Krishna Wali gali (near HDFC Bank) and falls into the Lasara drain. The work is being done at a cost of Rs 50 lakhs and entails usage of super sucker machines to clean the drain. Drain has different dimensions at different places varying from 36 inches to 56 inches. The drain has been constructed using time tested technology of brick lining 56 inches holes in the form of dome (dak sewer) and is a very strong structure Super sucker machines are working to de-silt the drain, while plastic and other nonbiodegradable wastage is also being removed. Machines have removed tonnes of plastic, dead animals, flex PVC sheets, rotten vegetables and fruits from the sewer. He appealed people not to throw waste fruits and vegetables especially at the points near


