Neeraj Chopra captures India's firstever World Athletics C'ships gold

AGENCY BUDAPEST, AUG 28

India's Olympic medalist Neeraj Chopra made history in the early hours of Monday, capturing his country's first-ever gold medal at the World Athletics Championships and edging out Pakistan's Arshad Nadeem by less than a meter at the

final of men's javelin throw event in Budapest. Neeraj recorded his best throw of 88.17 m in his second attempt and managed to keep his lead intact till the very end. Nadeem, the Commonwealth Games champion with 87.82 m got a silver medal. Czech Republic's Jakub Vadlejch secured the bronze with the best throw of 86.67 m. Kishore Jena (best of 84.77 m) finished fifth while DP Manu (best of 84.14 m) finished sixth. Now, India has medals of all colours at the World Championships. This is Neer-



aj's second medal at the World Championships after he secured a silver last year. Before his two medals, India's last medalist was Anju Bobby George back in the 2003 World Championships getting a bronze for the women's long jump. In the first round of attempts, Finland's Oliver Helander took the lead with a throw of 83.38 m.


the chairmanship of the Chief Minister here at his office in Punjab Civil



Cabinet gives nod for visiting faculty in govt schools

In order to ensure the holistic development of the students, the Cabinet also approved appointment of Visiting Faculty in the Government Schools of the state. In the first phase Visiting Faculty will be appointed in the 117 Government Schools of the state and then it will be replicated in the other schools. Persons who have retired as teaching faculty from any Government/ Private School, College or University will be eligible for the proposed Visiting Resource Faculty Scheme.

The Cabinet also gave approval to the Policy of Disbursement of Discretionary Grants by Chief Minister and Cabinet Ministers for the financial year 2023-24.

These funds are to be judiciously utilized for new and repair of existing Basic infrastructure, environment improvement and fulfilling the basic needs of the poor residing in Punjab. As per the policy, the Chief Minister Punjab will have Rs. 37 crore at his discretion while each Cabinet Minister will have Rs 1 crore at their discretion during financial year 2023-24.

The Cabinet also gave nod to amend section 4 in sub section (2), for clauses a, b and c, sub section (5) and sub section (6) of the Punjab Fiscal Responsibility and Budget Management Act, 2023. These amendments will enable clauses of



the Fiscal Responsibility and Budget Management Act, 2003 to sync with each other and to avoid the need of amendment every year. The Cabinet also gave its consent for sending the case of four prisoners for seeking the premature release of life convicts confined in the jails of the

state and one other for rejecting such premature release m. After the nod of the Cabinet under Article 163 of the Constitution of India, these special remission/ premature release cases will be submitted to the Punjab Governor under Article 161 of the Indian Constitution for consideration.

60 vehicles detained under ongoing spree against tax evaders: Cheema

In continuance with the on-going special drive to detect the Goods and Services Tax (GST) evasion in iron and steel industry, the mobile wings of Tax department on Monday inspected 12 furnaces and detained 60 vehicles during a surprise operation at Mandi Gobindgarh.

Disclosing this in a press communiqué issued here, Pun-jab Finance, Planning, Excise and Taxation Minister Advocate Harpal Singh Cheema said that this operation was conducted by the mobile wings of State Investigation and Preventive Unit (SIPU), Ropar, Patiala, Shambhu and Jalandscrutinising vehicles carrying iron scrap and finished goods. Most of the vehicles subjected to action lacked the necessary e-way bills corresponding to the transported goods", he added. Revealing further, the Finance Minister said that the further investigations revealed purchases were from noncompliant entities that have not contributed taxes to the government treasury. After a thorough inquiry, these vehicles could face fines exceeding to Rs 2 crore, said Cheema. 34,784 needy families provided with pucca houses so far under PMAYscheme: Bhullar

CHANDIGARH, AUG 28

Punjab Rural Development and Panchayats Minister S. Laljit Singh Bhullar, on Monday, informed that under the initiative of providing pucca houses to the needy families of the villages, so far 34.784 houses have been handed over to such families.

Asserting that Chief Minister S. Bhagwant Singh Mann led government has been making continuous efforts to transform the state into a 'Rangla Punjab', the Cabinet Minister S. Laljit Singh Bhullar said that a total of 40,326 houses have been sanctioned by the Rural Development and Panchayats department under the PMAY (G) scheme, of which 34,784 houses have been



given to the needy eligible families so far. He said that an amount of Rs.21.23 crore has been released today to the eligible beneficiaries for the construction of remaining 5,559 houses, and these houses will be completed by December this year. The Rural Development and Panchayats Minister mentioned that out of total Rs.21.23 crore disbursed to eligible beneficiaries for the con-

struction of pucca houses, 1139 beneficiaries will be provided with the first installment of Rs.30,000 each. 1712 beneficiaries will receive the second installment of Rs.72,000 each and 3051 beneficiaries to be given the installment Rs.18,000 each. S. Laljit Singh Bhullar emphasized that Punjab government is committed to provide pucca houses to the people who do not possess any house or living in Kachha/tented accommodation along with provision of basic amenities of drinking water, electricity connection, cooking gas and washroom facilities, besides 90 days of employment under MGNREGA, cattle shed

for animals, soak pits, and

vermi compost pits.

Health dept issues advisory regarding use of food, drink items in view of rainy season, festivals

FATEHGARH SAHIB (AJAY MALHOTRA): Keeping in mind the rainy and festivals season the District Health Department Fatehgarh Sahib has issued an advisory regarding food items for the common people and shopkeepers. Giving information, Civil Surgeon Dr. Davinderjit Kaur said that due to the beginning of the

rainy season and the festive season, food and drink items, especially sweets, should be used carefully to take care of one's health during this time. She said that stale fertilizers should not be eaten, food items should be kept covered, too ripe and cut fruits and vegetables should not be used.

Drinking water should be boiled or chlorinated, fertilizers sold in open form should not be used, she also appealed to the shopkeepers selling fertilizers across the district to keep the food items cov-

ered, she said that cleanliness should be taken care of while preparing food items for sale, along with maintaining personal hygiene of the artisans preparing the items, they should also prepare fertilizers by wearing gloves and covering their head hair. Utensils should be kept clean and food should be prepared at proper temperature, stale food should not be sold and prepared items should be kept covered. She appealed to the people to inform the health department about those who sell food prepared in a wrong way so that they can be punished.

"The present Government committed to provide quality education to the youth and this Yojna will ensure that no youth of the State is deprived of higher or professional education due to constraint of financial resources," said the Chief Minister. Such students whose annual family income was less than Rs. 4 lakh were eligible to avail the loan under



this Yojna, he said. The Chief Minister said that a corpus will be kept at the level of the Deputy Commissioner of all the districts to release first installment of fee money to the concerned institution, in such cases where bank was taking time to release first installment of fee money, and if fee is required to be deposited immediately to save the

student's admission. The State Government would designate Nodal Bank for claiming interest subsidy in lieu of educational loans taken by the eligible students from the department of Higher Education through an online portal. Nodal Bank will enter into a MoU with the department of Higher Education. Borrower students before getting admission in the institution of their choice would register them self on the portal and upload the documents required under the scheme. Thereafter, he would also upload the document certifying his selection for admission and if found eligible Director of Higher Education would recommend the case to the concerned bank for releasing first installment

of bank loan. Under the Yojna, eligible students will be able to avail education loan upto maximum of Rs. 20 lakh from any scheduled bank located in Himachal to meet expenses of boarding, lodging, tuition fees, books and other allied expenses associated with their education. The students having 60 percent marks in previous class will be eligible to avail the loan at the interest rate of one percent to pursue Diploma and Degree Courses in Professional and Technical Education Medical, Engineering, Management, Para-Medical, Pharmacy, Nursing, Law etc. and Technical Courses from ITI's, Polytechnics and Ph.D. from the recognized Educational Institutions and Universities.



Editorial New army

uriouser and curiouser. Only Jadavpur University is not Alice's wonderland: it is an educational institution into which an ordered group in army fatigues marched in and arranged itself before the administrative building. Its claims were various, from being part of the Indian army to being connected to the National Human Rights Commission. Apart from the wildly divergent nature of these two claims, the impossibility of an NHRC team in camouflage gear did not seem to have struck the group. Chillingly, it used the official logo and insignia of the Indian army, not just the fatigues, and it is on this basis that the police filed a suo motu case against it when the Eastern Command denied any knowledge of it. But the enigma about its identity did not end there. The letters on the members' shoulder lapels were supposed to stand for "World Human Rights Peace Force" and the letterhead they carried said "Asian Human Rights Society". They claimed to have come to establish peace in the university campus, to provide security and 'human surveillance'. Who were they and where had they come from? How did they get to wear army fatigues with the army's official logo? Who invited them?

The officiating vice-chancellor, a pro-Bharatiya Janata Party teacher, did not say he had invited such an outfit, but it was his resistance to permit complaints to the police that appeared to have delayed the university's first information report for two days. The police are not allowed in the campus without the vice-chancellor's say-so. But the officiating vice-chancellor had no objection to an apparently military-minded force — he called them an 'NGO' — volunteering to ensure security within university premises. The recent horror of a fatal ragging appears to have been the raison d'etre of the outfit's entry. Later he claimed that objecting to them was acceptable since the police had found they were not part of the army. Did that mean that he would welcome official military presence in the university? Or was it just politic withdrawal after a mysterious toe-dipping exercise? Whatever the outfit's claims, the blossoming of a private army in the city at the heart of a leading educational institution augurs severe danger. The police need to uncover the identity and origin of the group to stop its proliferation.

New test chamber to keep people cool

shipping container that can be used to test passive cooling systems could assist researchers and builders in discovariant carbon free callities. ering carbon-free solutions to keep people cool in high temperatures.

Washington State University researchers created the 60-square-feet chamber to test passive systems that use wind towers along with water evaporation instead of electricity to cool spaces.

Finding cooling methods that don't require putting more greenhouse gases into the air is crucial to helping a growing population adapt to climate change, said Omar Al-Hassawi lead author of the study in the journal, Energies. "Cooling is increasingly in demand in buildings, especially as the climate gets hotter," said Al-Hassawi, assistant professor in WSU's School of Design and Construction. "There might be inclusion of mechanical systems, but how can we cool buildings to begin with — before relying on the mechanical sys-

The test chamber the researchers developed is solar powered with battery storage and is completely independent of grid power. It can be heated to a temperature range between 125 and 130 degrees Fahrenheit year-round to test cooling innovations, measuring the temperature, humidity and air velocity within and around a cooling system. The researchers calibrated the chamber using the results of a fullscale experiment that was conducted on a passive, downdraft cooling system tested under the hot dry conditions of Phoenix, Arizona. "We can simulate extreme conditions,"

Al-Hassawi said. "With smaller scale models, we can also do much quicker tests and get results sooner than having to wait on large-scale prototype construction.

Buildings consume about 60% of the world's electricity with nearly 20% of that going to keep them cool, according to Al-Hassawi. In the U.S., almost 90% of residential homes and apartments use mechanical air conditioners. As people worldwide grapple with global warming, energy demand for mechanical air conditioning is expected to dou-



ble by the year 2050. Powering air conditioning units requires electricity, which is often generated by fossil fuels, increasing carbon emissions and contributing to worsening global warming.

"There's a lot of new construction with the rising global population that is going to happen in the coming years, and a lot of it is going to be in the developing world," Al-Hassawi said. "So if we build like we've been building and continue to rely on mechanical systems to meet cooling demands, that's going to be an issue. There's going to be a lot more air conditioning that's needed, especially with the population rise in the hotter regions of the world.

Passive cooling systems that don't require electricity have been used for centuries by people in hot places, going back to about 2500 BC in ancient Egypt. One cooling strategy involves capturing breezes from a tower. With a layer of moisture at the top of the tower, evaporation cools the air, which then becomes heavier and sinks by gravity into a living space below. The moisture can be provided by wetted pads, shower heads, or misting nozzles. Typically, mechanical fans are only required as a backup.

Although such systems are occasionally used in hot places like Phoenix, Arizona, people and building professionals are often not familiar with passive cooling techniques or misunderstand them. A passive cooling strategy could make use of old smokestacks in older buildings, for instance, as a cooling tower and could be applicable both for existing or new construction, said Al-Hassawi.

"It's an older technology, but there's been an attempt to innovate and use a mix of new and existing technologies to improve performance and the cooling capacity of these systems," he said.

Wider adoption of such passive cooling systems could lower energy demand, but trying to research and test passive cooling systems takes considerable investment and training. "That's why research like this would really help," he said. "How can we address building design, revive some of these more ancient strategies, and include them in contemporary building construction? The test

chamber becomes a platform to do this.' Students have designed and built some prototype cooling systems which utilize the passive downdraft cooling system. These will be tested starting next semester.

Al-Hassawi hopes that industry partners might also be interested in testing passive system designs in the chamber over the coming academic year.

Evergrande Group's shares plummet over 80pc in Hong Kong

orld's most in-debted real state developer, Evergrande Group's shares plummeted 87 per cent on Monday after the lifting of a 17-month trading suspension, CNN reported. In the first six months

Sunday filing to the Hong Kong stock exchange said that its loss attributable to shareholders amounted to 33 billion yuan (USD 4.5 billion), which is 50 per cent of the 66.4 billion yuan loss (USD 9.1 billion) recorded in the same period a year ago. Revenue surged 44 per

cent from a year ago, reaching 128.2 billion yuan (USD 17.6 billion).

The company said it had "actively planned for the resumption of sales and successfully seized the short boom of the property market that emerged at the beginning of the year."

For years, the Shenzhen-based company was one of China's largest property developers by sales. But it had borrowed heavily to fund its expan-



debt in 2021, sparking a crisis in China's real state sector, which accounts for as much as 30 per cent of the country's economy. Earlier this month, it applied for bankruptcy in the United States, reported CNN. Earlier this month, Evergrande filed for Chapter 15 bankruptcy, which is a way for foreign companies to use US bankruptcy law to restructure debt.

The downfall of Evergrande started in 2021, when the central government moved to curb excessive borrowing to try to slow the rise in home

prices, effectively cutting off a major source of funding for property developers, as per CNN.

which Evergrande, had 300 billion USD in liabilities, couldn't shore up cash fast enough to make its debt payments.

It defaulted in December 2021, triggering a market panic. A wave of defaults followed, and China's vast real estate market has yet to recover. The building was suspended on dozens of projects, leaving many "pre-sale" buyers with no new home and a hefty debt burden, according to CNN.

France will ban wearing abaya dress in schools



head of the start of the new school year, France's education minister has said **L**that wearing abaya, a loose-fitting, full-length robe worn by certain Muslim women, will be banned in state-run schools. reported Al Jazeera.

Since 19th-century legislation eliminated any traditional Catholic influence from public education, France has strictly prohibited religious signs in state-run schools and has struggled to modernise regulations to meet with a rising Muslim population.

The wearing of huge crosses, Jewish kippas, or Islamic headscarves is not permitted in French public schools, according to Al Jazeera. Both the 2004 and 2010 bans on full face veils in public spaces infuriated a large portion of the nation's five million-strong Muslim population. "I have decided that the abaya could no longer be worn in schools," Al Jazeera reported quoting Education Minister Gabriel Attal's interview with TV channel

TF1. "When you walk into a classroom, you shouldn't be able to identify the pupils' religion just by looking at them.

The decision was made following months of discussion on the wearing of abayas at French schools, where women have traditionally been prohibited from donning the hijab. The ban had been promoted by the right and extreme right, who claimed it would violate civil liberties. Abayas, in contrast to headscarves, were in the grey region and had not yet been banned.


Clothing alone is not "a religious sign," according to the French Council of Muslim Faith (CFCM), a national organisation that represents numerous Muslim organisations.




