The BJP held a meeting on Thursday which was chaired by National President JP Nadda. In a meeting that went on for more than TWO hours. Over 1 crore people screened for sickle cell disease

NEW DELHI: More than one crore people have been screened for sickle cell disease under the National Sickle Cell Anaemia Elimination Mission since its launch by Prime Minister Narendra Modi in July last year, an official said on Tuesday.

The programme aims to eliminate sickle cell disease in India, particularly among the country's tribal population in 17 high prevalence states, by 2047. The focus is on 278 districts of 17 states with higher prevalence of the disease -- Gujarat, Maharashtra, Rajasthan, Madhya Pradesh, Jharkhand, Chhattisgarh, West Bengal, Odisha, Tamil Nadu, Telangana, Andhra Pradesh, Karnataka, Assam, Uttar Pradesh, Kerala, Bihar and Uttara-

Transporters stage protests across country against new hit-and-run law

AGENCY NEW DELHI, JAN 2

Several transporters and auto-driver associations across India are on protest against the new law on hit and Run incidents. Under the Bharatiya Nyay Sanhita (BNS), which replaced the Indian Penal Code, drivers who cause a serious road accident by negligent driving and run away without informing the police or any official from the administration can face punishment of up to 10 years or a fine of Rs 7 lakh. Earlier, the punishment in such cases was two years in the IPC. Private transport operators claim the law discourages drivers and may lead to unjust punishments. They claim that the drivers could be subject to mob violence when they attempt to transport the injured to hospitals and demand the repeal of the law.

On the protest by transport associations, and drivers against the new law on hit-and-run cases, All India Motor & Goods Transport Association President, Rajendra Kapoor said "Our only demand from the govt is that the decision should have been taken after having consultations with our stakeholders. There was no discussion with anyone on this, and no one was asked



Chandigarh caps sale of fuel amid panic buying

CHANDIGARH: Amid an ongoing strike by fuel-tanker drivers against stricter punishments in hit-and-run cases in the new law, Chandigarh on Tuesday imposed a temporary restriction on the sale of petrol and diesel. Fuel pumps in several states have been witnessing massive queues amid apprehensions that the truckers' protest will hit supply. Effective immediately, two-wheelers in Chandigarh are limited to 2 litres or a maximum value of ₹ 200 of fuel, while four-wheelers are limited to 5 litres or a maximum value of ₹ 500. "The imposed limitations are a proactive measure to ensure the availability of fuel for all during this period of temporary disruption of fuel supply," the Chandi-

SC agrees to hear Himachal DGP Sanjay Kundu's plea against his removal

NEW DELHI: The Supreme Court on Tuesday agreed to hear the January 3 plea of Himachal Pradesh Director General of Police Sanjay Kundu, who challenged the High Court's order to shift him to another post to ensure that he doesn't influence the probe into the alleged harassment of Palampur businessman Nishant Sharma.

A bench of Chief Justice of India DY Chandrachud and Justices JB Pardiwala and Manoj Misra agreed to hear the plea on January 3 after senior advocate Mukul Rohatgi, representing Kundu, sought urgent listing of the case.

Rohatgi mentioned the matter today before the top court, saying the police officer was not heard by the High Court, which before passing the order on December 26, directed the state government to shift him. Rohatgi said, "According to the High Court, he (DGP) should be transferred out of his post in regard to some inquiry that is to be taken without hearing us.

Japan Airlines aircraft catches fire at Airport; five dead

AGENCY TOKYO, JAPAN, JAN 2

Five people were killed when a Japan Airlines plane burst into flames on the runway of Tokyo's Haneda Airport on Tuesday after apparently colliding with a coast guard aircraft, media reports

Images on broadcaster NHK showed the plane moving along the runway before a large explosion of orange flames exploded from beneath and behind it.

All 367 passengers and 12 crew onboard the Airbus plane were evacuated, NHK reported. Those onboard included eight children, Kyodo News reported.



The five killed were on board the coast guard aircraft.

NHK reported that one of the six crew members on the coast guard plane was safe but that the other five were unaccounted for. The cause of the incident was not immediately clear, but television

a coast guard aircraft. The Jiji news agency reported the coast guard plane was scheduled to leave to help with rescue efforts following a massive earthquake in central Japan on Monday. Reports said that the plane had just arrived from Sapporo airport on the northern Japanese island of Hokkaido. A coast guard official at Haneda Airport, one of the world's busiest, said they were "checking details". "It's not clear if there was a collision. But it is certain that our plane is involved," he told a news agency. JAL said the passenger plane either collided with the other aircraft on a runway or a taxiway after it touched down, Kyodo reported.

This comprehensive mapping will ensure that infrastructure is systematically developed in alignment with the specific needs of each area. Adequate stock of petrol and diesel in state: Punjab CM

SHASHI PAL JAIN CHANDIGARH, JAN 2

Acting on the directions of the Chief Minister, Sh Bhagwant Mann, a high level meeting involving senior state and district officials was

convened to monitor the distribution of petrol in diesel in the State of Punjab. Sharing the de-

tails with a section of mediapersons after the meeting, Gurkirat Kirpal Singh, Home Secretary, Punjab said that there was no need for the public to panic as adequate stock of

Petrol and Diesel is available in the State. Against a daily consumption of about 4100 KL of petrol, the stock of petrol in various petrol pumps across the State is about 22,600 KL and the same shall be replenished from time to time, he said. Similarly the State consumes about 10000 KL of Diesel daily and the stocks with the Filling Stations is currently more than 30,000 KL, and 90000 KL is also available at various Terminals, he added. All the terminals are connected through pipeline with the respective refineries and there's constant flow of petroleum products to these terminals Commenting upon the media reports re-

garding acute shortage of petrol / diesel in certain Filling Stations, the Home Secretary


said that at any point in time the stock is not uniformly positioned in all the Filling Stations. While certain Filling Stations may be at zero level others may have full stock and, therefore, the stock position of a few Filling Stations should not be used to reflect the position of total stocks in the State.

The Home Secretary appealed to the public to refrain from panic buying as they are putting themselves to unnecessary trouble in the cold weather.

During the meeting district officials were asked to remain vigilant and ensure smooth movement of petrol and diesel trucks across the state. They were also asked to have meetings with the section of striking transporters to facilitate redressal of their grievance.

Cold wave grips North, temperature dips further

NEW DELHI: There was no respite for North India from bone-chilling cold, as the region woke up to another icy morning on Tuesday, with the minimum temperature in the Ridge area of the national capital dropping below the freezing point, at -0.3°C. There were no signs of the prevailing cold wave slackening its hold on the national capital and vast swathes of North India, as Delhi's Safdarjung observatory recorded a minimum temperature of 1.4°C. The Palam observatory recorded the mercury at 1.2°C while Ayanagar logged 1.0°C at 8.30 am. With the mercury taking a downward shift, locals were pictured sitting around bonfires as the biting cold chilled them to the bone. Meanwhile, in keeping with the weather pattern of the last few days, dense fog shrouded the national capital and elsewhere in its neighbourhood on Tuesday, with the visibility reduced significantly in isolated pockets of Uttar Pradesh, Haryana, Punjab, Uttarakhand, Rajasthan, and Madhya Pradesh, the India Meteorological Department (IMD) informed.

Police arrest 24 criminal elements during statewide special checking

Amidst the ongoing drive to make Punjab a safe and secure state as per the vision of Chief Minister Bhagwant Singh Mann, Punjab Police on Tuesday conducted a special Cordon and Search Operation (CASO) under the name of "OPS Eagle-III" at and around all the Bus Stands and Railway Stations across the state. The operation was conducted on the directions of Director General of Police (DGP) Puniab Gauray Yaday.

The CASO was conducted from 12noon to 3pm simultaneously in all the 28 Police districts under which Police teams with the assistance of sniffer dogs frisked people arriving and departing at Railway Stations and Bus Stands. "We had strictly instructed all the



Transporters and truck drivers have gone on strike against the new hit and run law implemented in the country. Transport unions across the country are protesting against the new Indian Civil Code Act. He has demanded Prime Minister Narendra Modi to withdraw the law. Transporters and truck drivers across the country are on strike and people from various unions are continuously appealing for chakka jam. In fact, the Central Government has made a provision of 10 years' imprisonment and a fine of Rs 7 lakh in the hit and run case. Petrol has run out at all the petrol pumps around Dharamshala. Petrol is available at only one petrol pump. Two wheelers are getting petrol at Rs 200 and four wheelers are getting petrol at Rs 1000. Due to this there has been a long traffic jam. Seeing the seriousness of the situation, the local administration has deployed the police. In view of the shortage of petrol and diesel, private bus drivers have also parked their buses like this. It has become a cause of trouble for daily commuters. In view of this matter, Deputy Commissioner of Kangra District, Dr. Nipun Jindal has also issued orders to Maan Filling Station that petrol and diesel should be reserved for government vehicles. So that the officials coming and going for government work do not have to face trouble. On this occasion, local citizens said that the Central Government should think about the public interest before taking any decision. Local people said that the amendments made by the Central Government in the hit and run case are not right and the Central Government should withdraw this decision.

DM issues orders to maintain minimum reserve capacity of petroleum products at petrol and diesel pumps

UNA: Due to the strike of truck operators, the supply of petroleum products has been disrupted in Una district for the last two days, due to which the availability of petroleum products is not as per requirement. For this reason, there may be a possibility of shortage of petroleum products at various petrol pumps in the district.In this regard, District Magistrate Raghav Sharma has issued orders keeping in mind the Himachal Pradesh Hoarding and Profiteering Prevention Order 1977. He has asked all petrol pump operators in the district to ensure availability of minimum reserve petroleum products for emergency situations. He said that petrol and diesel pumps with capacity of 25 thousand or more have been asked to keep a minimum reserve of 3 thousand diesel and 2 thousand petrol for emergency situations. Apart from this, orders have been issued to keep minimum reserve of 2 thousand diesel and 1 thousand petrol capacity for emergency on diesel and petrol pumps with capacity less than 25000. District Magistrate has ordered the pump operators to fill only 10 liters of oil at a time. If any vehicle owner asks to fill more oil than this, he will have to take permission from the concerned SDM. He said that no person will be given oil in any container other than the tank of vehicle. Raghav Sharma said that emergency vehicles like ambulance, fire brigade or vehicles supplying other essential commodities, public transport vehicles will be given priority in filling oil.

PIL in SC seeking to include CJI in selection committee for CEC, EC appointment

NEW DELHI, DEC 2

A Public Interest Litigation (PIL) was filed in the Supreme Court seeking direction to the Union of India to implement an independent and transparent system of selection constituting a neutral and independent selection committee for the appointment of the Chief Election Commissioner (CEC) and other Election Commissioners (ECs). The PIL seeks direction to set aside Gazette issued by the Centre on December 28, 2023, for the appointment of CEC and ECs. It seeks direction to the Centre to include the Chief Justice of India in the selection committee for the appointment of the CEC and ECs which currently comprises of the Prime Minister, the Leader of the Opposition in Lok Sabha and a Union Cabinet Minister nominated by the Prime Minister. The PIL filed by advocate Gopal Singh



stated, "The pivotal legal question placed for the court's consideration in the present writ petition revolves around the constitutional inquiry of whether the Parliament or any legislative assembly possesses the authority to promulgate a gazette notification or ordinance to nullify or amend a judgment previously rendered by this Court, particularly when the judgment emanates from a Constitution bench." Earlier, on December 28, the President gave

Commissioner and Other Election Commissioners (Appointment, Conditions of Service and Term of Office) Bill 2023. Notably, on December 21, the Loksabha passed a bill to regulate the appointment and service terms of the Chief Election Commissioner (CEC) and election commissioners, with Law Minister Arjun Meghwal stating that legislation has been brought following a judgement of the

Editorial All work, no play

R. Narayana Murthy's recent endorsement of a 70-hour work week opens up space to engage with it critically. It is imperative to delve into the profound implications it holds for class dynamics, gender disparities, and the psychological well-being of the workforce. Murthy's exhortation echoes a perspective deeply rooted in privilege. The luxury to choose to work extended hours is a prerogative that not everyone possesses. For individuals from economically weaker backgrounds and lower castes, the concept of choice is eclipsed by the stark reality of necessity. Working 70 hours a week becomes less about personal ambition and more about the fundamental need to make ends meet. How ethical is it to put the burden of productivity on those who are already at the receiving end? The International Labour Organization has consistently highlighted the disproportionate impact of long working hours on vulnerable groups. Their reports shed light on how such labour dynamics perpetuate an economic hierarchy that disproportionately affects those with fewer resources, reinforcing systemic inequalities.

Murthy's vision of a 70-hour work week also seems to be framed within the context of traditional male privilege. Men, historically shielded from the domestic responsibilities that women shoulder, can afford to dedicate extensive hours to their professional lives. On the contrary, women find themselves navigating a double burden, juggling not only their professional commitments but also the extensive responsibilities of household management. World Bank data make it evident that the gender disparities in the workforce contribute to an uneven distribution of labour responsibilities. Advocating a 70-hour work week without addressing inherent gender inequities would perpetuate male privilege and do a disservice to the principles of equality and inclusion in a democratic country.

This debate is not confined merely to economic and gender disparities; it transcends into the realm of mental well-being. Research from the World Health Organization and mental health institutions underscore the negative impact of overworking on mental health. Employees subjected to prolonged working hours often find themselves trapped in a cycle where the boundaries between professional and personal life blur, leaving little room for creative endeavours and rejuvenation. Such conditions foster an environment ripe for burnout, eroding not only mental health but also overall productivity.

Pakistan electoral body rejects over 3000 nominations

The Pakistan Election Commission (ECP) rejected the nomination papers of 3,240 candidates aspiring to contest elections at national and provincial levels to be held on February 8, 2024, ARY News reported on Monday.


It reported that the official data released by the Pakistan electoral body revealed that 1024 candidates were denied eligibility to contest national assembly elections and 2,216 individuals, failed to secure approval for the provincial assembly race.

A total of 25,951 nominations were filed by the candidates from which the Returning Officers (ROs) accepted 22,711 candidates. For the National Assembly, 6,449 candidates received approval and 1024 faced rejection. The ROs accepted 16,262 nominations for various provincial assembly seats. Punjab witnessed the highest number of rejections (521) for National Assembly nominations, followed by Sindh (166), Khyber-Pakhtunkhwa (152), Balochistan (92), and Islamabad Capital Territory (93).

For provincial assembly seats, the ROs rejected the nomination papers of 943 candidates in Punjab; 520 in Sindh; 386 in Balochistan and 367 in the K-P, for a total of 2,216. The total number of people who filed nomination papers to contest provincial assembly elections was 18,478.

Following the completion of two phases of the election process, in the third phase, appeals against the acceptance or rejection of nomination papers can be submitted by Wednesday and decisions on these appeals will be made by the 10th of this month, ARY News reported.

The preliminary list of candidates will be displayed on the 11th and candidates can withdraw their nomination papers by the 12th of this month. The electoral symbols will be allotted on the 13th of this month, while polling for the general elections will



be held on the 8th of next month. Moreover, ECP rejected the nomination papers for Pakistan Tehreek-e-Insaf (PTI) founder Imran Khanb, dealing a major blow to the former Prime Minister ahead of the upcoming elections slated for February 8, 2024, The News International reported on Saturday.

Despite being disqualified from contesting the upcoming general elections in Pakistan, jailed ex-PM Imran Khan submitted his nomination papers from his home constituency in Mianwali on Friday, as reported by Geo News.

Meanwhile, in a development that has led to heavy criticism for Islamabad, the Pakistan Markazi Muslim League (PMML), a political entity of Hafiz Saeed, has fielded candidates for each and every national and provincial assembly constituency across Pakistan for the upcoming general elections slated to be held on February 8, 2024.

Hafiz Saeed's son Talha Saeed is also going to contest the polls from the National

Light exercise can be key to reducing childhood obesity linked to inactivity

hildhood obesity is directly connected to increased sedentary time as a youngster through puberty, but new research has discovered that mild physical activity can totally reverse the negative trend.

The study, published in Nature Communications, was conducted in collaboration with the Universities of Exeter, Eastern Finland, Bristol, and Colorado, and is the largest and longest follow-up to objectively measure physical activity and fat mass using data from the University of Bristol's Children of the 90s (also known as the Avon Longitudinal Study of Parents and Children). The study comprised 6,059 11-year-old children (53 percent of whom were female) who were followed up on until the age of 24.

Recent reports concluded that more than 80 percent of adolescents across the globe do not meet the World Health Organization's (WHO) recommended average of 60 minutes a day of moderate-tovigorous physical activity. It is estimated that physical inactivity will have caused 500 million new cases of heart disease, obesity, diabetes, or other noncommunicable diseases by 2030, costing £21-million annually. This alarming forecast regarding the morbid danger of physical inactivity necessitates urgent research on the most effective preventive approach. Yet results from this new study shows that moderate-to-vigorous physical activity is



up to ten times less effective than light physical activity in decreasing overall gain in fat mass. Dr Andrew Agbaje of the University of Exeter led the study and said: "These new findings strongly emphasise that light physical activity may be an unsung hero in preventing fat mass obesity from early life. It is about time the world replaced the mantra of 'an average of 60 minutes a day of moderateto-vigorous physical activity' with 'at least 3 hours a day of light physical activity'. Light physical activity appears to be the antidote to the catastrophic effect of sedentary time in the young population." During the study, a waist-worn accelerometer measured sedentary time, light physical activity, and moderate-tovigorous physical activity among participants at ages 11, 15, and 24 years

Excessive coal consumption leads to rise in respiratory diseases

facility. He thought that rising air pollution from burning coal and cars was the primary cause of the rise in respiratory issues.

According to Provincial EPD Head Muhammad Ibrahim Dadfar, one of the serious problems of this season is the rise in environmental pollution. He also stated that all citizens and businesses must abide by local and environmental rules.

He said that the majority of the coal loading and unloading facilities in the




Qarghna Tou area had been relocated outside of residential areas in order to reduce environmental pollution, as reported by Paihwok News.

Technology, economics might help save endangered species

In the 50 years after the Endangered Species Act (ESA) was passed in December 1973, the world has changed drastical-▲ ly. Two Ohio State University academics were among a group of experts invited by the journal Science to explore how the ESA has evolved and what its future may hold. Tanya Berger-Wolf, faculty director of Ohio State's Translational Data Analytics Institute, led a group that wrote on "Sustainable, trustworthy, human-technology partnership." Amy Ando, professor and chair of the university's Department of Agricultural, Environmental, and Development Economics, wrote on "Harnessing economics for effective implementation." Berger-Wolf and her colleagues wrote, "We are in the middle of a mass extinction without even knowing all that we are losing and how fast." But technology can help address that. For example, they note the value of tools like camera traps that survey animal species and smartphone apps that allow citizen scientists to count insects, identify bird songs and report plant observations.

New tech has allowed scientists to monitor animal and plant populations at scale for the first time, said Berger-Wolf, who is also a professor of computer science and engineering, evolution, ecology and organismal biology, and electrical and computer engineering. One challenge is to find new ways to extract all the information from these new sources of data. "But



even with all this data, we are still monitoring only a tiny fraction of the biodiversity out in the world," she said. "Without that

information, we don't know what we have, how different species are doing and whether our policies to protect endangered

species are working."

Most important, Berger-Wolf said, is the need to make sure to keep humans in the process. Technology needs to connect data, connect different regions of the world, connect people to nature and connect people to people.

"We don't want to sever the connection between people and

nature, we want to strengthen it," she said.
"We cannot rely on technology to save the world's biodiversity. It has to be an intentional partnership between humans

and technology and AI."

Economics should be another partner in the fight to save

endangered species, Ando said.
"There's this tendency to think that protecting endangered species is all about biology and ecology," Ando said. "But various tools in economics are very helpful in making sure the work we do to implement the Endangered Species Act is successful. That is not always obvious to people."

For example, bioeconomic research is a multidisciplinary effort between economists and biologists to work together to see how human behaviour interacts with ecological processes

"We have to take into account feedback effects. People take an action, and that changes the ecosystem and that changes what people do," she said. "We need to capture those feedback effects."

The result can be novel ways to protect endangered species, such as "pop-up" habitat modification. For example, ranchers can take down fences temporarily while elk are migrating to allow them to move freely. Rice fields can be temporarily flooded during shorebird migration to give them a place to rest and feed on their travels.

We can "draw upon economics to optimize the timing, location and extent of temporary actions to maximize their net ben-

efits to society," Ando wrote in Science. Another way economics can help is to develop policies that protect species before they become so threatened that they need

ESA protection.

A common issue is that multiple landowners will all need to work together to protect the habitat of threatened species. But often, if some landowners take actions to protect a species, other landowners will think they don't have to. "Economists have been working to understand how we can coordinate landowners where we don't have to implement draconian land use regulations, but still protect habitat," Ando said.

Litchfield also set a new highwater mark for most runs by an Australian woman in a three-game

ODI series, eclipsing Meg Lanning's 246 against New Zealand in 2016.

Litchfield is the second Australian woman to hit a one-day ton at Wankhede, following Lanning who hit a ton at the iconic Mumbai ground during the 2013 World Cun

She also became just the seventh visiting batter to hit a oneday hundred in India.

Litchfield has scored more runs in 50-over cricket in a calendar year before her turning 21 than any other Australian woman batter. She has amassed 485 runs in 2023 surpassing Meg Lanning's previous tally by a single run.


