Putin wins Russia election



MOSCOW: President Vladimir Putin won a record post-Soviet landslide in Russia's election on Sunday, cementing his already tight grip on power in a victory he said showed Moscow had been right to stand up to the West and send its troops into Ukraine. Putin, a former KGB lieutenant colonel who first rose to power in 1999, made it clear that the result should send a message to the West that its leaders will have to reckon with an emboldened Russia, whether in war or in peace

EC orders removal of West Bengal DGP, Home Secretaries in 6 states

AGENCY NEW DELHI, MAR 18

Ahead of the ensuing Lok Sabha polls the Election Commission of India (ECI) on Monday issued orders for the removal of West Bengal's Director General of Police Rajeev Kumar and Brihanmumbai Municipal Corporation Commissioner Iqbal Chahal along with some other senior officials from various states.

The ECI has also ordered the remov al of certain key officials of six states in what it termed a decisive move towards upholding the principles of free, fair and transparent elections.

Home Secretaries in six states-name-Gujarat, Uttar Pradesh, Bihar, Jharkhand, Himachal Pradesh and Uttarakhand have been asked to step down. Additionally, the secretaries of the General Administrative Department in Mizoram and Himachal Pradesh have been removed.

The DGP had been in the spotlight after the BJP and other opposition parties criticised the Bengal police for alleged inaction in giving justice to the victims of Sandeshkhali.

The Sandeshkhali area had been witnessing unrest after women protestors sought justice against alleged atrocities committed by Trinamool Congress (TMC) leader Sheikh Shahjahan and his aides

Meanwhile, the Election commission also directed all the State governments to transfer officers connected with election-related work, who have completed three years or are in their home districts

/ Deputy Municipal Commissioners. While conveying displeasure to the Chief Secretary, the Commission directed the transfer of Brihanmumbai Municipal Corporation Commissioner and the additional / Deputy commissioners with the direction to report by 6pm today.

The Chief Secretary was further directed to transfer all the similarly placed Municipal commissioners and Addition-



al / Deputy Municipal Commissioners of other Corporations in Maharashtra.

This step comes as part of the Commission's resolve and commitment to maintaining a level playing field and ensuring the integrity of the electoral process, which has been emphasised by CEC Rajiv Kumar time and again and recently during the press conference for the announcement of Schedule for General Elections 2024.

The Commission meeting, chaired by Rajiv Kumar, comprising of Election Commissioners Gyanesh Kumar and Sukhbir Singh Sandhu was held today at noon.

The officials who have been re moved in these seven states were found to be holding dual charges in the office of Chief Minister in respective states which may potentially compromise or



be seen to be compromising the impartiality and neutrality required during the electoral process, especially in matters relating to law and order, deployment of forces, etc.

Through these measures, the Commission says it has ensured that all stakeholders uphold the highest standards of integrity and impartiality, thereby safeguarding the level playing field in the entire electoral process.

BJP to contest 17 seats, JDU 16, **Chirag Paswan's party 5 in Bihar**

The NDA formally an-nounced its seat-share formula in Bihar this evening, which placed the BJP firmly as the 'big brother' in the state with 17 seats to contest. Chief Minister Nitish Ku-mar's Janata Dal United, which previously had the pole position in the alliance in Bihar, will contest on 16 seats. Chirag Paswan's Lok Janshakti Party will contest on five seats, Jitan Ram Manjhi's Hindustan Awam Morcha and Upendra Kushwaha's RLM gets one seat each.

The LJP faction led by Chirag Paswan's uncle Pashupati Paras -- who landed a cabinet berth after splitting the party three years ago -- is not part of the NDA. The Paras faction was dropped after it became clear that Chirag Paswan's unit had complete command over the Paswan vote. The community comprises 6 per cent of the voting population. The BJP has taken Nawa

da -- a stronghold of the LJP and has given Sheohar to Mr Kumar's JD(U) in place of Gaya and Karakat. The JD(U) has also got Kishanganj, which it lost to the Congress last time.

Mr Kumar's JD(U), which broke the Grand Alliance a second time and joined hands with the BJP early this year, appeared nonchalant about



The Supreme Court on Monday refused to stay the order of the Himachal Pradesh Assembly Speaker disqualifying six Congress rebels, who had cross-voted in the recent Rajya Sabha polls in the

state. A bench of Justices Sanjiv Khanna and Dipankar Datta issued notice to the office of HP Assembly speaker Kuldeep Singh Pathania and sought its re-

sponse to the plea in four weeks.

The bench said that pending adjudication of their plea, rebel HP Congress MLAs will not be allowed to vote or participate in the proceedings of the Assembly. "On the question of by-election on six vacant seats, we will have to examine whether the elections which have been notified by the ECI are to be stayed during the pendency of plea," the bench said.

The bench said that its February 15 judgment mandated the SBI to disclose all details including the date of pur-

selective on disclosing the details. Last week, the apex court took exception to SBI for not furnishings Electoral Bonds data with unique alphanumeric numbers, which help identify the bond, and issued notice to it.

Court suspends sentence of Cine Actor Jayaprada; grants interim bail

The Supreme Court recently suspended the sentence of cine actress Jayaprada in connection with a case against her for her failure to pay contributions to the Em-

ployees State Insurance Corporation (ESIC). The counsel of the actress

informed the Court that a sum of Rs 9,80,000 has been deposited with ESIC.

A bench comprising Justice Abhay S Oka and Justice Ujjal Bhuyan on March 15 granted Jayaprada interim bail.

The interim bail was granted to Jayaprada after Senior Advocate Sonia Mathur appearing for her submitted that a sum of Rs

9,80,000 has been deposited with ESIC.

An appeal against her conviction is still pending before a sessions court.

The matter pertains to a case in which Jayaprada and her brothers Ramkumar and Raj Babu were partners of Jayapradha Cine Theatre, which went defunct around ten years ago

The ESIC alleged that the management of the now-de-funct cinema theatre had been deducting ESI amounts from the dues payable to theatre workers but had not been paying these amounts to the State Insurance Corporation.

In August last year, a Me-topolitan Magistrate Court in Chennai sentenced Jayaprada to six months in prison on a complaint by the ESIC.

Eminent agricultural scientist, M.S. Swaminathan passes away

Mankombu Sambasivan Swaminathan, popularly known as M.S. Swaminathan, the legendary agri-cultural scientist and a key architect of the country's 'Green Revolution,' passed away at his residence in Chennai on September 28, 2023 at 11.20 am, following age-related issues. He was 98. He is survived by three daughters



Soumya Swaminathan, former chief scientist, World Health Organisation; Madhura Swaminathan, professor, economic analysis unit, Indian Statistical Institute, Bengaluru and former chairperson, MSSRF, and Nitya Rao, director, NISD, University of East Anglia, UK. His wife, Mina Swaminathan, who was Distin-guished Chair, Gender and Development, M. S. Swaminathan Research Foundation (MSSRF),

died in March 2022. Born in Kumbakonam on August

7, 1925 to M.K. Sambasivan, a surgeon, and Parvati Thangammal, Swaminathan had his schooling there. His keen interest in agricultural science coupled with his father's participation in the freedom movement and Mahatma Gandhi's influence inspired him to pursue higher studies in the subject. Otherwise, he would have become a police officer, for which he got qualified in the late 1940s. By then, he got two undergraduate degrees, including one from the Agricultural College, Coimbatore (now, Tamil Nadu Agricultural University).





CEO holds meeting with political parties; apprises about key election process

Punjab's Chief Electoral Officer (CEO) Sibin C, convened a meeting with representatives from major political parties in the state to discuss essential aspects of the upcoming elections

During the session, he provided detailed insights into the election process, highlighting key statistics such as the total number of voters (2,12,71,246), including Male voters (1,11,92,959), Female voters (1,00,77,543), Transgender voters (744). Persons with Disabilities (PwD-1,57,257), Overseas Voters (1597) and the number of polling stations

(24,433). Additionally, he informed attendees about re-cent provisions allowing PwD voters and individuals aged 85 and above to opt for voting at home. Regarding Electronic Voting Machine (EVM) availability, Sibin C stated that the state boasts 150% availability, ensuring a surplus of 50% more than required. Furthermore, he assured that all polling stations would be equipped with essential facilities such as ramps, water sup-



ply, proper lighting arrangements, and toilets. He emphasized that all polling stations would be conveniently located within 2 kilometers of voters' addresses.

He elaborated on various intricacies of the electoral process, including candidate qualifications for Lok Sabha elections, disgualification provisions (both constitutional and statutory), nomination procedures, grounds for rejection of nominations, and rules governing withdrawal of nominations, as well as sym-

allotment regulations. bol CEO also outlined the key provisions of the Model Code of Conduct, stressing that political parties and candidates must refrain from hate speech, religious or castebased vote solicitation, personal attacks on opponents, or criticism based on unverified reports. He further emphasized the necessity of obtaining prior permission from district authorities for meetings and other events.

RO orders for implementation of **Model Code of Conduct in SLSC**

The Returning Officer (RO)cum-Deputy Commissioner, Sangrur, Jitendra Jorwal in the presence of SSP Sangrur, Sartaj Singh Chahal and Additional District Election Officer (ADEO), Akash Bansal held a press conference (PC) in the meeting hall of the district administrative complex here today. The main aim of this PC was to inform in de-tail about the guidelines and instructions issued by the Election Commission of India (ECI) regarding the Lok Sabha elections -2024, to be held on June 1.

While addressing the PC. the RO said that the violation of the Model Code of Conduct (MCC) will not be tolerated at any cost and the entire work of the election will be carried out in the peaceful, transparent and secure environment. He said that various teams have been made operational to maintain full vigilance in all the constituencies falls under Sangrur Lok Sabha Constituency (SLSC) and in order to implement the MCC, all the political parties and common people have also been informed to carry out the entire election process in a smooth



manner. The RO said that the ECI will issue the gazette notification for the Lok Sabha elections on 7th May 2024 and the candidates will be able to submit their nomination papers till 14th May. He said that the scrutiny of the nomination papers will be held on May 15, while the candidates will be able to withdraw their nomination papers till May 17. The RO said that the votes will cast their votes on June 1 and the counting of votes will take place on June 4. He said that during the Lok Sabha elections held in 2019, 72.44% votes were cast in SLSC and this time the Election Commission has set a target of crossing the percentage of votes in SLSC from 80 per-

cent. The RO further said that 15 lakh 48 thousand 37 citizens are registered as voters in Sangrur constituency, out of which 8 lakh 19 thousand 994 are male, 7 lakh 27 thou sand 997 are female. 46 are third gender. He said that 31641 voters in the age group of 18-19 years, 10467 disabled voters, 36 NRIs, 32831 senior citizens, of which 347 senior citizens are more than 100 years old. He further said that the number of service voters is 7290 and 1765 polling sta tions to be established. He added that the postal ballot facility will be provided to dis abled voters and senior citi zens/voters above 85 years of age.

Jitendra Jorwal said that the election commission has increased the expenditure limit of the candidates contesting the elections from 70 lakhs to 95 lakhs. He said that there will be webcasting at the polling stations and micro observers will be appointed separately.

October 2024 could enroll. Manish Garg said that until the nomination is filed, new names will be included in the voter list. Tashiganga is the world's highest polling station. Situated at a height of 15256 feet above sea level, Tashigang Monestry in the Spiti Valley of Lahaul Spiti district under Mandi Parliamentary Constituency would be the highest polling station in the state, having near 50 voters. Kaa-6 in Kalpa in Kinnaur district would be the smallest polling district, with only 16 electorate in 5 rural areas. The Parliamentary Shimla Summerhill-2 polling station

would have only 34 votes. Under Kangra Parliamentary Manol-1 polling station in Dalhousie assembly of Chamba district, there are the highest 1410 voters.

Tibet's political situation discussed in Tibetan Parliament session

The Speaker urged all members to unite and work towards

He noted the current turmoil within the Chinese government, highlighted by the recent cancellation of the Chinese Prime Minister's annual press conference, and stressed the importance of keeping the Tibet issue on the agenda as elections in Europe and India approach. Gave. In honoring the Tibetan martyrs, he stressed that China cannot ignore the Tibetan struggle,

given the selfless sacrifice of these brave individuals and the tireless efforts of His Holiness the Dalai Lama. The Speaker outlined the agenda for the first day of the parliamentary session. including resolutions on solidarity with Tibetans inside Tibet, the budget for 2024-25 and reports of review committees. He expressed hope for meaningful discussion and legislative progress during the session, and also named his replacement in his absence.

Memorandum to CM regarding SC ST Tribe Development Fund Act

On the contrary, in the last 5 years, the budget provision under this sub-scheme has been limited to only 5%, which should have been 33%in proportion to the population of the concerned category. In the memorandum, he has demanded from the Himachal Government that a special law for Scheduled Castes and

Tribes Development Fund should be made on the lines of Telangana State. and provision of 33% of the total budget should be made in proportion to the population of Scheduled Castes and Tribes. He said that this law will be implemented in Himachal Pradesh. This will prove to be a milestone in the direction of all-round development of Scheduled Castes and Tribes in the state

He said that after the implementation of the Model Code of Conduct, the advertisements and news published through print media unit, electronic media unit, social media unit, FM, local radio unit, electronic media, monitoring unit and media center will be monitored and If any violation of the model code of conduct is found, action will be taken as per rules.

Moreover, Kapur highlighted other tactics employed by cyber criminals, such as threats to block phone numbers citing TRAI guidelines or impersonating officials from agencies like CBI. 

Editorial Broken tooth

If the upcoming elections tell us anything at all about the news media, it is that it has become largely incon-sequential during elections. Notions of being the fourth estate may sustain its morale but there are indications all around that the agenda-setting it might want to do will be limited in impact. The political class swamps the media real estate with advertising, and media-owners are so grateful for this that, in terms of visibility, the news often gets short shrift. About the only use that the Narendra Modi government demonstrates for the mainstream media is as a platform for advertising. The weaponisation of agencies, such as the Enforcement Direc-to-rate and the Central Bureau of Investigation, and the use of terrorism laws have taken away the mainstream media's zeal for trying to hold this government to account. Even the bravest among the media are scared to offend

The national broadcaster's role has been redefined to serve the cause of religious majoritarianism. It now does more consequential agenda-setting than ever before, the high point being showcasing the prime minis-ter performing priestly duties at the consecration of the Ram temple in Ayodhya. Last week, Doordarshan was pressed into service to offer a daily telecast at 6.30 am of the morning aarti from the Ram temple in Ayodhya.

What is spent on political image building is largely unquantifiable. The unfolding electoral bond revelations demonstrate that both the Centre and the state governments have not been shy of extorting from corporates to continue to win elections. Even a ruling party with considerable public legitimacy in terms of seats held looks to spend unprecedented sums of money in the next few months to continue winning.

The quantum of spending on advertising and other kinds of outreach is evident in the manic frequency of the 'Modi Ki Guarantee' advertisements on television, in the manpower deployed for social media outreach to the voter, and in the scale of the disinformation cam-paigns being mounted. However, since state governments also do a lot of spending which builds the prime minister's image, it is difficult to compute the overall cost. No realistic estimate of election outreach is possible or available. Except for some of the social media

spending, which is small. Earlier this month, The News- Minute reported that data from Google's Ads Transparency Center showed that the Bharatiya Janata Party had spent Rs 29.7 crore in the 30 days preceding March 1 on streaming ads, mostly videos, which boosted the image of the prime minister, Narendra Modi, and the Union government's schemes in multiple languages. In comparison, the party had spent Rs 12.3 crore in the four-month period leading up to the general elections in 2019.

Putin mulls establishment of 'sanitary zone' in Ukraine

ussian President Vladimir Putin, in his R remarks at his campaign headquarters, suggested the possibility of establishing a "sanitary zone" in neighbouring territories in response to the attacks by the Armed Forces of Ukraine (AFU) on the Belgorod region, TASS reported.

"I'm not ready to talk now about what, how and when we should annex. But I do not rule out that, bearing in mind the tragic events taking place today, we will be forced at some point - when we consider it appropriate - to create a certain "sanitary zone" in today's territories subordinate to the Kiev regime," Putin said, commenting on proposals to annex the Kharkov region to prevent Ukrainian attacks on the Russian border.

'To create a security zone, which will be quite difficult to overcome using the weapons that the enemy uses, primarily, of course, foreign-made," the head of state stated, however, he refrained from specifying what the depth of the "sanitary zone" might be, according to TASS.

"This is a separate issue," he said in response to a corresponding request.

Russia's recent presidential election, spanning from March 15 to 17, marked a key moment in the nation's political landscape. With a record-breaking turnout of over 74 per cent of eligible voters, this engagement soared to heights unseen in over two decades, as confirmed by the Russian Cen-

tral Election Commission (CEC) on Sunday. Putin's remarks at his campaign headquarters underscored the gravity of the situ-

ation, as he contemplated the necessity of such a security measure in response to the

challenges posed by the Kyiv regime.

The president's comments come amidst



reports of military build-up and clashes along the border, with Kiev amassing significant troop deployments while facing losses during confrontations, including casualties among so-called volunteer forces.

Putin, however, adopted a pragmatic stance, acknowledging that these losses could inadvertently favour Russia's strategic objectives by diminishing enemy capabilities in other theaters of conflict.

The Russian President highlighted that the heavy losses sustained during cross-border attacks play in the hands of Russia, saying, "Well, if they want to have it that way,

we have nothing against it <...>. This plays in our hands to a certain extent. Let them have a good try. It means that there will be less personnel taking part in hostili ties in other areas.

Due to ongoing cross-border attacks in the Belgorod Region, he hinted Russia may be forced to create "a buffer zone of some sort," which will be "fairly hard to cross.' However, its possible width is unknown and "it is a separate question."

The Russian military is advancing day by day, and its strategy currently implies 'something more than just active defence,' **Russia's recent** presidential election, spanning from March 15 to 17, marked a key moment in the nation's political landscape. The volcano that erupted on Saturday in southwestern Iceland has been recorded for the fourth time in three months, reported The Washington Post

The eruption led to destructive lava flowing towards the town of Grindavik, prompting the evacuation of the Blue Lagoon geothermal spa resort and the nearby town of Grindavik, amid emergency warnings.

Moreover, it quickly formed a 1.8mile-long fissure in the ground, the Icelandic Meteorological Office said.

Lava was still flowing early Sunday, and footage of the eruption was being live-streamed by RUV, Iceland's national broadcaster, according to The Washington Post.

However, there was no such information available about the scale of damage or possible casualties

The sky around Mount Hagafell and Mount Stora Skogfell was captured,



turning a molten orange as people watched and emergency services prepared to respond.

Early Sunday, lava was flowing towards the south and southeast at a pace of about 0.62 mph, the Meteorological Office said.

If that pace continues, it said, lava could reach the ocean -- which can send steam flying and, in some cases, cause explosions of lava fragments that can be dangerous to anyone nearby, it added.

According to the local media, follow ing the alert, authorities moved to evacuate people from the area, including the Blue Lagoon, one of the country's most popular tourist attractions.

Iceland is one of the most active volcanic areas on the planet. Instead of have ing a central volcano, the Reykjanes Peninsula is dominated by a rift valley, with lava fields and cones, CNN reported



akistan International Airlines (PIA) incurred a substantial penalty after one of its air hostesses reached Canada without a passport, as reported by ARY News, citing insider sources

According to sources, the air hostess was scheduled for duty on flight PK-781 from Islamabad to Toronto when the unprecedented incident occurred

She travelled from Islamabad to Toronto using only PIA General Declaration documents, circumventing the standard passport requirement.

In the aftermath of this breach, the national carrier faced a significant fine for permitting flight attendants to enter Canada without appropriate documentation.

A spokesperson for PIA confirmed the imposition of a USED 250 fine for the incident, emphasising the gravity of the violation. However, the spokesperson refuted claims suggesting the air hostess had intentions to seek political asylum upon arrival in Canada. It's worth noting that over the past two years, more than 10 PIA air host esses have reportedly gone missing in Canada, sparking concerns regarding the welfare and safety of airline staff on international routes. Earlier this month, on March 1. another PIA cabin crew member was reported missing in Canada, as confirmed by the national airline spokesperson. Jibran Baloch, a flight steward, was expected to return for duty on PIA flight PK-782 in Toronto on February 29, but failed to show up for work on the return flight to Pakistan. Recently, a female air hostess named Maryam Raza also disappeared from her hotel

Children with 'lazy eye' at higher risk of serious disease in adulthood: Study

ccording to a new study performed by UCL researchers, those who had amblyopia ('lazy eye') in childhood are more likely to experience hypertension, obesity, and metabolic syndrome in adulthood, as well as an increased risk of heart attacks.

In publishing the study in eClinicalMedicine, the authors stress that while they have identified a correlation, their research does not show a causal relationship between amblyopia and ill health in adulthood. The researchers analysed data from more than 126.000 participants aged 40 to 69 years old from



the UK Biobank cohort, who had undergone ocular examination. Participants had been asked during recruitment

whether they were treated for amblyopia in childhood and whether they still had the condition in adulthood. They were also asked if they had a medical diagnosis of diabetes, high blood pressure, or cardio/cerebrovascular disease (ie. angina, heart attack, stroke).

Meanwhile, their BMI (body mass index), blood glucose, and cholesterol levels were also measured and mortality was tracked. The researchers confirmed that from 3,238 participants who reported having a 'lazy eye' as a child, 82.2% had persistent reduced vision in one eye as an adult. The findings showed that

participants with amblyopia as a child had 29% higher odds of developing diabetes, 25% higher odds of having hypertension and 16% higher odds of having obesity. They were also at increased risk of heart attack - even when other risk factors for these conditions (e.g. other disease, ethnicity and social class) were taken into account.

This increased risk of health problems was found not only among those whose vision problems persisted, but also to some extent in participants who had had amblyopia as a child and 20/20 vision as an adult, although the correlation was not as strong

Corresponding author, Professor Jugnoo Rahi (UCL Great Ormond Street Institute for Child Health, UCL Institute of Ophthalmology and Great Ormond Street Hospital), said: "Amblyopia is an eye condition affecting up to four in 100 children. In the UK, all children are supposed to have vision screening before the age of five, to ensure a prompt diagnosis and relevant ophthalmic treatment. "It is rare to have a 'marker' in childhood that is associated with increased risk of serious disease in adult life, and also one that is measured and

known for every child - because of population screening.

"The large numbers of affected children and their families, may want to think of our findings as an extra incentive for trying to achieve healthy lifestyles from childhood." Amblyopia is when the vision in one eye does not develop properly and can be triggered by a squint or being long-sighted. It is a neurodevelopmental condition that develops when there's a breakdown in how the brain and the eve work together and the brain can't process properly the visual signal from the affected eye.

ndroid 15 is still months away, but one of Android 15 is still months away, but one o its new features has recently surfaced. Reportedly, users will be able to archive an app to save space on their smartphone, instead of completely uninstalling it. This app archiving feature is currently available in Google Play Store, for apps downloaded through the marketplace. However, there is no manual control, and apps downloaded from other app marketplaces do not support it. This is why ar operating system-level feature via Android 15 could be much more useful. 

Media Certifica tion and Monitoring Committee (MCMC) has been formed for compliance of the Model Code of Conduct. This committee will keep an eye on whether any rumor or false news was being spread in any campaign media, due to which the voters got confused in the elections. He said that during the

election process, the purity of news in newspapers, TV chan-nels, local cable TV, social media should be maintained. No fake or paid news should ap pear in the media. If any com munication medium broadcast misleading news, the Elec tion Commission can take ac tion against it. He said that if there is any kind of complaint regarding advertisement or news, then the Election De-

wanted to get an advertise ment broadcast in a TV channel or newspaper on the day before and after voting, he will have to obtain a pre-certificate from the MCMC Committee. He said that for this advertisement, candidates from political parties registered with the Election Commission of India will have to submit their applications to the committee three days in advance and the remaining candidates will have to submit their applications to the committee seven days in advance. The committee will examine the advertisement material and give its approval or rejection within two days.
