Campaigning for the seventh and final phase of the Lok Sabha elections 2024 concluded on Thursday, May 30. Leaders of top political parties intensified their efforts with last-minute rallies. Voting will be held on June 1 in 57 parliamenta ry constituencies across seven states and the Union Territory of Chandigarh. A total of 904 candidates are contesting in this phase. Thirteen seats each in Uttar Pradesh and Punjab, nine in West Bengal, eight in Bihar, Six in Odisha, four in Himachal Pradesh, three in Jharkhand, and one in Chandigarh are set to go to polls on June 1. Additionally, 42 Assembly seats in

Odisha would also hold elections. The counting of votes was scheduled for June 4. However in this phase, all focus is on Varanasi, where Prime Minister Narendra Modi is contesting for a hat-trick vic-Though the Prime Minister has not

addressed any meeting after his roadshow and filing of nominations on May13-14, almost all senior BJP and NDA leaders have camped in the temple city to woo the voters. There are a total of 144 candidates in

the fray for the Lok Sabha constituencies in this phase in UP, comprising 134 male and 10 female candidates. Concurrently, 6 candidates are competing for the Duddhi (ST) assembly by-election in Sonbhadra district State Chief Electoral Officer (CEO)

The Chief Electoral Officer has advised the polling personnel and voters to use light cotton clothes while taking full precautions to avoid the heat. "To protect from the scorching Sun, keep a cap, umbrella, white cotton towel, or any other cloth covering the head. Keep a water bottle, and occasionally use plain water, lemonade or ORS as needed. On voting day, voters should reach the polling booths in large numbers and vote before the Sun is at its peak," Rinwa appealed to the people. The CEO announced that under Section 126 of the Representation of the People Act, 1951, to ensure free and fair elections, all election-related activities and campaigns will be prohibited in the 13 Lok Sabha constit-

LS polls: Campaigning ends for final phase, voting tomorrow Cong'strangled' constitution during emergency: PM Modi

Prime Minister Narendra Modi on Thursday attacked the Congress for "ranting" about the Constitution when it was the one that "strangled" it during the Emergency and not care about it when Sikhs were killed in the 1984 riots. "Sikhs were killed after putting burning tyres around them. At that time, they did not care about the Constitution," Modi said in his last poll rally in the seven-phase

At the rally in favour of his party's Hoshiarpur candidate Anita Som Parkash and Anandpur Sahib nominee Subhash Sharma here, the prime minister also touched upon the issues of reservation, corruption and the Ram

Hitting back at the Con-ress for its charge that the BJP would scrap the Constitution if voted to power, Modi said, "Nowadays people of the country are hearing rants from INDI alliance about the Constitution. Man dies of heat in Delhi hospital, fever shot up to 107 degrees

NEW DELHI, MAY 30

A 40-year-old man from Bihar's Darbhanga died at Delhi's Ram Manohar Lohia hospital yesterday after he suffered a heatstroke during the record-breaking heatwave in the national capital. The man was admitted to the hospital late

A doctor who attended to him said he was living in a room with no cooler or fan and had high fever. The body temperature, the doctor said, crossed the 107 degrees Celsius mark -nearly 10 degrees above normal. This is the first heat-stroke death reported in Delhi this summer. The national capital has been living its summer nightmare with record-breaking temperatures, all-time high power demand and a crippling water crisis. The Mungeshpur weather station on the city's outskirts recorded a reading of 52.9 degrees Celsius -- the highest-ever for any station in the country. The weather office is now investigating if the Mungeshpur station's record reading was due to a sensor error or local factors. M Mohapatra, director general of India Meteorological Department, has said that of the 20 monitoring stations in Delhi, 14 recorded a drop in temperature vesterday and the average across the city was in the 45-50 degrees Celsius



Editorial The Indian formula

What is considered to be economic progress may not necessarily match the target of realising social welfare. In fact, the gross domestic product is primarily an index for measuring the economy, not human welfare. Thus, the current paradigm of develop-ment needs to be urgently replaced by development models that are just, sustainable, and inclusive in na-

Financing sustainable development is one of the major bottlenecks faced by the vulnerable communities in the Global South. A report by the UN Inter-Agency Task Force warns that the current SDG financing deficit can snowball into a massive sustainable development divide if not checked in time. Several low-income economies, small island developing states and least developed countries suffer from soaring debt burdens. This is jeopardising their recovery efforts, creating a vicious cycle of fiscal stress and climate vulnerability

Development partnerships are not a new phenomenon. But with the (re)emergence of some of the developing economies, such as India, China, Indonesia and Brazil, taking up the mantle of providing crucial resources — skills training, capacity-building, knowledgesharing—development partnerships are no longer a monopoly of the West. Further, there has been a transition from 'aid' to 'cooperation', reflecting a relationship based on an equal footing. Also, the transfer of resources, finances or knowledge is no longer an obliga-

tion but a condition for achieving greater global good. But there is a need to reform the existing financing architecture to achieve just financing. Countries in need should be in a position to secure not just adequate quantities of finance but also the requisite quality of fi-— finance that creates sustainability. The current model of official development assistance appears to be incapable of dealing with the challenges of the developing world. Also, one must look at solutions that can supplement and scale up existing ODA levels through critical sources like private capital funds and foreign direct investment remittances. Experts suggest that these private pools of capital are an underutilised resource. The option of blended finance — combining concessional public funds with philanthropic capital to involve and attract the private sector — can also be explored.

The scale of humanitarian assistance needed is daunting. Almost 360 million are estimated to be in

need of assistance, up from 30% since the beginning of 2022; 80% of the humanitarian needs are driven by conflicts. As per the Global Humanitarian Overview 2024 report released by the UN Office for the Coordination of Humanitarian Affairs, funding requirement for the humanitarian crisis is estimated to be approximately \$46.4 billion this year. Furthermore, in 2023, donors could only meet 35% of the total funding needs of the UN. Worse, climate exigencies are accelerating humanitarian emergencies in the form of extreme weather events.

North Korea fires missiles into Sea of Japan

orth Korea has fired a clutch of short-range ballistic missiles towards the Sea of Japan on Thursday, South Korean news agency Yonhap reported, citing the country's military.

This follows a day after Pyongyang sent hundreds of large thrash and manure filled balloons into South Korea and days after a military spy satellite rocket launch by Pyongyang did not succeed.

The South Korean military also said today that it has detected attempts by North Korea to jam GPS signals for a second straight day.

Meanwhile, the United States has called on North Korea to stop "further unlawful and destabilizing acts," after the latest launch of ballistic missiles into the Sea of

According to South Korea's Joint Chiefs of Staff (JCS), about 10 projectiles were launched around 6:14 a.m. from the Sunan area of Pyongyang and were estimated to have flown about 350 kilometers before falling into the sea, Yonhap reported.

The JCS told reporters that South Korean military has "strengthened monitoring and vigilance" against additional launches and shared information with US and Japanese authorities.

The US Indo-Pacific Command said it was consulting closely with South Korea, Japan and other regional allies and part-"We are aware of the DPRK's ballistic

missile launch," it said adding that the United States condemns these actions and will continue to monitor the situation. The US commitments to the defence of

the Republic of Korea and Japan remain ironclad," it said in a statement. Japan's Prime Minister Fumio Kishida

told reporters in Tokyo that North Korea



had launched a ballistic missile that was believed to have fallen outside Japan's exclusive economic zone and a protest had been lodged with Pyongyang.

A South Korean official was cited by Yonhap as saying that the UN Security Council (UNSC) will convene an open meeting on Friday to discuss North Korea's recent launch of a military reconnaissance satellite that exploded after liftoff, resulting in failure.

UNSC resolutions prohibiting Pyongyang from conducting launches that use ballistic missile technology

On Tuesday, UN Secretary-General Antonio Guterres condemned Pyongyang's launch and urged it to return to dialogue. The US and South Korea have also criti-

cised North Korea for the launch. The Joint Chiefs of Staff (JCS) of South Korea stated that as of Wednesday morning, the military had detected some 260 balloons sent from the North since Tuesday night,

which fell in various locations across the

country, including border areas, Seoul and even the southeastern province of South Gyeongsang. Meanwhile, according to the Korean



Researchers find how areas of brain are associated with helping decisions

esearchers found that a particular brain region-which they identified through a study of patients who had brain damage to that region--controls our willingness to assist others.

Understanding the areas of the brain associated with "helping" decisions is crucial to comprehending how people could be inspired to take on major global issues like infectious diseases, climate change, and international conflict. It is also necessary to discover novel treatments for social interaction diffi-

Researchers from the Universities of Birmingham and Oxford conducted the study, which was published in Nature Human Behaviour. It demonstrates for the first time how the ventromedial prefrontal cortex (vmPFC), a brain region, plays a crucial role in helpful, or "prosocial." activities.

Lead author Professor Patricia Lockwood said: "Prosocial behaviours are essential for addressing global challenges. Yet helping others is often effortful and humans are averse to effort. Understanding how effortful helping deci-



sions are processed in the brain is ex-

be important for decision-making and

tremely important.' In the study, the researchers focused on the vmPFC, a region located right at the front of the brain, which is known to

other executive functions. Previous studies using magnetic resonance imaging (MRI scanning) have linked the vmPFC to choices that involve a trade off between the rewards available and the effort required to obtain rewards.

However, these techniques cannot show whether a part of the brain is essential for these functions. Three groups of participants were recruited for the study. 25 patients had vmPFC damage, 15 patients had damage elsewhere in the brain, and

40 people were healthy age and gendermatched control participants. These groups allowed the researchers to test the impact of damage to vmPFC specifi-

Each participant attended an experiment where they met another person anonymously. They then completed a decision-making task that measured how willing they were to exert physical effort (squeezing a grip force device) to earn rewards (bonus money) for themselves and for the other person. By enabling participants to meet - but not see the person they were 'working' for in advance, researchers were able to convey the sense that participants' efforts would have real consequences, but hide any information about the other person that could affect decision-making. Each choice the participants made varied in how much bonus money for them or the other person was available, and how much force they would have to exert to obtain the reward. This allowed the researchers to measure the impact of reward and effort separately, and to use advanced mathematical modelling to

precisely quantify people's motivation.

The results of the study clearly showed that the vmPFC was necessary for motivation to help others. Patients with vmPFC damage were less willing to choose to help others, exerted less force on even after they did decide to help, and earned less money to help others compared to the control groups.

In a further step, the researchers used a technique called lesion symptom mapping which enabled them to identify even more specific subregions of the vmPFC where damage made people particularly antisocial and unwilling to exert effort for the other person. Surprisingly, damage to a nearby but different subregion made people relatively more willing to help

Co-lead author Dr Jo Cutler said: "As well as better understanding prosocial motivation, this study could also help us to develop new treatments for clinical disorders such as psychopathy, where understanding the underlying neural mechanisms can give us new insights into how to treat these condi-

PARIS: The world number one tennis star Iga Swiatek secured a win over former world number one Naomi Osaka in a gruelling, hardfought second-round game at the ongoing French Open on Wednesday

Swiatek defeated Osaka

by 7-6 (1), 1-6, and 7-5, after both were five-all in the final

The current champion has secured three Roland Garros titles and is considered as one of the finest active players on clay surface. Just five months into her comeback following her

daughter Skai's hirth Osaka pushed Swiatek to her limit and even won a set against the numero uno of women's

In this tense game, no less than a championship final just considering the quality of tennis played, a vintage Osaka was at work.

Following her win, Osaka said as quoted by WTA, "It is hard to have any logical thoughts, because for sure it was really intense and on a really high level. I was in huge trouble in the third set. I honestly did not believe that I could win -that would be pretty naive.

But I managed somehow to win this match. I am glad I did not give up."

Osaka also cried after getting off the court, but 30 minutes late while talking to the media, she remarked that this was the most fun match she has participated in since her comeback.

"It just felt really incredible, the atmosphere, and how fun I guess everyone in the crowd was having, too. It was definitely very memorable for me," she said.

"I kind of realize I was watching Iga win this tournament last year, and I was pregnant. It was just my dream to be able to play her. When I kind of think of it like that, I think I am doing pretty well," he added.

This was Swiatek's 16th successive win at French Open, the most since Justine Henin's 24 straight wins between 2005-10. This also marks the Poland star's 14th straight win this year.

Osaka secured more points, and had 17 more winners and more service breaks under her belt. But Swiatek prevailed at the most crucial junctures to end the match in two hours

NEW DELHI: Gymnast Dipa Karmakar, who secured the gold medal at the Asian Championships, expressed happiness on finally securing the cherished medal after missing out on some opportunities by a narrow

margin earlier and opened up on

the tough journey towards the top

podium finish Karmakar scripted her name in the history books on Sunday after she clinched India's first gold medal in gymnastics in the Asian senior championships

With an impressive total score of 13.566 in the women's vault final, Dipa took the gold medal while South Korea's Kim Son Hyang secured silver and her compatriot Jyo Kyong Byal bagged the bronze. The 30-year-old Olympian registered an average score of 13.566. Kim Son Hyang finished with 13.466 and Jo Kyongbyol with 12.966.

"It feels great. There was a lot of struggles, including surgery. In the last three World Cups, I missed medals by a very small margin. I am speechless. During the competition period, I was focused on just performing, not the result. My scoring was not good on the first day. I wanted to give my 100 per cent during the finals," Karmakar told ANI.

Dipa's journey towards this medal was not an easy one as she battled injuries, and a suspension by the National Anti-Doping Agency for testing positive for a banned substance, which ended
