#### **SC fixes June 26** for hearing Kejriwal's plea against Delhi HC's stay order on bail

**NEW DELHI:** The Supreme Court on Monday fixed June 26 for hearing Chief Minister Arvind Kejriwal's plea against the Delhi High Court order putting interim stay on his bail in the money-laundering case linked to the alleged excise

A vacation bench of Justices Manoj Misra and SVN Bhatti said it would like to wait for the pronouncement of the high court order on the issue

Senior Advocate Abhishek Singhvi, appearing for Kejriwal, sought vacating of the interim stay on the bail

ASG SV Raju, appearing for the ED, opposed the plea of Kejriwal, and said the high court is about to pronounce the verdict on its stay application.

The leaders of the Opposition bloc INDIA staged a protest outside the Parliament on Monday amid the oath-taking of newly elected MPs for the 18th Lok Sabha. The leaders, including Congress president Mallikarjun Kharge, party leader Sonia Gandhi, and Samajwadi Party leader Akhilesh Yadav, were seen holding copies of the Constitution as they protested against the BJP-led NDA government.

Meanwhile, Prime Minister Narendra Modi took the oath as a member of the 18th Lok Sabha on Monday and will be the Leader of the House. The swearing-in of the other

Union ministers and newly elected MPs to be members of the Lower House is under-Pro-tem Speaker Bhartruhari Mahtab is administering the oath to the

newly elected MPs.
Earlier today, President Droupadi
Murmu administered the oath to BJP MP





Bhartruhari Mahtab as the pro-tem Speaker of the 18th Lok Sabha.

Congress and INDIA bloc MPs - who are panel members-refrained from assisting in the oath-taking ceremony of the newly elected MPs during the first session of the 18th Lok Sabha, which began today, expressing dissatisfaction over the appointment of BJP MP Bhartru-hari Mehtab as pro-tem Speaker instead of the eight-time Congress MP K Suresh.

The first session of the 18th Lok Sabha began today with the swearing-in of all newly elected Members of Parliament and will run until July 3. Following the two-day swearing-in ceremony, the election for the Lok Sabha Speaker is slated for June 26, and President Murmu will address a joint session of both houses on June 27. The Leader of the Opposition in the Lok Sabha will be chosen for the first time in

ten years. At the start of the first session of 18th Lok Sabha, Prime Minister Narendra Modi launched a direct attack on the opposition saying the country needs "substance, not slogans, tantrums and drama", even as he expressed hope that the opposition will play a constructive role in the new Lok Sabha starting Monday.

#### **BJP president and Union Minister JP Nadda named Leader of House in RS**

**NEW DELHI: BJP president and Union Health** Minister J P Nadda was on Monday named Leader of the House in Rajya Sabha and may perhaps become the first leader in the party to hold three major posts simultaneously. The Tribune had reported on June 14 that Na-

Nadda's term as BJP president is about to end shortly and he may continue till the time a new

party president is elected. Nadda's rise in BJP ranks continues unabated with the Himachal Pradesh strongman silently eking his way through a complex power structure. Nadda replaces Union Minister Piyush Goyal as Leader of the House in Rajya Sabha. Goyal has been elected to the Lok Sabha.

#### **Unfortunate that acts glorifying** terrorism allowed in Canada routinely: Indian High Commission

OTTAWA: Terming the frequent acts glorifying terrorism in Canada as 'deplorable', India has said it was 'unfortunate' that such actions are allowed to be 'routine' on many occasions here when it should be condemned by all peace-loving countries and people. In a statement on the 39th anniversary of the 1985 Kanishka bombing, in which 329 persons, most of them Canadians of Indian descent, on board an Air India flight lost their lives, the Indian High Commission said that terrorism knows "no borders, nationality, or race". The Montreal-New Delhi Air India Kanishka Flight 182 exploded 45 minutes before it was to have landed at London's Heathrow Airport on June 23, 1985, killing 86 children. The bombing was blamed on Sikh militants in retalia-Operation Bluestar' to flush out militants from the Golden Temple in 1984. The Indian High Commission in Ottawa and the consulates of India in Toronto and Vancouver organised memorial services, on Sunday, and solemnly remembered the victims of the 'dastardly act of terror'.



Applicants are required to submit their applications either before or within 30 days of the marriage date. To enhance transparency, the Punjab Government launched the Ashirwad portal

in April 2023 for online application submissions.

She further added that eligibility criteria for the Ashirwad scheme require applicants to be permanent residents of Punjab, belong to the Scheduled Castes, Backward Classes, or Economically Weaker Sections, have an annual family income of less than Rs. 32,790 and fall below the poverty line. Financial assistance is available for up to two daughters per eligible

of reserved categories and 50 percent for those from general categories on the insurance of livestock in the state" Kanwaljit disclosed while adding that this rebate is offered by the department of Dairy Development Punjab under 'national livestock mission'

scheme. He also said that under this scheme a person can get upto five milch animals insured and each milch animal would be valued upto rupee

seventy thousand. He disclosed that one can get any animal insured by paying the insurance premium after deduction of rebate. Though the owners of animals were earlier supposed to pay hefty insurance premiums. But now after rebate one needs to shell out rupee 1,120 for one year, 2, 100 for two years and rupee 2,800 for a period of three years per milch



#### **Gazetted and special paid holiday** declared for bye-elections

A spokesperson of the state government informed here today that on account of the bye-election (in case poll is held) on 10 July 2024, a gazetted holiday has been declared in Dehra, Hamirpur, Nalagarh Assembly constituencies. This holiday will be applicable to the employees of all the government offices, Boards, Corporations, educational institutions and industrial establishments to enable them to exercise their right to franchise. This will also be a paid holiday for daily wage employees on poll day as provided in Section 135 B of the Representation of People Act, 1951. The spokesperson said that it will be a special paid holiday for registered voters of Punjab State working in the border areas of Una, Kangra, Chamba, and Solan districts due to the bye-election to Assembly Constituency Jalandhar West in Punjab. Additionally, a special paid holiday has been declared on the same day for registered voters of Uttarakhand State working in the border areas of Sirmour and Shimla districts in light of the bye-election to Badrinath and Manglaur Assembly Constituencies of Uttarakhand. This special paid holiday would be applicable to all government and semi-government employees, as well as employees in industrial establishments who are registered voters in the mentioned states under Section 25 of the Negotiable Instruments Act, 1881. The Spokesperson said that apart from this, a special casual leave may be granted to employees working in different places in Himachal Pradesh but voting in other constituencies within the state, upon production of a certificate from the Presiding Officer confirming that the employee has cast their vote.

#### **Constitution destroyers now pretending** to be protectors: Suresh Bhardwaj



SHIMLA: Former BJP state president and former minister Suresh Bhardwaj addressed a press conference, criticizing the Emergency imposed by Indira Gandhi, labeling it as the darkest chapter in India's history. #### Paddy straw based state of art RE power plant re-commissioned after about 15 years

PATIALA (RAWEL BHINDER): Power Minister . Harbhajan Singh E.T.O. today announced the successful recommissioning of the 10MW Biomass Power Plant at Village Jalkheri, District Fatehgarh Sahib, highlighting its significant environmental and economic benefits for Punjab.

PSPCL's 1x10MW Biomass Plant at Village Jalkheri (Dist. Fatehgarh Sahib) was originally com-

missioned in June 1992. The plant remained operational till July 1995 after which it was given on lease to M/s Jalkheri Power Plant Ltd (JPPL) in July 2001. The plant was recommissioned in July 2002 and remained operational till September 2007. In 2012, efforts were made to restart the project by giving a licence to a private developer to run it for a specific period by giving it on lease. In 2018, the plant was re-tendered to be leased out on ROT basis.



Now the renovated plant has been recommissioned on June 21, 2024 and officially commenced operations. It utilizes advanced Denmark Technology boilers and is designed to generate electricity using 100% paddy straw. This state-of-the-art facility biomass plant will consume approximately 1 lakh tons of paddy straw annually which will help state government to curb the problem of stubble burning in nearly 50 thousand acres of area in Punjab. This initiative will provide direct and indirect employment to 400-500 individuals, fostering eco nomic growth in the region.

# **India slams Canada for allowing** glorification of acts of terrorism

NEW DELHI/OTTAWA, JUNE 24

Observing the 39th anniversary of the Kanishka terror bombing, India said that any glorifying terrorism should be condemned, and slammed Canada for allowing such glorification to be routine on many occasions.

In a statement, the Indian High Commission in Ottawa said the bombing of the Air India flight 182 by Khalistani terrorists is the worst ever in Canadian aviation history to date, and pointed out that "the perpetrators and the coconspirators of this dastardly act remain free".

"While thirty-nine years have passed since the cowardly act, terrorism has unfortunately assumed proportions of an existential threat peace international and security today. "Any act of glorifying terrorism, including

the bombing of Al-182 in 1985, is deplorable and should be condemned by all peace-loving

countries and people," it said. "It is unfortunate that such actions are allowed to be routine on many occasions in Canada.' it added. The AI flight 182 Kanishka on June 23, 1985 from two baggage handlers. The statement by the Indian HC in Toronto with a brief stopover at Montreal was en route to New Delhi when it exploded off the coast of Ireland while preparing to land at Heathrow airport. The mid-air explosion which killed

all the 329 people on board is widely considered to be one of the world's deadliest acts of terrorism and civilian aviation sabotage. It was one of two related bomb explosions carried out by Khalistani terrorists. The

other explosion occurred at the

## Various grant schemes launched for fish farming **Scheduled Caste families: Ranjana Rani**

The Haryana government has launched various grant schemes for the welfare of Scheduled Caste families engaged in or interested in fish farming business, so that their social upliftment can be ensured by increasing their livelihood. District Fisheries Ranjana Rani Officer informed that for leasing rural ponds for fish farming, a grant of Rs 50,000 per hectare or 50 per cent of the actual lease amount, whichever is less, will be given on the lease amount during the first year, maximum limit of which will be Rs 2 lakh. She informed

that a grant of 50 per cent of total amount sanctioned for fishing in notified waters or up to a maximum of Rs 5 lakh will be given. Similarly, on purchase of a cart worth Rs 60,000 for sale of fish products established by department, 60 per cent or maximum of Rs 36,000, whichever is less, will be given to the beneficiary.

He informed that fish farmers will be given a subsidy of 60 percent or up to Rs 24 thousand, whichever is less, on the purchase of nets worth Rs 40 thousand. Similarly, a subsidy of 60 percent of Rs 150000 per hectare or Rs 90,000 per hectare will be given on

fertilizers and feed, the maximum limit of which is limited to 4 hectares. He informed that a maximum subsidy of Rs 40 thousand per hectare or 40 percent, whichever is less, will be given on lease amount of the second coming year. Fisheries officer informed that this financial assistance is for beneficiaries of Scheduled Caste and a certificate of Scheduled Caste should be attached with application form. #### **Editorial**

#### **Cancel Neet-UG exam** and hold retest for all

fter dithering over weeks despite strong observa-Hions by the apex court, the Union government has finally acknowledged the possibility of foul play in the National Eligibility-cum-Entrance Test for undergraduate medical courses (Neet-UG) and ordered an investigation by the Central Bureau of Investigation (CBI) into the "cases of alleged irregularities/cheating/impersonation/malpractices" in it.

A barrage of reports on the other competitive examinations, including the National Eligibility Test (NET) and the CSIR-UGC NET examinations, has also forced the government take a series of measures, which include the removal of the head of the National Testing Agency (NTA) and the setting up of a review panel of experts to make the conduct of the competitive examinations fool proof. The government has also postponed the Neet examination for post-graduate courses which was scheduled for June 23.

The events that unfolded after the publication of the Neet-UG results on June 4 in which an unprecedented number of 67 students scoring full marks should have prompted the government to act with alacrity and take immediate steps to see if something had gone wrong. But it did not; it was in denial instead. That even the Supreme Court openly questioning the sanctity of the examination did not awaken the government from its slumber, with the education minister, Dharmendra Pradhan, claiming that there was no evidence of leakage of the question papers and dismissing the allegations as being motivated.

The government, which is "committed to ensuring the sanctity of examinations and protect the interest of students", now has been forced to act but only after it was pushed to the corner by a turn of events unacceptable to people who believe in the systems which the country has built assiduously over the decades. The removal of the head of the NTA should have immediately followed the surfacing of the serious allegations.

However, it defies logic that Mr Pradhan, who presided over the decadent system that failed the students and the nation at large, before, during and after the examinations, is being allowed to continue. That the corrosion in the system is so pervasive that it has almost brought itself down has not dawned on him yet. One can only hope that the review panel under the former chairman of the Indian Space research Organisation, comprising people in the higher education system, will be able to identify the moles and loopholes.

# The pursuit of learning in Nalanda's homeland

t is ironic that Prime Minister Narendra Modi was extolling the virtues of Asia's oldest centre of higher learning at Nalanda in Bihar in the same week when a controversy around the national testing of the educational attainments of students was engaging nationwide attention. Nalanda Universi ty did not become world famous overnight. It took long years of scholarship of learned men and women for the institution to earn its reputation.

"Learned men from different cities who desire to acquire renown in discussion, come here in multitudes to settle their doubts, and then the streams of their wisdom spread far and wide", wrote the Chinese Buddhist monk Hieun Tsang after his mid-7th century visit. By then Nalanda was already at least a 100-year-old institution, if not more. How many Indian universities set up in the 20th century have been able to protect their reputation into the 21st Nalanda is a question and a reminder.

The Indian civilisation, with all its faults and inequalities, was a knowledge-based civilisation, like any other great civilisation. It respected scholarship and the flights of imagination. On his visit last week to the Nalanda University campus, Prime Minister Narendra Modi lamented its destruction. The point is most that the person responsible for Nalanda's destruction was a Muslim invader. In the same week, a movie aimed at damaging the already "blemished" reputation of contemporary India's best-ranked university was released in cinema halls. Titled Jahangir National University, the movie has been pitched as an attack on Jawaharlal Nehru University, a public university that the Union education ministry's own ranking places it at the top of Indian universities

Of what use is the lament of past tragedies when new ones occur every day



and we learn so little from the experience of the past? There is, however, no point in engaging in the usual political blame game. No political party, no PM, no CM, no minister for education at the Centre or in the states can be absolved of the responsibility for the sorry state of public universities today. Nor, indeed, can they be pardoned for presiding over the extensive privatisation of education at all levels

None other than the political, business and intellectual elite of the country have demonstrated their lack of pride in the country's educational system. Just look at how

many of them take pride in the fact that their children have studied or are studying

Till a couple of decades ago, most students going overseas went for post-graduate education. Today they also do for undergraduate and even high school education. The Covid-19 lockdown and suspension of cross-border travel brought the extent of such elite dependence on overseas education to the fore. Some attribute the rise in numbers to the growing prosperity of the Indian middle class. Perhaps so. However, what is striking is that even as more Indian students

go overseas, fewer foreign students are coming to India.

According to data collected by the ministry of external affairs, the number of Indian students studying overseas was estimated to be 13.24.954 in 2022. This does not include the 20,000 students forced to return home that year from Ukraine after the outbreak of war with Russia. The MEA data also probably underestimates the number of Indian students studying in China, at 6,000, since many who returned home after the Covid-19 outbreak did not go back. Given news reports of increasing numbers of Indian students going overseas in the past year, one can safely presume that the number in 2024 would be upwards of 14 lakhs.

By comparison, the number of foreign students studying in India was estimated to be 46,878 in 2022, according to the All-India Survey on Higher Education conducted by the Union ministry for human resources development. While most Indian students going overseas are concentrated in the United States, Canada, Australia and the UAE, most foreign students in India are nationals of Nepal and Afghanistan

Most foreign students studying in India are concentrated in four states: Karnataka, Maharashtra, Telangana and Delhi.

There was a time when Indian universities attracted many students from Africa. The numbers have dwindled with many Africans headed to China. In 2019, before Covid-19, over 80,000 African students were studying in China compared to 25,000 in In-

There may be any number of reasons why foreign students do not prefer Indian universities over campuses in China or else where. We must reckon with the fact that we are not considered to be an attractive destination by comparison to others

#### **Coping with Polycystic Ovary Syndrome**

ARA (26) was 13 when she was diagnosed with polycystic ovary syndrome (PCOS). Initially, her doctor attributed excessive acne on her face and back, thick facial hair, weight gain and hair fall to hormonal adjustments during teenage years. Symptomatic treatment didn't help, with acne and other symptoms only worsening. After a year, she lasted a few months but the associated risks and management are lifelong.

Sonepat-based Namita (37) was diagnosed with PCOS at 28. She would experience irregular periods and struggled with weight. An ultrasound during treatment for a urinary tract infection (UTI) revealed heavy and bulky ovaries, indicating PCOS. A hormonal disorder prevalent among at least 20 per cent young Indian women, it impacts fertility, besides leading to serious health issues. A mother of a toddler now, Namita's journey to conception was long and difficult.

Many studies have also found women with PCOS at a higher risk of developing



diabetes. Namita has to take metformin for life. Sara, too, became a pre-diabetic during the lockdown after gaining

#### Study finds how blood tests predict Parkinson's seven years before symptoms

group of scientists from University College London (UCL) and University Medical Center Gottingen have created a straightforward blood test that employs Artificial Intelligence (AI) to forecast Parkinson's disease up to seven years before symptoms appear.

Parkinson's disease, which presently affects about 10 million people worldwide, is the neurological ailment with the greatest

The illness progresses over time and is  $% \left\{ 1,2,...,n\right\}$ brought on by the death of nerve cells in the substantia nigra, a region of the brain that regulates movement. Because of the accumulation of the protein alpha-synuclein. these nerve cells degenerate or malfunction, losing their capacity to generate the vi-

tal neurotransmitter dopamine. Currently, people with Parkinson's are treated with dopamine replacement therapy after they have already developed symptoms, such as tremor, slowness of movement and gait, and memory problems. But researchers believe that early prediction and diagnosis would be valuable for finding treatments that could slow or stop Parkin-




son's by protecting the dopamine producing brain cells. Senior author and Professor Kevin Mills (UCL Great Ormond Street Institute of Child Health) said, "As new therapies become available to treat Parkinson's, we need to diagnose patients before they have developed the symptoms. We cannot regrow our brain cells and therefore we need to protect those that we have.

"At present we are shutting the stable door after the horse has bolted. We need to start experimental treatments before patients develop symptoms.

This was a man who successfully introduced us to weight loss through intermittent fasting. He had experimented often with food and diet and was a health guru on the BBC. His sudden death — and the subsequent hunt for his body — shocked the

Though I loved watching his shows, I never tried his diet or followed his advice — but many people did all over the world. And to think it was just heat and perhaps dehydra-



tion that would ultimately destroy him... Fat or thin — life can be taken away in an instant! So diet all you want — but live life to the fullest.

Another person whose life changed so very suddenly — despite leading what looked like a charmed one — is Catherine, Princess of Wales. Finally she came out in the public af-

ter her cancer diagnosis, though she did appear very much more serious than she had been before. There was no public interaction which she had been very good at. She was able to perform her duty surrounded by her children and husband. This was much appreciated as she has been frank about her cancer in recent weeks. Indeed, King Charles as a fellow cancer suffer er had elevated Kate to Companion of Honour in recognition of her determination to go public about her ailment This has had a very good impact on. the way people view cancer.

However, it seems she is now focussed on projecting Prince William as a father, possibly concerned about what lies ahead. A keen photographer, she recently released some love ly photos on his birthday which showed the future King playing on the beach with his children. These only depict Prince William with the children, all rather poignant moments, as she is not in them.

Dr. Aggarwal explained that the nomination papers of the following candidates were rejected: Anju Angural (covering candidate, BJP), Karan Suman (covering candidate, Congress), Atul Bhagat (covering candidate, AAP), and Paramjit Mall (covering candidate, BSP) because the main candidates' nomination papers were found valid. Additionally, the nomination papers of Iqbal Chand were rejected due to a proposer being from Hoshiarpur district, Balwinder Kumar due to lack of the required 10 proposers, and Mahinderpal for not signing the nomination form 2-B as a candidate and also lacking the required 10 proposers.



#### Robbery at closed plywood factory in Hadoli, guards beaten by masked thieves
