AGENCY WAYANAD (KERALA), JULY 30

Heavy rains triggered a series of massive landslides in the hilly areas of Kerala's Wayanad district early on Tuesday, leaving at least 108 persons dead and sparking apprehensions of possible increase in fatalities due to hundreds of people feared trapped under the debris.

Calamity struck in the early hours of

Tuesday, catching the sleeping victims offguard. Frantic calls for help were made and the rescue personnel were racing against time to pull out survivors.

In connection with the landslide in

Chooralmala she confirmed that 36 deaths have been reported. Additionally, nine bodies swept away by the Chaliyar River were recovered in Malappuram.

The bodies of the deceased are being taken to various hospital morgues for

identification and autopsy. Mundakkai, Chooralmala, Attamala, and Noolpuzha villages were among the areas affected and cut off by the landslides, authorities said. Rescue teams were working tirelessly to evacuate those stranded, with the Indian Army joining the efforts. Besides the National Disaster Response Force (NDRF), the state government has also deployed disaster response teams from the police and the fire force to affected areas.

PM talks to Kerala CM, announces Rs 2 lakh ex-gratia

WAYANAD (KERALA) (UNI): Prime Minister Narendra Modi, who spoke to Kerala Chief Minister Pinarayi Vijayan over phone, has announced an ex-gratia of Rs 2 lakh from the Prime Minister's National Relief Fund (PMNRF) for the next of kin of each deceased in the landslides in parts of Wayanad on Tuesday. "The injured would be given Rs 50,000. Distressed by the landslides in parts of Wayanad. My thoughts are with all those who have lost their loved ones, and prayers are with those injured," the PM said in a post on X. "Rescue ops are currently underway to assist all those affected.

One of the key amendments introduces life imprisonment for those found guilty of "love jihad" in the state.



Chief Minister Thakur Sukhvinder Singh Sukhu inaugurated the 75th Statelevel Van Mahotsav by planting an oak sapling at his official residence, Oak Over, today. officers of the State Forest Development Corporation to expedite tree removal following the first phase approval of the Forest Conservation Act, particularly for linear projects. The Chief Minister also launched the beta testing of the e-forest software, a new digital initiative aimed streamlining departmental operations and enhancing transparency within the Forest Department. He emphasized the importance of increasing the plantation of fruit trees in forest areas from 30 percent to 60 percent, with anticipated positive outcomes within the next ten years. He highlighted that the Forest Department and Corporation processed 15,000 salvage trees last year, generating substantial revenue from timber sales, which resulted in an increase in the state government's royalty

income from Rs. 35 crore to Rs. 70 crore in just one and a half years. In a strategic shift, the State Government has decided to shut down the construction wing of the Forest Department to allow it to concentrate on core forestry activities. In Lahaul-Spiti district, Mahila Mandals have been engaged in plantation and activities conservation, generating revenue for these women's groups. The Chief Minister remarked that the current State Government has undertaken numerous initiatives for 'Vyavastha Parivartan' (systemic transformation). 

Monsoon is seen wreaking havoc in Himachal Pradesh this year as well. Like last year, this year too, reports of continuous damage are coming in many parts of District Kullu and District Mandi along



with District Shimla. In this incident that took place in Manikaran of District Kullu, many shops were washed away in the strong flow of water. Apart from this, some parts of a private hotel have also been damaged. After the cloudburst like situation here, the bridge connecting Nakthan also got washed away due to sudden rise in water level. The relief in this incident is that there is no news of any casualty in this entire incident. According to the local people, the water level in the drain suddenly increased late at night and cloudburst like situation arose.

HP revenue officers' protest hits online work



Rajya Sabha Chairman Jagdeep Dhankar expressed concern over the loss of lives in Wayanad landslides. He said that the Central and state governments are taking necessary steps.

Speaking in Rajya Sabha, Union Minister JP Nadda said that the central government under the leadership of Prime Minister Narendra Modi is working proactively given the tragedy. He said that work was being

done in coordination with the state government. "I would like to say this is a tragedy of not just Kerala alone, but the entire nation is concerned. 

Under India's bridges

A sthe summer sun cast its relentless heat on Delhi's streets, a distressing scene unfolded beneath its bridges — a scene that resonates far beyond the confines of India's capital. Across the length and the breadth of the nation, under bridges lie the forgotten souls of our society — the homeless people — seeking refuge amidst sweltering heat, dust storms and deluges.

According to the data from the ministry of housing and urban affairs, India's homeless population is estimated to be around 1.77 million. However, the actual number is likely to be significantly different from the data recorded in the 2011 Census. Recent trends have indicated a decline in multidimensional poverty. However, the progress has been overshadowed by social inequality, unemployment, evictions, and natural disasters. The plight of the homeless serves as a stark reminder of the systemic failures that perpetuate poverty and inequality.

The challenges faced by the homeless are particularly acute during India's scorching summer when the risks of heat stroke and dehydration are high. Homeless women, especially young women, are disproportionately affected by violence, trafficking and sexual exploitation. They also face severe obstacles in accessing healthcare and education.

Addressing homelessness demands a nationwide commitment to social justice and equity. It also requires niche policies that prioritise the needs of marginalsed communities so that they can break free from the vicious cycle of poverty and despair. This not only mandates the provision of shelters and support services but also substantial investments in affordable housing, healthcare, and education. A comprehensive approach targeting the root causes of homelessness along with greater collaboration among such stakeholders as government agencies, non-profit organisations, civil society, and the private sector is necessary. The multifaceted challenge that is homelessness can be addressed only through collective effort and the pooling of resources

According to the Indian Constitution, the right to adequate housing is enshrined as a fundamental right, with Articles 14, 19, and 21 playing pivotal roles in safeguarding an individual's dignity. Over the past few decades, India has made significant strides in addressing the plight of the homeless. Initiatives such as the Footpath Dwellers Night Shelter Scheme, intro-duced during the 8th Five Year Plan, marked a crucial step towards providing shelter to the vulnerable. Subsequent plans, including the recognition of the right to access housing as a fundamental right in the 11th Five Year Plan, underscored the government's commitment to tackling homelessness

Xi maintains his laser-like focus at China's third plenum


he Third Plenum - a meeting of Central Committee members held from 15-18 July to clarify China's long-term economic and social policies - illustrated how Chairman Xi Jinping is holding unwaveringly to his vision for China. It also demonstrated how he is ignoring calls for any course correction.

A total of 199 members and 165 alternate members attended this plenary session of the 20th Central Committee, held nine months late. Xi's overarching objective is to attain a "high-standard socialist market economy in all respects" by 2029, with Xi Jinping Thought acting as the guiding light.

Since 1982, the Chinese Communist Party (CCP) has usually convened seven plenums every five years. Whereas the first and second plenums in each five-year term focus on senior party leadership appointments and restructuring of governmental institutions, the third plenum typically introduces major policy initiatives for the next 5-

This Third Plenum was the first since November 2013 and, reflecting China's increasing opacity, the CCP offered no explanation as to why it was delayed for so long. The party also simply announced refinements of existing measures, rather than any major shift in strategy. Markets reacted glumly to Xi's unwavering trajectory, with Chinese stocks promptly suffering their largest decline in six months.

Neil Thomas, a Fellow on Chinese Politics at the Asia Society Policy Institute's Center for China Analysis, pointed out how draft decisions in 2013's plenum invoked 2,564 comments and 539 revisions, equating to a 21 per cent acceptance rate for modifications. On the other hand, the 2024 plenum's draft drew 1.911 comments and just 221 revisions, a remarkably lower 12 per cent ac



ceptance rate. Thomas thus concluded, "Cadres are less willing to speak, and Xi is less willing to listen... There is less internal policy discussion; cadres sent 25% fewer comments." The academic added, "In 2013, Xi chaired several plenary meetings of the drafting team.

This year, he just reviewed drafts, gave instructions and read notes from team interviews with other leaders. Xi seems increasingly secluded from lower-level officials and less interested in policy debates.'

The CCP, in an 18 July communique, patted itself on the back. "At the session, the Central Committee gave a highly positive assessment of the success and achievements we have made in comprehensively deepening reform since the beginning of the new

era, and studied the issue of further deepening reform comprehensively to advance Chinese modernization.

However, members were cognizant of growing challenges: "It was stated that the present and the near future constitute a critical period for our endeavor to build a great country and move toward national rejuvenation on all fronts through Chinese modernization.

China's position is "serious and complex," it said. Indeed, COVID-19 precipitated am existing crisis, including weak consumption, a slowing economy and unequal wealth distribution.

Xi highlighted five foci at the plenary session. The first was the "leading role of economic system reform". Of course, "re-

form" in Chinese vocabulary has a vastly different connotation to its meaning in the West. Chinese "reforms" do not mean altering direction but, rather, minor technical adjustments. After all, major shifts in strategy would be an admission that the CCP had been mistaken, something anathema to authoritarian systems. Economically, the communique stated, "We must better leverage the role of the market, foster a fairer and more dynamic market environment, and make resource allocation as efficient and productive as possible. We will lift restrictions on the market while ensuring effective regulation, striving to better maintain order in the market and remedy market failures.

Perhaps surprisingly, the communique glossed over the need to raise domestic consumption. Household consumption in China, expressed as a percentage of GDP, plummeted after 2019.

China wants to lure back Western companies too, as net inflows of foreign direct investment collapsed. After reaching their acme in 2021, by 2023 China had suffered a 90 per cent drop in investment to just USD33 billion. This amount represented a 30-year

However, Xi did not offer any positive recommendations as to how this situation could be reversed. Instead, China articulated rhetorical goals of "fostering a first-rate business environment that is market-oriented, law-based and internationalized, and protecting the rights and interests of foreign investors in accordance with the law"

With China surreptitiously supporting Russia's war in Ukraine, Western restrictions are only likely to increase. Furthermore, spooked private companies are reshoring in their home countries or moving operations to the likes of India, the Philippines, Thailand or Vietnam

Uyghurs in US commemorate 10th anniversary of Yarkand massacre

he Uyghur community, led by the East Turkistan Government in Exile (ETGE) and the East Turkistan National Movement (ETNM), gathered in Washington, DC to commemorate the 10th anniversary of the 2014 Yarkand massacre.

The event called for urgent US action against China's ongoing persecution of Uyghurs. Yarkand massacre occurred on July 28, 2014, when Chinese security forces brutally suppressed peaceful Uyghur protesters in Yarkand County, Xinjiang, China

In a recent post on X, the East Turkistan Government in Exile (ETGE) highlighted the significance of the commemora-



tion, stating, "#Uyghurs in DC, led by ETGE and ETNM, commemorated the 10th anniversary of the 2014 Yarkand Massacre, in which 3,000 to 5,000 Uyghurs were killed by Chinese forces, and called on the US Government to take action to

end #China's ongoing #UyghurGenocide."

Reports indicate that between 3,000 and 5,000 Uyghurs were killed by Chinese forces during the violence, and is a stark reminder of the ongoing genocide faced by the Uyghur people at the hands of the Chinese government.

The Yarkand massacre exposes the multifaceted oppression enforced by the Chinese government against the Uyghurs. Indiscriminate force is routinely abused, they are branded as "gangs" and "separatists." Moreover, the Chinese government covers up the death count and arrests netizens who aim to expose the

At the commemoration event, Uyghur leaders and activists called on the US to adopt a more robust stance towards China, akin to its approach towards Tibet.

They advocated for the passage of the Senate's Uyghur Policy Act and the appointment of a Special Coordinator for East Turkistani issues within the State Department. The speakers emphasised the critical need for US support in restoring East Turkistan's independence, underscoring the importance of international intervention to halt the persecution and ensure justice for the Uyghur people.

The East Turkistan National

Movement (ETNM) is a nonprofit organisation dedicated to human rights and political advocacy. Established in Washington, DC, in June 2017 by Salih Hudayar, a Uyghur American consultant and graduate student, ETNAM has been at the forefront of raising awareness about the plight of Uyghurs.

East Turkistan, a name historically used and favoured by many advocacy groups, refers to the Xinjiang Uygur Autonomous Region (XUAR). Reports on human rights violations in Xinjiang highlight severe abuses against Uyghur Muslims and other minority groups.

Significant decline in malnutrition among children: Dr. Baljit Kaur

CHANDIGARH, JULY 30

The Punjab government, under the leadership of Chief Minister Bhagwant Singh Mann, continues to prioritize the welfare of children and women alongside other sectors. To further this objective, Social Security, Women and Child Development Minister Dr. Baljit Kaur convened a meeting with District Program Officers and Development Project Officers on Tuesday at MGSIPA to discuss crucial departmental schemes and issues.

During the meeting, Dr. Baljit Kaur highlighted that the Punjab government has achieved a significant reduction in malnutrition among children under Chief Minister Bhagwant Singh Mann's tenure. Union Women and Child Development Minister Annapurna Devi confirmed in a written reply in the Lok Sabha on July 26 that stunting among children in Punjab has decreased from 22.08% in 2022 to 17.65% in 2024, wasting has reduced from 9.54% to 3.17%, and underweight children have declined from

12.58% to 5.57% Dr. Baljit Kaur stated that Punjab has been ranked first among neighboring states, including Haryana, Himachal Pradesh and Rajasthan, in

reducing malnutrition among children. Official statistics show a rapid decline in the number of malnourished children in Punjab over the last two years. According to the 'POSHAN Tracker,' key indicators such as stunting, wasting and underweight have significantly improved among children aged 0-5 years in the state. Addressing reports of a scam in the distribution of panjiri to children at Anganwadi centers in Punjab, Dr. Baljit Kaur gave clear instructions and protocol for

lapse in the implementation of the scheme would face strict action, as the food provided at Anganwadi centers directly affects the health of children, pregnant women and lactating mother. Dr. Baljit Kaur also highlighted the 'POSHAN Tracker,' a mobile-based application launched by the Ministry of Women and Child Development, Government of India, which identifies stunted, wasted and underweight children. The Tracker aims to provide nutritional services to the most vulnerable members of society. The minister noted that nutrition profile of the items delivered has been revised to tackle malnutrition more effectively, emphasizing dietary diversity and fortified foods to meet protein, healthy fats and micronutrient requirements.
