Contractual employees get job security in Haryana

Haryana government led by Chief Minister Sh Nayab Singh Saini has made a historic decision to ensure job security for contractual employees. This move will benefit approximately 1.20 lakh contractual employees across the state. The decision will apply to employees working under HKRN, including those engaged under outsourcing policy Part-1 and Part-2

Haryana Cabinet which met under the chairmanship of Chief Minister Sh. Nayab Singh Saini here today approved to bring the Haryana Contractual Employees (Security of Tenure) Ordinance 2024. This ordinance will enhance facilities for contractual employees and guar antee their job security until the age of superannuation. Cabinet also approved to give a Bonus on Kharif crops in Harv ana. With this decision, farmers will receive Rs. 2000 per acre one time bonus for all Kharif and Horticulture crops.

The farmers and other Kisan Organizations of the State were raising issues of high input costs due to adverse weather conditions this year for Kharif Crops This year, heat waves/stress caused more water consumption and other crop-maintaining inputs. Further, it has also been observed that there is a deficit

He wrote on X (earlier Twitter) that Haryana's brave daughter Vinesh performed amazingly to reach the Olympic final.

According to this ordinance, the state government has established provisions to ensure job security for all contractual employees working across various state departments, including Hary-

ana Kaushal Rojgar Nigam, until their age of superannuation. Contractual employees who complete 5 ears of service by August 15, 2024, will be eligible under this decison. They will receive a basic salary equivalent to the pay scale of posts. Additionally, their consolidated monthly remuneration will be increased with effect from first day of

January and first day of July every year corresnding to the increase in Dearness Allowance. The ordinance also includes provisions for an annual increment on the consolidated monthly remuneration for contractual employees after one year of service. These employees will be entitled to death-cum-retirement gratuity benefits. In addition, contractual employees will also be eligible for all the benefits under the Maternity Act. Under the PM-Jan Arogya Yojana-Chirayu Extension Scheme, the families of contractual employees will also be provided the benefit of health facilities. However, employees earning more than Rs 50,000 per month will not be covered. Those working under centrally sponsored schemes will also be excluded. Those who have worked for 5 years or more will get 5% more pay than the minimum pay level of the same post in addition to the consolidated remuneration.

Centre introduces Waqf (Amendment) Bill in LS, Oppn calls it draconian law

The Central government on Thursday introduced the Waqf (Amendment) Bill, 2024, in the Lok Sabha amid protest

by the Opposition.

The Bill was introduced by the Union Minister of Minority Affairs Kiren Rijiju, aimed at amending the law governing Waqf boards, proposes far-reaching changes in the Wakf Act. 1995

Speaking in the Lok

Sabha while introducing the Bill, Kiren Rijiju said, "This bill being brought today is based on the report of the Sachar committee which was made by the Congress and which called for reform.

"With this bill, there is no interference in the freedom of any religious body. Forget about taking anyone's rights, this bill has been brought to give rights to those who never got them" he added.

Soon after the Bill was in troduced, Congress MP KC Venugopal, who had submitted notice to oppose its introduction, accused the government of violating freedom of religion and attacking the federal system through it.

"This is a draconian law and a fundamental attack on the Constitution," Venugopal

Samajwadi Party leader Habibbullah opposed the bill and said, "Waqf is a religious matter and this legislation is interference in religious

practice"

Financial stability is challenge for the 'stable' CM

he 'Sukhu' government in Himachal Pradesh which has recovered not only from natural disasters but from many calamities, is stable. Now the next challenge is to maintain finan-

cial stability in the state. During last one and a half years of congress government's power in Himachal, many political storms came, and the 'swaying' government couldn't work properly. This was the reason, neither the administration nor the MLAs themselves took the government's performance seriously. In the exercise of saving the chair and persuading the disgruntled, Congress ultimately won the game. Meanwhile, the BJP sitting in opposition suffered considerable loss to obtain a Rajya Sabha seat

Whether it was the terrible nat-ural disaster that hit the state last vear, or the case of his own people showing eyes to 'Sukhu' in the Rajya Sabha seat elections, or the by-elections along with the Lok Sabha, these were all Sukhu'spolitical stormy trials, and in these, he won the lost game along with getting his wife to the assembly.

This was the first time in the political history of Himachal Pradesh when someone got an opportunity in disaster itself during the storm of by-elections. This political disaster taught such a lesson to many enthusiastic leaders including Congress rebels, which was a clear message of not messing with the simple traditions of Dev Bhoomi like Himachal Pradesh.

Now it's time for the stable government to clean up the mud of political nests uprooted by the storm. While the

financial condition of the state is a big cause of concern for the government, the poor financial situation is also troublesome for employees, and people associated with horticulture and tourism businesses. Sensing this danger, Sukhu's Congress government in the state is taking bitter decisions. Or let's say, making impractical decisions more practical.

Himachal is neither a poor state, nor is there a situation of starvation. But people want to get the comfort of government jobs more than private or tourism business. This is where the political game is laid out. Creating the influence of employees on parties. The Congress government in the state had come to power on the issues of pension and wallet allowance. But pensions, salaries, allowances became so heavy that development works were questioned. On top of that, the fury of disaster. Increment, arrears payment is also

a long list leading increase of debt burden. Now it's imperative for the Sukhu government to take bitter decisions. In the cycle of pension, electricity also went out of hand and transport fare was charged on bags in buses. Apart from these economies, the government is trying to recover crores of rupees in Himachal from forests and electricity. For this, electricity and forest advisors have also made strong promises, but it seems difficult that the central government will accept the advocacy of the government of opposition parties.

In such a situation, two difficulties of the Congress government may increase in the coming time. First, the fulfilment of the incomplete promise of pension. That is, the displeasure of not getting pension in boards - corporations, constitutional institutions, second, tightening the reins on the scheme of free habit. 'Free' electricity closed, 'free' travel closed, 'free' water closed,

if these are closed then 1500 rupees going into the wallet will make a way. It is discussed that there was promise of giving free in the party manifesto but there was no declaration of closing the free schemes. From these decisions, the Sukhu government may face political difficulties, which BJP will exploit well. Neither will the centre govern-ment have mercy on Himachal, nor will Congress be able to bring a special budget to the state Overall, if Sukhu's scissors run on

impractical decisions of half a decade, the financial condition will not improve in a jiffy, but it can be considered a step towards improvement. It is impossible to change the system of 50 years in just five years. Until solid policies are placed on the ground.Whether it's the path of self-reliance from tourism, or employment system for the people of the state, or rapid improvement and change in agriculture, horticulture

and animal husbandry. If future plans are run with administrative strength system change will be visible in the next five years. For example, it should be decided that in five years all hotels of the Tourism Corporation will be in profit. Or there should be subjects related to skill job opportunities and teachers posts in schools and colleges will be filled. There should not be a race for re-

cruitment of Patwari and Constable. Every house should be healthy, every house should have drinking water The path of every house should be safe. If these fundamental changes happen, there will be no need to close anything. For system change, the formula of change should be applied instead of 'closure'. Woman drug smuggler among two held from Ferozepur; 6.6kg heroin, Rs 6L money recovered

Security forces to deploy Al-based security systems at Red Fort on I-Day

Security agencies will be artificial deploying intelligence-based security systems with enhanced surveillance features and automated crowd estimation facilities at and around Red Fort on the upcoming Independence Day, sources said. A document reveals that CCTVs having video analytics features will be deployed at important locations at the venue. The intelligence video surveillance system will have features like a vehicle number plate recognition system, face detection, people movement counting, tripwire, audio detection, intrusion, defocus, and abandoned or missing objects. "We will also be or missing using AI-armed cameras to



count the entry and exit of people inside the premises. The estimation of the crowd will be done through AI," an official added.

The cameras, said the official, will have the capability of detecting abandoned baggage in public places. Intrusion detection features will be the security

of high risk. Different zonebased alarms can be set as per priority and sensitivity of each zone.

The advanced FRS facility will be in recognition of faces on live cameras as well as on recorded videos. Detect any matches with faces on the "Watch List" database and provide alerts

Detecting from group images and searching for similar faces from a single camera or across multiple cameras. An enrolled person can be searched by names or similar faces and also search via. unknown faces using a single

image or group photo.
Divulging further details on the new changes, a senior government official informed that they have been using a facial recognition system for the past several years but this year they will be deploying Number Plate Recognition (NPR) that will have vehicle plate detection based on realtime 24x7 video processing. It will immediately video record and snapshot each vehicle or violated vehicle. It will be integrated with multiple cameras or sensors for driver image capture.

Traffic police issues challans to



Editorial Guns, not roses

For the past 51 months, the military crisis between India and China on the disputed border in eastern Ladakh has bedevilled the bilateral relationship between the two Asian giants. Despite 16 rounds of diplomatic talks and 21 rounds of military talks, the two armies remain arraved against each other in an inhospitable terrain. This is the largest near-combat deployment by the People's Liberation Army since the end of the border conflict with Vietnam in 1987. The former US intelligence official, Dennis J. Blasko, suggests that this is the land domain equivalent of the PLA navy's reef expansion construction in the South China Sea and the deterrence operations conducted around

Blasko's analysis of satellite imagery since 2020 shows that the PLA has constructed enough fortified positions in the area to support a full division-size deployment (around 10.000 soldiers) on top of the two border defence regiments (approximately 5,000 soldiers) al ready assigned to the region. There are around 20,000 PLA soldiers deployed over the 250-mile front in the Aksai Chin, including engineer, artillery and other support elements, reaching back to a distance of over 20 miles. These forces, scattered across such a large frontage, may be insufficient for the PLA to launch a full-fledged military offensive in such a difficult terrain. But by indicating that the PLA is ready to maintain its deployments near the LAC in eastern Ladakh indefinitely, Beijing has put New Delhi in a bind. India finds its forces overstretched along the border and noises from the security establishment in New Delhi suggest a desire for an early resolution to the crisis.Eastern Ladakh, or the Karakoram plateau as the Chinese military media calls it, falls under the Western Theatre Command of the PLA. This is part of a new structure of command and control of the PLA which emerged a decade ago. The theaterisation of the PLA was one of the most important reforms initiated by Xi Jinping after he became the leader of China's communist party. As part of the ongoing reforms under Xi, the PLA has focused on preparing to fight under conditions of the 'Information Age', integrating its services, arms and systems into a joint, network-centric fighting force.

By all accounts, the PLA has been able to take major strides within a short period of time towards the completion of the unfinished business of reform. This is a testament to Xi's ability to push structural changes through a bureaucracy that has historically resisted them and an indication that the PLA is now on track to field a more professional and capable joint force to launch military operations

US, Australia agree to strengthen cooperation in Indo-Pacific

he United States and Australia held ministerial consultations on Tuesday to strengthen the alliance and cooperation between the two countries in the Indo-Pacific region and globally.

US Secretary of State Antony Blinken and Secretary of Defence Lloyd Austin hosted Australian Foreign Minister Penny Wong and Deputy Prime Minister and Defence Minister, Richard Marles in Annapolis, Maryland.

"The Secretaries and Ministers (principals) reaffirmed that the US-Australia Alliance is essential to promoting a prosperous and peaceful region. They expressed the importance of the history and values shared by the United States and Australia and renewed their commitment to support a stable and open international system that protects each nation's ability to make sovereign decisions free from coercion or threats of force," the joint statement read.

The leaders welcomed actions by both governments that build upon the commitments made during the visit of Australian Prime Minister Anthony Albanese to the US and his meeting with President Joe Biden in October 2023 across the full breadth of the bilateral relationship, to build an "Innovation Alliance."

The major actions announced during the meeting between Biden and Albanese include Australia's endorsement of the US' Framework to Counter Foreign State



Information Manipulation through a bilateral Memorandum of Understanding

They also agreed to establish the Australia-US Landsat Next Partnership between Geoscience Australia and the US Geological Survey, enhancing cooperation on satellite imaging data collection and analysis capability to assist our nations, and the Indo-Pacific, with resources management, urban planning, climate change and disaster relief.

Australia's continued progression in joining the US Global Entry Program, streamlining entry to the United States

and strengthening our robust people-topeople links.

They also announced a new four-year phase of the U.S. Agency for International Development (USAID) - Australia Mekong Safeguards Program to support strengthened environmental, social, and governance (ESG) standards for infrastructure development in the Mekong subregion.

US and Australia committed to conclude a space framework agreement to facilitate cooperation on civil space activities, including further cooperation on the US National Air and Space Agency's (NASA) Artemis program.

An inaugural Ministerial First Nations Dialogue, focused on advancing economic development, Indigenous rights and environmental stewardship with First Nations peoples in Australia and federally recognised tribes in the US, which builds on the US hosting of an Australian First Nations business leaders' delegation that enables knowledge-sharing on business development, the statement added.

The two nations signed an MoU by representatives of the Australian Department of Foreign Affairs and Trade (DFAT) and US Department of State (State) Diplomatic Security to establish exchanges in the areas of technical security, cyber security, and threat analysis.

They also agreed to co-host the Pacific Banking Forum, where the US and Australia committed to supporting the Pacific Islands Forum Secretariat's Correspondent Banking Relationship Roadmap and other efforts to address de-risking in the

US support for cultural preservation efforts in the Pacific comes through the Australian Museum's Pasifika Tauhi project. The nations agreed for continued progress by the Australia-US Critical Minerals Taskforce (CMTF) to pursue secure and diverse critical mineral supply chains, increase investment in mining and processing projects in our respective countries, and enhance market transparency.





How seaweed antioxidants help in prevention of Parkinson's

he neurodegenerative condition known as Parkinson's disease is transported by the loss of neurons that produce dopamine, a neurotransmitter essential for both motor control and cognitive function. The number of people with Parkinson's disease is rising quickly as the world's population ages. Reactive oxygen species overproduction damages neurones, which causes Parkinson's disease.

Because reactive oxygen species formation kills dopaminergic neurones, which control dopamine neurotransmitters, it must be suppressed. Since there is now just symptomatic treatment available, therapeutic regimens and preventative measures

Graduate School of Human Life and Ecology led a research group

that has verified the physiological effect of Ecklonia cava polyphenols, seaweed antioxidants, on the prevention of Parkinson's disease.

In this study, two types of motor function tests were conducted using Parkinson's disease model mice that were orally fed the antioxidants daily for one week and then administered rotenone. Results showed that motor function, which was decreased by rotenone, was restored.

There was also improvement in intestinal motor function and the colon mucosa structure, a special tissue that covers the colon.

Further, cellular experiments using Parkinson's disease model

cells verified the biochemical interaction of the preventive effect of Ecklonia cava. Validation results showed that the antioxidants activate the AMPK enzyme (adenosine monophosphate-activated protein kinase), an intracellular energy sensor, and inhibit the production of reactive oxygen species that cause neuronal cell death.

"This study suggests that Ecklonia cava antioxidants may reduce neuronal damage by AMPK activation and inhibiting intracellular reactive oxygen species production," stated Professor Kojima-Yuasa. "It is hoped that Ecklonia cava will be an effective ingredient in the prevention of Parkinson's disease."



Initially, 86,717 societies were registered under the Societies Registration Act, 1860. Out of these, only 12,923 societies have re-registered under the HRRS Act, 2012, leaving 73,981 societies pending re-registration.
