AAP registers first win in J&K

JAMMU: The Aam Aadmi Party registered its first victory in assembly elections in Jammu and Kashmir on Tuesday when its candidate Mehraj Malik defeated his nearest rival from the BJP in Doda constituency by a margin of over 4,538 votes. Malik, a District Development Council (DDC) member, polled 23,228 votes against BJP's Gajay Singh Rana's 18,690 votes. National Conference leader and former minister Khalid Najib Suharwardy and DPAP leader Abdul Majid Wani got 13,334

Haryana CM Nayab Singh Saini wins Ladwa seat

CHANDIGARH: Haryana Chief Minister Nayab Singh Saini won Ladwa assembly seat on Tuesday by a margin of 16,054 votes against his nearest Congress rival Mewa Singh, according to the Election Commission. The BJP is in the lead in 50 of the 90 seats in Haryana while the Congress is ahead in 35. Haryana went to polls on October 5 and the counting of votes is underway.

JJP fails to open account

CHANDIGARH: From emerging as a kingmaker in the 2019 Haryana Assembly polls to facing a potential wipeout five years later, the Jannayak Janta Party has witnessed a dramatic fall in its electoral fortune after its alliance with the BJP ended in March.Party leader and former deputy chief minister Dushyant Chautala faced a humiliating defeat . In 2019, the JJP won 10 of the 90 assembly seats, but it emerged as a kingmaker and forged a post-poll alliance with the BJP, which

In the first assembly election held in Jammu and Kashmir after a decade and abrogation of Article 370, the National Conference (NC)-Congress alli-ance swept the polls, breaking a three-decade-long jinx by securing a majority on its own. Out of the 90 seats in the Jammu and Kashmir Assembly, the NC-Congress alliance won 48 seats, crossing the majority mark of 46. Led by veteran politician Farooq Abdullah, the NC secured 42 seats, including 35 from the Kashmir region and the remaining from Jammu. In the Kashmir Valley, the NC contested 40 seats . NC Vice President Omar Abdullah triumphed, win-

ning both his seats from Budgam and Gan-derbal. Commenting on the results, NC President Farooq Abdullah said that this represents a clear rejection of the Centre's August 5, 2019 move- that revoked J&K's Special Status.

Vinesh Phogat wins from Julana

JULANA: Congress candi date Vinesh Phogat on Tuesday emerged victorious in Julana Assambly Constituency in Haryana as she defeated Bharitva Janta Party (BJP) candidate Yogesh Kumar as per the Election Commission of India

Manohar Lal credits Hry's "victory" to party workers

Punjab cabinet okays custom milling policy for kharif 2024-25

BUREAU CHANDIGARH, OCTOBER 8

The Punjab Cabinet led by Chief Minister Bhagwant Singh Mann on Tuesday approved The Punjab Custom Milling Policy for Kharif 2024-25, for conversion of paddy procured by State Procurement Agencies (Pungrain, Markfed, Punsup and PSWC) into Custom Milled Rice and its delivery into the Central Pool.

A decision to this effect was taken by the Council of Ministers in its meeting held under the chairmanship of the Chief Minister at his official residence.

Disclosing this here today a spokes person of the Chief Minister's Office said that the Kharif Marketing Season 2024-25 will start from October 1, 2024 and the procurement of paddy will be completed up to November 30, 2024. During KMS 2024-25, the paddy so procured will be stored in eligible rice mills situated in the State. The Department of Food, Civil Supplies & Consumer Affairs, Punjab issues Custom Milling Policy every year before the com-mencement of the Kharif Marketing Season to get the paddy milled which is procured by the State Agencies as per the specifications laid down by the Govern-



ment of India.

As per the provisions of "The Punjab Custom Milling Policy for Kharif 2024-25", the Rice Mills will be linked online to the mandis in time by the Department. The paddy allocation to Rice Millers under RO scheme will be automatic through an online portal. The paddy will be stored at the eligible rice mills as per their entitlement and agreement executed between the State agen-

cies and the rice millers. The rice millers shall deliver the due rice of paddy stored up to March 31, 2025 as per policy and agreement. In a major initiative aimed at giving further fillip to the industrial development of the state, the Cabinet also gave nod to reduce the environmental clearance processing fee by introducing seven slabs based processing fee structure for granting environmental clearance in the state.

J-K polls: BJP's Devender Rana wins with highest margin

SRINAGAR: BJP candidate Devender Rana won from Nagrota segment with the highest margin while the PDP's Tral candidate Rafiq Ahmad Naik had the lowest margin for victory in the Jammu and Kashmir assembly elections whose results were declared on Tuesday.

Rana, who had won the 2014 assembly elections on the National Conference (NC) ticket, retained the Nagrota seat on BJP ticket by a margin of 30.472 votes. His nearest rival. NC's Joginder Singh, got 17,641 votes. AICC general secretary Ghulam Ahmad Mir also won big with a margin of 29,728 votes, closely followed by Rana's fellow NC defector to BJP, Surjit Singh Slathia, who won by a margin of 29,481 votes from Samba seat.



J-K: 7 independents emerge victorious

JAMMU: Seven independent candidates have emerged victorious in the Jammu and Kashmir Assembly polls, marking an increase from the 2014 elections when three such candidates had won

Satesh Sharma, who left the Congress and contested as an independent from the Chhamb seat of Jammu region, won the election by defeating BJP candidate Rajeev Sharma with a margin of 6,929 votes. Satesh Sharma, 42, who is son of twotime MP and former Congress minister Madan Lal Sharma, polled 33,985 votes. Former deputy chief minister and Congress candidate Tara Chand, who had won this seat three times, finished third with 16,449 votes.

Two police officers found dead after juvenile escapes custody near Adampur PARAMJIT SINGH

JALANDHAR: In a tragic turn of events, two police officers from Hoshiarpur district were found dead after a juvenile d custody near Adamnur while being tr from Kapurthala court to Hoshiarpur Juvenile Jail. The incident occurred under the jurisdiction of Jalandhar Rural Police. The police team was escorting two juvenile accused. One of them, Amandeep @ Kalu, aged 17, is facing charges including murder, criminal intimidation, and conspiracy under FIR No. 67 of 2024 at PS City Kapurthala. The second accused, Dev Kumar, aged 17.5, is charged under FIR No. 184 of 2024 at PS City Kapurthala for gang rape and offences under the POCSO Act. Amandeep @ Kalu escaped custody near Adampur Bus Stand while returning from court. Despite immediate pursuit by LR/ASI Jiwan Lal and LR/ASI Pritam Dass, the accused evaded capture. Subsequently, the bodies of the two officers were discovered at Adampur Railway Station. Preliminary reports suggest they consumed a toxic substance. LR/ASI Harjinder Singh, the third officer, successfully retained custody of the second accused, Dev Kumar, and promptly informed the authorities about the incident. Senior Superintendent of Police, Jalandhar Rural, Harkamal Preet Singh Khakh, said that upon receiving information about the incident, a police team led by SHO Adampur, under the supervision of DSP Adampur, rushed to the spot and immediately launched a probe into the matter. In this regard a case has been registered against the escaped juvenile, Amandeep @ Kalu. A thorough investigation is underway, and efforts are being made to apprehend the fugitive. Cheema Brothers of Village Teipur: A model for sustainable farming without burning stubble

RAWEL BHINDER

PATIALA: To help reduce environmental pollution, farmers in Patiala district are adopting modern farming machinery to manage crop residue. Among them are Gurmukh Singh and Jatinder Singh, brothers from Village Teipur, who have not burned stubble on their 10 acres of land for the past nine years. By planting wheat without burning the leftover straw, they have not only increased their income but also contributed to



a cleaner environment. Farmer Gurmukh Singh explained that since 2015, they have been incorporating stubble back into the soil without burning it. He uses a combine harvester equipped with a Super SMS and then plants wheat using a Super Seeder. Sharing his farming experience, Gurmukh noted that by mixing stubble into the soil, the salinity in the land has decreased, fertility has increased, and the use of urea fertilizer has been cut in half. He further added that crop yields have improved, and the quality and color of the crops have seen noticeable enhancements. There is also a reduction in pest attacks, and the soil's ability to absorb water has increased, eliminating the growth of weeds in the fields. Gurmukh Singh highlighted that the Super Seeder is not only environmentally friendly but also offers several other benefits, including faster wheat sowing in a single pass and significant time savings.

Editorial Create a niche

Productive employment creation is a significant development challenge. But we must ask: how to create employment when no wherewithal exists in rural India? Is it going to be done within the 'business as usual' paradigm with an unshakeable faith in the 'trickle down' effect of market fundamentalism with a reliance on investment of corporate capital? Not at all; the reason being employment intensity of corporate capital is too low to be accepted as a means of redressal of unemployment, which is growing at a frightening scale. Moreover, openings in the government or public sector are few. Unemployment is also an acute problem in rural India, which is vulnerable to uncertain agricultural performance.

The challenge is how to create space for the educated folk in the rural economy that might transform itself through the creation of employment and income opportunities. Low capital-based but efficient local development process can create such a space in the rural economy. This is possible to achieve, I argue, by way of instituting an alternative mode of employment creation through new models like collective entrepreneurship structure or 'niche structure'. The employment-generation schemes as provisioned in the national budget have reasons to lend credibility to this model. The alternative route to employment creation in rural India as suggested by this model may not only extricate the rural economy from the low-level equilibrium trap but also trigger consumption demand which, in turn, could lead to a rise in investment and create employment.

Niche structure is a new collective entrepreneurial structure or collective enterprising system for a variety of economic activities in the form of self-organisation as a part of commons. It gives rise to innumerable associated producers' self-organisations in all kinds of activity, including manufacturing, processing, repairing, construction and servicing. These are collective enterprises — but not co-operatives in the traditional sense — with a low capital base that maintain relative autonomy. It is a reinvention of workers' cooperatives, an independent creation of the workers not as a protégé either of the government or of large capital. It can even take the support of the State but it must not be ruled by it. Workers themselves are owners here.

What matters is how one calibrates the utilisation of material resources for job creation. The production processes and services may be encouraged to grow with green technology. These are small-scale ventures but energy-efficient, non-polluting and communityoriented.

China remains mum on possible PLA Navy submarine accident

There has been intense Western media reporting alleging that a novel Chinese submarine prototype destined for the People's Liberation Army Navy (PLAN) sank whilst under construction at the Wuhan Shuangliu shipyard on the Yangtze river four months ago.

Thomas Shugart, an analyst at the Center for a New American Security and a former US Navy submariner, first noticed in satellite imagery an unusual collection of four crane barges around what appeared to be a submarine either fully or partially submerged. The Wall Street Journal was the first to publish a story on this speculative event on September 26, with many other outlets rapidly jumping on the story.

on the story. The hybrid submarine in question was a first-of-class Type 041, also known as the Zhou class, which state-owned China State Shipbuilding Corporation was building in Wuhan. Satellite images showed crane barges were present from at least 12-17 June, as well as a boom net to capture oil spills. Such cranes would be necessary to lift a submarine off a riverbed. By the first week of July, the barges were gone, the submarine presumably salvaged, and activity seemed to have returned to normal. What attracted the most attention were allegations that this submarine featured a nuclear reactor. Importantly, there has been no release of radiation nor any evidence of a nuclear emergency response, so this was certainly not a Chernobyl-type incident.

An unnamed Pentagon spokesperson quoted by The Wall Street Journal article said the Type 041 is a "new class of nuclear submarine that is similar in size to navy conventionally powered submarines, but with a small nuclear reactor". They added, "As such, we do not know if the submarine reactor was fueled at the time of incident, or if it is going to be re-



located to a known nuclear-certified facility for its initial fueling, such as Huludao shipyard, which has built all previous navy nuclear submarine classes." The American spokesperson provocatively noted: "It's not surprising that the PLA Navy would try to conceal the fact that their new first-in-class nuclear-powered attack submarine sank pierside."

China has indeed been silent on the incident, neither confirming nor denying it. When asked about the potential incident, a Chinese Foreign Ministry spokesperson said at a Beijing press conference on 27 September that he was unfamiliar with the topic. A Chinese embassy spokesperson in Washington also said, "We are not familiar with the situation you mentioned and currently have no information to provide."

Considerable caution is needed when discussing Chinese military programs, especially when China refuses to divulge information. It can be dangerous to speculate or make assertions based on fragmentary evidence or episodes. Indeed, the assertion by some media that this was a nuclear-powered submarine was a mischaracterization. There is no doubt that China has been developing the Type 041 SSP(N) type, as its existence is noted in the latest order of battle in the reputable Modern Chinese Maritime Forces listing. Authored by Manfred Meyer, this publication is the most comprehensive, unclassified, open-source Chinese data available on the PLAN. This document described the Zhou class as "a testbed for air-independent propulsion (AIP) with micronuclear reactor". The submarine has a tentative displacement of 4,000 tons and is 84m long.

Furthermore, there was previous evidence that China was developing such technology. Slides from a Chinese presentation by retired Rear Admiral Zhao Dengping of the PLAN in 2017 hinted that China was pursuing such a concept. Richard D. Fisher Jr., an American analyst with the International Assessment and Strategy Center, analyzed this information revealed at that time. He assessed: "Zhao ... revealed the PLAN may be working on a novel low-power, low-pressure auxiliary nuclear power plant for electricity generation for fitting into conventional submarine designs, possibly succeeding the PLAN's current Stirling engine-based AIP systems.

Fisher elaborated: "One slide seems to suggest that the PLAN will continue to build smaller submarines around the size of current conventional powered designs, but that they will be modified to carry the new nuclear auxiliary power plant to give them endurance advantages of nuclear power."

Today, the US Navy produces only nuclear-powered submarines, whereas China has pursued the twin prongs of conventional and nuclear propulsion. Now it seems to be combining the best of both design types by developing a hybrid that is principally a dieselelectric boat, but which adds a nuclear reactor to greatly increase its submerged range.

According to ARY News, the probe into the recent explosion near airport has yielded significant progress, with investigators uncovering valuable leads from the suspect's repeated stays at two local hotels. Authorities have established a 3kilometer security perimeter around the blast site and taken several individuals into custody for questioning regarding potential connections to the terrorists, the ARY News reported.

As part of the ongoing investigation, officials are actively collecting details and data related to suspicious calls, Investigators are probing how sensitive information regarding the movements of Chinese engineers was leaked to terrorists. to 12 years in prison on election-related offences. Researchers find clues about dementia's behavior changes

hen most people think of dementia, particularly Alzheimer's disease, they often think of memory loss first.

However, dementia alters a person's behaviour, whether it leads them to become agitated or worried, melancholy, nervous, or apathetic, or even changes their entire personality.

Over time, these behavioural changes can cause as much disruption in their life as losing their capacity to think and remember effectively.

Now, a team of University of Michigan researchers reports new clues about what might be happening in the brains of people experiencing even the earliest signs of dementia-related behavior changes.

Using two types of advanced medical imaging to study the brains of 128 people in the early stages of dementia, they show links between one of the brain's most crucial communication networks, a protein called tau, and the level of behavioral symptoms a person has.

This goes beyond the role of tau that scientists have already known about in people with more advanced dementia: causing tangled nerve



fibers in brain regions involved in thinking and memory. The new study suggests that tau disrupts the integrity of the brain's salience network. This highway of connections between specific brain regions is key to our ability to understand and decide how to react to things that are happening around us. It also helps us process our own thoughts and emotions.

The researchers showed that the more a person's salience network had been disrupted in the presence of tau, the more behavioral changes that person would experience. They report their findings in Alzheimer's & Dementia: The Journal of the Alzheimer's Association.

While the one-time imaging of these 128 research volunteers can't show cause and effect, the strong association between tau, salience network disruption and behavior change is intriguing, the team says.

They call for further study of the potential connection in other populations, and for research to evaluate change over time to explore what might be going on within the pathways of connected brain cells that make up the salience network, and explore how it relates to tau buildup and behavioral changes over the course of years.

They also hope to test whether they could slow behavioral change in people with earlystage dementia by targeting the salience network with mild electrical current or magnetic fields applied from outside the skull and guided by precise imaging.

The researchers, from the Research Program on Cognition and Neuromodulation Based Interventions (RP-CNBI), are led by Alexandru D. Iordan, Ph.D. and program leader Benjamin M. Hampstead, Ph.D. Both are faculty in the U-M Medical School's Department of Psychiatry.

Iordan, a neuroscientist who is lead author of the new study, says, "What we see is that the presence tau pathology relates to behavioral symptoms not in a direct relationship, but rather through dysfunction of a specific network in the brain - the salience network. The more affected this network is, the more severe the behavioral symptoms."

He adds, "This is the first study that links the biomarker status of an individual with the dysfunction of this network, and behavioral symptoms, in people on the Alzheimer's disease spectrum."

The team used functional magnetic resonance imaging, or fMRI, to study each volunteer's brain and trace three different networks that each connect far-flung areas of the brain.

Chandigarh faces tobacco challenge as 1 in 8 men struggle with addiction

handigarh: The tobacco epidemic continues to enslave millions across the country, with recent findings from the National Family Health Survey (NFHS-5) indicating that around 12.1% of men aged 15 and older in Chandigarh are caught in the grip of tobacco use. This local statistic mirrors a national con-



cern, as India grapples with approximately 267 million tobacco users, constituting nearly 29% of the adult population. This troubling situation underscores the crucial need for vigilant public health initiatives and proactive strategies to stem this growing tide of addiction.

Dr Ankur Gupta, a consultant cardiologist at Paras Health in Panchkula, highlights the urgency of addressing this crisis, saying, "The tobacco epidemic in India necessitates immediate action. More than 12% of men in Chandigarh are currently battling tobacco

addiction. With an astonishing 267 million users nationwide, it is crucial to rejuvenate our cessation strategies, integrating evidence-based alternatives specifically designed for dedicated smokers. By learn ing from successful international models such as those in Japan. Sweden, the UK. and the USA, we may develop innovative and safer options like Heated Tobacco

Products (HTPs) to assist smokers on the path to quitting."

The NFHS-5 findings convey startling regional disparities across India, emphasizing that tobacco poses a public health risk everywhere, even in areas like Chandigarh with relatively lower usage rates. Instead of fostering com-

placency, these statistics should galvanize an intensified effort to enhance preventive measures and incorporate innovative deaddiction strategies into the healthcare framework of the region.

Dr Pawan Gupta, Senior Consultant of Pulmonary Medicine at BLK-MAX Super Speciality Hospital, reinforces the need for comprehensive strategies, asserting, "The compulsion of tobacco, combined with its widespread availability in various forms, presents a formidable challenge





From watching the Ramleela to savouring sweets: Sony SAB's artists share their Dusshera memories




