Govt scraps windfall profit tax on domestic crude oil, export of fuels

NEW DELHI: The government on Monday scrapped 30-month old windfall profit tax on domestically-produced crude oil and on export of jet fuel (ATF), diesel and petrol following a decline in international oil prices. Minister of State for Finance Pankaj Chaudhary tabled a notification in Rajya Sabha scrapping the levy on crude oil pro-duced by firms like stateowned Oil and Natural Gas Corporation (ONGC) and exports of fuels done by companies like Reliance Industries Ltd. The notification rescinded June 30, 2022 order and withdrew levy of special additional excise duty (SAED) on production of crude oil (which is refined into fuels like petrol and diesel) and on export of aviation turbine fuel (ATF), diesel and petrol, he said

UPSC teacher **Awadh Ojha** joins AAP

SC asks protesting farmer leaders not to cause inconvenience to people



AGENCY NEW DELHI, DEC 2

The Supreme Court on Monday asked Punjab farmer leader Jagjit Singh Dallewal, who is on a fast-unto-death at the Khanauri border point to press for the acceptance of farmers' demands, to persuade the protesting farmers not to obstruct highways and cause inconvenience to peo-

A bench of Justices Surya Kant and Ujjal Bhuyan disposed of a habeas corpus petition filed on behalf of Dallewal, who was removed from the Khanauri protest site on the Punjab-Haryana border on November 26

"We have seen that he has been released and he even persuaded a fellow protestor to end his fast-unto-death protest on Saturday," the bench said, adding that the issue raised by the farmers has been noted by the court and is considered in a pending

"In a democratic setup, you can engage in peaceful protests but do not cause inconvenience to people. You all know that the Khanauri border is a lifeline for Punjab. We are not commenting on whether the protest is right or wrong," the bench told advocate Guninder Kaur Gill, appearing on behalf of Dallewal.

Justice Kant said that Dallewal could persuade the protestors to organise peace-ful protests under the law and without causing any inconvenience to people. The bench said that at this stage, it

was not entertaining Dallewal's petition but he could approach later. Hours before beginning his fast-unto-

death on November 26, Dallewal was allegedly forcibly removed from the Khanauri border and taken to a hospital in Ludhiana. He was discharged on Friday evening. The plea was moved in the apex court on November 29 challenging his alleged illegal detention by the Punjab Police. On November 30, a day after he was

Cops remove barricades after farmers leave protest site on Noida Expressway

NEW DELHI: Traffic movement along the Noida-Greater Noida expressway resumed on Monday evening after hundreds of farmers who had gathered for a "Delhi Chalo" march over various demands, agreed to vacate the site. Earlier in the day, massive traffic snarls caused inconvenience to commuters crossing the Delhi-Noida border, as police set up multiple barricades to prevent the protesting farmers from Uttar Pradesh from marching towards the Parliament complex over various demands, including a legal guarantee on Minimum Support Prices (MSPs).

Besides a legal guarantee for MSP, the farmers are demanding implementation of the Swaminathan Commission's recommendations, pension for farmers and farm labourers, farm debt waiver, reinstatement of the Land Acquisition Act, 2013 and compensation to the families of farmers.

Cheema advocates for extension of GST compensation cess regime beyond 2026

tinuation of the Goods and Services Tax (GST) Compensation cess regime, Punjab Finance Minister Advocate Harpal Singh Cheema on Monday strongly recommended the continuation of the Goods and Services Tax (GST) Compensation Cess regime beyond March 31, 2026, to ensure that states can mitigate the revenue loss caused by the subsumation of various taxes into GST. The scheme requires farmers to pay a premium of Rs. 25 per



kanal, with a sum insured of Rs. 5,000. For non-loanee farmers, insurance can be done at nearby Lok Mitra Kendras by submitting essential documents such as an Aadhaar card, bank passbook, land ownership papers, and crop sowing certificates. Farmers cultivating leased land can get their crops insured by submitting an affidavit. For loanee farmers, insurance automatically through their bank branches. Dr. Dhiman highlighted the

Regarding attack of pink stem of wheat, it is Necessary to inspect crop before watering to check attack of pink stem: Dr. Amrik



FARIDKOT (SURINDER DAMDAMI): The wheat sowing work in the district will be completed during this week. In the meantime, the wheat crop sown in the first week of November has been seen attacked by the insects called Pink Sundi and Sainik

Chief Agriculture Officer Dr. Amrik Singh, giving information about the attack of pink borer, said that in most of the area, wheat has been sown with super/happy, smart or surface seeder, in some places, the pink borer is damaging the wheat crop, which requires continuous monitoring to prevent it. He said that this time due to seasonal changes, the wheat crop planted in the first week of November has been attacked by pink borer. He said that every farmer must first inspect the wheat crop before applying water and if any attack of pink borer is found in any field then the concerned agricultural officials should be contacted.

He said that the pink borer can attack the wheat crop sown with all kinds of techniques. Apart from wheat, this sundi corn , also attacks in paddy, basmati and sorghum, so there is a need not to fear pink blight but to treat it using recommended tech-

WD likely to bring rain, snowfall in J&K: MeT

SRINAGAR, DEC 2

Night temperatures in the Valley Kashmir improved but remain below freezing, ahead of an expected Western Disturbance (WD) that could bring snow and rain to Jammu and Kashmir, officials said. The Meteorological (MeT) Department stated that a weak WD is likely to affect the region, potentially causing light rain and snow over higher reaches and scattered areas from late Monday evening to Tuesday morning. Dry weather is expected to prevail afterward until December 7, they said. On December 8 there is a possibility of another wet spell with the possibility of light rain and light snow over the higher reaches and at isolated places, the MeT office said. The weather will



remain dry hereafter till December 12. The Kashmir Valley continued to shiver even as the day and night temperatures slightly improved but stayed below normal at most places, with the tourist destinations of Gulmarg emerging as the coldest place at minus 2.9°C and Pahalgam at 2.3°C on Monday. The minimum

temperature recorded during the intervening night of Sunday and Monday in Srinagar improved and settled at minus 0.8°C against the minus 1.3°C the previous night. This was 0.4°C above normal for the summer capital of Jammu and Kashmir during this period of the season. Srinagar's iconic Dal Lake and other parts were

also engulfed with the fog, disrupting normal activities. Qazigund recorded a low of minus 1.4°C against minus 1.8°C a day ago, and this was 0.2°C below normal for the gateway of Kashmir in south Kashmir. The minimum temperature at Pahalgam dipped to minus 2.3°C against the minus 0.3°C on Sunday. This was still 1.0°C

tourist destination in south Kashmir. The ski resort of Gulmarg in north Kashmir's Baramulla district emerged as the coldest place, with the mercury settling at minus 2.9°C on Monday against the minus 2.6°C recorded the previous night. Chief Agriculture Officer Dr. Jagdish Singh said that pest surveillance teams have been formed for the survey of pests and diseases on the crops in the district, which are going to the farmers' fields from time to time, surveying the crops and advising them to use pesticides if necessary. is being given Dr. Giving information, Jagdish Singh said that the wheat crop should be continuously monitored, if the wheat crop sown in the first week of November is getting more than the economic value in the fields, then he advised the farmers that the recommendation of the Punjab Agricultural University Accordingly, before watering the wheat crop, mix 7 kg of Fipronil or



one liter of Chlorpyrifos 20 EC in 20 kg of silty soil. He said that it is preferable to water the wheat crop first during the day so that the birds can hunt more and

more birds.

He said that if the attack of sundi appears after the first watering, then 50 ml of chlorantraniliprole (corazine) 18.5 SC should be dissolved in 100 liters of water and sprayed. Chief Agriculture Officer Barnala, while giving information,

said that farmers should continuously survey their wheat crop, if damage is seen or found on the wheat crop due to pink sundi, then contact their respective block agriculture officer or circle. Contact should be established with the agricultural authorities so that it can be controlled by using insecticides as per the recommendations of Punjab Agricultural University, Ludhiana in time for its

prevention.

Trapped again

hen camera traps were put into use in forests to monitor animal habitats and learn more about the animals, it was not imagined that they could be used as traps for women. After interviewing 270 villagers, including women, who live around Jim Corbett National Park and enter the forest to gather produce, researchers found that their normal practices have undergone a change because they know they are being watched. For these women, ironically enough, the forest was a safe place where they went not only to forage but also for some relief from the conflicts at home. This was a man-free area. Here they bonded with one another, talked and sang, loudly enough to keep away elephants and tigers. But technology meant for conservation and learning is being used by local officials and men from the villages for surveillance of the women without their consent, even when they go to relieve themselves in some cases. Such monitoring means that the man-free space is now penetrated with an overall male gaze. Not sure of who is watching, women are no longer free, talking and singing softly, and thus laying themselves open to attacks from predators. One of the women in the interview was later taken by a tiger.

The research exposes the tragic nature of gender inequality in India. No space is protected from male control, whether by rules, social norms or simply the gaze. Necessarily, in such a situation, women become the objects and men one comprehensive subject. From this point of view, what is happening in Jim Corbett National Park is symbolic of women's position. Women are denied their 'naturalness', their feeling of transitory freedom, their window of occasional escape. More, they are made vulnerable to predators. It is a kind of psychological imprisonment; the women are caught between men's surveillance and beasts of prey. The men's actions argue a distortion that comes from a sense of unchecked entitlement: they affect the women's physical safety, mental health and behaviour. It must also be asked how men from the village are allowed to watch the feed from the camera traps and whether forest officials are doing their actual duty of watching animals and protecting them if they are monitoring the women. Obviously, technology for the best purposes can be perverted to truly damaging uses.

Biden pardons son Hunter in tax violation case

S President Joe Biden signed a pardon for his son, Robert Hunter Biden, who had been convicted on charges related to gun crimes and tax violations. The pardon ensures that Hunter Biden will not face sentencing for these offences and removes the possibility of prison time.

In a statement, President Biden addressed the charges against his son, arguing that individuals in similar situations--such as those with tax payment issues due to addiction--typically receive non-criminal resolutions. He contended that Hunter's case was treated differently, leading to felony charges despite the absence of aggravating factors.

Biden also stressed his commitment to not interfere with the Justice Department's decision-making, despite his belief that his son had been "selectively and unfairly prosecuted."

"Today, I signed a pardon for my son Hunter. From the day I took office, I said I would not interfere with the Justice Department's decision-making, and I kept my word even as I have watched my son being selectively and unfairly prosecuted. Without aggravating factors like use in a crime, multiple purchases, or buying a weapon as a straw purchaser, people are almost never brought to trial on felony



charges solely for how they filled out a gun form.

Those who were late paying their taxes because of serious addictions but paid them back subsequently with interest and penalties are typically given non-criminal resolutions. It is clear that Hunter was treated differently," the statement read.

Biden explained that the charges against his son were initiated after political opponents in Congress pushed for the case to be brought forward. He added that a plea deal, which had been negotiated with the Department of Justice, unraveled in court due to political

pressure.

"The charges in his cases came about only after several of my political opponents in Congress instigated them to attack me and oppose my election. Then, a carefully negotiated plea deal, agreed to by the Department of Justice, unravelled in the courtroom--with a number of my political opponents in Congress taking credit for bringing political pressure on the process. Had the plea deal held, it would have been a fair, reasonable resolution of Hunter's cases," the statement added.

The President maintained that the charges were politically motivated, as-

serting that Hunter was targeted because of his relationship with him. Biden concluded his statement by expressing his belief that, while he had faith in the justice system, the legal process had been influenced by politics, leading to a "miscarriage of justice."

"No reasonable person who looks at the facts of Hunter's cases can reach any other conclusion than Hunter was singled out only because he is my son-and that is wrong. There has been an effort to break Hunter, who has been five and a half years sober, even in the face of unrelenting attacks and selective prosecution. In trying to break Hunter, they've tried to break me-and there's no reason to believe it will stop here. Enough is enough," Biden said.

"For my entire career I have followed a simple principle: just tell the American people the truth.

They'll be fair-minded. Here's the truth: I believe in the justice system, but as I have wrestled with this, I also believe raw politics has infected this process, and it led to a miscarriage of justice--and once I made this decision this weekend, there was no sense in delaying it further. I hope Americans will understand why a father and a President would come to this decision," the statement added.

UNRWA pausing delivery of aid through Kerem Shalom

The United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) announced that it is pausing the delivery of aid through Kerem Shalom, the main crossing point for humanitarian aid into Gaza.

Philippe Lazzarini, the UNRWA Commissioner-General, said in a post on his official X account (previously known as Twitter), that, "We are pausing the delivery of aid through Kerem Shalom. The road out of this crossing has not been safe for months. On 16 November, a large convoy of aid trucks was stolen by armed gangs. Yesterday, we tried to bring in a few food trucks on the same route. They were all taken."

This difficult decision he explained, comes at a time when hunger is rapidly deepening. "The delivery of humanitarian aid must never be dangerous or turn into an ordeal."

In Gaza, he added, the humanitarian operation has become unnecessarily impossible due to the ongoing siege, hurdles from Israeli authorities, political deci-



of safety on aid routes and targeting of local police.

All of the above led to a breakdown in law and order. The responsibility of protection of aid workers and supplies is with the State of Israel as the occupying power. They must ensure aid flows into Gaza safely & must refrain from attacks on humanitarian workers, he concluded.

ut of all the fluff created towards the end of a year, wrap-ups are increasingly becoming the most loved way of, well, wrapping up the year. Be it the Spotify Wrap or Vox's Year in Review, which recaps the entire year's news in mere minutes, netizens have grown an appetite for summed-up year-enders.

Another such wrap-up from the world of linguistics and literature is Oxford's Word of the Year. It is a contest of popularity between the most used words in a single year. list of contenders being put to a popular vote, allowing people to help shape the final decision.

The ultimate choice is made by a panel of language experts, who evaluate which word best encapsulates the mood or concerns of the year. Whether it's a new term or one with a renewed significance, the chosen word speaks to the evolving ways we communicate and understand the world.

The Oxford University Press's justification of Brain rot wining this contest is "Our experts noticed that 'brain rot' gained new prominence this year as a term used to capture concerns about the impact of consuming excessive amounts of low-quality online content, especially on social media. The term increased in usage frequency by 230% between 2023 and 2024."

The other five words in this year's shortlisted words include demure, romantasy, lore, slop and dynamic pricing. It is very important to note that out of these six choices only one word (dynamic

pricing) is chosen because it has been a phenomenon in the actual world and not just a social media storm.

As another year ends, this wrap of linguistics and world of lexicography extends a unique lens to reflect on the increasing pace of evolution of our culture and language. "Brain rot," this year's winner, captures a growing unease with the overwhelming influence of trivial online content on our mental states-a phenomenon that resonates deeply in today's hyper connected digital age.

The increasing popularity of wrap-ups like this underscores our collective fascination with distilling complex realities into digestible summaries. While the shortlisted words reflect varied dimensions of contemporary life, the victory of "Brain rot" highlights not just a linguistic trend but a societal reckoning with how we consume and prioritize information. In doing so, it reminds us that language, much like culture, is ever-changing, mirroring the concerns and preoccupations of the time.
