6 dead as helicopter crashes in Uttarakhand

DEHRADUN: At least six people were killed and several others injured when a helicopter carrying pilgrims to the holy shrine of Gangotri Dham crashed in Uttarkashi district of Uttarakhand on Thursday morning, an official said.

There were seven people on board, including the pilot.

Ihere were seven people on board, including the pilot. While six bodies have been recovered, one passenger is safe. Chief Minister Pushkar Singh Dhami has expressed grief over the accident. State Disaster Response Force (SDRF) Commandant Arpan Yaduvanshi said a helicopter crash was reported in Gangnani area at around 8:50 am. A team led by chief constable Naveen Kumar was immediately dispatched from post Rhatwordi.

India neutralises Pak missiles aimed at 15 cities, destroys Air Defence System in Lahore

AGENCY NEW DELHI, MAY 8

Pakistan's attempts late last night and early this morning to escalate tension by targeting Indian military installations in the northern and western parts of the country including Jammu and Kashmir, Punjab, and Gujarat - have been negated, the government said Thursday.

The government said Indian forces responded by targeting and neutralising Pakistani Air Defence Radars and systems in several locations, including Lahore, in response to Pak attempts to attack multiple locations, including Srinagar, Pathankot, Amritsar, Ludhiana, and Chandigarh.

Indian forces' response, the

Indian forces' response, the government underlined this afternoon, was "in the same domain (and) with the same intensity" as



the attacks launched by Pakistan.
Pak forces used drones and
missiles that were disabled by India's air defence systems.

Debris from the destroyed drones and missiles is being collected, the government said, and will add to the volume of evidence supporting India's charges that Pakistan, or the Pak deep state, supports cross-border terrorism targeting India, whether by financial funding or military training.

Attempted military action against India comes a day after Indian armed forces' carried out precision strikes at four terrorist camps in Pak and five in Pak-occupied Kashmir, or PoK.

Operation Sindoor, as the strikes were codenamed, spanned a 25-minute period that began Wednesday morning at 1.05 am and included a barrage of 24 munitions - from HAMMER smart bombs to SCALP missiles - that destroyed terrorist groups' HQs and training camps.

Sindoor was in response to the April 22 Pahalgam terror attack; four terrorists from The Resistance Front, a proxy of the Lashkar-e-Taiba, killed 26 people, many of whom were civilians, at the Baisaran Valley, a tourist hotspot less than 70 km from J&K capital Srinagar. In a press briefing Wednesday afternoon the Army and Air Force said the targets had been chosen based on credible intelligence, and that its action was "focused, measured."

Pakistani missiles intercepted in Jammu, blackout across city

JAMMU: Pakistan, shortly after its foiled attempt to target 15 Indian cities, fired missiles and drones at Jammu. Loud explosions were heard from the city followed by clamour of sirens and a blackout. The attack is



still on. Cellphone service is down.

Cellphone videos sent by locals show lights streaking across the sky, indicating interception of the missiles and drones by the Air Defence System of the Indian armed forces.

Kupwara, a town more than 300 km away, and Pathankot experienced a similar situation. Blackout was declared in Gurudaspur, a nearby town in Punjab. Heavy shelling is already in progress at the International Border at Samba, Akhnoor,

PM stresses on alertness, operational preparedness

In the wake of 'Operation Sindoor', Prime Minister Narendra Modi chaired a high-level meeting with secretaries of various ministries on Thursday and called for continued alertness and clear communication, while reaffirming the government's commitment to national security and op-

erational preparedness.

The issues discussed during the meeting included strengthening of civil defence mechanisms, efforts to counter misinformation and fake news, and ensuring the security of critical infrastructure, a statement issued by the Prime Minister's Office (PMO) said.

Govt orders complete 'blackout' in Gurdaspur

GURDASPUR: The Government of India and the Punjab Government have issued directives under the Civil Defence Act, 1968, to enforce a complete blackout in the Gurdaspur district from 9:00 PM to 5:00 AM, effective from May 8, 2025, until further orders.

The statement released reads, "Due to a sensitive environment on the Indo-Pak border, guidelines of the Government of India and the Government of Punjab. According to this, further orders will be issued from 08.05.2025 to deal with the emergency situation under the Civil Defense Act 1968. From 9.00 pm to 5.00 am the next day, there will be complete "black out" in district Gurdaspur.

Gates of Baglihar, Salam Dams opened

NEW DELHI: The central government opened two gates at the Baglihar Hydroelectric Power Project in Ramban and three gates at the Salal Dam in Reasi. This reportedly aimed at managing rising water levels triggered by heavy rainfall in the region and also to manage dam pressure. The development comes just days after the Chenab's water levels had dropped sharply, following the government's decision to restrict the river's flow.

Ministries were also advised to maintain close coordination with state authorities and ground-level institutions, it said.

The high-level meeting, which included secretaries of various Ministries and departments of the government of India, reviewed national preparedness and inter-ministerial coordination in light of recent developments concerning national security.

PM Modi stressed the need for seamless coordination among ministries and agencies to uphold operational continuity and institutional resilience, the statement said.

Schools shut across six border districts in Pb

CHANDIGARH: Amid soaring tension between India and Pakistan, all schools in six border districts of Punjab remained shut on Thursday, officials said. The schools were closed in Ferozepur, Pathankot, Fazilka, Amritsar, Gurdaspur and Tarn Taran districts, they said. Tensions escalated after Indian armed forces early Wednesday carried out missile strikes on nine terror targets in Pakistan and Pakistan-occupied Kashmir (PoK), including the Jaish-e-Mohammad stronghold of Bahawalpur and Lashkar-e-Taiba's base in Muridke, in retaliation for the April 22 terror attack in Kashmir's

Khudian urges centre for Rs 17.5k/ha cash incentive to promote crop diversification



Gurmeet Singh Khudian on Thursday provide a cash incentive of Rs 17,500 per hectare to farmers opting for crop diversification in place of paddy during the Kharif season. S. Khudian said that the Central Government in its letter dated June 10, 2024 rolled out the revised guidelines for crop diversifica Programme (CDP) for Paddy replacement which mentioned to pay cash incentive of Rs. 17,500 per Hectare (upto 5 hectares per farmer) to farmers who go for alternative crops like Maize and cotton etc. during the Kharif Season. In continuation the Governmer of India further issued two letters in November and December last year, but remained silent on financial support, leaving farmers in uncertainty.

The Food Corporation of India has stated that as on May 7, 2025, a total quantity of 126.20 lakh metric tonnes (LMT) of wheat has arrived in the mandis of Punjab. Out of this, 10.13 LMT has been purchased by private parties and the rest quantity of 115.36 LMT has been purchased by the government, under central pool.

The wheat is being pur-

chased from the farmers at a Minimum Support Price (MSP) of Rs. 2,425/- per quintal. As of now, 8 lakh farmers have benefitted from this purchase of 115 LMT of wheat amounting to Rs. 27,975 crores, which shall be borne by the Government of India. Out of the

around 80 lakh metric tonnes of wheat has already been lifted from the man dis. In the corresponding period last year, a quantity of 78.5 LMT of wheat had been lifted from the mandis. The lifting of wheat is thus more than the last FCI has already moved

out 8.13 LMT of wheat in 275 rakes till date, in this Rabi Marketing Season 2025-26. A further 12 - 15 rakes are also being moved out on a daily basis. The daily arrival of

JALANDHAR (PARAMJIT SINGH): In exercise of powers vested in her under Section 163 of the Indian Civil Protection Code, 2023, Police Commissioner Dhanpreet Kaur has banned the honking of horns in residential areas from 10 pm to 6 am in the silence zone except in cases of public emergency

The orders issued by the Police Commissioner, citing the orders of the Hon'ble Supreme Court, have directed that the sound level of public places where loudspeakers or public address systems or any sound-producing source are being used should be kept at the prescribed level for the area. As per the orders, no person shall play drums or trumpets, any sound-producing device, sound amplifiers and DJs etc. in marriage palaces and hotels between 10 pm and 6 am (except in cases of public emergency). Similarly, the noise level of a privately owned sound system or sound generating device shall not exceed the noise standards prescribed for the boundary area of a private place of 5 dB(A). The orders also state that in the case of vehicles having music system, it should be ensured that the sound generated by the music system is not audible outside the vehicle at any time of the day. If any violation of these orders is found, the sound devices involved

CM blasts Centre, BBMB over water issue: 'Punjab fighting enemies within and beyond'

RUPNAGAR, MAY 8

Asserting that the state is fighting twin battles one against Pakistan to safeguard our borders and other against the Union government and Haryana government to protect the snatching of our waters, the Punjab Chief Minister Bhagwant Singh Mann on Thursday foiled the nefarious design of Bhakra Beas Management Board (BBMB) to steal the waters of state. 

Fresh LoC firing forces villagers in J-K's Akhnoor to relocate

AKHNOOR, MAY 8

Families living near the Line of Control (LoC) in the Akhnoor sector have been forced to leave their homes once again due to ongoing cross-border firing and to take shelter at safer places.

Ajit Singh, a resident of Palatnagarh village located just 200 metres from the Pakistan border, recalled past experiences. "Bullets have hit our homes. In 2016, seven walls of my house were damaged. government gave us 4.5 acres of land, and we built new homes with their help," he said.

"When firing starts, people leave the village. Once it stops, they return to

the farm. Even animals get scared," he said. Singh said they were recently advised to evacuate. "Yesterday, we met the BLO. They told us to leave immediately. We walked until we saw a vehicle and spent the night here with our children," he said, referring to their current temporary shelter. He recalled being displaced

during the Kargil war in 1999. "We were sent to camps then. Later, we were told this place would be safe. Now, five or six families from my village stay here.' Singh said more than 20 people, including six families, took shelter last night. "It was cold at first but better now," he added.

The local administration

and has arranged for temporary relief for the displaced families.

Ministry of External Affairs (MEA) said that 13 civilians had lost their lives in Poonch while a total of 59 people, 44 of them in Poonch district of Jammu and Kashmir sustained injuries due to ceasefire violations by Pakistan along the Line of Control (LoC),

The intense shelling by the Pakistani army along the LoC came in retaliation for the May 7 'Operation Sindoor' in which India's armed forces targeted a total of nine terror camps in Pakistan and Pakistanoccupied Kashmir (PoK).

After 'Operation Sindoor', the Pakistan Army continued its series of ceasefire violations by targeting civilian areas in the border areas of Jammu and Kashmir on Wednesday. Officials said the shelling caused panic among villagers and damaged several houses. Shelling by Pakistan damaged civilian infrastructure, shattered window panes and cracked walls. Residents in border villages in Jammu and Kashmir's Rajouri returned to their homes on Thursday morning after they were forced to flee their homes in panic, seeking safety in the wake of the intense shelling by Pakistan.

Maternal penalty

The 'motherhood penalty' — wherein women earn less after having children— is a well-known global issue with serious implications for career growth, family finances, and gender equality. In India, this penalty is especially pronounced. Research on 'motherhood penalty' remains limited even though studies and personal experiences paint a grim reality. Many women exit the workforce after childbirth; those who return often encounter career stagnation, reduced wages, and restricted opportunities. An estimate by IWWAGE of Krea University showed a sharp decline in female labour force participation in salaried jobs for both rural and urban India in 2017-18 and in 2023-24. Childcare and household chores were cited as the main reasons for this trend.

Our research, along with Anirban Mukherjee from the University of Calcutta, draws on data from the India Human Development Survey (2004-05 and 2011-12) and confirms that the 'motherhood penalty' remains a persistent issue. Our findings reveal that working mothers continue to face challenges regardless of age, education, job type, family structure, or financial status. However, the severity of this penalty varies across professions and family dynamics.

One of the most eye-opening insights from our research concerns the economic toll of an unplanned pregnancy. If a woman has one more child than what she intended, her wages drop by 2.9% and the likelihood of employment falls by 8%. This effect is more pronounced outside the southern states where an unintended birth results in a 5% wage decline and a 1.2% lower chance of finding a job. These challenges affect both full-time and part-time workers, underscoring the deep-rooted barriers that mothers face in the workforce. Compared to Western Europe and the United States of America, where the motherhood wage penalty ranges from 3% to 16%, India's challenge is unique: many women permanently drop out of the workforce after becoming mothers.

Real-life experiences highlight how this penalty plays out. Zeba, a graphic designer based in Calcutta, saw her freelance work dry up when she started working from home to care for her child. While mothers face setbacks, fathers often experience the opposite — known as the 'fatherhood bonus'. Souray, an IT professional in Calcutta, got a raise and more responsibilities after his son was born. Meanwhile, working women get passed over for promotions or nudged into less demanding roles after maternity leave.

Pakistan's propaganda machine on overdrive

Pollowing India's decisive strike under 'Operation Sindoor', Pakistan has been trying to mount a full-blown disinformation offensive – a desperate attempt to shift the focus with a barrage of lies and digital theatrics.

In reponse to a focused and effective military operation by the Indian Armed Forces targeting terror sites, Pro-Pakistan social media handles and even influential political figures are deliberately spreading fake news, fabricating stories of miraculous military victories and heroic retaliation that simply do not exist

In a blatant effort to hijack the narrative and distract from the reality on the ground, Pakistan's state-affiliated accounts have turned to their familiar playbook: recycling outdated images, misrepresenting old videos, and inventing completely fabricated claims. Their goal is clear – to flood the information space with falsehoods so quickly and overwhelmingly that it becomes difficult to separate fact from fiction. This is not just misinformation; it is a calculated, coordinated campaign designed to distort reality, mislead the public, and manipulate perceptions across the region.

One of the most prominent examples is a viral image falsely claiming that the Pakistan Army had shot down an Indian Rafale jet near Bahawalpur. The image, however, was debunked by PIB Fact Check, which confirmed that it was actually from a MiG-21 crash in Moga, Punjab, in 2021 – entirely unrelated to current events.

Another brazen piece of misinformation surfaced in the form of a video falsely claiming that the Indian Army raised a white flag and surrendered at Chora Post. This fabricated narrative was amplified by Pakistan's Minister Attaullah Tarar, who publicly en-

dorsed the claim without a shred of evidence. By lending official weight to an unverified and clearly false story, Tarar not only misled his own citizens but also actively contributed to the propaganda campaign.

Unrelated footage passed off as combat evidence- In another misleading post, a video was circulated with the claim that the Pakistan Air Force targeted the Srinagar airbase. A fact-check unit of the Central government has debunked the claim circulating on social media. In reality, this footage was traced back to sectarian clashes in Khyber Pakhtunkhwa, Pakistan, that occurred in early 2024. The video had no connection to

Kashmir or any recent airstrike.

A separate rumor claimed that Pakistan destroyed an Indian Brigade Headquarters, a claim that has no basis in fact and has been entirely fabricated, according to defense sources

Additionally, another old image -- this time of a MiG-29 crash in Barmer, Rajasthan, from September 2024 -- was recirculated by pro-Pakistan social media handles to imply recent Indian Air Force losses, which did not occur

Pakistan's Defence Minister Khawaja Asif was on Tuesday exposed on International TV. While appearing on a CNN interview the CNN Anchor asked Asif, "You say Pakistan shot down 5 Indian jets. Where's the evidence? A stumped Khwaja Asif replied, "It's all over social media,"

The Anchor replied, "I'm sorry we didn't ask you here to talk about social media content."

A Defence Minister citing social media content to back unverfied claims shows that the Pakistan's rank and file has relied on fake news to push its case.

Khawaja Asif also made a baseless claim that Indian soldiers were captured during the recent military strikes, a statement that was later debunked and retracted.

Trump says 145pc tariffs on China are here to stay for now

S President Donald Trump on Wednesday said that the 145 per cent tariffs on most imports from China will remain in place "for now," even as US and Chinese officials prepare for trade talks in Switzerland this week.

swearing in ceremony of David Perdue as the new US Ambassador to China, Trump said the US was no longer facing massive trade losses as it once did.

"We were losing a trillion dollars a year, now we're not losing anything. That's the way I look at it," Trump said when asked about the upcoming talks.

When asked in the Oval Office whether he would consider reducing the tariffs to bring China back to the nego-



tiating table, Trump simply replied, "No." He also rejected China's claim that the US had initiated this week's round of trade talks. "They said we initiated? Well, I think they ought to go back and study their files," he added. According to CNN, US stock markets dropped slightly after Trump's comments and have continued to decline since the official announcement of the tariff decision. Trade between the

world's two largest economies has largely stalled since the tariff war began in March.

However, this week's meeting between top US and Chinese trade officials marks the first round of formal talks since then, CNN reported. Meanwhile, Federal Reserve Chair Jerome Powell said that the outcome of the trade talks could have a significant impact on the US economy.

calation." "I reiterate my condemnation of all terrorist attacks and attacks against civilians and civilian infrastructure. I firmly believe that dialogue and diplomatic solutions in line with the UN Charter and international law are the only ways to resolve differences and achieve lasting peace and stability," he added. His statement comes after Indi-

an Armed Forces targeted terrorist infrastructure in Pakistan and Pakistan-occupied Jammu and Kashmir (PoJK) under 'Operation Sindoor' on Wednesday in response to the April 22 Pahalgam terror attack.



Kalma was demanded, Fatihah is being recited now

n April 22 in Pahalgam, Pakistan-sponsored terrorists brutally gunned down twenty-six Hindu male tourists in front of their families simply because they couldn't recite the Kalma when asked to. The massacre has sent shockwaves across the nation, leaving India trembling with grief and seething with anger.

Prime Minister Narendra Modi, speaking on behalf of 1.4 billion Indians, vowed that these terrorists would be hunted down from every corner of the earth—no matter how deep they hide—and be punished in an unimaginable manner.

And Modi is known for following through. True to his word, on the midnight of May 7, he orchestrated the destruction of nine terrorist camps in Pakistan. According to government sources, around a hundred terrorists were eliminated in the operation, including fourteen from the family of dreaded terrorist leader Masood Azhar. The man once declared the world's most dangerous terrorist by the United Nations broke down in tears upon hearing the news—lamenting why he wasn't killed along with his family, wondering what was left to live for.

Masood Azhar, who shed no tears when innocents were massacred around the world at his



behest, now weeps and prays for death. And to that, India says: Ameen. But we promise—we before you go to meet your seventy-two virgins,

answer this: where were these tears when you orchestrated the killings of hundreds of innocent men, women, and children across the globe? Why didn't their suffering torment you? Know this—the agony you're now in is the result of the curses of those very families you destroyed.

Pakistan has always tried to project itself as a victim of terrorism and pleads for international aid. But its own defence minister and Bilawal Bhutto recently exposed the truth—admitting publicly that Pakistan nurtured terrorism within its borders. They even tried to shift the blame, saying they did it under pressure from the US and the UK. But Operation Sindoor, executed by India, has confirmed beyond doubt Pakistan's role in fostering terror.

If Pakistan was innocent, why were the bodies of the slain terrorists wrapped in the national flag after Operation Sindoor? Why did their army, police, and politicians offer them final salutes? The answer is clear—Pakistan not only harbours terrorists but glorifies them. The world now has undeniable proof that Pakistan is a terrorist state—the very cradle of terrorism.

As the saying goes, you reap what you sow. Today, India's Defence Minister has made it

clear in an all-party meeting that Operation Sindoor isn't over yet. And Pakistan is already reeling. Since morning, explosions and gunfire have shaken Lahore, Rawalpindi, Islamabad, and Quetta. Their air defense systems have been destroyed. Some say the Balochistan Liberation Army and Tehrik-i-Taliban Pakistan are behind the attacks—but regardless of who's responsible, Pakistan is now trapped in the consequences of its own actions, with no way out in sight. What happens next to Pakistan is known only to God.

India, however, remains a tolerant nation. If Pakistan wishes to avoid the wrath of Operation Sindoor and seeks peace in the region, it must accept its fault—acknowledge that it fostered terrorism, caused deaths in India and across the world, and sincerely apologize.

It must vow never to support terrorists again, dismantle all terror camps, and hand over those responsible for attacks in India—most notably Hafiz Saeed, Asad Mazhar, and Dawood Ibrahim.

If Pakistan fails to act, India will ensure the complete eradication of these terrorists, their hideouts, and their backers—and only then will there be peace.

Uttarakhand CM Dhami meets Nitin Gadkari, disccusses infrastructure projects of state

Uttarakhand Chief Minister Pushkar Singh Dhami on Thursday met with Union Road Transport and Highways Minister Nitin Gadkari in New Delhi and discussed various issues related to important road and infrastructure projects of state.

He also requested for approval for other necessary works including additional assistance of Rs110 crore for the Metro corridor along with the proposed elevated road on NH-07. The Chief Minister thanked the Union Minister for giving positive assurance for all the projects. Earlier in the day, CM Dhami met Union Minister for Environment, Forest and Climate Change Bhupendra Yadav and

requested approval for crucial projects aimed at strengthening the state's infrastructure and addressing environmental challenges. During the meeting, CM Dhami sought environmental clearance and the transfer of forest land for the 120MV Sirkari Bhyol Rupasiyabagh Hydroelectric Project on the Gauriganga River. Triveni Ghat, Rishikesh to Neelkanth Mahadev Temple. He further urged the Union Minister to support the revival of Chaurasi Kutiya (Beatles Ashram), a significant cultural and tourism landmark. Nimrat Kaur reflects on her theatre roots and career milestones

ctress Nimrat Kaur, known for her roles in films like 'Lunchbox' and the series 'Kull,' recently shared her journey and experiences with students at the Actor Prepares School in Mumbai.

During a conversation with ANI, Kaur opened up about her early days in theatre, her breakthrough roles, and what drives her passion for acting.

Kaur, who arrived in Mumbai in 2004 with dreams of making it big, initially found herself drawn to modelling and ad films. "I thought I would make a lot of money from modelling and get some experience in front of the camera," she said.

However, it didn't take long before she realised that acting required much more than just reading lines.

"I started with music videos, then moved on to ads. But soon enough, I understood that acting is a completely different ball game. Playing a character, feeling it, and embodying it-that's what I wanted to learn," Kaur

Her exposure to theatre came when she began attending plays around Mumbai, which led her to pursue a more structured path in acting.

Kaur's first big break in theatre came with Thespo, a youth theatre forum, where she won the Best Actress award. She went on to perform in numerous plays at renowned venues like Prithvi Theatre, NCPA Experimental, and more.

Kaur's theatre journey took her to cities across India, including Calcutta, Pune, Delhi, and Bangalore.

'Whatever I have learned today, I owe it all to theatre," she said, emphasising how those early experiences shaped her as an art-

One of the pivotal moments in Kaur's career came with her breakthrough role in 'The Lunchbox' (2013), where she played the lead-ing lady opposite Irrfan Khan.

Reflecting on how she landed the role, she credited the late casting director Seher Latif, who believed in her potential.

"I was doing plays when Seher Latif showed some of my performances to Ritesh Batra, the director of The Lunchbox. I didn't even have to audition for it," Kaur recalled

She described getting the role as a "blessing" and a turning point in her career.

"The way The Lunchbox came to me felt like destiny. It was such a big gift. I feel like God had a hand in this," she added, still in awe of the life-changing opportunity that came her way

Currently, Kaur is earning praise for her role as Rani Indrani Rai Singh in the period drama series 'Kull', which was recently released on Jio Hotstar.

The series explores the dynamics of a royal family, and Kaur's character is filled with emotional depth and complexity.

'Rani Indrani is a princess on the outside, but inside, she's struggling with complicated family relationships, especially with her younger brother," she said.

The role includes a hauntingly poignant moment where Kaur's character sings a Ra-



jasthani folk lullaby, a scene that Kaur de-

scribes as "painful and haunting."

"It's a lullaby she used to sing to her younger brother as a child. It's a deep part of the character, and it's woven into the show in very emotional way," Kaur shared.

When asked about the best compliment she has ever received, Kaur shared, "My mother called me after watching the show. She was completely stunned by my performance and said, 'I couldn't believe this could happen.' Her words meant the world to me.'

She further mentioned that the positive feedback from audiences has been overwhelming, especially in the series' intense

"People have been coming up to me, almost shocked by the depth of the character. That's the kind of response you hope for as an actor," she said.
