This will be the flight of the PSI the 27th using the PSLV-XL configuration In a post on X, ISRO shared, "ISRO's 101st launch. PSLV-C61 at a glance. 63rd PSLV flight Height: 44.5 m I Mass: 321 t. 4 stages I 6 XL boosters Live from 5:29 AM. The mission will place the Earth Observation Satellite into a Sun Synchronous Polar Orbit (SSPO), continuing PSLV's track record of dependable performance across various payloads and orbits. After the EOS-09 satellite is deployed, Orbit Change Thrusters (OCT) will be used to lower the altitude of the PS4 stage. This will be followed by passivation, a measure aimed at reducing the stage's orbital life and ensuring responsible space operations.


# Turkey must reconsider supporting Pakistan, over 200 million Muslims live in India: Asaduddin Owaisi

Addressing this critical issue, renowned fertility specialists Dr. Pooja Mehta, Head of Department and Dr. Sunita Chandra, Senior Consultant, Fortis Bloom IVF Centre, Mohali and Dr. Ruchi Chaudhary, DGO Medline Hospital, Karnal shared their insights on IVF failures and advancements in fertility treatments.Dr. Ruchi Chaudhary emphasized that access to a well-equipped IVF lab plays

a crucial role in determining

the success of fertility



treatments. Dr. Ruchi explained that IVF failure primarily stems from two factors: embryonic and endometrial. Embryonic issues may arise due to poor egg quality caused by like conditions endometriosis, poor ovarian reserve, premature ovarian failure, or severe Polycystic Ovarian Syndrome (PCOS). Sperm-related problems

such as low count, poor

motility, or abnormal

morphology also contribute significantly. Additionally, laboratory conditions, including incubator quality, culture media, and expertise of embryologists, play a vital role in embryo development. Dr. Pooja Mehta highlighted that severe PCOS and blocked fallopian tubes are among the leading causes of infertility in women, while male infertility accounts for nearly 30% of cases in India.

# Inflation in check, focus on growth

The moderation of the inflation rate, both at the wholesale and retail consumer levels, in April extends a welcome trend seen over the past few months. The wholesale inflation rate, measured by the Wholesale Price Index (WPI), showed only a marginal increase of 0.9% last month, marking a 14-month low. Wholesale price inflation has been low or even negative in the last two years and the last month's figure comes as no surprise. Retail inflation, which is of greater significance for consumers and policymakers and measured by the Consumer Price Index (CPI), marked an increase of a mere 3.2% in April, the lowest level in six years. It was 3.3% in March.

It was the decline in vegetable prices in the last few weeks that accounted for the fall in the inflation rate. There was an 11% fall in vegetable prices and a 5% fall in the prices of pulses which have an important place in the food basket. The decline was mainly due to a favourable supply position resulting from climate and other factors. The government helped to ease the supply position by strengthening the buffer stocks, making open market releases, and easing import restrictions. There was a baseline effect as well because the prices peaked last April. The low liquidity in the system also contributed to the easing of pressures in the last few months. Inflation is likely to further moderate in the current financial year to about 3.5%, as against the 6% levels seen in recent years. This outlook is based on expectations of a decline in crude oil prices and an above-normal monsoon which can boost farm output.

The consistent moderation in the inflation rate from the beginning of the year has provided relief to consumers who were weighed down by high prices in the last many years. It is almost certain to have an impact on the Reserve Bank of India's policy decision. With inflation under control, the RBI is bound to turn its attention to facilitating growth with the help of the policy tool at its disposal. Growth rates have been under stress for various reasons and would need a boost.

The RBI has already cut the policy rate by 25 basis points at its April meeting. It is almost certain that there will be another rate cut at the Monetary Policy Committee (MPC) meeting in June. There are expectations that the rate will be cut by another 50 basis points over the policy reviews to be held next month and in


# 'Sindoor' was Modi's finest hour: Next, let's win peace!

Tronically, I met more Pakistanis than Indians during my short stay in London, which, tragically, coincided with the "Four-Day War" that shook the subcontinent. Here's the thing: Not a single Pakistani or Indian I encountered crowed or bragged about "showing the other side". Nobody wanted a bloody, extended yudh. There was anxiety, fear, concern and pain being openly expressed, as we swapped scraps of news received from relatives back home. Nobody was paying attention to foreign channels presenting distorted versions of what was happening thousands of miles away. A Pakistani Uber driver spoke with tears in his eyes about the futility of such a war, and blamed the highly corrupt generals of his country for creating such a hostile situation.

He'd left Pakistan over twenty years ago. "We work hard here... life is tough... fortunately, the law is the same for all... it's equal", he said. "But there is zero equality in Pakistan. Our elections are rigged. Our people are unhappy and helpless. Imran Khan remains in jail, even though people love him. Nobody has a voice. We can't speak up or complain. Pakistan has no money. When Pakistanis visit London, they can't afford Ubers, like Indians.

You are so much better off in India." As he dropped me off, he warned repeatedly against bag and phone snatchers. "Be careful, sister..." he gently added, "and look after yourself."

He waited till I crossed the road safely before driving away. That's tameez! "Operation Sindoor" was underway. My heart was in my mouth as I participated in a panel discussion on Shyam Benegal's Life and Films, organised by the well-respected UKAFF (27th edition), ably steered by Pushpinder Chowdhry and her "Tongues on



Fire" team. One of the organisers was receiving non-stop updates and live video footage of the attacks from her brother in Baramulla, where he lived with their parents

Despite the mounting tension, she remained calm and went about her responsibilities with admirable fortitude. My concentration had taken a hit.

I was receiving frantic texts about blackout drills, sirens and emergency instructions from the family in Mumbai. It was hard to focus on Mandi or Bhumika (my personal Benegal favourites). Goutam Ghose, my co-panellist, calmly went through his presentation, referencing multiple memories of his interactions with the much-admired, greatly loved late filmmaker.

Mercifully, by the time I landed in Mumbai, the horror of those terrifying few days was behind us. It has to be said loudly and clearly: this has been Indian Prime Minister Narendra Modi's finest hour. He was at his dazzling best as he took complete charge of the unfolding theatre of war. We are stuck with a dysfunctional neighbour hell bent on stirring conflict in our backyard, clearly instigated by sponsors: in this case, the devilish Chinese.

Given Pakistan's clumsy propaganda and amateurish disinformation, it's laudatory that India kept its cool despite extreme provocation, and did not jump the gun (literally)! We patiently waited to present hard evidence to critics. This was imperative for preserving India's credibility within the global community. We achieved it with ab-

solute finesse and assurance thanks to two brilliant individuals in the PM's team: external affairs minister S. Jaishankar and foreign secretary Vikram Misri. Mr Jaishankar's hard-hitting line, "need partners, not preachers", has gone down as a devastating snub to Europe for daring to tell us how to deal with the crisis. But the most memorable put-down aimed at silencing critics came from the PM's perfectly-timed visit to Adampur airbase, where he landed on the same runway Pakistan claimed to have bombed. He rallied not just troops but every Indian citizen. "I have come here for a darshan of our brave soldiers," Narendra Modi declared, against the backdrop of an S-400 launcher, as the nation cheered. He followed that up with a loud and clear warning to our hostile neighbour: "Stop supporting terror or face annihilation". Then came the chilling reference to "blood and water", leaving no room for debate.

There were several psychological firsts during this challenging period. Picking two outstanding women officers (Col. Sofiya Qureshi and Wing Commander Vyomika Singh) to lead the briefings on the Indian military strikes was pure genius: besides being an inspired tactic, it was a fitting reminder of India's supreme confidence in its armed forces, never mind gender.

"Operation Sindoor" may sound as melodramatic as an Ekta Kapoor serial from the 1990s... but it packed an unbeatable emotional punch, particularly in the context of a terrorist's taunt to a young wife ("Go tell Modi") during the dastardly Pahalgam attack.

The importance of scoring big in the psychological aspect of a military confrontation was underlined by Mr Modi's unambiguous language: don't mess with us, don't mess with our women

# Beat the heat naturally

Summer, the season of dreadful temperatures, have stolen everyone's cool. And the temperatures are only going to soar in the next couple of months. However, nature also provided a balance or rather a natural antidote in the form of seasonal fruits, one of the few things that can bring some of the cool back literally.

Most summer fruits are packed with hydration, vitamins and minerals, says Abhilasha V, a Bengaluru-based senior nutritionist.

Seasonal fruits like watermelon, muskmelon and the king of all fruits, the juicy, pulpy mango are natural heat busters, says Dr Neelu Malhotra, a Mohali-based diet consultant and nutritionist.

WATERMELON: The colourful red and green fruit has over 90 per cent water and keeps you cool and quenched, says Abhilasha. Watermelon is a good source of vitamin C. Its seeds are rich in potassium, needed for brain function,



controlling high blood pressure, water balance and flushing away toxins from the body, says Malhotra.

This juicy fruit has plenty of the carotenoid called lycopene, a compound which provides bright yellow, orange or red colour to fruits and vegetables. Lycopene is a powerful antioxidant. Antioxidants can destroy free radicals in the body.

Free radicals are harmful molecules, responsible for ageing and many serious diseases, including various cancers, adds Malhotra.

# A new challenge for Indian immigrants in the U.S.

major challenge is emerging for Indians living in the United States. Recently introduced in the U.S. Congress, 'The One Big Beautiful Bill' proposes a 5% tax on remitances sent abroad by non-U.S. citizens. This includes H-1B visa holders, green card holders, and other non-citizens. If passed, this bill will have a direct financial impact on millions of Indians working in the U.S. who regularly send money back home to their families in India.

The goal of this proposed tax is to generate additional revenue for the U.S. government. However, it has become a matter of concern for immigrant communities, particularly the Indian diaspora.

According to a report by the Times of India, this tax could cost the Indian community approximately \$1.6 billion (about Rs 13,000 crore) annually. Remit-

# Voices from the forest

he Indian side of the Sundarbans—the world's largest mangrove forest—is spread across approximately 4,000 square kilometres, consisting of 102 islands. Of these, 54 islands are inhabited and are administratively divided into 181 gram panchayats across six blocks of North 24 Parganas district and 13 blocks of South 24 Parganas district in West Bengal.

The region is home to around five million people, many of whom are facing severe livelihood crises triggered by the increased frequency of climatechange-influenced events like cyclones, tidal surges, erratic rainfall and so on. The most devastating cyclone to hit the area in the recent past was Cylone Aila in 2009. The last significant cyclone before Aila was in 1988; but in the last six years, five major cyclones — Fani and Bulbul in 2019, Amphan in 2020, Yaas in 2021 and Remal in 2024 — have impacted the region. While most of these events automatically get termed as natural disasters, a key point to note is that not everything

is 'natural' in these 'natural disasters'.

There is clear evidence that local, man-made factors are exacerbating the devastation in many such events. In fact, the present crises have been in the making for close to 250 years. They are



and align with the natural mangrove ecosystem of the area.

The British saw the mangrove

The British saw the mangrove landscape of the Sundarbans as a wasteland. Profit was a key motivation in the 1780s when East India Company officials actively pushed socially and economically marginalised people to settle down in the Sundarbans. The company had faced a severe financial crisis and, in 1773, had received from the British government what the historian, William Dalrymple, has termed as history's first mega corporate bailout.

For the EIC officials, clearing mangrove forests to bring more land under rice cultivation was a commercial decision.

The extraction, exploitation and exclusion continued under colonial rule. By the 1880s, timber from the mangrove forests became the commodity of choice. 'Scientific' forestry was introduced. As more people got settled, human-animal conflicts increased. The government's response in 1883, as revealed through archival research by Ranjan Chakrabarti, was to introduce a reward system of paying Rs 50 for

killing an adult tiger and Rs 10 for each cub, both huge sums of money at the time.

After Independence, by the 1980s, the focus had shifted to tiger conservation. While new laws to protect mangrove forests and its rich biodiversity got introduced, access of locals to the forest areas got restricted and many local occupations connected to the forest that had emerged to serve colonial interests got banned.

Ecologically, the inhabited islands are now distinctly different from the mangrove forests. The mangrove vegetation in these islands have all but disappeared. The hydrology of these islands — the tidal interplay so essential for sustaining a mangrove forest — has been completely transformed to be able to support agriculture. They now have an agrarian economy that has been imposed on what used to be a mangrove ecosystem. Yet, it is not uncommon for a person from a marginalised background to go into the forest to fish, catch crabs or collect honey, eke out a living during monsoon as a farm labourer or as a marginal farmer, and even resort to seasonal migration for certain months to work as a daily wager. Ironically, if the mangrove ecosystem thrives naturally, most aspects of

the local economy of the settled areas, as it exists now, will collapse. Understandably, sustaining local livelihoods in the Sundarbans is a significant development priority for the government and construction of concrete embankments have become a pivotal part of the government's developmental efforts.

A recent conversation during a visit to the Sundarbans with an acquaintance was an eye-opener for me. Chapal is from a landless family whose mud hut seemed especially vulnerable, located just outside an embankment right at the edge of a mangrove forest. Sitting in it, I could not stop myself from asking how people like Chapal coped with storm surges and high winds during cyclones.

Chapal commented that when alerts were issued for Cyclone Amphan in 2020, the family got into a small dinghy and took shelter inside the mangrove forest. Seeing my perplexed look, he smiled and said gently, "You will not get it, the forest is our second home, we go there all the time to catch

fish and crabs."

I know that mangroves are important shock absorbers during cyclones,

floods and tsunamis. But, through my lived experiences, I cannot imagine a mangrove forest as a safe space. I realised that the loss of mangrove cover of the inhabited islands has increased their vulnerability during climatechange-influenced events. More importantly, I realised that whether it is our imagination of the Sundarbans as home to the Bengal Tiger, or the decision to construct concrete embankments, to keep locals away as the principal way of protecting the forest, normalise the extraction of timber and the destruction of the ecosystem through 'scientific' forestry, perceive the mangrove ecosystem as a 'wasteland', the fate of Sundarbans' landscape has always been shaped by the outsiders' perceptions of it. Locals like Chapal, who feel most at home in the landscape and know it intimately, have never had any say in determining its fate.

It is now accepted globally that mangrove ecosystems play an important role in protecting biodiversity by serving as nurseries for many marine species. They are also a powerful natural ally against climate change, acting as efficient carbon sinks and shock absorbers during cyclones, floods and tsunamis. In the Sundarbans, the stakes are already very high.

## Shimla turns hostile: Stray dogs create citywide crisis **BUREAU** SHIMLA, MAY 17

Once known for its tranquil

beauty and British-era charm, Shimla is now spiraling into a dangerous urban crisis — a surge in aggressive, stray unchecked populations that are not just a nuisance, but a threat to public and life.Across neighborhoods, the streets of Shimla are no longer safe. Children walk to school gripped with fear, elderly citizens avoid stepping out early or after dusk, and joggers arm themselves with sticks for self-defense. From Lakkar Bazaar to Panthaghati, and from Chotta Shimla to Sanjauli, the city's once peaceful corners are echoing with barks and cries of distress.The number of dog



bite cases reported in hospitals has seen an alarming rise, some estimates suggesting a jump of over 40% in the past year alone. This growing menace is more than a health issue — it is a public safety emergency. Medical experts point out that even a single bite, if left untreated, can result in rabies, a disease that is almost always fatal once symptoms appear. India already accounts for

36% of the world's rabies deaths, and Shimla is now on the verge of contributing to that grim statistic.IGMC MS Dr Rahul Roy stated that average 50 cases of dog bites are reported to this single hospital.The threat goes beyond bites. Packs of stray dogs often chase twowheelers, putting lives at risk on Shimla's narrow and winding roads. In several incidents, pedestrians and

injuries while trying to escape sudden attacks. The fear of falling or being bitten is now a part of everyday life for residents. Animal waste and carcasses are commonly found near garbage dumps where these dogs scavenge, further compounding public health risks and affecting the city's hygiene. For a tourist destination that prides itself on being clean and green, this paints ' paints a disturbing picture.MC commissioner disturbing says that he is helpless and no Dr is available with them at MC .Residents are voicing their frustration and fear not out of cruelty, but out of helplessness. "How long should we live in fear of stepping outside our own homes?" asked a local mother whose daughter was bitten on

"We love animals, but we also deserve safety."The sterilization and vaccination programs that were supposed to control the stray population have failed to make any meaningful impact. In fact, in many areas, sterilized dogs have returned to aggressive behavior due to territorial conflicts and food scarcity.Shimla's growing stray dog population is no longer just a civic issue — it is a full-blown public health and safety crisis. Without a swift, scientific, and comprehensive intervention, the city risks losing not just its peace, but also the trust of its people and visitors. As the summer tourist season begins, the question Shimla must urgently answer is this: Will its streets remain free for peopleor continue to be ruled by fear.
