Five killed as car falls off bridge on Mumbai-Goa highway

RATNAGIRI: A car carrying seven people plunged nearly 100 feet from a bridge into the Jagbudi river on the Mumbai-Goa Highway near Bharne Naka in Ratnagiri district early Monday morning, killing five people. The victims were travelling from Mira Road in Mumbai to Devrukh to attend a funeral when the tragedy struck around 5:30 am. According to reports, the vehicle veered off the bridge near Khed and fell into the river. Five passengers died on the spot, while two others, including the driver, sustained serious injuries.

Survey To continue At Sambhal Mosque, **HC rejects muslim** side's Plea

NEW DELHI: The Allahabad High Court on Monday said the survey at a mosque in Uttar Pradesh's Sambhal will continue, rejecting the petition filed by the Muslim side. A single bench of Justice Rohit Ranjan Agarwal also said the order to appoint a court commissioner and the suit were maintainable The case centred around a civil revision petition filed by the Jama Masiid Management Committee, challenging the maintainability of a suit that led to a survev order by the Sambhal Civil Court.

SC rejects MP minister's apology on Col Sophiya, forms SIT for probe

NEW DELHI, MAY 19

The Supreme Court on Monday outright rejected the apology by Madhya Pradesh Minister Kunwar Vijay Shah over his

controversial comment on Col Sofiva Qureshi and ordered formation of a Special Investigation Team (SIT) to probe the incident.

senior Indian Police Service (IPS) officers has been asked to submit its status report by May 28. Shah, a BJP leader, has been directed to fully cooperate with the investigation.

"We are a country which follows rule of law. It is same for the highest to the lowest," the court observed.

The court expressed deep disapproval of the Minister's comment stating that he (Shah) had brought shame to the entire nation.

A bench comprising Justice Surya Kant and Justice N Kotiswar Singh was hearing Shah's plea challenging a Madhya Pradesh High Court order that had directed the registration of a criminal case against him.

The High Court had taken suo motu cognizance of Shah's alleged remark, Condemning the statement as "crass and shameful," the apex court remarked "the entire nation is ashamed of you. It is for you to decide how you wish to redeem vourself.

Mr Justice Kant took serious note of Shah's attempt to tender an apology, dismissing it as insincere and manipulative.

'We don't need this apology. You're not in contempt of court that you're offering it here. You commit a wrong and then try to escape through a hollow apology. Is this your attitude, the court asked.

The bench observed that Shah's

statement had deeply hurt public sentiment and that his so-called apology appeared crafted only to avoid legal conse-

The court further observed that Shah, a senior political figure, should have been far more cautious in his

> "You're a public figure. Your words carry weight. From the video, it appears you were on the verge of using abusive language but stopped mid-sentence perhaps out of self-restraint or simply because you couldn't find the right

Rejecting the Minister's claim of genuine regret, the court said, "If you call this genuine regret, we outright reject it. You've said, 'If I've hurt anyone, then I apologize' this kind of conditional apology is unacceptable. You don't even acknowledge the harm

Clarifying that the high court had not passed a conviction but merely directed the registration of an FIR, the Supreme Court concluded, "We are a country governed by the rule of law. The same standards apply to all.

Top court agrees to hear plea of Ashoka University professor against arrest

NEW DELHI: The Supreme Court on Monday agreed to hear plea of Ali Khan Mahmudabad, associate professor and head of the Political Science department at Ashoka University in Harvana, against his arrest over a social media post on Operation Sindoor. A bench of Chief Justice of India BR Gavai and Justice Augustine George Masih said it would list the matter for hearing on May 20 or 21. The bench agreed to give urgent hearing of the plea after senior advocate Kapil Sibal mentioned it seeking urgent hearing. "He has been arrested for a patriotic statement. Please list it." Sibal said.

Delhi Police has busted a fake government job recruitment racket and arrested two men, including its kingpin, officials said on Monday.

The main accused, identified as Rashid Choudhury, a native of Hyderabad, allegedly ran a cyber scam by using the name "National Rural Development and Recreation Mission (NRDRM)" to falsely present it as a government body under the Ministry of Rural Development, police said.

"The matter came to light following a com-



plaint from the Ministry of Rural Development on March 22, reporting fake recruitment advertisements on two different fake websites featuring images of Union ministers and top officials to mislead job seekers

Traffic fines in India top Rs 12,000 cr, exceeding GDP of several small nations police officer. As many as 51.3 per cent said they immediately check

AGENCY NEW DELHI, MAY 19

A recent survey report by CARS24 has revealed that traffic violation fines imposed in India have surpassed the GDP of many small nations. According to its 2024 report, approximately 8 crore traffic challans were issued, with total fines of around Rs 12,000 crore. This means almost every second vehicle on the road has been fined at least once. However, a significant portion (Rs 9.000 crore) remains unpaid. Out of the 140 crore people living in India, only 11 crore own a vehicle. This shows that a relatively small section of the population is responsible for a large number of violations, raising concerns about traffic discipline and accountability. Many drivers follow traffic rules only when law enforcement is present, indi-

cating that fear rather than habit



adjusts their driving based on law enforcement, only 43.9 per cent of the respondents claimed they follow traffic rules regardless of whether police are present. On the other hand, 31.2 per cent said they occasionally check for police before adjusting their driving,

monitoring their surroundings to avoid being fined. This highlighted that many drivers consider traffic rules to be optional unless law enforcement is visibly present.

The survey also looked into how people react upon spotting a traffic

they slow down instinctively, even if they are not breaking any rules. Meanwhile, 12.9 per cent said they either change their driving behaviour or take a detour to avoid getting caught. When it comes to the impact of surveillance on road behaviour, 47 per cent of the respondents claimed they drive the same way regardless of CCTV cameras. Around 36.8 per cent admitted to slowing down only when they spot a camera, and 15.3 per cent said they adjust their driving only for speed cameras, ignoring other types. Surveillance technology alone is not enough to bring about behavioural change unless penalties are strict enough to instil fear.

Two held for leaking sensitive military information to Pakistan's ISI

VERMA GURDASPUR, MAY 19

In a major counter-espionage operation amidst the ongoing drive to make Punjab a safe and secure state as per vision of Chief Minister Bhagwant Singh Mann, Gurdaspur Police has arrested two individuals for leaking critical information concerning the Indian Armed Forces to Pakistan's Inter-Services Intelligence (ISI), said Director General of Police (DGP) Punjab Gaurav Yadav here on Monday.

Those arrested have been

identified as Sukhpreet Singh, a resident of village Adiyan in Gurdaspur and Karanbir Singh, a resident of Chandu Wadala in Gurdaspur. Police teams have also recovered three mobile phones and eight live cartridges of .30 bore from their possession.

DGP Gaurav Yadav said that Gurdaspur Police has thwarted an attempt to compromise national security by apprehending these two persons involved in leaking sensitive military information, related to 'Operation Sindoor,' including troop movements and key strategic locations in Punjab, Himachal Pradesh, and Jammu & Kashmir, with their ISI handlers.

He said that preliminary investigation has confirmed both the accused were in direct contact with ISI operatives and had transmitted critical information concerning the Indian Armed Forces.

Reiterating that the Punjab Police stands strong with the Indian Army, the DGP said that any attempt to undermine the security of our armed forces will be met with firm and immediate action. Further investigation in this case in ongoing and more dis-

closures are expected as the probe deepens, he said.

Sharing operation details, Senior Superintendent of Police (SSP) Gurdaspur Aditya said that on May 15, 2025, credible intelligence inputs indicated that suspects Sukhpreet Singh and Karanbir Singh were engaged in sharing defence-related classified details with ISI handlers. Act-

both the suspects under surveillance and apprehended them, he said. He said that forensic examination of their mobile phones has confirmed the intelligence inputs. Preliminary investigation has revealed that the arrested accused persons were passing on military secrets in exchange for monetary benefits, he said. "During the investigation, it was also discovered that they were previously involved in drug smuggling activities, through which they came into contact with ISI handlers. Their financial transactions, including online and cash dealings, also came under scrutiny," said the SSP, while adding that further investigations are on.

Arrangements done for uninterrupted power supply during paddy season: Harbhajan Singh ETO

CHANDIGARH, MAY 19

The Punjab Government led by Chief Minister Bhagwant Singh Mann has completed all arrangements to ensure uninterrupted power supply to farmers during the paddy season.

Announcing this while addressing a press conference here today, Punjab Power Minister Harbhajan Singh ETO said that Chief Minister Bhagwant Singh Mann has issued directives to promote DSR (Direct Sowing of paddy) in the state. In view of this the schedule for direct sow ing of paddy has been released earlier than in previous years. The Cabinet Minister further stated that it takes approximately 3,800 liters of water to produce one kilogram of rice using traditional methods, whereas the DSR method can save 400-500 liters of water per kilogram of rice. In addition, the state government provides a subsidy of ?1,500 per acre to farmers who adopt the DSR method. The Power Minister added that uninterrupted electricity supply for 8 hours daily will be ensured during the paddy season, and this

the paddy season, and this duration may be extended if necessary. Out of the 15 exist ing power units in the state 14 are currently operating at full capacity, and the remain ing unit will be functional within the next three days He noted that last year, the peak electricity demand in the state was 16,058 MW, and this year, arrangements have been made for 17,000 MW. Furthermore, the power plants have a 30-day coal reserve, and transmission in frastructure in the state has also been upgraded. The Power Minister stated that paddy sowing, including direct sowing (DSR), will be conducted in a phased manner according to the prescribed schedule.

Though Deputy Chief Minister recently issued a clarification assuring continuation of the benefit, Nanda claimed there were discussions underway to withdraw this concession in urban areas — a proposal likely to be presented in the upcoming cabinet meeting on May 19. Pointed out that while the state currently offers 50% fare relief to all women passengers, the government seems inclined to revoke this for urban areas in a bid to increase revenue.

Hod Chhilar Village in Haryana reclaims its identity after 41 years in presence of senior officials

After 41 long years, the village of Hod Chhilar in Haryana, which witnessed unspeakable tragedy during the anti-Sikh riots of 1984, has finally reclaimed its lost identity. This milestone was marked in the presence of senior administrative officers and local leaders.On November 2, 1984, a violent mob carried out a well-planned massacre in Hod Chhilar, brutally killing 32 Sikhs and throwing their bodies into a nearby well, which was later set ablaze with kerosene. At the time, 18 Sikh families lived in grand ancestral havelis in the village. Following the massacre, surviving families fled in fear and trauma to various cities across India, taking shelter with relatives. In the aftermath, wealthy individuals from the region began encroaching on the abandoned properties, demolishing the havelis and illegally cultivating land that belonged to the Sikh families. Speaking on the matter, Bhai Darshan Singh Gholia, President of the Hod Chhilar Sikh Justice Committee, revealed that despite years of silence and pain, efforts to reclaim the land and identity of the martyrdom village intensified recently. With the cooperation of Haryana administration

officials and the local village head (Sarpanch) Ravi Kumar Chhilar, progress has finally been made.During a seven-hour-long land verification and survey process, tense moments arose, including heated arguments between Tehsildar Vinash Kumar, Kanungo Vijay Singh, Patwari, and Marker Mukesh Kumar. Yet, significant discoveries were made: Three to four old village roads were uncovered, Seven acres of land were reclaimed, The original Gurdwara Singh Sabha land was identified, And the historic Shaheedi Khooh (Martyrdom Well) was located. To mark the boundaries of the rediscovered land. seven-foot-tall boundary stones were installed in the presence of Haryana government officials, farmers, and local leaders. Interestingly, records revealed that some of the land had been transferred to the Central Government after 1984, while other parts remained under the Chhilar Panchayat in the revenue department's records. 

Take precautions to prevent dengue and malaria

MAINPAL KASHYAP

Senior Medical Officer of local Civil Hospital, Dr. Satvir Singh, while alerting people about health, said that different types of mosquitoes spread many serious diseases like dengue, chikungunya, malaria and Japanese brain fever. Many concrete steps have been taken by health department to prevent them.Dr. Satvir Singh said that female Anopheles mosquito, which spreads malaria, bites mostly at night and the female Aedes mosquito, which spreads dengue and chikungunya, bites during the day. He said that the female mosquito lays eggs in stagnant clean water such as drains, water pits, water storage tanks, near water taps, coolers, flower vases. open bottles, broken utensils, old tyres and tubes, open boxes, plastic bags, water pots kept for birds, heaps of wet garbage and other such useless things in which water stagnates.Dr. Satvir Singh said that main symptoms of dengue are high fever, severe



headache, pain behind eves (which increases on moving the eyes), pain in muscles and joints etc. Similarly, main symptoms of Chikungunya are pain and swelling in joints along with fever, sudden increase in fever with shivering and chills, headache etc. He said that in case of malaria, high fever comes with severe chills and shivering at regular intervals of one, two or three days which subsides in about two hours. Dr. Satvir Singh said that pre-

vention of mosquito-borne diseases is simple and inexpensive. For this, some common precautions and careful treatment is required such as preventing the Aedes mosquitoes from breeding and preventing their bites. He said that people should not allow water to collect in and around the house. Fill the pits with soil. Clean the blocked drains. Keep water tanks, utensils etc. properly covered so that mosquitoes cannot enter and breed in them. Empty the wa-

ter collecting tray kept under the refrigerator daily. Keep the house and surrounding area clean. Some small types of fish (such as Gambusia, Labister) can also be put in water sources. These fish eat eggs/larvae of mosquitoes growing in water. He told that to drive away or kill mosquitoes, use liquid medicine, cream, spray, mats, mosquito repellent incense sticks etc. properly. After spraying liquid medicine, spray or burning mosquito repellent incense sticks etc., close the room for half an hour and come out so that the mosquitoes die.

Wear socks, shoes and full-sleeved clothes that cover the maximum part of the body and mosquitoes cannot bite. This precaution is also necessary for children. He told that dengue patients must use mosquito nets so that this disease does not spread further. To avoid bites of female Anopheles mosquitoes which spread malaria in a cheap and effective way, be sure to use mosquito nets at night.

Sharp nose

atriotism can now be worn on the sleeve literally. An illustrative development in the wake of India's military retaliation against Pakistan after the butchering of tourists by terrorists in Pahalgam — Operation Sindoor was the code name of this endeavour — has been the feverish sale of merchandise that cashes in on the Indian military's firm action. For instance, an entrepreneur based in Himachal Pradesh had embossed a reply by an air marshal during a press conference on T-shirts; a saree seller in Karnataka rebranded his stock of red-and-maroon apparel as 'Sindoor sarees'. Both products are apparently selling like the proverbial hot cake. Other producers, unsurprisingly, have been keen to cash in on this phenomenon as well. This spirit of innovation is not quite novel. Historians tracking mass sartorial taste would point out that several items that have tasted popularity globally bomber jackets, cargo pants, pea coats, aviator sunglasses, the trench coat, to name a few — have intrinsic links to military wear and conflicts. Nonetheless, the development, it must be admitted, lays bare, once again, not only the market's nose for the pulse of the people but also its ability to make use of prevailing consumer sentiments to profit commercially. Another line of thought would argue that this is the aam aadmi's way of expressing solidarity with their brethren in the

But as is often the case, a phenomenon, no matter how popular, is often dual-edged. There is an ethical side to the monetisation of conflict that cannot be ignored. After all, a military engagement, no matter what its scale and result, entails the loss of lives of not just soldiers but also ordinary people. Perhaps this explains the sensible decision on the part of one of India's biggest business houses to step back from applying for a trademark for Operation Sindoor.

The installation marks a significant milestone for the temple and the Hindu community in the region, the report said.

In a post shared on X, Indian Embassy in Guyana stated, "A 16 feet Murti of Bhagawan Hanuman ji has been installed in Essequibo at the Seeta Ram Radhey Shyam Mandir in Sparta- as a symbol of faith, friendship and firm resolve. Drinking more water may lower risk of high blood pressure

People with higher sodium levels -- still within the normal range -- are more likely to develop high blood pressure and heart failure, but staying well-hydrated can help prevent these problems, Israeli scientists said on Sunday.

from Bar-Ilan University examined 20 years of electronic health records from more than 407,000 healthy adults enrolled in Leumit Healthcare Services, one of Israel's largest health providers. Their findings, published in the peer-reviewed European Journal of Preventive Cardiology, suggest that individuals with sodium levels at the higher end of the normal range face significantly elevated risks for high blood pressure and heart



failure.Till now, the 135-146 mmol/L sodium range was broadly accepted as "normal," with little clinical concern unless levels were outside this band. But the Barllan study found that otherwise healthy individuals with sodium levels between 140-146 mmol/L still face measurably higher risks of developing chronic cardiovascular conditions.For those with levels above 143 mmol/L, the risk jumped to

29 per cent for hypertension and 20 per cent for heart failure. "Our findings point to hydration as a critical and overlooked part of chronic disease prevention," said Prof. Jonathan Rabinowitz of the Weisfeld School of Social Work at Bar-Ilan University, who led the study. "A simple blood test might flag people who could benefit from basic lifestyle adjustments-like drinking more water, which reduces sodium levels."

Bangladesh will discuss with India to resolve trade problems

After India placed curbs on Bangladeshi exports via land ports, the interim government in the country says it wants to resolve all trade problems with India. An Adviser to the Interim government of Bangladesh led by Nobel Laureate Muhammad Yunus, said that Bangladesh wants to discuss all issues with India.

Recently, India had banned the import of Ready Made Garments (RMG), Fruit/Fruit flavoured and carbonated drinks, baked goods, snacks, chips and confectionary, cotton and cotton yarn waste, plastic and PVC finished goods and wooden furniture from Bangladesh by road. Earlier, Bangladesh had banned the import of yarn from India




by land route. India had also cancelled the transshipment facility for the export of goods from Bangladesh to third countries. Thus, reciprocal trade restrictions are being imposed between the two neighbouring countries. "We do not know anything officially about India's steps yet. We will be able to take action after we know offi-

cially. She expressed concern over the widespread misinformation about the disease, which can hinder timely treatment and proper care. "IBD in children is no longer rare. Factors like dietary changes, urban lifestyles, and the overuse of antibiotics have contributed to this growing burden. What's deeplyconcerningistheamount of misinformation in public

discourse," she said.

Emphasizing the vital role of public healthcare in combating misinformation and ensuring early diagnosis, Dr Lal said, "If public-sector research and education don't step in, patients fall prey to half-truths and delayed treatments. In paediatric IBD, timely diagnosis, tailored treatment, and informed choices are crucial - not just for disease control but also for a child's growth, schooling, and social well-being and

individual," she stated Dr Lal underscored that pediatric IBD with onset from less than a year to 18 years, often manifests more severely than in adults, with a higher likelihood

of requiring surgical intervention and potential longterm developmental impacts. "Treating children like small adults is a clinical misjudgment. Pediatric IBD demands pediatric expertise, and children upto at least 18 years with IBD must be treated by Paediatric Gastroenterologists not Adult physicians due to the different behaviour and special needs of this population" she emphasized.

During the session, Dr Lal, explained the differences between Ulcerative Colitis and Crohn's Disease, the two most common types of IBD. She also highlighted monogenic IBD, which affects only children under two to 5 years of age and requires a distinct approach for diagnosis and needs tailored

Theimportanceofnutrition was also emphasized, with Dr. Lal advocating for a diet based on fresh, well-cooked, natural foods, while cautioning against processed, spicy, and fried items that can worsen inflammation. "Well-cooked, fresh, and natural food forms the base of dietary therapy, while processed, spicy, and deep-fried foods exacerbate inflammation and must be avoided," she

VB nabs Kanungo red-handed accepting Rs 25,000 bribe

SANGRUR: Continuing its relentless crackdown on corruption, the Punjab Vigilance Bureau (VB) has apprehended field kanungo, Avtar Singh, posted at subtehsil Sherpur, district Sangrur, red handed while accepting a bribe of Rs 25,000. Municipal Corporation Commissioner Dr. Vaishali Sharma held an important meeting regarding flood control preparation so that the city residents did not face any problems during monsoon. In the meeting, she instructed the engineers to ensure that all the rain drains, drains and culverts should be cleaned before June 15. Engineers from Municipal Corporation, Irrigation, Haryana Urban Development Authority and Public Health and Engineering Department attended the meeting.

The Municipal Commissioner directed the SDO of the Irrigation Department to get the drain number-1 cleaned from Heritage Lawn culvert to Aavardhan Canal at a fast pace. The drain number-1 culvert in Ansal Town should also be widened so that there was



no obstruction in the drainage of water. She said that the drain number-1 should be cleaned from Aavardhan Canal to Indri Escape and Yamuna River. She directed the Executive Engineer of Irrigation vide five dewatering pumps in

working condition to the Municipal Corporation for flood relief work in the city and also directed the SDO of Sub-Division Indri Water Services to get the work of the culvert under construction near Heritage Lawn completed soon.

She asked the Superin-

tending Engineer, HSVP to get the RCC box drain cleaned from NH-44 to Mela Ram School. On this, the Superintending Engineer said that it was cleaned last year itself. There was no need to clean it as there was no accumulation of dirt or mud in it. However, there was dirt in some part of this drain towards Mela Ram School culvert, which will be cleaned. The Municipal Commissioner directed the SE to get the drains from Government College in Sector-14 to Clock Tower Chowk and from this Chowk to Ambedkar Chowk cleaned properly, so that the mud or soil that has entered the drains due to the construction work of the over bridge can be removed.

The SE informed the Municipal Commissioner that he was going to get the main trunk sewer line cleaned from Meerut Road Chowk to Mughal Canal.




