4 children killed, 38 injured in bomb blast in Pak

KARACHI: At least four children were killed and 38 others injured when a school bus was hit by a blast in Pakistan's Balochistan province on Wednesday morning, ac cording to media reports The blast occurred in the Khuzdar district, the Dawn newspaper reported, quoting Khuzdar Deputy Commissioner Yasir Iqbal Dashti. The bus was targeted when it was near Zero Point. Four children were killed in the blast while 38 others were injured, Dashti said, adding that the bodies and those injured were shifted to a nearby hospi-

stan-based Lashkar-e-Taiba (LeT) co-founder Amir Hamza was seriously iniured under mysterious circumstances and was admitted to a hospital in Lahore under heavy ISI se curity

The 66-year-old editor of LeT magazines was critically injured at his home and is now undergoing treatment at a military hospital in Lahore under ISI protection

The incident comes three days after Abu Saifullah, a senior LeT operative and key recruiter, was shot dead by unidentified assailants in Pakistan. Telegram channels linked to LeT supporters said on Tuesday evening that members must remain strong during the "crisis" and called the incident just an "accident".

C'garh: Topmost Maoist leader Basavaraju among 27 killed **HM Amit Shah lauds security forces**

AGENCY NEW DELHI, MAY 21

CPI-Maoist general secretary Nambala Keshav Rao alias Basavaraju, the top-most leader and backbone of the Naxal movement, was among the 27 dreaded Naxals killed by security forces in Chhattisgarh on Wednesday, Union Home Minister Amit Shah announced.

He also said that this is for the first time in three decades of India's battle against Naxalism that a general secretary-ranked leader has been neutralised by the security forces.

"A landmark achievement in the battle to eliminate Naxalism. Today, in an operation in Narayanpur, Chhattisgarh. our security forces have neutralized 27 dreaded Maoists, including Nambala Keshav Rao, alias Basavaraju, the general secretary of CPI-Maoist, topmost leader, and the backbone of the Naxal move-ment," Shah wrote on X.

Applauding the "brave security forces and agencies for this major breakthrough", the home minister said he was glad to share that after completion of Operation Black Forest, 54 Naxalites have been arrested and 84 others have surrendered in Chhattisgarh, Telangana, and Maharashtra.

"The Modi government is resolved to eliminate Naxalism before the 31st of March 2026," he said.

Basavaraju was in his late 60s, officials said.

The encounter took place in dense forests of Abhujmad on the tri-junction of Narayanpur-Bijapur-Dantewada districts, they said.

The operation involving personnel

750 pilgrims selected for upcoming Kailash Manasarovar Yatra



NEW DELHI: A total of 750 pilgrims were chosen through a computerised draw of lots on Wednesday for the upcoming Kailash Manasarovar Yatra in Tibet which is taking place after a gap of nearly five years. The resumption of the Yatra is being seen as an attempt to normalise India-China relationship that was severely hit by the eastern Ladakh border standoff. This year's pilgrimage will begin in June and continue until August, the Ministry of External Affairs (MEA) said.



Kaithal, Jind, Sirsa, Mahendragarh, Bhiwani, Charkhi Dadri, Fatehabad, and Mewat (Nuh), which has now been approved by the Chief Minister.

Sh. Vij informed that about Rs. 12 crores will be spent on infrastructure, furniture, vehicles, fuel, etc., for the establishment of these 12 Labour Courts. At present, nine Labour Courts are operational across six districts-one each in Ambala, Panipat, Hisar, and Rohtak; two in Gurugram; and three in Faridabad. One Labour Court is currently under construction in Bawal, Rewari district. Additionally, as per the 2025-26 budget speech, approval has already been granted for the establishment of one Labour Court each in Sonipat, Jhajjar, Palwal, and Rewari. This brings the total to 14 Labour Courts either operational, under construction, or approved across 10 districts.

Now, as a result of Sh. Anil Vij's efforts, the process for establishing 12 new Labour Courts in the remaining districts of the state has been finalized. With this, Harvana will have a total of 26 Labour Courts. Sh. Anil Vij stated that his aim is to ensure the swift resolution of industrial disputes related to the Labour Department, so that workers receive timely justice. To achieve this goal, Labour Courts are being established in every district, he added.

Ashoka University professor gets relief from court

The Supreme Court on Wednesday granted interim bail to Ali Khan Mahmudabad, associate professor and head of the Political Science Department at Ashoka University in Harvana, who was arrested over a social media post on Operation Sindoor.A bench of Justices Surya Kant

and N Kotiswar Singh refused to stay the two FIRs registered by Haryana Police against him, saying he has not made out any case for a stay on investigation. However, the bench released him on interim bail."We direct the petitioner to be released on interim bail subject to furnishing of bail bonds to the satisfaction of the CJM Sonepat," ordered the bench while

imposing certain conditions on his release. The apex court re-strained the associate professor from making any further online posts or speeches on the issue. No article or online posts are to be made, nor will any speech be delivered on the subject matter of the case. Further, he was re-trained from making any comments on the terrorist attack on Indian soil or the counter-re-

sponse given by India. The bench also asked him to surrender his passport.It also ordered constitution of a Special Investigation Team (SIT) within 24 hours to probe the matter. The top court directed that the SIT will be comprised of senior IPS officers, who do not belong to Haryana or Delhi and one officer of the SIT should be a woman

Kannada writer Banu Mustaq wins International Booker Prize

AGENCY LONDON, MAY 21

In a signifacant literary breakthrough, Indian writer, lawyer and activist Banu Mustaq has become the first author writing in Kannada to win the prestigious International Booker Prize for her powerful short story anthology 'Heart Lamp'.

It is the first short story collection

to win the presigious prize. The anthology, spanning 12 stories written between 1990 and 2023, was translated into English by Deepa Bhasthi, who also became the first Indian translator to win the coveted literary award.

This book was born from the belief that no story is ever small; that in the tapestry of human experience, every thread holds the weight of the



whole," Mustaq declared in her acceptance speech.

"In a world that often tries to divide us, literature remains one of the last sacred spaces where we can live

inside each other's minds, if only for a few pages," she added. Hailing from a modest township

in Karnataka, Mustaq's journey to authorship was anything but conven-

tional. Her short story appeared in a local magazine a year after she had married a man of her choosing at the age of 26, but her early marital years were also marked by conflict and strife - something she openly spoke of, in several interviews

Over the years Mushtaq's writings have won numerous prestigious local and national awards including the Karnataka Sahitya Academy Award and the Daana Chintamani Attimabbe Award. Mushtaq's win comes off the back of Geetanjali Shree's Tomb of Sand - translated from Hindi by Daisy Rockwell - winning the prize in 2022, reports BBC. In 2024, the translated English compilation of Mushtaq's five short story collections published between 1990 and 2012 - Haseena and Other Stories - won the PEN Translation Prize.

Impose at least 100 percent import duty on Turkey apple, CM writes to PM

AGENCY SHIMLA, MAY 21

Chief Minister Thakur Sukhvinder Singh Sukhu has urged Prime Minister Narendra Modi to increase the import duty on apples from 50 percent to at least 100 percent to discourage the import of apples from Turkey and to safeguard the interests of the apple growers of Himachal Pradesh. He also urged that quantitative restrictions should also be imposed on imported apples.

In a letter to the Prime Minister, the Chief Minister said that Himachal Pradesh is known as 'Apple Bowl' of the country and is famous for producing delicious varieties of apple. The apple is prime cash crop of the State and generates an income of about Rs. 4500 crore annually. He said that about 10 lakhs mandays are generated due to apple crop, thereby providing direct and



indirect employment to more than 2.50 lakh families.

Shri Sukhu stated that at present apples are being imported from nearly 31 countries and about 5.19 lakh metric tonne of fresh apples was imported during the year 2024, an increase of 500 time as compared to 1100 metric tonne imported during the year 1998. He said that the import share from Turkey was increased during the year 2020 and recorded

highest increase with 1.29 lakh metric tonne during the 2023. He said that substantial import of 1.17 lakh metric tonne was done from Turkey during 2024 which is 23 percent of the total apple import. The Chief Minister said that

apples from Turkey have been flooding the Indian markets in the recent years, which has posed a great threat to the apple growers of the country. The influx of apples from Turkey has not only

undermined the competitiveness of local apple producers but also jeopardizes the livelihoods of small and marginal apple growers of Himachal Pradesh, Uttarakhand and Union Territory of Jammu & Kashmir. Shri Sukhu said that he would also personally take up the issue for enhancing the import duty on apples being procured from Turkey with the Prime Minister during his upcoming visit to Delhi.

Forest department under fire for burning plantation in Bhingu

AGENCY SHIMLA, MAY 21

A mock drill conducted by the Forest Department to train staff in fire-fighting techniques went terribly wrong in the Bhingu forest under the Ghumarvi range, as the fire lit for practice engulfed a plantation spread across two bighas. Villagers claimed that nearly 1,000 pomegranate and teak plants, raised under the JICAfunded biodiversity conservation project, were destroyed in the blaze. The plantation, nurtured over the last four years by forest lovers of the village, was part of a Palmarosa grass cultivation project meant to generate income through the extraction of aromatic oils. Villagers allege that nearly Rs 25 lakh had been spent on the initiative so far, and the mock drill has now rendered it useless.

Former JICA committee head Rajesh Sharma, along with Joginder Singh, Sitaram, Ramesh Chandra, Manoj Kumar and others, blamed departmental negligence for the damage. They demanded a high-level probe into



the incident, criticizing the department for wasting resources in the name of mock drills that yield no real results.

Officials including Forest Range Officer Hansraj and Section Officer Deshraj maintained that the drill was conducted as per standard procedures and claimed that only one bigha of open area without trees was designated for the exercise. However, the fire reportedly spread beyond control, aided by dry undergrowth.

The villagers also pointed out the irony that in a summer marked by multiple rain spells and fewer forest fires, it was the government machinery itself that caused preventable destruction.

Sweet success: Anubhav Sood earns Rs 30 lakh annually through beekeeping

His venture has also created direct employment for 10 other individuals. Sood's inspiring journey has become a model for youth seeking self-employment. Under the brand 'Pahadi Honey', he markets various high-quality honey varieties such as Black Forest, Black Diamond, Multiflora, Saffron, and Acacia. These products are now gaining popularity well



beyond Himachal's borders. Inspired by his mother, Nisha Sood, who is involved in food processing, Anubhav received training through the Horticulture Department at Dr. YS Parmar University of Horticulture and Forestry in Solan, and at Sher-e-Kashmir Agricultural University in Katra. With 80% subsidy support under the Mukhyamantri Madhu Vikas Yojana, he began his

enterprise with 25 bee boxes. The initial success encouraged him to expand through a Rs 10 lakh loan under the Prime Minister's Employment Generation Programme (PMEGP). Today, he operates 300 beehive boxes, producing around 10,000 kilograms of honey annually. His honey, priced between Rs 500 and Rs 1,200 per kilogram depending on variety and quality, is FSSAI-certified.

Decomposed, mutilated body found in Western Yamuna Canal near Dhanora Jagir

INDRI: Panic spread in the region after a decomposed body of an unidentified man was found under suspicious circumstances in the Western Yamuna Canal near Dhanora Jagir village. The body, with its neck and one hand severed, was spotted floating under the canal bridge by passersby, who immediately alerted police through Dial 112. Police reached the spot swiftly and, with the help of local residents, retrieved the body from the canal. The corpse was found in an advanced state of decomposition, and its identity has not yet been established. Authorities suspect that the man was murdered and his body dumped in the canal several days ago. The body has been sent to Kalpana Chawla Government Medical College and Hospital in Karnal for postmortem examination. The case is being thoroughly investigated. Station House Officer of Indri Police Station, Vipin, said that the initial information came from the sarpanch of Dhanora Jagir, who reported the presence of a badly decomposed body under the canal bridge. "Given the condition of the body and the missing neck and hand, foul play is strongly suspected. We are probing all possible angles," he said.

Rs 41,000 is given for girls from Backward Classes and General Categories whose family income does not exceed Rs 1.80 lakh per annum. Rs 51,000 is provided to widows, orphans, divorced, and destitute women, as well as their children. Women sportspersons (with annual family income up to Rs 1.80 lakh) are also eligible for Rs 41,000 in assistance. If both bride and groom are differently-abled, the assistance is Rs 51,000; if only one is differently-abled, the amount is Rs 41,000.

According to local people, immediately after the accident, the dumper driver tried to run away, but passersby caught him and handed him over to the police who reached the spot. Social organizations and local people have appealed to come forward to help Shashi Bala's family. The police have taken the dumper driver into custody and started an investigation. Shashi Bala's death not only took away the support of her children, but also created a lot of anger in the area. This is not the first case, in the last few months, many lives have been lost in Ambala area due to overloaded and high speed vehicles. A few months ago, a dumper had crushed three children, while a woman and her daughter died in the Saha area. Near Ugala also, two bullet riders had lost their lives due to a collision with a dumper. Despite these incidents, the action of the administration and the police has proved inadequate so far.

Editorial Good move

f the many strategic gains that India can claim from Operation Sindoor, few represent as dramatic a turnaround as the growing bonhomie between New Delhi and the Taliban rulers of Afghanistan. Last week, the external affairs minister, S. Jaishankar, spoke to the Taliban's foreign minister, Amir Khan Muttaqi, marking the highest-ever public contact between Kabul and New Delhi, building on a rapidly developing relationship that would have been impossible to imagine four years ago. Mr Jaishankar thanked Mr Muttaqi for the Taliban government's unequivocal condemnation of the Pahalgam terrorist attack on April 22 that triggered a brief but intense military confrontation between India and Pakistan. He also thanked his Taliban counterpart for rejecting false suggestions emanating from Pakistan that India, in the course of Operation Sindoor, had fired missiles into Afghanistan. For 25 years since the Taliban first grabbed power in Afghanistan in 1996, then was ousted by an invasion by the United States of America in 2001, and eventually took charge again in 2021, India viewed the group as a proxy of Pakistan's military and intelligence services. India blamed the Taliban and their allies like the Haqqani network for carrying out multiple deadly attacks against its embassy and consulates in Afghanistan. For the same Taliban — with the Haqqanis in senior ministerial positions - to now effectively serve as potential allies against terrorism is a stunning shift in India's relationship with the Afghan group.

Jaishankar's call with Mr Muttaqi has been years in the making. Soon after the Taliban returned to power, they indicated that they wanted better ties with India where thousands of Afghans study and seek medical treatment. At the same time, the Taliban's relations with Pakistan soured, with Islamabad accusing its former allies of allowing anti-Pakistan terror groups to operate from Afghan soil.

Since then, India has carefully built up its ties with the Taliban, including through a meeting in January between India's foreign secretary, Vikram Misri, and Mr Muttaqi. A deepening relationship with the Taliban even though India does not recognise the group's government in Afghanistan — helps New Delhi strategically in its efforts to put pressure on Pakistan. The Taliban are also seeking wider diplomatic recognition: Mr Muttaqi was in Iran over the weekend, is in China this week, and will also meet Pakistan's foreign minister in Beijing.

First global pandemic agreement



In a move aimed at safeguarding global health, Member States of the World Health Organisation (WHO) have unanimously adopted the world's first Pandemic Agreement at the 78th World Health Assembly. The agreement seeks to boost international coordination and ensure equitable access to life-saving tools during future pandemics, while reaffirming respect for national sovereignty in public health decisions.

public health decisions. In a press release on Tuesday, the WHO said, "Member States of the World Health Organisation (WHO) today formally adopted by consensus the world's first Pandemic Agreement. The landmark decision by the 78th World Health Assembly culminates more than three years of intensive negotiations launched by governments in response to the devastating impacts of the COVID-19 pandemic, and driven by the goal of making the world safer from - and more equitable in response to - future pandemics."

Tedros Adhanom Ghebreyesus, WHO Director-General, hailed the agreement as a victory for public health and said it will safeguard the world from future pandemic threats."The world is safer today, thanks to the leadership, collaboration and commitment of our Member States to adopt the historic WHO Pandemic Agreement.

The Agreement is a victory for public health, science and multilateral action. It will ensure we, collectively, can better protect the world from future pandemic threats. It is also a recognition by the international community that our citizens, societies and economies must not be left vulnerable to again suffer losses like those endured during COVID-19," Ghebreyesus said. The governments adopted the WHO Pandemic Agreement today in a plenary session of the World Health Assembly, WHO's peak decision-making body. The adoption followed yesterday's approval of the Agreement by vote (124 in favour, 0 objections, 11 abstentions) in Committee by Member State delegations. The WHO Pandemic Agreement sets out the principles, approaches, and tools for better international coordination across a range of areas, strengthening the global health architecture for pandemic prevention, preparedness, and response.

This includes equitable and timely access to vaccines, therapeutics, and diagnostics.Regarding national sovereignty, the Agreement stated, "Nothing in the WHO Pandemic Agreement shall be interpreted as providing the Secretariat of the World Health Organisation, including the Director-General of the World Health Organisation, any authority to direct, order, alter or otherwise prescribe the national and/or domestic law, as appropriate, or policies of any Party, or to mandate or otherwise impose any requirements that Parties take specific actions, such as ban or accept travellers, impose vaccination mandates or therapeutic or diagnostic measures or implement lockdowns."

Since the outbreak of the Gaza war in 2023, the US has sought to avoid such escalation.

Nagas of Manipur preserve heritage through handloom and handicrafts

Nagas are the third-largest ethnic group in Manipur, primarily inhabiting the hills. Despite modern challenges, they proudly preserve their heritage through vibrant festivals, traditional dress, and intricate handicrafts. In Tamenglong, where the majority belong to the Zeliangrong Naga tribe, a centuriesold tradition of handloom weaving thrives, carried on by rural women and artisans who keep this craft alive across generations.

"We work here making traditional clothes. It takes one to two days to weave a piece of fabric, which requires a lot of effort. We make clothes for both women and men. Prices start around three thousand rupees and increase if more fabric is used or if the work is more intricate," says Thinglung Lio, a handicraft artist.

"Phule" co-writer and consultant Muazzam Beg shared interesting aspects related to the film

I was very excited, but there was a deadline - the shoot was to begin in



case their incredible sacrifices and contributions, inspiring the audience through their remarkable journey. "During script discussions, I, Ananth Mahadevan, Anuya Chauhan and Ritesh Kudecha built a strong bond, and they entrusted me with more responsibilities. I became the Creative Consultant. I was involved in casting, music, and was present on set during the shoot, working closely with director Ananth Mahadevan, DOP Sunita Radia, costume designer Aparna Shah and the entire team. We shared a great bond to make Phule. We all knew we were making a special and important

three months. I left everything else and focused my entire attention on Phule. I began extensive research, which revealed many interesting facts and key aspects of their lives. They had achieved so much - it was beyond my imagination. Kya kya kar gaye... aur kaise kar gaye. My involvement went beyond the dialogues; I contributed to the screenplay to ensure emotional depth and authenticity. Also, I had to write dialogues in three languages: Hindi, English and Marathi." One of the biggest challenges, according to

One of the biggest challenges, according to Beg, was to present sensitive content without hurting any community. The idea was to showfilm." After the shoot, Ananth Mahadevan, Anuya Chauhan and Muazzam Beg worked closely during post-production. Baig says, "After our first edit, we realised that the film was too heavy, and had a lot of English dialogues. We kept these dialogues for authenticity, but we understood that the common man would not understand the important information, risking loss of interest. We decided to use voice-over narration to explain the context of those scenes, so we added the voice-over. We also decided to include two songs in the narrative: For "Dhun Lagi Aazadi Ki", I asked my poet friend Sarosh Asif to write a revolutionary song showing the footage.
