### **SC introduces** reservation for apex court staff

NEW DELHI: In a first, the Supreme Court has introduced a formal reservation policy for the direct appointment and promotion of its staffers belonging to scheduled castes and scheduled tribes.

The decision was communicated in a circular issued on June 24 to all Supreme Court employees.

"As per the directions of the Competent Authority, it is to notify for the informa tion of all concerned that the Model Reservation Roster and Register has been uploaded on the Supnet (internal email network) and it is made effective from June 23, 2025.

### **Five feared** killed in crackers factory blast in TN's Sivakasi

VIRUDHUNAGAR: At least five workers, including two women, were killed in a sudden blast at a firecracker manufacturing factory in Sivakasi in the district on Tuesday, police said. The devastating fire gutted the unit and left many injured, they said. Smoke that billowed from the factory as the firecrackers burst, could be seen from a distance. Police and fire and rescue services personnel who reached the spot, rushed the injured to the hospital

### Rupee rises 25 paise to close at **85.51 against US dollar**

MUMBAI: Rupee appreciated 25 paise to close at 85.51 (provisional) against the US dollar on Tuesday, supported by weakness of the American currency in the overseas market and a positive tone in the domestic equities amid rise in risk appetite.

Forex traders said the US dollar is trading at lowest levels since February 2022 as President Donald Trump's growing influence on Federal Reserve policy revived fears over the central bank's independence. Moreover, Brent crude prices remained subdued. offering a buffer to India's import bill and helping cool

### **Dalai Lama** may announce his successor on Sunday



CHANDIGARH: The No bel Peace laureate, His Holiness the Dalai Lama may announce his successor this week, possibly through a message or on July 6, his birthday, during a gathering expected to include numerous dignitaries from both India and abroad. The year-long birthday celebrations of the Tibetan spiritual leader will start in McLeodganj in Dharmashala, the headquarters of the Tibetan government-in-exile, and conclude on July 5 2026.

# Cloudbursts wreak havoc in Mandi; four dead, 16 missing



SHIMLA, JULY 1

Mandi district in Himachal Pradesh is facing severe devastation due to heavy monsoon rains and multiple cloud-

During the past 15 hours, Sandhole recorded 224 mm of rainfall, Mandi 216 mm, and Pandoh 215 mm, causing flash floods and landslides.
Four people have lost their lives,

while four were injured, and 16 others are missing. Rescue teams have saved 287 people, including 233 in Mandi, 51 in Hamirpur, and three in Chamba. Houses, roads, and bridges have been damaged, with 10 homes and 12 cowsheds destroyed.

A key bridge was washed away, and NH-305 remains blocked, leaving many stranded.

### Haryana sees 30 pc surplus rains in June, Punjab 28 pc

CHANDIGARH: Several parts of Punjab and Haryana received rainfall on Tuesday. The common capital, Chandigarh, witnessed 13.5 mm rainfall In Haryana, rains were witnessed in Ambala, Hisar, Rohtak, Karnal, Narnaul,

Charkhi Dadri, Panchkula and Rewari, among other places. In Punjab, places including Amritsar, Ludhiana, Patiala, Pathankot, Mohali and Gurdaspur re-

Chandigarh has seen heavy downpour, measuring more than 200 mm, in the last three days According to the Met department, Chandigarh received 13.5 mm rains in the

24 hours until 8.30 am on Tuesday. In the two days prior to that, the city had received 190 mm rain. The Met office also said that Punjab, Haryana and Chandigarh have received surplus rain in June. Punjab received 69.7 mm rainfall last month, against the normal of 54.5 mm, which was 28 per cent surplus, the Met office said. Likewise, Haryana received 30 per cent surplus rains in June, with 71.7 mm rains in June, against its normal of 55.3 mm.

# Mixer tipper plunges into pond near Moga; three injured, driver untraceable for 20 hours

JAGRAJ SINGH SANGHA MOGA, JULY 1:

A high-speed mixer tipper veered off the road and plunged into a deep roadside pond near village Fatehgarh on the Mo ga-Jalandhar Highway late last night. leaving three motorcyclists seriously injured and the driver missing for nearly

The accident occurred around 9:30 pm on Sunday. Members of the Samaj Sewa Society, led by Mayor Baljit Singh Chani, and the Bhagat Puran Singh Sewa Dal, led by Daljit Singh Gill, along with police personnel from Dharamkot police station, DAP Ramandeep Singh, and SHO Jatinder, rushed to the scene and rescued the injured. Two of the victims were admitted to Faridkot Medical Hospital, while the third was referred to Bathinda. One of them is reported to be in critical

Despite continuous efforts by local divers and social service volunteers, the administration failed to retrieve the submerged mixer tipper from the pond. The



district administration and municipal authorities reportedly lacked the necessary heavy machinery, including a Hydra crane, to aid in the recovery operation.

As public frustration mounted over the prolonged inaction, a twist emerged late in the evening when workers from the company owning the mixer claimed that the missing driver was "with them." However, when pressed by journalists about his whereabouts, the company

representatives offered vague responses, further fuelling anger among local residents and volunteers.

A bottle of liquor was also recovered from the vehicle, raising questions about the driver's sobriety at the time of the crash. Social workers have demanded legal action against the driver and called on the Dharamkot police to investigate the company's role in withholding informa-

There is also widespread criticism of both the National Highways Authority and local administration for failing to secure the accident-prone pond alongside the highway. Citizens

have demanded immediate fencing and safety measures, warning that such negligence could lead to more tragedies in the future. Many have also pointed out that mixer tippers and other heavy vehicles operating in the area often lack proper documentation, and some drivers don't possess valid licenses—raising serious concerns about regulatory enforce-

## **Record-breaking GST growth of 44.44%** in June, 27% in 1st quarter: Cheema

CHANDIGARH, JULY 1

Punjab has recorded a record breaking 44.44 percent growth in Net GST collections for June 2025 and a substantial 27.01 percent growth for the first quarter of Fiscal Year (FY) 2025-26, marking the highest-ever GST revenue growth in a fiscal quarter and for the month of June in the state's history. Punjab Finance, Planning, Excise and Taxation Minister Advocate Harpal Singh Cheema revealed this while addressing a press conference after facilitating the top five taxpayers of the state for their exemplary contribution to the state's economic growth and revenue generation, including Ashu Agnihotri from Ambuia



Sanjay Malhotra from HPCL-Mittal Energy Limited (HMEL), Chaman Lal Sharma from Samsung India Pvt Ltd, Ankush Sharma from Tata Steel and Nitin Dada from Dada Motors. The Minister acknowledged their contributions and emphasized the importance of responsible tax practices in achieving inclusive development and fiscal sustainability. Finance Cheema

accompanied by Secretary Taxation Ajit Balaji Joshi and and Taxation Commissioner Jitendra Jorwal highlighted that Punjab has outpaced the national average in GST growth, firmly positioning itself among the top-performing states in tax mobilization despite facing national and geopolitical challenges, including borderrelated tensions. The Net GST collection for June 2025 stood

a remarkable revenue growth of Rs 732.21 crore over the Rs 1647.69 crore collected in June 2024. This follows monthly net growth trends of 15.35 percent in April and 24.59 percent in May. The net GST collection during the first quarter of FY 2025-26 reached Rs 6,830.40 crore, even amidst the conflict between India and Pakistan in May 2025, compared to Rs 5,377.75 crore in the first quarter of 2024-25. This represents a growth rate more than four times the 6.41 percent growth rate registered during the first quarter of FY The Finance Minister also launched a scathing attack on the previous SAD-BJP and Congress-led governments, citing their

and improve the state's fiscal health. He asserted that the Chief Minister Bhagwant Singh Mann-led Punjab Government has ensured consistent month-on-month and year-on-year growth. He noted a GST collection growth rate of 16.25 percent in FY 2022-23, 15.51 percent in FY 2023-24, and 12.84 percent in FY 2024-25, registering a total collection of Rs 62,733 crore in three years. In contrast, during the Congress regime from FY 2018-19 to FY 2021-22, the state merely collected Rs 55,146 crore. ### **EDITORIAL**

### India's lonely war on terror

ndia has been virtually waging a lonely battle against crossborder terrorism with little or no help even from those nations that make lofty claims about commitment to combating global terrorism. Though New Delhi has been a victim of Pakistansponsored terrorism for decades, it was only after the 9/11 terror strikes in the heart of America that the international community, particularly the Western countries, woke up to the seriousness of the problem. But, then, there has been a stunning duplicity when it comes to denouncing terror acts that have roots in Pakistan. The deliberations at the recent meeting of the Defence Ministers of the Shanghai Cooperation Organisation (SCO) in Qingdao, China, once again proved that India should not rely on multilateral forums in its fight against terrorism. The meeting omitted any reference to the horrific terror attack in Kashmir's Pahalgam on April 22. India, represented by Defence Minister Rajnath Singh, did the right thing by refusing to sign the SCO joint statement and insisting that the statement must explicitly mention the Pahalgam attack to highlight the ongoing threat of terrorism in the region. It is clear that Pakistan used its clout to block the proposal. What is more shocking is that the joint statement included references to militant activities in the restive Balochistan province. This blatant duplicity shows that the SCO meeting skewed the outcome in favour of Pakistan's narrative. The experience is a reminder that India's war on terror has been a lonely battle in the past and will remain so in the future.

Unfortunately, the global community has so far failed to achieve consensus on dealing with the menace of terrorism. While the SCO has often projected itself as a Eurasian pillar of security cooperation, the inability to agree on the definition or mention of terrorism especially after a daredevilry attack targeting tourists of a particular religion — renders that claim increasingly hollow. India's refusal to endorse the final statement reflects not just New Delhi's firm stance but also the limits of multilateralism. Cross-border terrorism emanating from Pakistan is one of the major concerns of India. But, Islamabad continues to be in a denial mode and hoodwinks the international community through obfuscation and a smokescreen of counter-terrorism measures. China's vague characterisation of the meeting as having "achieved successful results" only sharpens the contrast between public diplomacy and private dysfunction. Beijing, keen to preserve the image of SCO unity, may prefer ambiguity over substance, but that posture also limits the organisation's credibility. If SCO defence ministers cannot even acknowledge the targeting of civilians in a terrorist attack, holding such meetings becomes pointless as they only serve empty symbolism.

Vague and ambiguous statements and photo opportunities are no substitute for actionable solidarity. If counter-terrorism cannot be a unifying pillar, then a question mark hangs over the core objectives of the SCO

# Shubhanshu conducts muscle stem cell research on ISS

Indian Space Research
Organisation (ISRO) astronaut
and Group Captain
Shubhanshu Shukla, currently
aboard the International Space
Station (ISS) as part of the Axiom
Mission 4 (Ax-4), conducted a series
of scientific experiments on
Monday focused on muscle health,
digestion in space, and astronaut
mental well-being. According to
NASA, Shukla worked inside the
Kibo laboratory's Life Sciences
Glovebox to study how muscle
stem cells behave in microgravity.

He also recorded an educational video for Indian school students explaining how the human digestive system adapts in space.NASA said, "Indian astronaut Shubhanshu Shukla filmed a video targeted to young Indian students discussing how the digestion system adapts to space Next, Shukla worked in Kibo's Life Science Glovebox checking muscle stem cell cultures to learn how to maintain muscle health in space."The Life Sciences Glovebox is a sealed and sterile workspace aboard the ISS that allows astronauts to safely handle biological samples in microgravity. It is large enough to allow two astronauts to work together and is used for experiments requiring clean conditions. According to NASA, ISRO's experiment, Myogenesis, investigates how muscle cells regenerate in space. Astronauts tend to lose muscle mass during extended missions, partly due to microgravity disrupting the function of mitochondria, the part of the cell responsible for energy production.



The study involves testing certain metabolic supplements to see if they can improve muscle repair in microgravity. Results from the research may help in developing treatments for age-related muscle loss or muscle-wasting diseases on Earth, in addition to improving astronaut health during long-duration spaceflights.NASA explained the purpose, saying, "Astronauts lose muscle mass and

the ability of muscle cells to regenerate during spaceflight, which may be due to microgravity interfering with metabolism in mitochondria, cell structures that produce energy.

The Effect of Metabolic Supplements on Muscle Regeneration Under Microgravity (Myogenesis - ISRO) investigation on the Axiom 4 (Ax-4) private astronaut mission uses muscle stem cell cultures to examine the muscle repair process and test chemicals known to support mitochondrial function. Results could lead to interventions that maintain muscle health during long-term space missions and help people on Earth with muscle-related challenges such as agerelated muscle loss and musclewasting diseases."Other Ax-4 crew

members also contributed to

scientific research. Mission Commander Peggy Whitson used the Ultrasound 2 device to perform vein scans on Hungarian astronaut Tibor Kapu, to help understand how space affects blood pressure, balance, and vision. According to NASA, the Ultrasound 2 on the International Space Station (ISS) is a modified commercial off-the-shelf (COTS) ultrasound system that provides high-resolution ultrasound images of target areas in the human body."Polish astronaut Slawosz Uznanski-Wisniewski tested a braincomputer interface using a special headset developed by the European Space Agency (ESA). He later joined Whitson and Shukla in filming content for an astronaut mental health study

NASA stated, "The Thoughts over Gravity, a Test of Using fNIRS-based Brain, Computer Interface in LEO Conditions (PhotonGrav) investigation verifies the effectiveness of nearinfrared technology (fNIRS) in low Earth orbit to record brain activity for constructing brain-computer interfaces (BCI) operated in the microgravity environment."Commenting on the crew's schedule, NASA said, "The Ax-4 private astronauts had a science-packed Monday fulfilling research objectives for their home countries."The Ax-4 mission is taking place alongside the activities of the ISS's regular Expedition 73 crew. While Ax-4 focuses on privately funded science, Expedition 73 astronauts continue to work on NASA- and ESA-backed research.

# Over 50,000 evacuated as Turkiye battles Izmir wildfires for second day



urkiye continued to fight intense wildfires for a second straight day on Monday in its western province of Izmir, prompting the evacuation of more than 50,000 residents from 41 affected areas, Al Jazeera reported, citing local authorities. As per Al Jazeera, citing Turkish Forestry Minister Ibrahim Yumakli, strong overnight winds, reaching 40-50 km/h (25-30 mph), fuelled the fires in the Kuyucak and Doganbey regions with over 1,000 personnel, along with helicopters, firefighting aircraft, and ground vehicles involved in the firefighting efforts. The

Turkish disaster agency AFAD later confirmed on X that more than 50,000 people had been temporarily relocated, mostly from areas near Izmir, a popular resort region.

"A total of over 50,000 citizens from 41 settlements have been temporarily relocated to safe areas." AFAD stated on X. Due to the spreading fire, operations at Izmir's Adnan Menderes Airport were suspended, with visuals showing thick smoke, scorched hills, and helicopters dropping water, while residents used tractors equipped with water tanks to combat the flames, as reported by Al

Jazeera.

Earlier efforts were hampered when high winds grounded helicopters, leaving water-bombing planes and ground crews to contain the fire.

The initial blaze started

on Sunday between the Seferihisar and Menderes districts. The fire rapidly expanded with wind gusts Al Jazeera stated, citing the Governor of Izmir. Suleyman Elban. Another fire erupted at a landfill site in Gaziemir, just 13 km (8 miles) from central Izmir, spreading into nearby forest areas and threatening the Otokent industrial zone, where multiple car dealerships are located, as reported by Al Jazeera. Turkiye's coastal areas have also experienced increasing wildfire threats in recent years due to hotter, drier summers, conditions scientists attribute to climate change. The same region in Izmir suffered a major wildfire just last

of suicide in Nangarhar and Kandahar provinces have brought renewed focus on growing mental health issues among Afghan youth, with drug addiction, domestic violence, and unemployment cited as leading causes, TOLO News reported. One of the victims, Abdul Hag, a resident of Nangarhar, hanged himself at home, leaving behind two orphaned children. Family members told TOLO News that he struggled with mental illness and drug addiction and had been hospitalised several times."He was addicted to drugs. When I realised it, he had already left home twice. but I brought him back," said his father, Noorurrahman, "I brought him back a third time as well and took him to the hospital, where he received treatment. However, after returning home, he left again."

His brother, Samiullah, added,
"Two days had passed since he
hanged himself before the
neighbours informed us. We went
and brought back his body,
arranged for his shroud, coffin, and
burial."According to official data



recent weeks. On the 17th of Jawza (solar calendar), a young man named Abdullah Abid in Uruzgan, and on the 7th of Saratan, Fida Mohammad in Kandahar, died by suicide due to economic and mental stress. Similarly, in Paktika province's Barmal district, a young man named Allah Noor and his fiancee took their own lives because they couldn't afford the dowry. Religious scholars and mental health experts have expressed concern over the trend. Abdulrahman, a religious scholar in Nangarhar, said, "The Prophet's savings clearly prohibit suicide

accountable in this world and in the hereafter. "Dr. Amir Pamir, a physician in Nangarhar, told TOLO News that many suicides are linked to mental health challenges and psychological pressure. "Mental illness and sudden psychological pressures lead many young people to take their own lives. ### Relentless rain batters Bilaspur, PWD reports losses worth Rs 5.5 crores

BILASPUR: Bilaspur district has been reeling under heavy rainfall for the past three days, significantly disrupting daily life and causing widespread infrastructural damage. The Public Works Department (PWD) has borne the brunt of the impact, reporting estimated losses exceeding Rs 5.5 crores, with the Bilaspur and Jhanduta divisions being the hardest hit. Despite the intensity of the rainfall, no road remains officially closed. However, 50 out of 563 roads under the PWD have been affected due to falling trees, debris, and damage to road structures. Prompt action by the department ensured swift restoration, with all roads now reopened. The losses include massive damage to road embankments, safety walls, and drainage systems. Division-wise, Bilaspur Division No. 1 recorded the highest loss at Rs 2.88 crores, followed by Ghumarwin at Rs 1.61 crores, Swarghat at Rs 1.16 crores, and Division No. 2 at Rs 51 lakhs. Notably, Rs 4 crores of the damage occurred by June 30, with an additional Rs 1.5 crores on Tuesday alone.

### Still mopping it old school: Dyson study reveals India's obsession with clean homes, but we could be making our floors dirtier

LUDHIANA:- Dyson announced the results of its first Global Wet Cleaning Study, to investigate wet cleaning habits and behaviours, frustrations people face with their wet cleaning tools, and why our best intentions might not be delivering the hygienic homes we expect. The global study uncovers that despite frequent cleaning by Indian households, current tools and habits could be making homes less hygienic, not cleaner The study finds that hard floors dominate Indian homes, with 94.5% of people having floors made of tiles, stone, or wood-materials that attract dirt easily and require



frequent wet cleaning. However, popular cleaning methods including traditional mops, buckets, and cloths, may be spreading dirt rather than removing it. Unlike South Korea or Australia, where wet cleaning happens more reactively, occasionally or for specific messes, in India, wet cleaning is part of the daily routine. Traditional wet floor cleaning methods remain the most preferred choice for many Indian households. with mops, cloths, or wet sweepers in constant use. Yet, despite their popularity, these tools bring their own set of challenges: 1 in 3 Indians say wet cleaning is simply too time-consuming. In fact, 75% spend over an hour on their cleaning routines, with nearly 35 minutes devoted to wet cleaning floors. Indian use of mops, brooms, and wet cloths is the highest in APAC-yet only 33% finds cloths or sponges truly effective for hard floors.49% admit they don't change the cleaning water for every room. This means dirty water, and the

germs in it, are spread from one part of the house to another, defeating the purpose of cleaning.45% cite stubborn stains as their top cleaning challenge, and 31% worry about

### Som river damages retaining wall near Chhachhrauli, access to Assahapura blocked for public safety

ilaspur (Savita):The retaining wall built along the road from Chhachhrauli to Assahapura has collapsed at three locations due to the heavy flow of the Som river. The 200-metre-long wall, constructed in 2018 by the Public Works Department (PWD) was part of an incomplete road project that resumed in 2024 after being halted due to legal complications. With the collapse, the PWD has now closed the route to ensure public safety. Officials have stated that repairs can only begin once the monsoon season ends, as the current weather conditions make restoration work unfeasible. The road, originally sanctioned by then Assembly Speake remained incomplete due to objections raised in 2018. The retaining wall had been constructed at that time merely to protect the earthworks, not to withstand water flow. Local residents like Sunil Garg and Deshrai expressed their frustration, noting that the contractor cannot be held accountable anymore since the standard five-year liability period has expired. With the wall damaged, the government, and locals will once again face delays. Until the road is restored, villagers must detour around 10 kilometres via Ledhi They blamed administrative apathy, stating that despite the road work beginning in 2018, it remains unfinished. "It's time to question who is truly responsible—government ninistration, or the public," they said




