As the Dragon spacecraft carrying astronaut Shubhanshu Shukla returned to Earth after an 18-day stay aboard the International Space Station (ISS), it carried with it more than just scientific data and seed samples, it brought home a story of grit, dreams, and India's growing space ambitions.

Group Captain Shukla, a 39-year-old Indian Air Force officer and test pilot, completed his maiden space voyage as part of the Axiom-4 mission, a commercial spaceflight supported by ISRO and NASA, and operated by Axiom Space.

The journey marked a milestone for India: Shukla is Sharma's the first Indian to step aboard the ISS and only the second Indian to go into space, following Rakesh Sharma's oht in 1984

Educated at City Montessori School (CMS), Shukla's journey to the stars was anything but scripted. In a stroke of destiny, a classmate applying to the National Defence Academy (NDA) realised he was overage and passed on the form to Shukla. He was commissioned into the Indian Air Force in 2006 and went on to become a decorated test pilot with over 2,000 hours of flying time on advanced fighter aircraft such as the Su-30 MKI, MiG-29, Jaguar, and Dornier-228. He later earned an MTech in Aerospace Engineering from the Indian Institute of Science, Bengaluru. Last year, he was chosen as one of four astronauts in India's Gaganyaan programme, alongside Prasanth Balkrishnan Nair, Angad Pratap, and Ajit Krishnan.

The quartet underwent intensive training in Russia's Gagarin Cosmonaut

Training Centre and ISRO's Astronaut Training Facility in Bengaluru. But before Gaganyaan's scheduled launch in 2027, Shukla got the opportunity to fly as part of the Ax-4 crew—an Indian was part of a human spaceflight mission after 41 years. After several postponements, Shukla finally launched from the Kennedy Space Center on June 25, aboard the SpaceX Falcon 9 rocket.

5 killed and 17 injured after tempo overturns near Doda AGENCY DODA, JULY 15

No seizure or suspicious item was recovered," Singh clarified, stating the agency was simply completing procedural aspects of the investigation.

During the discussion on the Bill in the Punjab Vidhan Sabha today, Mr. Aman Arora underlined the failure of previous governments, including the Akali-BJP and Congress regimes, to deliver justice in sacrilege cases, particularly the 2015 Bargari, Kotkapura and Behbal Kalan incidents. which involved the desecration of Sri Guru Granth Sahib



Ji. While highlighting the hypocrisy of Congress party, Mr. Aman Arora stated that despite constitution of multi-Special Investigation ple Teams (SITs) and commissions by previous regimes, none had named the Badals as accused in sacrilege cases. However, after the Aam Aadmi Party (AAP) came to power in Punjab, a thorough investigation was initiated. A SIT led by

ADGP, L.K. Yadav submitted a comprehensive challan of over 7,000 pages, naming former Chief Minister Late Parkash Singh Badal, Sukhbir Singh Badal, former DGP Sumedh Singh Saini, and others as accused. The case is currently pending in the Court of Faridkot Additional Sessions Judge.

The Badals, who claim to be guardians of Sikh faith, did nothing when Guru Granth

Sahib Ji's sanctity was violated. Even the SAD government sent a weak bill to the Centre in 2016, which was rejected because it only protected one scripture. Now, they have the audacity to question our government's sincerity, said Mr. Arora

He pointed out that previous governments failed to take action against the main culprits in sacrilege cases, with investigations being delayed or stalled. In contrast, the AAP government has taken a decisive approach, filing chargesheets in all cases and naming individuals, including the Badals , as accused based on investigation findings. While highlighting the key provisions of the Bill, Mr. Aman Arora stated that it prescribes stringent punishments for sacrilege, including 10 years to life imprisonment. The hill drafted after extensive consultations, defines desecration broadly to include

acts such as tampering, burning, tearing, destruction, and defiling of sacred texts, encompassing scriptures like Sri Guru Granth Sahib, Gutka Sahib, Srimad Bhagavad Gita, Quran Sharif, and Holy Bible, among others. Notably, the bill makes desecration a non-bailable and non-compoundable offense, punishable with a minimum sentence of 10 years and a fine ranging from Rs 5 lakh to Rs 10 lakh. A key aspect of the bill is its inclusive nature, covering all religions and emphasising equal respect for all holy scriptures. He said that the bill also ensures speedy investigation by a DSP or above rank officer, and mandates respectful handling of evidence, prohibiting any disrespect to religious remains. This provision underscores the importance of dignity and reverence in the handling of sacred texts, while ensuring swift justice in sacrilege incidents.

Widening of Ghaggar river and strengthening embankment near village Tiwana under consideration: Goyal

CHANDIGARH, JULY 15

Punjab Water Resources Minister Sh. Barindar Kumar Goyal, while responding to a call attention motion, informed that the proposal to widen the Ghaggar river near village Tiwana in the Dera Bassi and strengthen its embankment is under considera-

Responding to the call attention motion presented in the Vidhan Sabha by MLA Dera Bassi S. Kuljit Singh Randhawa, the Water Resources Minister said that due to heavy rainfall in 2023, the water level in the Ghaggar at Village Tiwana had risen significantly. Consequently, floodwater from the Ghaggar River inundated the cultivable land on the left bank and erosion caused the ground level to drop by approximately 8 to 10 feet. Subsequently, the department installed stone revetment and studs along a 2500foot stretch to protect the cultivable land from erosion. To support this revetment, an



embankment was constructed behind it by filling it with soil. He informed that the department spent Rs.5.06 crores on this project. Goyal revealed that heavy rainfall in the Ghaggar's catchment area on June 29, 2025 caused the river's water level to surge suddenly, but the stone revetment remained completely intact. However, the soil embankment behind the revetment suffered some erosion in certain areas. The department immediately took action and completed the embankment repairs. This restoration work was carried out entirely at the department level. He mentioned that on July 8, 2025, substantial water flow occurred again in the Ghaggar River, but it passed through without causing any damage to the embankment.

The Cabinet Minister reiterated that the proposal is also under consideration to widen the Ghaggar River on the right side near Village Tiwana and utilize the excavated soil to broaden and strengthen the left bank.

Entire gram panchayat **Chawdi quits over** opening of wine shop

AGENCY SHIMLA: In a rare and strong show of protest, the entire body of gram panchayat Chawdi in development block Seoni, district Shimla, has tendered its resignation following the opening of a wine shop at Khera village despite local opposition and the subsequent lodging of FIRs against protesting women. In a letter addressed to the district panchayat officer, dated July 10, the pradhan, deputy pradhan, and all seven ward members expressed deep anguish over the state government's decision to permit the opening of the wine shop from July 1. The panchayat had unanimously passed a resolution against it in its meeting on June 24, citing adverse social and cultural impacts on the community. The letter accuses the excise and taxation department of disregarding local sentiment and using coercive means, including the filing of FIRs against women who were peacefully opposing the shop. It

states that the shop's operation has stirred unrest in the village, affecting peace and dignity, particularly of women and school-going children. "We feel betrayed by the administration and no longer wish to be a part of a governance system that disregards the will of the people, the letter states.

CM approves power infrastructure plan to resolve Kangra crisis

AGENCY KANGRA, JULY 15

Himachal Pradesh Road Transport Corporation Vice Chairman Ajay Verma has assured that a permanent solution to the power issues plaguing Kangra city and nearby rural areas will be implemented soon. Ajay Verma announced that Chief Minister Sukhvinder Singh Sukhu has approved a power infrastructure development plan worth Rs 22.67 crore to resolve the persistent electricity problems in the region. Under the plan, 18 new transformers will be installed and 13 existing ones will be upgraded. A new 33 KVA substation will be constructed at Daulatpur at a cost of Rs 11 crore, which is expected to significantly improve electricity supply to Kangra city and adjoining villages. An additional Rs. 90 lakh will be spent on upgrades at the Sheb substation. To eliminate the overhead wiring clutter in Kangra city, an integration project worth Rs 1.75 crore will be undertaken. Who is ultimately responsible for the accidents happening despite strict rules on paragliding in the district. Even in the year 2022, a helper pushing a glider in Bir Billing, Kangra, got stuck in the rope, due to which the balance of the glider got disturbed, due to which 2 youths fell from a height of 25-30 feet and died on the spot. After this accident, the Tourism Department had banned paragliding across the district. That is, the administration and the tourism department wake up only after accidents. The administration has come into action after the death of a Gujarat youth in paragliding on Sunday. In January 2025, a young woman from Gujarat died in a paragliding accident. This girl died after falling from a height due to harness failure during



the flight. In 2021, an accident also happened with a tourist at Indranag paragliding site, in which he was seriously injured. If we see, the local paragliding pilots do not have all those safety facilities, which can protect both the pilot and the tourist during an accident.

Dharamshala paragliding has become just a business in which there is no guarantee of life. The Tourism Department has completely banned paragliding in the entire district from 15 July to 15 has September. The Tourism Department has taken this

tough decision in view of the rainy season. District Tourism Officer Vinay Dhiman, while giving information, said that like every year, this time also paragliding activities have been suspended in the valley due to safety reasons. Vinay Dhiman said that during the rainy season, there is heavy

and uncertain rainfall in the area, due to which the take-off site Billing and landing site Cure become slippery. This situation becomes risky for both the pilots and the tourists. In such a situation, the administration has taken this decision as a precaution. He said that this decision will be applicable to all types of flights including tandem flights. Bali recently refuted claims that the Board of Directors (BoD) had approved handing over 14 lossmaking units to private entities. His statement contradicts earlier reports, deepening the rift between the board, employees, and

the state government. Minister Chief Sukhvinder Singh Sukhu tried to downplay the situation, asserting that only senior officers would be relocated to Dharamshala. However, employees fear the shift could be the beginning of a larger overhaul that sidelines the workforce in Shimla.

The state's handling of HPTDC affairs has also come under judicial scrutiny. In recent months, the Himachal Pradesh High Court rebuked the government for its opaque functioning and mismanagement in tourism

operations. As discontent brews within the corporation, the shifting of its head office to Dharamshala has become another flashpoint in the ongoing friction between HPTDC employees and the state administration.

Editorial New vision

he recent five-nation trip took Prime Minister Narendra Modi to three continents spread over tens of thousands of miles. While the visits to Brazil for the BRICS Summit and to Trinidad and Tobago and Argentina were all significant, there was a deep symbolism to the manner in which Mr Modi bookended his travels, starting out in Ghana and returning to Africa with a trip to Namibia. New Delhi, of course, has never abandoned Africa. But it has, far too often, shown interest in deepening its engagement with the continent, only to then get distracted, undermining its own previous efforts. In Namibia, Mr Modi laid out what amounts to a fresh vision for India's relations with Africa. And the timing could not be more critical. At a time when China's deep influence in the continent is facing pushback in some African nations and the United States of America appears to be openly pitching for a neocolonial approach, India's long history with several African nations, coupled with its softer touch, could give it an edge. It is already a major trading partner of several African countries and has offered billions of dollars in concessional loans. Generations of young Africans have studied in India.

Yet, India has also been guilty of relegating ties with the continent to the sidelines at times. For instance, New Delhi has not held an India-Africa Summit since 2015 even though China, the US, Turkey, Japan, Russia and South Korea have all held such conclaves. Rebuilding India's influence on the continent will come with its own challenges. China has been Africa's largest trading partner for over a decade and is also a major investor. The meeting between the presidents of Gabon, Senegal, Guinea-Bissau, Liberia and Mauritania and the US president, Donald Trump, in Washington last week also made it evident that African nations know that American investors can bring cash that no one else can match. But some African countries have renegotiated mining deals with Beijing amid concerns that they are not benefiting enough from the relationship. India to become a global employment epicenter

India to become a global employment epicenter as the global labour market is undergoing rapid transformation, with rising demand of skilled workers across economies as ageing population in many countries and businesses are adopting digitisation, according to a report by Crisil Intelligence."

The global labour market is undergoing rapid transformation, with demand for skilled workers rising sharply across advanced as well as emerging economies because of ageing population in many countries and businesses looking to adopt and scale up digitalisation." noted the report The report also highlighted that while some countries are witnessing rising unemployment, many employers across the world continue to face challenges in finding skilled workers. It stated "India to become a global employment epicenter..., the global labour market is undergoing a contradictory situation, where some countries are experiencing rising unemployment even as employers struggle to find skilled workers".

The primary reason for this paradox is the growing demographic divergence. High-income countries are experiencing rapid population ageing due to sustained decline in fertility rates and rising life expectancy. This has resulted in a high dependency ratio of elderly people in the working population, further deepening the skills short-



age. On the other hand, lower- and middle-income countries are seeing a demographic expansion, with a rising number of young individuals entering the workforce.

According to the International Monetary Fund's World Economic Outlook, by 2050, these countries are expected to contribute nearly two-thirds of the global workforce entrants.

The report also mentioned that India, with 65 per cent of its population under the age of 35, finds itself in a unique position to bridge this global skill shortage.

The country has the potential to supply surplus labour and fill the talent gaps in high-income nations.However, Crisil's report also cautioned that India's labour market faces serious challenges, particularly in the form of under qualification and widespread skill gaps.As per the Periodic Labour Force Survey, less than half of India's graduates are considered fully employable, and only 4.4 per cent of the workforce has received formal vocational training

This indicated that despite having a large workforce, the issue of inadequate skill development has become endemic in the country.

The report outlined that India must urgently address the structural gaps in its skilling ecosystem. By doing so, the country can not only improve domestic employment and productivity but also contribute to bridging the global skills shortage.

Booster Dose at 4–6 Years Essential to Maintain Vaccine Protection

NEW DELHI : As children in India approach the start of formal schooling, health experts are urging families to ensure their children receive the recommended booster dose against diphtheria, tetanus, pertussis (whooping cough), and polio. This booster, advised between four and six years of age, is a scheduled part of the national immunisation programme and plays a vital role in extending protection beyond early childhood. Initial protection is provided through primary immunisation in infancy. As per



this condition.

India's National Immunization Program (NIP), DTP vaccines are administered at 6, 10, and 14 weeks, fol lowed by a booster at 16 to 24 months. Polio vaccines are also provided in two fractional doses during infancy. However, medical evidence confirms that immunity begins to decline a few years after these early doses, leaving children more susceptible by the time they enter high-contact environments such as schools. Dr Nitin Verma, Director, Rosewalk by Rainbow, Panchsheel Park, Delhi explains, "The 4 to 6 age window is when immunity from infant vaccines starts tapering off. This is also when exposure increases due to schooling and group play. The

booster is designed to protect children during this high-risk transition." Recent data from global and national health agencies also highlights the risk of poliovirus reintroduction in under-immunised populations, particularly as the virus remains active in neighbouring regions. Maintaining high coverage of scheduled boosters is essential to sustain India's progress in disease elimination. The Indian Academy of Paediatrics supports the use of modern combination vaccines that combine protection against multiple infections into a single dose.

Meanwhile, a Memorandum of Understanding (MoU) under the National Rabies Control Programme with Peedu (Animal Welfare NGO), located in SAS Nagar, was also signed to facilitate coordinated efforts towards the preparation of the State Action Plan for Rabies Elimination by 2030. The initiative involves the engagement of various stakeholders, along with training of health staff and counseling sessions at Anti-Rabies Clinics in District Mohali, with the scope for future expansion across the State.

Haryana Education Minister, Mahipal Dhanda said that the Government Women's College in Bawani Khera will be named after the late Thakur Sh. Shambhu Singh, a freedom fighter from the Azad Hind Fauj and the Chief Minister has also approved naming the Government College, Kharak (Bhiwani) after Martyr GajendraSingh.

Notably, on March 7, 2018, Sh. Gajendra Singh, who served as an Assistant Commandant in the 134

Battalion of the Border Security Force, was martyred while valiantly fighting Naxals near the Maspur village in the Natala Reserved Forest area of Kanker District Chhattisgarh. In recognition of his bravery, he was awarded the Gallantry Medal on January 26, 2021.
